1 AN ACT Relating to apportionments to educational service districts
2 for the 2010-11 school year; amending RCW 28A.510.250; and declaring an
3 emergency.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 28A.510.250 and 1990 c 33 s 426 are each amended to
6 read as follows:

7 (1) Except for the 2010-11 school year, on or before the last
8 business day of September 1969 and each month thereafter, the
9 superintendent of public instruction shall apportion from the state
10 general fund to the several educational service districts of the state
11 the proportional share of the total annual amount due and apportionable
12 to such educational service districts for the school districts thereof
13 as follows:

15	October	9%
16	November	5.5%

1	December	9%
2	January	9%
3	February	9%
4	March	9%
5	April	9%
6	May	5.5%
7	June	6.0%
8	July	10.0%
9	August	10.0%

11 (2) Subject to the payment process in subsection (1) of this
12 section, for the 2010-11 school year, the superintendent of public
13 instruction shall apportion from the state general fund on the
14 following schedule:

15	<u>On or before the last business day of September</u>	<u>.....</u>	<u>9%</u>
16	<u>On or before the last business day of October</u>	<u>.....</u>	<u>9%</u>
17	<u>On or before the last business day of November</u>	<u>.....</u>	<u>5.5%</u>

19	<u>On or before the last business day of January</u>	<u>.....</u>	<u>9%</u>

26	<u>On or before the last business day of July</u>	<u>.....</u>	<u>10.0%</u>

28 (3) The annual amount due and apportionable shall be the amount
29 apportionable for all apportionment credits estimated to accrue to the
30 schools during the apportionment year beginning September first and
31 continuing through August thirty-first. Appropriations made for school
32 districts for each year of a biennium shall be apportioned according to
33 the schedules set forth in this section for the fiscal year starting
34 September 1st of the then calendar year and ending August 31st of the
35 next calendar year. The apportionment from the state general fund for
36 each month shall be an amount which will equal the amount due and
37 apportionable to the several educational service districts during such

1 month: PROVIDED, That any school district may petition the
2 superintendent of public instruction for an emergency advance of funds
3 which may become apportionable to it but not to exceed ten percent of
4 the total amount to become due and apportionable during the school
5 districts apportionment year. The superintendent of public instruction
6 shall determine if the emergency warrants such advance and if the funds
7 are available therefor. If the superintendent determines in the
8 affirmative, he or she may approve such advance and, at the same time,
9 add such an amount to the apportionment for the educational service
10 district in which the school district is located: PROVIDED, That the
11 emergency advance of funds and the interest earned by school districts
12 on the investment of temporary cash surpluses resulting from obtaining
13 such advance of state funds shall be deducted by the superintendent of
14 public instruction from the remaining amount apportionable to said
15 districts during that apportionment year in which the funds are
16 advanced.

17 NEW SECTION. **Sec. 2.** This act is necessary for the immediate
18 preservation of the public peace, health, or safety, or support of the
19 state government and its existing public institutions, and takes effect
20 immediately.
