SUBSTITUTE HOUSE BILL 1266

State of Washington 66th Legislature 2019 Regular Session

By House Finance (originally sponsored by Representatives Springer, Orcutt, Tarleton, Vick, Pettigrew, Walen, and Stokesbary)

1 AN ACT Relating to exempting certain standard financial 2 information purchased by investment management companies from sales 3 and use tax in order to improve industry competitiveness; amending 4 RCW 82.08.207 and 82.12.207; creating new sections; and providing 5 expiration dates.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 NEW SECTION. Sec. 1. (1) The legislature finds that a strong financial cluster is critical to the economic health of Washington 8 state. The legislature further finds that anchor institutions are key 9 10 growing a strong financial cluster, including international to 11 investment management firms. Therefore, the legislature finds that 12 maintaining a competitive tax policy in Washington state enables the 13 state to maintain its anchor investment management firms.

14 (2) The legislature finds that standard financial information has 15 not historically been subject to sales tax. In 2007 the legislature 16 clarified that sales tax does not apply to electronically delivered 17 standard financial information purchased by investment management 18 institutions. In 2013, the companies or financial legislature 19 provided clarification by passing a sales and use tax exemption for 20 standard financial information purchased by investment management 21 companies.

1 (3) The legislature further finds that taxation of such standard financial information would be uncompetitive and inconsistent with 2 3 fundamental structure of sales tax as a tax on retail the transactions. Therefore, it is the legislature's intent to conform 4 with a previously determined policy objective of exempting certain 5 6 standard financial information purchased by investment management 7 companies from sales and use tax in order to improve industry competitiveness. 8

9 <u>NEW SECTION.</u> Sec. 2. (1) This section is the tax preference 10 performance statement for the tax preferences contained in sections 3 11 and 4, chapter . . ., Laws of 2019 (sections 3 and 4 of this act). 12 This performance statement is only intended to be used for subsequent 13 evaluation of the tax preferences. It is not intended to create a 14 private right of action by any party or be used to determine 15 eligibility for preferential tax treatment.

16 (2) The legislature categorizes these tax preferences as ones 17 intended to improve industry competitiveness, as indicated in RCW 18 82.32.808(2)(b) and to reduce structural inefficiencies in the tax 19 structure as indicated in RCW 82.32.808(2)(d).

20 (3) It is the legislature's specific public policy objective to 21 maintain a viable financial cluster. It is the legislature's intent 22 to exempt sales and use taxes on sales of standard financial information to qualifying international investment management 23 24 companies, in order to maintain the presence of at least one 25 international investment management services firm headquartered in Washington state with at least two hundred billion dollars of assets 26 27 under management.

(4) If a review finds that there is at least one international investment management services firm with at least two hundred billion dollars of assets under management headquartered in Washington state, then the legislature intends to extend the expiration date of the tax preferences.

33 Sec. 3. RCW 82.08.207 and 2013 2nd sp.s. c 13 s 702 are each 34 amended to read as follows:

(1) The tax imposed by RCW 82.08.020 does not apply to sales of standard financial information to qualifying international investment management companies <u>or a person affiliated with a qualifying</u> <u>international investment management company</u>. The exemption provided 1 in this section applies regardless of whether the standard financial 2 information is provided to the buyer in a tangible format or on a 3 tangible storage medium or as a digital product transferred 4 electronically.

(2) Sellers making tax-exempt sales under this section must 5 6 obtain an exemption certificate from the buyer in a form and manner 7 prescribed by the department. The seller must retain a copy of the exemption certificate for the seller's files. In lieu of an exemption 8 certificate, a seller may capture the relevant data elements as 9 allowed under the streamlined sales and use tax agreement. For 10 11 sellers who electronically file their taxes, the department must 12 provide a separate tax reporting line for exemption amounts claimed under this section. 13

14 (3) A buyer may not continue to claim the exemption under this section once the buyer has purchased standard financial information 15 16 during the current calendar year with an aggregate total selling 17 price in excess of fifteen million dollars and an exemption has been claimed under this section or RCW 82.12.207 for such standard 18 financial information. The fifteen million dollar limitation under 19 this subsection does not apply to any other exemption under this 20 21 chapter that applies to standard financial information. Sellers are 22 not responsible for ensuring a buyer's compliance with the fifteen 23 million dollar limitation under this subsection. Sellers may not be assessed for uncollected sales tax on a sale to a buyer claiming an 24 25 exemption under this section after having exceeded the fifteen 26 million dollar limitation under this subsection, except as provided 27 in RCW 82.08.050 (4) and (5).

(4) The definitions in this subsection apply throughout thissection unless the context clearly requires otherwise.

30 (a) <u>"Affiliated" means a person that, with respect to another</u> 31 <u>person:</u>

32 (i) Has an ownership interest of more than twenty percent, 33 whether direct or indirect, in the related person; or

(ii) Is related to the other person because:

35 (A) The other person has an ownership interest of at least twenty
36 percent, whether direct or indirect, in the related person; or

37 (B) A third person, or group of third persons who are affiliated 38 persons with respect to each other, holds an ownership interest of 39 more than twenty percent, whether direct or indirect, in the related 40 persons.

1 (b) "Indirect ownership interest" means an ownership interest in a person by virtue of an ownership interest in an entity that has an 2 3 ownership interest in the person or in an entity that has an indirect ownership in the person. 4 (c) "Ownership interest" means the possession of equity in the 5 6 capital, stock, or profits of the other person. 7 (d) (i) "Qualifying international investment management company" 8 means a person: (A) Who is primarily engaged in the business of providing 9 investment management services; and 10 11 (B) Who has gross income that is at least ten percent derived 12 from providing investment management services to: (I) Persons or collective investment funds residing outside the 13 14 United States; or (II) Collective investment funds with at least ten percent of 15 16 their investments located outside the United States. 17 (ii) The definitions in RCW 82.04.293 apply to this subsection 18 (4)((-(a))) (d). (((b))) (e)(i) "Standard financial information" means financial 19 data, facts, or information, or financial information services, not 20 21 generated, compiled, or developed only for a single customer. 22 Standard financial information includes, but is not limited to, financial market data, bond ratings, credit ratings, and deposit, 23 24 loan, or mortgage reports. 25 (ii) For purposes of this subsection (4)(((b))) <u>(e)</u>, "financial 26 market data" means market pricing information, such as for securities, commodities, and derivatives; corporate actions for 27 publicly and privately traded companies, such as dividend schedules 28 29 and reorganizations; corporate attributes, such as domicile, currencies used, and exchanges where shares are traded; and currency 30 31 information. 32 (5) This section expires July 1, ((2021)) <u>2031</u>. Sec. 4. RCW 82.12.207 and 2013 2nd sp.s. c 13 s 703 are each 33 amended to read as follows: 34 35 (1) The tax imposed by RCW 82.12.020 does not apply to the use of standard financial information by qualifying international investment 36 management companies or a person affiliated with a qualifying 37 38 international investment management company. The exemption provided in this section applies regardless of whether the standard financial 39

1 information is in a tangible format or resides on a tangible storage 2 medium or is a digital product transferred electronically to the 3 qualifying international investment management company.

4 (2) The definitions, conditions, and requirements in RCW 5 82.08.207 apply to this section.

6 (3) This section expires July 1, ((2021)) <u>2031</u>.
