1 AN ACT Relating to counting mailed ballots that are missing 2 postmarks; and reenacting and amending RCW 29A.40.110.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

 Sec. 1. RCW 29A.40.110 and 2011 c 349 s 18, 2011 c 348 s 4, and

 2011 c 10 s 41 are each reenacted and amended to read as follows:

6 (1) The opening and subsequent processing of return envelopes for 7 any primary or election may begin upon receipt. The tabulation of 8 absentee ballots must not commence until after 8:00 p.m. on the day 9 of the primary or election.

10 (2) All received return envelopes must be placed in secure 11 locations from the time of delivery to the county auditor until their 12 subsequent opening. After opening the return envelopes, the county 13 canvassing board shall place all of the ballots in secure storage 14 until processing. Ballots may be taken from the inner envelopes and 15 all the normal procedural steps may be performed to prepare these 16 ballots for tabulation.

17 (3) The canvassing board, or its designated representatives, 18 shall examine the postmark on the return envelope and signature on 19 the declaration before processing the ballot. The ballot must either 20 be received no later than 8:00 p.m. on the day of the primary or 21 election, or must be postmarked no later than the day of the primary

1 or election. All personnel assigned to verify signatures must receive training on statewide standards for signature verification. Personnel 2 shall verify that the voter's signature on the ballot declaration is 3 the same as the signature of that voter in the registration files of 4 the county. Verification may be conducted by an automated 5 6 verification system approved by the secretary of state. A variation between the signature of the voter on the ballot declaration and the 7 signature of that voter in the registration files due to the 8 substitution of initials or the use of common nicknames is permitted 9 so long as the surname and handwriting are clearly the same. 10

(4) If the postmark is ((missing or)) illegible, the date on the ballot declaration to which the voter has attested determines the validity, as to the time of voting, for that ballot.

(5) If the postmark is missing on a ballot that is received by 14 the county auditor after election day, the ballot may be counted only 15 16 if the voter signs a declaration attesting, under penalty of perjury, 17 that the ballot was mailed on or before election day. The county auditor must notify every such voter by first-class mail. If the 18 19 voter has not responded at least three business days before the final meeting of the canvassing board, then the auditor must attempt to 20 notify the voter by telephone, using the voter registration record 21 22 information.

<u>(6)</u> For overseas voters and service voters, the date on the declaration to which the voter has attested determines the validity, as to the time of voting, for that ballot. Any overseas voter or service voter may return the signed declaration and voted ballot by fax or email by 8:00 p.m. on the day of the primary or election, and the county auditor must use established procedures to maintain the secrecy of the ballot.
