SUBSTITUTE HOUSE BILL 1369

State of Washington 64th Legislature 2015 Regular Session

By House Health Care & Wellness (originally sponsored by Representatives Riccelli, Schmick, Robinson, Parker, Holy, Haler, Tharinger, Cody, and Ormsby)

AN ACT Relating to enabling student volunteers to provide health care services; amending RCW 18.57.040, 18.71.030, and 18.79.240; adding a new section to chapter 18.64 RCW; adding a new section to chapter 18.57 RCW; adding a new section to chapter 18.71 RCW; and adding a new section to chapter 18.79 RCW.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 <u>NEW SECTION.</u> Sec. 1. A new section is added to chapter 18.64 8 RCW to read as follows:

9 (1) This chapter does not prohibit a student from practicing 10 pharmacy if:

(a) The student is enrolled in a college or school of pharmacy accredited by the commission and is registered as a pharmacy intern under RCW 18.64.080;

(b) The student performs services without compensation or theexpectation of compensation as part of a volunteer activity;

16 (c) The student is under the direct supervision and control of a 17 pharmacist licensed under this chapter, a physician licensed under 18 chapter 18.71 RCW, an osteopathic physician and surgeon licensed 19 under chapter 18.57 RCW, or a registered nurse or advanced registered 20 nurse practitioner licensed under chapter 18.79 RCW; (d) The services the student performs are within the scope of
 practice of: (i) A pharmacist licensed under this chapter; and (ii)
 the person supervising the student;

4 (e) The student, supervisor, and organization for which the 5 student is volunteering enter into a written agreement defining the 6 time frame for the volunteer activity and the specific tasks the 7 student is permitted to perform; and

8 (f) The college or school in which the student is enrolled 9 verifies in writing that the student has demonstrated competency 10 through his or her education and training to perform the tasks 11 defined in the written agreement.

12 (2) The commission may adopt rules to implement the requirements13 of this section.

14 **Sec. 2.** RCW 18.57.040 and 1991 c 160 s 5 are each amended to 15 read as follows:

16 Nothing in this chapter shall be construed to prohibit:

17 (1) Service in the case of emergency;

18 (2) The domestic administration of family remedies;

19 (3) The practice of midwifery as permitted under chapter 18.50
20 RCW;

(4) The practice of osteopathic medicine and surgery by any commissioned medical officer in the United States government or military service or by any osteopathic physician and surgeon employed by a federal agency, in the discharge of his or her official duties;

(5) Practice by a dentist licensed under chapter 18.32 RCW when engaged exclusively in the practice of dentistry;

(6) Practice by any osteopathic physician and surgeon from any other state or territory in which he or she resides: PROVIDED, That such practitioner shall not open an office or appoint a place of meeting patients or receive calls within the limits of this state;

31 (7) Practice by a person who is a student enrolled in an 32 accredited school of osteopathic medicine and surgery approved by the 33 board((÷ PROVIDED, That)) if:

34 <u>(a) The performance of such services ((be)) is only pursuant to a</u> 35 course of instruction or assignments from his or her instructor or 36 school, and such services are performed only under the supervision of 37 a person licensed pursuant to this chapter or chapter 18.71 RCW; or

38 (b)(i) Such services are performed without compensation or 39 expectation of compensation as part of a volunteer activity; (ii) The student is under the direct supervision and control of a
 pharmacist licensed under chapter 18.64 RCW, a physician licensed
 under chapter 18.71 RCW, an osteopathic physician and surgeon
 licensed under chapter 18.57 RCW, or a registered nurse or advanced
 registered nurse practitioner licensed under chapter 18.79 RCW;

6 (iii) The services the student performs are within the scope of
7 practice of: (A) An osteopathic physician and surgeon licensed under
8 this chapter; and (B) the person supervising the student;

9 <u>(iv) The student, supervisor, and organization for which the</u> 10 <u>student is volunteering enter into a written agreement defining the</u> 11 <u>time frame for the volunteer activity and the specific tasks the</u> 12 <u>student is permitted to perform; and</u>

13 (v) The school in which the student is enrolled verifies in 14 writing that the student has demonstrated competency through his or 15 her education and training to perform the tasks defined in the 16 written agreement;

(8) Practice by an osteopathic physician and surgeon serving a period of clinical postgraduate medical training in a postgraduate program approved by the board: PROVIDED, That the performance of such services be only pursuant to a course of instruction in said program, and said services are performed only under the supervision and control of a person licensed pursuant to this chapter or chapter 18.71 RCW; or

(9) Practice by a person who is enrolled in a physician assistant program approved by the board who is performing such services only pursuant to a course of instruction in said program: PROVIDED, That such services are performed only under the supervision and control of a person licensed pursuant to this chapter or chapter 18.71 RCW.

This chapter shall not be construed to apply in any manner to any other system or method of treating the sick or afflicted or to apply to or interfere in any way with the practice of religion or any kind of treatment by prayer.

<u>NEW SECTION.</u> Sec. 3. A new section is added to chapter 18.57
 RCW to read as follows:

The board may adopt rules to implement the requirements of RCW 18.57.040(7).

37 **Sec. 4.** RCW 18.71.030 and 1996 c 178 s 4 are each amended to 38 read as follows:

1 Nothing in this chapter shall be construed to apply to or 2 interfere in any way with the practice of religion or any kind of 3 treatment by prayer; nor shall anything in this chapter be construed 4 to prohibit:

5 (1) The furnishing of medical assistance in cases of emergency
6 requiring immediate attention;

(2) The domestic administration of family remedies;

8 (3) The administration of oral medication of any nature to 9 students by public school district employees or private elementary or 10 secondary school employees as provided for in chapter 28A.210 RCW;

11 (4) The practice of dentistry, osteopathic medicine and surgery, 12 nursing, chiropractic, podiatric medicine and surgery, optometry, 13 naturopathy, or any other healing art licensed under the methods or 14 means permitted by such license;

28 (a) The performance of such services ((be)) is only pursuant to a 29 regular course of instruction or assignments from his or her 30 instructor $((\tau))$; or ((that))

31 <u>(b)</u> Such services are performed only under the supervision and 32 control of a person licensed pursuant to this chapter; or

33 (c)(i) Such services are performed without compensation or 34 <u>expectation of compensation as part of a volunteer activity;</u>

(9) The practice of medicine by a person who is regularly enrolled in a physician assistant program approved by the commission, however, the performance of such services shall be only pursuant to a regular course of instruction in said program and such services are performed only under the supervision and control of a person licensed pursuant to this chapter;

(10) The practice of medicine by a licensed physician assistant which practice is performed under the supervision and control of a physician licensed pursuant to this chapter;

(11) The practice of medicine, in any part of this state which shares a common border with Canada and which is surrounded on three sides by water, by a physician licensed to practice medicine and surgery in Canada or any province or territory thereof;

(12) The administration of nondental anesthesia by a dentist who 30 31 has completed a residency in anesthesiology at a school of medicine 32 approved by the commission, however, a dentist allowed to administer nondental anesthesia shall do so only under authorization of the 33 patient's attending surgeon, obstetrician, or psychiatrist, and the 34 commission has jurisdiction to discipline a dentist practicing under 35 this exemption and enjoin or suspend such dentist from the practice 36 of nondental anesthesia according to this chapter and chapter 18.130 37 38 RCW;

9 <u>(e)</u> Prohibiting auxiliary services provided by persons carrying 10 out duties necessary for the support of nursing services, including 11 those duties that involve minor nursing services for persons 12 performed in hospitals, nursing homes, or elsewhere under the 13 direction of licensed physicians or the supervision of licensed 14 registered nurses;

15 (((+e))) (f) Prohibiting the practice of nursing in this state by 16 a legally qualified nurse of another state or territory whose 17 engagement requires him or her to accompany and care for a patient 18 temporarily residing in this state during the period of one such 19 engagement, not to exceed six months in length, if the person does 20 not represent or hold himself or herself out as a registered nurse 21 licensed to practice in this state;

22 (((f))) (g) Prohibiting nursing or care of the sick, with or 23 without compensation, when done in connection with the practice of 24 the religious tenets of a church by adherents of the church so long 25 as they do not engage in the practice of nursing as defined in this 26 chapter;

27 (((g))) <u>(h)</u> Prohibiting the practice of a legally qualified nurse 28 of another state who is employed by the United States government or a 29 bureau, division, or agency thereof, while in the discharge of his or 30 her official duties;

31 (((h))) (i) Permitting the measurement of the powers or range of 32 human vision, or the determination of the accommodation and 33 refractive state of the human eye or the scope of its functions in 34 general, or the fitting or adaptation of lenses for the aid thereof;

35 (((i))) (j) Permitting the prescribing or directing the use of, 36 or using, an optical device in connection with ocular exercises, 37 visual training, vision training, or orthoptics;

38 ((((j))) <u>(k)</u> Permitting the prescribing of contact lenses for, or 39 the fitting and adaptation of contact lenses to, the human eye; 1 (((k))) (1) Prohibiting the performance of routine visual
2 screening;

3 (((+))) (m) Permitting the practice of dentistry or dental
4 hygiene as defined in chapters 18.32 and 18.29 RCW, respectively;

5 (((m))) <u>(n)</u> Permitting the practice of chiropractic as defined in 6 chapter 18.25 RCW including the adjustment or manipulation of the 7 articulation of the spine;

8 (((n))) (<u>o</u>) Permitting the practice of podiatric medicine and 9 surgery as defined in chapter 18.22 RCW;

10 ((((o)))) (<u>p</u>) Permitting the performance of major surgery, except 11 such minor surgery as the commission may have specifically authorized 12 by rule adopted in accordance with chapter 34.05 RCW;

13 (((p))) <u>(q)</u> Permitting the prescribing of controlled substances 14 as defined in Schedule I of the Uniform Controlled Substances Act, 15 chapter 69.50 RCW;

16 (((q))) <u>(r)</u> Prohibiting the determination and pronouncement of 17 death;

(a) Prohibiting the incidental care of the sick by domestic servants or persons primarily employed as housekeepers, so long as they do not practice practical nursing within the meaning of this chapter;

(b) Preventing a person from the domestic administration of family remedies or the furnishing of nursing assistance in case of emergency;

(c) Prohibiting the practice of practical nursing by students
 enrolled in approved schools as may be incidental to their course of
 study or prohibiting the students from working as nursing assistants;

(d) Prohibiting auxiliary services provided by persons carrying out duties necessary for the support of nursing services, including those duties that involve minor nursing services for persons performed in hospitals, nursing homes, or elsewhere under the direction of licensed physicians or the supervision of licensed registered nurses;

(e) Prohibiting or preventing the practice of nursing in this state by a legally qualified nurse of another state or territory whose engagement requires him or her to accompany and care for a patient temporarily residing in this state during the period of one such engagement, not to exceed six months in length, if the person does not represent or hold himself or herself out as a licensed practical nurse licensed to practice in this state;

36 (f) Prohibiting nursing or care of the sick, with or without 37 compensation, when done in connection with the practice of the 38 religious tenets of a church by adherents of the church so long as 39 they do not engage in licensed practical nurse practice as defined in 40 this chapter;

1 (g) Prohibiting the practice of a legally qualified nurse of 2 another state who is employed by the United States government or any 3 bureau, division, or agency thereof, while in the discharge of his or 4 her official duties.

5 <u>NEW SECTION.</u> Sec. 7. A new section is added to chapter 18.79 6 RCW to read as follows:

7 The commission may adopt rules to implement the requirements of 8 RCW 18.79.240(1)(d).
