- 9 (1) "Local telephone directory" means a publication listing 10 telephone numbers for various businesses in a certain geographic area 11 and distributed free of charge to some or all telephone subscribers

- 13 (2) "Local telephone number" means a ((telephone number that can 14 be dialed without incurring long distance charges from telephones
- 15 located within the area covered by the local telephone directory in
- 16 which the number is listed. The term does not include long distance
- 17 numbers, toll-free numbers, or 900 exchange numbers listed in a local
- 18 telephone directory)) specific telephone number, area code and
- 19 prefix, assigned for the purpose of completing local calls between a
- 20 <u>calling party or station and any other party or station within a</u>

- 11 (1) Listing a local telephone number in a local telephone 12 directory if:
- (a) Calls to the telephone number are routinely forwarded or otherwise transferred to a business location that is outside the calling area covered by the local telephone directory; and
- 16 (b) The listing fails to conspicuously disclose the locality and
 17 state in which the business is located; or
- 18 (2) Listing a business name in a local telephone directory if:
- 19 (a) The name misrepresents the business's geographic location;
 20 and
- 21 (b) The listing fails to disclose the locality and state in which
- 22 the business is located.)) (1) For purposes of this section, "floral
- 23 <u>or ornamental products or services" means floral arrangements, cut</u>
- 24 <u>flowers, floral bouquets, potted plants, balloons, floral designs,</u>
- 25 and related products and services.
- 26 (2) It is a violation for a provider or vendor of floral or
- 27 <u>ornamental products or services to misrepresent the geographic</u>
- 28 <u>location of its business by doing either of the following:</u>
- 29 <u>(a) Listing a local telephone number in any advertisement or</u>
- 30 <u>listing</u>, <u>unless the advertisement or listing identifies the true</u>
- 31 physical address, including the city, of the provider's or vendor's
- 32 <u>business; or</u>
- 33 <u>(b) Listing a fictitious business name or an assumed business</u>
- 34 name in any advertisement or listing if both of the following
- 35 <u>criteria are met:</u>
- 36 (i) The name of the business misrepresents the provider's or
- yendor's geographic location; and

- 1 <u>(ii) The advertisement or listing does not identify the true</u> 2 <u>physical address, including the city and state, of the provider's or</u> 3 vendor's business.
 - (3) A violation of this section is punishable, exclusively, by a fine not to exceed two hundred fifty dollars.
- 6 (4) This section does not create or impose any duty or obligation
 7 on a person other than a vendor or provider of floral or ornamental
 8 products or services.
 - (5) This section does not apply to any of the following:
- 10 <u>(a) A publisher of a telephone directory or other publication or</u>
 11 <u>a provider of a directory assistance service publishing or providing</u>
 12 information about another business.
- 13 <u>(b) An internet web site that aggregates and provides information</u> 14 <u>about other businesses.</u>
- 15 <u>(c) An owner or publisher of a print advertising medium providing</u> 16 information about other businesses.
- 17 <u>(d) An internet service provider.</u>
