**SUBSTITUTE HOUSE BILL 1610**

1 AN ACT Relating to compensation for lost or damaged commercial  
2 and treaty fishing gear; adding a new chapter to Title 77 RCW; and  
3 providing an expiration date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** The definitions in this section apply  
6 throughout this chapter unless the context clearly requires  
7 otherwise.

8 (1) "Account" means the commercial and treaty fisher's gear  
9 compensation account created in section 2 of this act.

10 (2) "Claim" means an application to the department for  
11 compensation under this chapter.

12 (3) "Commercial fisher" means any person who holds a current  
13 commercial fishing license from the department.

14 (4) "Compensation" means a cash payment, materials, or service.

15 (5) "Fishing gear" means any equipment, whether or not attached  
16 to a vessel, that is used in the handling or harvesting of fish and  
17 shellfish.

18 (6) "Treaty fisher" means any person who is a member of a  
19 federally recognized Indian tribe and who harvests fish or shellfish  
20 in Washington pursuant to an Indian treaty.

1        NEW SECTION.    **Sec. 2.**    The commercial and treaty fisher's gear  
2 compensation account is created in the custody of the state  
3 treasurer. In addition to moneys appropriated or transferred into the  
4 account, the department may deposit into the account any grants,  
5 gifts, or donations to the state for the purposes of section 3 of  
6 this act. Expenditures from the account may be used only for  
7 providing compensation to commercial and treaty fishers for lost or  
8 damaged fishing gear, as provided in section 3 of this act. Only the  
9 director of the department of fish and wildlife or the director's  
10 designee may authorize expenditures from the account. The account is  
11 subject to allotment procedures under chapter 43.88 RCW, but an  
12 appropriation is not required for expenditures.

13        NEW SECTION.    **Sec. 3.**    (1) The commission shall adopt rules to  
14 establish a commercial and treaty fisher's gear compensation program  
15 for commercial and treaty fishers whose fishing gear has been lost or  
16 damaged as a result of contact with other vessels in the marine  
17 waters of the state east of a line extending due north from the  
18 northernmost point of Tatoosh Island.

19        (2) Rules adopted by the commission pursuant to this section are  
20 subject to the following requirements:

21        (a) Compensation from the account is not available for loss of or  
22 damage to fishing gear that, at the time of loss or damage, was  
23 located within a shipping channel or other established routes for  
24 vessels such as Washington state ferries, tugs, commercial vessels,  
25 or log booms, a general anchorage area, or a precautionary area, as  
26 established on a navigational chart published by the national oceanic  
27 and atmospheric administration;

28        (b) In order to be eligible for compensation from the account,  
29 the commercial or treaty fisher must be a Washington resident, must  
30 have a claim of at least two hundred seventy-five dollars, and must  
31 be an enrolled participant in the crab gear damage and loss pilot  
32 program created in section 4 of this act;

33        (c) Compensation from the account to a commercial or treaty  
34 fisher is limited to the actual purchase cost of the fishing gear for  
35 lost fishing gear, or the actual repair cost of the fishing gear for  
36 damaged fishing gear. The actual purchase cost or actual repair cost  
37 must be established by receipts, estimates of costs of repair, or  
38 sworn affidavit;

1 (d) In order to be eligible for compensation from the account,  
2 the commercial or treaty fisher must provide the following  
3 information:

4 (i) Complete copies of all relevant licenses;

5 (ii) Complete copies of all vessel registration information;

6 (iii) Location, via latitude and longitude coordinates obtained  
7 from a global positioning system device affixed to the fishing gear  
8 or via a chart marked with the location of the incident, of the  
9 fishing gear at the time of loss or damage;

10 (iv) A complete description of all lost or damaged fishing gear,  
11 including photographs of damaged gear if available;

12 (v) To the extent known, a complete description of the incident  
13 giving rise to the loss or damage, including the name and other  
14 identifying information of the vessel that caused the loss or damage;

15 (vi) Receipts, estimates of costs of repair, or sworn affidavits  
16 establishing the actual purchase cost or actual repair cost of lost  
17 or damaged fishing gear;

18 (e) Claims for compensation from the account must be filed with  
19 the department no later than thirty days after the date that the  
20 commercial or treaty fisher first became aware of the loss or damage;

21 (f) The department shall acknowledge receipt of a claim for loss  
22 or damage within fifteen days of receiving the claim;

23 (g) Compensation from the account is not available for loss of or  
24 damage to fishing gear that is covered by a policy of insurance.

25 (3) In administering the commercial and treaty fisher's gear  
26 compensation program, the department shall pay eligible claims at the  
27 conclusion of the calendar year on a proportional basis, according to  
28 available funds.

29 (4) A commercial or treaty fisher who files a claim under this  
30 section may appeal the decision of the department pursuant to rules  
31 adopted by the commission if the claim:

32 (a) Is denied; or

33 (b) Is disputed by the commercial or treaty fisher and the  
34 commercial or treaty fisher disagrees with the amount of compensation  
35 determined by the department.

36 NEW SECTION. **Sec. 4.** (1) The department of fish and wildlife,  
37 in consultation with the department of commerce and the department of  
38 natural resources, is directed to conduct a study of crab fishing  
39 gear belonging to commercial and treaty fishers that has been lost or

1 damaged as a result of contact with other vessels in the marine  
2 waters of the state east of a line extending due north from the  
3 northernmost point of Tatoosh Island.

4 (2) The elements to be studied include, but are not limited to,  
5 the following:

6 (a) The types and value of crab fishing gear lost or damaged as a  
7 result of contact with other vessels;

8 (b) The frequency of crab fishing gear loss and damage as a  
9 result of contact with other vessels;

10 (c) The dates, times, and locations of crab fishing gear loss and  
11 damage; and

12 (d) The vessels, and types of vessels, contributing to crab  
13 fishing gear loss and damage.

14 (3) The department shall, as part of the study, establish a pilot  
15 program in which the department coordinates with willing fishers to  
16 track potential crab fishing gear damage and loss using global  
17 positioning system technology. In establishing the geographic scope  
18 of the pilot project, the department should select locations that are  
19 most likely to provide a comprehensive understanding of the issue of  
20 crab fishing gear loss and damage. As part of the pilot program, and  
21 subject to the availability of amounts appropriated for this specific  
22 purpose, the department may furnish wireless transponders to be  
23 placed on crab fishing gear in order to assist in the collection of  
24 data related to potential loss and damage.

25 (4) A report that includes the department's findings, as well as  
26 the department's recommendations for actions to reduce crab fishing  
27 gear loss and damage, must be completed by October 31, 2021, and  
28 submitted in accordance with RCW 43.01.036 to the standing committees  
29 of the house of representatives and the senate with jurisdiction over  
30 fisheries, water quality, and aquatic lands.

31 (5) This section expires December 31, 2021.

32 NEW SECTION. **Sec. 5.** Sections 1 through 4 of this act  
33 constitute a new chapter in Title 77 RCW.
