State of Washington 67th Legislature 2022 Regular Session

By Representatives Chase, McCaslin, Klippert, Eslick, and Chambers Prefiled 12/23/21.

- AN ACT Relating to recognizing the first day of May as home
- 2 school day; amending RCW 1.16.050; and creating a new section.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- NEW SECTION. Sec. 1. The legislature finds that home schooling serves as an excellent option for both parents and students allowing for uniquely tailored education, superior educational outcomes, and a pathway to opportunity for our future generations especially for Washingtonians from historically marginalized communities.
- 9 The legislature intends to establish home school day to celebrate 10 and raise awareness around the educational, social, and family 11 benefits that home schooling has provided for hundreds of thousands 12 of Washingtonians.
 - Amid the COVID-19 pandemic and much educational uncertainty for Washington students, tens of thousands of Washington families chose to temporarily or permanently use home schooling in order to ensure their children's safety and provide them with high quality education.
- Washingtonians from all backgrounds have been well-served through home schooling options. It is therefore the intent of the legislature to recognize and celebrate home schooling by designating the first day of May as home school day.

 - (h) The first Monday in September, to be known as Labor Day;
 - (i) The eleventh day of November, to be known as Veterans' Day;

- 25 (2) Employees of the state and its political subdivisions, except 26 employees of school districts and except those nonclassified employees of institutions of higher education who hold appointments 27 or are employed under contracts to perform services for periods of 28 less than twelve consecutive months, are entitled to one paid holiday 29 per calendar year in addition to those specified in this section. 30 Each employee of the state or its political subdivisions may select 31 32 the day on which the employee desires to take the additional holiday provided for in this section after consultation with the employer 33 pursuant to guidelines to be promulgated by rule of the appropriate 34 personnel authority, or in the case of local government by ordinance 35 36 or resolution of the legislative authority.
 - (3) Employees of the state and its political subdivisions, including employees of school districts and those nonclassified employees of institutions of higher education who hold appointments or are employed under contracts to perform services for periods of

1 less than twelve consecutive months, are entitled to two unpaid holidays per calendar year for a reason of faith or conscience or an 2 organized activity conducted under the auspices of a religious 3 denomination, church, or religious organization. This includes 4 employees of public institutions of higher education, including 5 6 community colleges, technical colleges, and workforce training 7 programs. The employee may select the days on which the employee desires to take the two unpaid holidays after consultation with the 8 employer pursuant to guidelines to be promulgated by rule of the 9 appropriate personnel authority, or in the case of local government 10 by ordinance or resolution of the legislative authority. 11 12 employee prefers to take the two unpaid holidays on specific days for a reason of faith or conscience, or an organized activity conducted 13 under the auspices of a religious denomination, church, or religious 14 organization, the employer must allow the employee to do so unless 15 16 the employee's absence would impose an undue hardship on the employer 17 employee is necessary to maintain public safety. Undue hardship shall have the meaning established in rule by the office of 18 19 financial management under RCW 43.41.109.

- (4) If any of the state legal holidays specified in this section are also federal legal holidays but observed on different dates, only the state legal holidays are recognized as a paid legal holiday for employees of the state and its political subdivisions. However, for port districts and the law enforcement and public transit employees of municipal corporations, either the federal or the state legal holiday is recognized as a paid legal holiday, but in no case may both holidays be recognized as a paid legal holiday for employees.

 - (6) Nothing in this section may be construed to have the effect of adding or deleting the number of paid holidays provided for in an agreement between employees and employers of political subdivisions of the state or as established by ordinance or resolution of the local government legislative authority.
