The purpose of the core competencies is to serve as a foundation for what early care and education professionals ((and child and youth development professionals)) who are voluntary participants in the quality rating and improvement system need to know and do to provide quality care for children. The core competencies must be reviewed and updated every five years. The department may not apply the core competencies to licensing standards.
