
SUBSTITUTE HOUSE BILL 1813

State of Washington 61st Legislature 2009 Regular Session

By House Education (originally sponsored by Representatives Hunt, Probst, Priest, Sullivan, Liias, Quall, Carlyle, Kelley, Santos, and Ormsby)

1 AN ACT Relating to a statewide effort to establish and meet
2 graduation and reengagement goals; amending RCW 28A.305.130,
3 28A.175.075, 28C.18.060, 28B.50.090, 43.330.050, and 70.190.100; adding
4 new sections to chapter 28A.175 RCW; adding a new section to chapter
5 50.08 RCW; adding a new section to chapter 43.70 RCW; and adding a new
6 section to chapter 43.20A RCW.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

8 NEW SECTION. **Sec. 1.** A new section is added to chapter 28A.175
9 RCW to read as follows:

10 (1) It is the goal of the state that by 2020, ninety-five percent
11 of students must graduate from high school in four years.

12 (2) It is the goal of the state that by 2020, sixty percent of
13 youth who have dropped out of school must be reengaged in education and
14 be college and work ready.

15 **Sec. 2.** RCW 28A.305.130 and 2008 c 27 s 1 are each amended to read
16 as follows:

17 The purpose of the state board of education is to provide advocacy
18 and strategic oversight of public education; implement a standards-

1 based accountability system to improve student academic achievement;
2 provide leadership in the creation of a system that personalizes
3 education for each student and respects diverse cultures, abilities,
4 and learning styles; and promote achievement of the goals of RCW
5 28A.150.210. In addition to any other powers and duties as provided by
6 law, the state board of education shall:

7 (1) Hold regularly scheduled meetings at such time and place within
8 the state as the board shall determine and may hold such special
9 meetings as may be deemed necessary for the transaction of public
10 business;

11 (2) Form committees as necessary to effectively and efficiently
12 conduct the work of the board;

13 (3) Seek advice from the public and interested parties regarding
14 the work of the board;

15 (4) For purposes of statewide accountability:

16 (a) Adopt and revise performance improvement goals in reading,
17 writing, science, and mathematics, by subject and grade level, once
18 assessments in these subjects are required statewide; academic and
19 technical skills, as appropriate, in secondary career and technical
20 education programs; and student attendance, as the board deems
21 appropriate to improve student learning. The goals shall be consistent
22 with student privacy protection provisions of RCW 28A.655.090(7) and
23 shall not conflict with requirements contained in Title I of the
24 federal elementary and secondary education act of 1965, or the
25 requirements of the Carl D. Perkins vocational education act of 1998,
26 each as amended. The goals may be established for all students,
27 economically disadvantaged students, limited English proficient
28 students, students with disabilities, and students from
29 disproportionately academically underachieving racial and ethnic
30 backgrounds. The board (~~(may establish school and school district
31 goals addressing high school graduation rates and dropout reduction
32 goals for students in grades seven through twelve)~~) shall establish
33 annual graduation rate targets for schools and school districts in
34 order to meet the graduation rate goal under section 1 of this act.
35 The targets shall reflect continuous and substantial improvement from
36 the prior year and shall ensure adequate progress is made for low-
37 income and minority students. The board shall establish annual targets
38 for youth who have dropped out of school in order to meet the

1 reengagement goal under section 1 of this act. The board shall adopt
2 the goals by rule. However, before each goal is implemented, the board
3 shall present the goal to the education committees of the house of
4 representatives and the senate for the committees' review and comment
5 in a time frame that will permit the legislature to take statutory
6 action on the goal if such action is deemed warranted by the
7 legislature;

8 (b) By December 1, 2009, the board shall, in consultation with the
9 office of the superintendent of public instruction and the building
10 bridges advisory committee established in RCW 28A.175.075, make
11 recommendations to the legislature on a focused assistance program and
12 incentives for school districts to improve their high school graduation
13 rate;

14 (c) Identify the scores students must achieve in order to meet the
15 standard on the Washington assessment of student learning and, for high
16 school students, to obtain a certificate of academic achievement. The
17 board shall also determine student scores that identify levels of
18 student performance below and beyond the standard. The board shall
19 consider the incorporation of the standard error of measurement into
20 the decision regarding the award of the certificates. The board shall
21 set such performance standards and levels in consultation with the
22 superintendent of public instruction and after consideration of any
23 recommendations that may be developed by any advisory committees that
24 may be established for this purpose. The initial performance standards
25 and any changes recommended by the board in the performance standards
26 for the tenth grade assessment shall be presented to the education
27 committees of the house of representatives and the senate by November
28 30th of the school year in which the changes will take place to permit
29 the legislature to take statutory action before the changes are
30 implemented if such action is deemed warranted by the legislature. The
31 legislature shall be advised of the initial performance standards and
32 any changes made to the elementary level performance standards and the
33 middle school level performance standards;

34 ((+e)) (d) Adopt objective, systematic criteria to identify
35 successful schools and school districts and recommend to the
36 superintendent of public instruction schools and districts to be
37 recognized for two types of accomplishments, student achievement and

1 improvements in student achievement. Recognition for improvements in
2 student achievement shall include consideration of one or more of the
3 following accomplishments:

4 (i) An increase in the percent of students meeting standards. The
5 level of achievement required for recognition may be based on the
6 achievement goals established by the legislature and by the board under
7 (a) of this subsection;

8 (ii) Positive progress on an improvement index that measures
9 improvement in all levels of the assessment; and

10 (iii) Improvements despite challenges such as high levels of
11 mobility, poverty, English as a second language learners, and large
12 numbers of students in special populations as measured by either the
13 percent of students meeting the standard, or the improvement index.
14 When determining the baseline year or years for recognizing individual
15 schools, the board may use the assessment results from the initial
16 years the assessments were administered, if doing so with individual
17 schools would be appropriate;

18 ~~((d))~~ (e) Adopt objective, systematic criteria to identify
19 schools and school districts in need of assistance and those in which
20 significant numbers of students persistently fail to meet state
21 standards. In its deliberations, the board shall consider the use of
22 all statewide mandated criterion-referenced and norm-referenced
23 standardized tests;

24 ~~((e))~~ (f) Identify schools and school districts in which state
25 intervention measures will be needed and a range of appropriate
26 intervention strategies after the legislature has authorized a set of
27 intervention strategies. After the legislature has authorized a set of
28 intervention strategies, at the request of the board, the
29 superintendent shall intervene in the school or school district and
30 take corrective actions. This chapter does not provide additional
31 authority for the board or the superintendent of public instruction to
32 intervene in a school or school district;

33 ~~((f))~~ (g) Identify performance incentive systems that have
34 improved or have the potential to improve student achievement;

35 ~~((g))~~ (h) Annually review the assessment reporting system to
36 ensure fairness, accuracy, timeliness, and equity of opportunity,
37 especially with regard to schools with special circumstances and unique

1 populations of students, and a recommendation to the superintendent of
2 public instruction of any improvements needed to the system; and

3 ((+h+)) (i) Include in the biennial report required under RCW
4 28A.305.035, information on the progress that has been made in
5 achieving goals adopted by the board;

6 (5) Accredite, subject to such accreditation standards and
7 procedures as may be established by the state board of education, all
8 private schools that apply for accreditation, and approve, subject to
9 the provisions of RCW 28A.195.010, private schools carrying out a
10 program for any or all of the grades kindergarten through twelve:
11 PROVIDED, That no private school may be approved that operates a
12 kindergarten program only: PROVIDED FURTHER, That no private schools
13 shall be placed upon the list of accredited schools so long as secret
14 societies are knowingly allowed to exist among its students by school
15 officials;

16 (6) Articulate with the institutions of higher education, workforce
17 representatives, and early learning policymakers and providers to
18 coordinate and unify the work of the public school system;

19 (7) Hire an executive director and an administrative assistant to
20 reside in the office of the superintendent of public instruction for
21 administrative purposes. Any other personnel of the board shall be
22 appointed as provided by RCW 28A.300.020. The board may delegate to
23 the executive director by resolution such duties as deemed necessary to
24 efficiently carry on the business of the board including, but not
25 limited to, the authority to employ necessary personnel and the
26 authority to enter into, amend, and terminate contracts on behalf of
27 the board. The executive director, administrative assistant, and all
28 but one of the other personnel of the board are exempt from civil
29 service, together with other staff as now or hereafter designated as
30 exempt in accordance with chapter 41.06 RCW; and

31 (8) Adopt a seal that shall be kept in the office of the
32 superintendent of public instruction.

33 **Sec. 3.** RCW 28A.175.075 and 2007 c 408 s 7 are each amended to
34 read as follows:

35 (1)(a) The office of the superintendent of public instruction shall
36 establish a state-level ((work-group)) building bridges advisory
37 committee that includes K-12 and state agencies that work with youth

1 who have dropped out or are at risk of dropping out of school. The
2 director of each of the following entities shall appoint a
3 representative to the building bridges advisory committee:

4 (i) The office of the superintendent of public instruction;

5 (ii) The workforce training and education coordinating board;

6 (iii) The state board for community and technical colleges;

7 (iv) The employment security department;

8 (v) The department of community, trade, and economic development;

9 (vi) The department of health;

10 (vii) The department of social and health services, in particular
11 the following divisions: Children's administration, health and
12 recovery services administration, division of alcohol and substance
13 abuse, mental health division, juvenile rehabilitation administration,
14 and office of juvenile justice;

15 (viii) The family policy council; and

16 (ix) The governor's committee on disability issues and employment.

17 (b) The state-level ((~~leadership group~~)) advisory committee shall

18 also consist of one representative from each of the following

19 ((~~agencies and organizations:—The workforce training and education~~

20 coordinating board; ~~career and technical education including~~)): Skill

21 centers; ((~~relevant divisions of the department of social and health~~

22 ~~services~~)) the juvenile courts; the Washington association of

23 prosecuting attorneys; the Washington state office of public defense;

24 ((~~the employment security department; accredited institutions of higher~~

25 education; ~~the~~)) educational service districts; ((~~the~~)) area workforce

26 development councils; parent and educator associations; ((~~the~~

27 ~~department of health~~)) local school districts; agencies or

28 organizations that provide services to special education students;

29 community organizations serving youth; federally recognized tribes and

30 urban tribal centers; each of the major political caucuses of the

31 senate and house of representatives; and the minority commissions.

32 (2) To assist and enhance the work of the building bridges programs

33 established in RCW ((~~28A.175.055~~)) 28A.175.025, the state-level ((~~work~~

34 group)) advisory committee shall:

35 (a) Identify and make recommendations to the legislature for the

36 reduction of fiscal, legal, and regulatory barriers that prevent

37 coordination of program resources across agencies at the state and

38 local level, including recommendations on flexible funding, common

1 program eligibility criteria, common objectives and strategies,
2 alignment of critical program resources, common assessment criteria or
3 tools, and connections between education and social service programs at
4 the local level;

5 (b) Develop and track performance measures and benchmarks for each
6 partner agency or organization across the state including performance
7 measures and benchmarks based on student characteristics and outcomes
8 specified in RCW 28A.175.035(1)(e); and

9 (c) Identify research-based and emerging best practices regarding
10 prevention, intervention, and retrieval programs.

11 (3) The ((~~work group~~)) advisory committee shall report to the
12 legislature and the governor on an annual basis beginning December 1,
13 2007, with recommendations for implementing emerging best practices,
14 needed additional resources, and eliminating barriers.

15 NEW SECTION. Sec. 4. A new section is added to chapter 28A.175
16 RCW to read as follows:

17 (1) Entities with appointed representatives on the building bridges
18 advisory committee under RCW 28A.175.075 shall, within existing
19 resources:

20 (a) Develop programmatic objectives and measures to help meet the
21 state dropout goals under section 1 of this act; and

22 (b) Explore opportunities for collaborative action to help reduce
23 the dropout problem in the state including, but not limited to:
24 Developing protocols and templates for model agreements on sharing
25 records and data to improve outcomes for at-risk youth; and providing
26 professional development that informs staff about the latest research
27 in working with at-risk youth and provides knowledge about programs and
28 services for such youth.

29 (2) The workforce training and education coordinating board shall
30 provide advice to the building bridges advisory committee on how best
31 to reengage older youth who have dropped out of school and help them
32 become college and work ready.

33 **Sec. 5.** RCW 28C.18.060 and 2008 c 212 s 2 are each amended to read
34 as follows:

35 The board, in cooperation with the operating agencies of the state
36 training system and private career schools and colleges, shall:

1 (1) Concentrate its major efforts on planning, coordination
2 evaluation, policy analysis, and recommending improvements to the
3 state's training system;

4 (2) Advocate for the state training system and for meeting the
5 needs of employers and the workforce for workforce education and
6 training;

7 (3) Establish and maintain an inventory of the programs of the
8 state training system, and related state programs, and perform a
9 biennial assessment of the vocational education, training, and adult
10 basic education and literacy needs of the state; identify ongoing and
11 strategic education needs; and assess the extent to which employment,
12 training, vocational and basic education, rehabilitation services, and
13 public assistance services represent a consistent, integrated approach
14 to meet such needs;

15 (4) Develop and maintain a state comprehensive plan for workforce
16 training and education, including but not limited to, goals,
17 objectives, and priorities for the state training system, and review
18 the state training system for consistency with the state comprehensive
19 plan. In developing the state comprehensive plan for workforce
20 training and education, the board shall use, but shall not be limited
21 to: Economic, labor market, and populations trends reports in office
22 of financial management forecasts; joint office of financial management
23 and employment security department labor force, industry employment,
24 and occupational forecasts; the results of scientifically based
25 outcome, net-impact and cost-benefit evaluations; the needs of
26 employers as evidenced in formal employer surveys and other employer
27 input; and the needs of program participants and workers as evidenced
28 in formal surveys and other input from program participants and the
29 labor community;

30 (5) In consultation with the higher education coordinating board,
31 review and make recommendations to the office of financial management
32 and the legislature on operating and capital facilities budget requests
33 for operating agencies of the state training system for purposes of
34 consistency with the state comprehensive plan for workforce training
35 and education;

36 (6) Provide for coordination among the different operating agencies
37 and components of the state training system at the state level and at
38 the regional level;

1 (7) Develop a consistent and reliable database on vocational
2 education enrollments, costs, program activities, and job placements
3 from publicly funded vocational education programs in this state;

4 (8)(a) Establish standards for data collection and maintenance for
5 the operating agencies of the state training system in a format that is
6 accessible to use by the board. The board shall require a minimum of
7 common core data to be collected by each operating agency of the state
8 training system;

9 (b) Develop requirements for minimum common core data in
10 consultation with the office of financial management and the operating
11 agencies of the training system;

12 (9) Establish minimum standards for program evaluation for the
13 operating agencies of the state training system, including, but not
14 limited to, the use of common survey instruments and procedures for
15 measuring perceptions of program participants and employers of program
16 participants, and monitor such program evaluation;

17 (10) Every two years administer scientifically based outcome
18 evaluations of the state training system, including, but not limited
19 to, surveys of program participants, surveys of employers of program
20 participants, and matches with employment security department payroll
21 and wage files. Every five years administer scientifically based net-
22 impact and cost-benefit evaluations of the state training system;

23 (11) In cooperation with the employment security department,
24 provide for the improvement and maintenance of quality and utility in
25 occupational information and forecasts for use in training system
26 planning and evaluation. Improvements shall include, but not be
27 limited to, development of state-based occupational change factors
28 involving input by employers and employees, and delineation of skill
29 and training requirements by education level associated with current
30 and forecasted occupations;

31 (12) Provide for the development of common course description
32 formats, common reporting requirements, and common definitions for
33 operating agencies of the training system;

34 (13) Provide for effectiveness and efficiency reviews of the state
35 training system;

36 (14) In cooperation with the higher education coordinating board,
37 facilitate transfer of credit policies and agreements between

1 institutions of the state training system, and encourage articulation
2 agreements for programs encompassing two years of secondary workforce
3 education and two years of postsecondary workforce education;

4 (15) In cooperation with the higher education coordinating board,
5 facilitate transfer of credit policies and agreements between private
6 training institutions and institutions of the state training system;

7 (16) Develop policy objectives for the workforce investment act,
8 P.L. 105-220, or its successor; develop coordination criteria for
9 activities under the act with related programs and services provided by
10 state and local education and training agencies; and ensure that
11 entrepreneurial training opportunities are available through programs
12 of each local workforce investment board in the state;

13 (17) Make recommendations to the commission of student assessment,
14 the state board of education, and the superintendent of public
15 instruction, concerning basic skill competencies and essential core
16 competencies for K-12 education. Basic skills for this purpose shall
17 be reading, writing, computation, speaking, and critical thinking,
18 essential core competencies for this purpose shall be English, math,
19 science/technology, history, geography, and critical thinking. The
20 board shall monitor the development of and provide advice concerning
21 secondary curriculum which integrates vocational and academic
22 education;

23 (18) Collaborate with other state agencies and organizations to
24 meet state graduation rate goals and help reduce the dropout rate, in
25 accordance with sections 1 and 4 of this act;

26 (19) Establish and administer programs for marketing and outreach
27 to businesses and potential program participants;

28 ((+19)) (20) Facilitate the location of support services,
29 including but not limited to, child care, financial aid, career
30 counseling, and job placement services, for students and trainees at
31 institutions in the state training system, and advocate for support
32 services for trainees and students in the state training system;

33 ((+20)) (21) Facilitate private sector assistance for the state
34 training system, including but not limited to: Financial assistance,
35 rotation of private and public personnel, and vocational counseling;

36 ((+21)) (22) Facilitate the development of programs for school-to-
37 work transition that combine classroom education and on-the-job

1 training, including entrepreneurial education and training, in
2 industries and occupations without a significant number of
3 apprenticeship programs;

4 ~~((+22+))~~ (23) Include in the planning requirements for local
5 workforce investment boards a requirement that the local workforce
6 investment boards specify how entrepreneurial training is to be offered
7 through the one-stop system required under the workforce investment
8 act, P.L. 105-220, or its successor;

9 ~~((+23+))~~ (24) Encourage and assess progress for the equitable
10 representation of racial and ethnic minorities, women, and people with
11 disabilities among the students, teachers, and administrators of the
12 state training system. Equitable, for this purpose, shall mean
13 substantially proportional to their percentage of the state population
14 in the geographic area served. This function of the board shall in no
15 way lessen more stringent state or federal requirements for
16 representation of racial and ethnic minorities, women, and people with
17 disabilities;

18 ~~((+24+))~~ (25) Participate in the planning and policy development of
19 governor set-aside grants under P.L. 97-300, as amended;

20 ~~((+25+))~~ (26) Administer veterans' programs, licensure of private
21 vocational schools, the job skills program, and the Washington award
22 for vocational excellence;

23 ~~((+26+))~~ (27) Allocate funding from the state job training trust
24 fund;

25 ~~((+27+))~~ (28) Work with the director of community, trade, and
26 economic development to ensure coordination between workforce training
27 priorities and that department's economic development and
28 entrepreneurial development efforts;

29 ~~((+28+))~~ (29) Conduct research into workforce development programs
30 designed to reduce the high unemployment rate among young people
31 between approximately eighteen and twenty-four years of age. In
32 consultation with the operating agencies, the board shall advise the
33 governor and legislature on policies and programs to alleviate the high
34 unemployment rate among young people. The research shall include
35 disaggregated demographic information and, to the extent possible,
36 income data for adult youth. The research shall also include a
37 comparison of the effectiveness of programs examined as a part of the
38 research conducted in this subsection in relation to the public

1 investment made in these programs in reducing unemployment of young
2 adults. The board shall report to the appropriate committees of the
3 legislature by November 15, 2008, and every two years thereafter.
4 Where possible, the data reported to the legislative committees should
5 be reported in numbers and in percentages;

6 ~~((+29))~~ (30) Adopt rules as necessary to implement this chapter.
7 The board may delegate to the director any of the functions of this
8 section.

9 **Sec. 6.** RCW 28B.50.090 and 2004 c 275 s 57 are each amended to
10 read as follows:

11 The college board shall have general supervision and control over
12 the state system of community and technical colleges. In addition to
13 the other powers and duties imposed upon the college board by this
14 chapter, the college board shall be charged with the following powers,
15 duties and responsibilities:

16 (1) Review the budgets prepared by the boards of trustees, prepare
17 a single budget for the support of the state system of community and
18 technical colleges and adult education, and submit this budget to the
19 governor as provided in RCW 43.88.090;

20 (2) Establish guidelines for the disbursement of funds; and receive
21 and disburse such funds for adult education and maintenance and
22 operation and capital support of the college districts in conformance
23 with the state and district budgets, and in conformance with chapter
24 43.88 RCW;

25 (3) Ensure, through the full use of its authority:

26 (a) That each college district shall offer thoroughly comprehensive
27 educational, training and service programs to meet the needs of both
28 the communities and students served by combining high standards of
29 excellence in academic transfer courses; realistic and practical
30 courses in occupational education, both graded and ungraded; and
31 community services of an educational, cultural, and recreational
32 nature; and adult education, including basic skills and general,
33 family, and workforce literacy programs and services. However,
34 technical colleges, and college districts containing only technical
35 colleges, shall maintain programs solely for occupational education,
36 basic skills, and literacy purposes. For as long as a need exists,

1 technical colleges may continue those programs, activities, and
2 services they offered during the twelve-month period preceding May 17,
3 1991;

4 (b) That each college district shall maintain an open-door policy,
5 to the end that no student will be denied admission because of the
6 location of the student's residence or because of the student's
7 educational background or ability; that, insofar as is practical in the
8 judgment of the college board, curriculum offerings will be provided to
9 meet the educational and training needs of the community generally and
10 the students thereof; and that all students, regardless of their
11 differing courses of study, will be considered, known and recognized
12 equally as members of the student body: PROVIDED, That the
13 administrative officers of a community or technical college may deny
14 admission to a prospective student or attendance to an enrolled student
15 if, in their judgment, the student would not be competent to profit
16 from the curriculum offerings of the college, or would, by his or her
17 presence or conduct, create a disruptive atmosphere within the college
18 not consistent with the purposes of the institution. This subsection
19 (3)(b) shall not apply to competency, conduct, or presence associated
20 with a disability in a person twenty-one years of age or younger
21 attending a technical college;

22 (4) Prepare a comprehensive master plan for the development of
23 community and technical college education and training in the state;
24 and assist the office of financial management in the preparation of
25 enrollment projections to support plans for providing adequate college
26 facilities in all areas of the state. The master plan shall include
27 implementation of the vision, goals, priorities, and strategies in the
28 statewide strategic master plan for higher education under RCW
29 28B.76.200 based on the community and technical college system's role
30 and mission. The master plan shall also contain measurable performance
31 indicators and benchmarks for gauging progress toward achieving the
32 goals and priorities;

33 (5) Define and administer criteria and guidelines for the
34 establishment of new community and technical colleges or campuses
35 within the existing districts;

36 (6) Establish criteria and procedures for modifying district
37 boundary lines consistent with the purposes set forth in RCW 28B.50.020

1 as now or hereafter amended and in accordance therewith make such
2 changes as it deems advisable;

3 (7) Establish minimum standards to govern the operation of the
4 community and technical colleges with respect to:

5 (a) Qualifications and credentials of instructional and key
6 administrative personnel, except as otherwise provided in the state
7 plan for vocational education,

8 (b) Internal budgeting, accounting, auditing, and financial
9 procedures as necessary to supplement the general requirements
10 prescribed pursuant to chapter 43.88 RCW,

11 (c) The content of the curriculums and other educational and
12 training programs, and the requirement for degrees and certificates
13 awarded by the colleges,

14 (d) Standard admission policies,

15 (e) Eligibility of courses to receive state fund support;

16 (8) Establish and administer criteria and procedures for all
17 capital construction including the establishment, installation, and
18 expansion of facilities within the various college districts;

19 (9) Encourage innovation in the development of new educational and
20 training programs and instructional methods; coordinate research
21 efforts to this end; and disseminate the findings thereof;

22 (10) Collaborate with other state agencies and organizations to
23 meet state graduation rate goals and help reduce the dropout rate, in
24 accordance with sections 1 and 4 of this act;

25 (11) Exercise any other powers, duties and responsibilities
26 necessary to carry out the purposes of this chapter;

27 ~~((+11))~~ (12) Authorize the various community and technical
28 colleges to offer programs and courses in other districts when it
29 determines that such action is consistent with the purposes set forth
30 in RCW 28B.50.020 as now or hereafter amended;

31 ~~((+12))~~ (13) Notwithstanding any other law or statute regarding
32 the sale of state property, sell or exchange and convey any or all
33 interest in any community and technical college real and personal
34 property, except such property as is received by a college district in
35 accordance with RCW 28B.50.140(8), when it determines that such
36 property is surplus or that such a sale or exchange is in the best
37 interests of the community and technical college system;

6 community networks and no network shall have fewer than forty thousand
7 population. When approving multicounty networks, considering dividing
8 a county between networks, or creating a network with a population of
9 less than forty thousand, the council must consider: (a) Common
10 economic, geographic, and social interests; (b) historical and existing
11 shared governance; and (c) the size and location of population centers.
12 Individuals and groups within any area shall be given ample opportunity

36 (8)(a) The council shall monitor the implementation of programs
37 contracted by participating state agencies by reviewing periodic
38 reports on the extent to which services were delivered to intended

3 This monitoring shall include provision for periodic feedback to

5 (b) The legislature intends that this monitoring be used by the

9 their programs. For this reason, and to conserve public funds, the
10 council shall not conduct or contract for the conduct of control group
11 studies, quasi-experimental design studies, or other analysis efforts
12 to attempt to determine the impact of network programs on at-risk

14 (9) Review the implementation of chapter 7, Laws of 1994 sp. sess.
15 The report shall use measurable performance standards to evaluate the
16 implementation; and

17 (10) Collaborate with other state agencies and organizations to
18 meet state graduation rate goals and help reduce the dropout rate, in
19 accordance with sections 1 and 4 of this act.
