
FOURTH SUBSTITUTE HOUSE BILL 1827

State of Washington 65th Legislature 2018 Regular Session

1 AN ACT Relating to expanding the current and future educator
2 workforce supply through evidence-based strategies to improve and
3 incentivize the recruitment and retention of highly effective
4 educators, especially in high-need subject, grade-level, and
5 geographic areas, and to establish a cohesive continuum of high
6 quality professional learning from preparation programs to job
7 embedded induction, mentoring, collaboration, and other professional
8 development opportunities; amending RCW 28A.415.370, 28A.660.020,
9 28A.660.035, 28B.10.033, 28B.76.699, 28A.630.205, 28B.102.020,
10 28B.102.030, 28B.102.045, 28B.102.090, 28A.660.042, 28A.660.045,
11 28B.102.055, 28B.102.080, 43.79A.040, 28B.15.558, 28A.415.265,
12 28A.405.100, and 41.32.068; adding a new section to chapter 28A.310
13 RCW; adding a new section to chapter 28A.630 RCW; adding new sections
14 to chapter 28A.410 RCW; adding new sections to chapter 28B.102 RCW;
15 adding a new section to chapter 28A.660 RCW; adding a new section to
16 chapter 28B.76 RCW; creating new sections; recodifying RCW
17 28A.660.042, 28A.660.045, and 28A.630.205; repealing RCW 28B.102.010,
18 28B.102.040, 28B.102.050, 28B.102.060, 28A.660.050, and 28A.660.055;
19 providing expiration dates; and declaring an emergency.

20 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

1 NEW SECTION. **Sec. 1.** FINDINGS—INTENT. (1) The legislature finds
2 that discrete efforts are being made at state and local levels to
3 address the educator shortage, but these efforts need to be
4 streamlined and performed in concert, in order to enhance the effect
5 of these recruitment and retention strategies.

6 (2) The legislature also reaffirms that excellent, effective
7 educators and educator leaders are essential to the state's ongoing
8 efforts to establish a world-class, globally competitive education
9 system. As acknowledged in Engrossed Substitute House Bill No. 2261
10 (chapter 548, Laws of 2009), "Teachers, principals, and
11 administrators must be provided with access to the opportunities they
12 need to gain the knowledge and skills that will enable them to be
13 increasingly successful in their classroom and schools. A system that
14 clearly defines, supports, measures, and recognizes effective
15 teaching and leadership is one of the most important investments to
16 be made."

17 (3) Therefore, the legislature intends to seize the challenges
18 presented by the educator workforce shortage in Washington to build
19 the capacity of the education system to attract, retain, support, and
20 sustain successful educators through:

- 21 (a) Intentional recruitment strategies;
- 22 (b) Expanding educator training programs;
- 23 (c) Focused financial incentives, assistance, and supports;
- 24 (d) Responsive and responsible retention strategies; and
- 25 (e) Deeper systems evaluation.

26 **PART I**

27 **RECRUITMENT—CHARACTERISTICS OF INDIVIDUALS**

28 NEW SECTION. **Sec. 101.** FINDINGS—INTENT. (1) The legislature
29 finds that effective educators who share their love of learning
30 inspire students to enter into the education profession. The
31 legislature further finds that every category and level of educator
32 should support and inspire the next generation into careers in
33 education.

34 (2) The legislature finds that a comprehensive effort is needed
35 to repair the disjointed system for attracting persons into
36 certificated educator professions. The legislature acknowledges that
37 Washington is facing a short-term recruitment problem with the

1 immediate need to fill classroom vacancies, but recognizes that it
2 must also solve its long-term recruitment problem by creating a
3 pipeline of interested persons entering into, and remaining in, the
4 educator workforce.

5 (3) Therefore, the legislature intends to support a multipronged
6 grow-your-own initiative to develop persons from the community, which
7 includes programs that target middle and high school students,
8 paraeducators, military personnel, and career changers who are
9 subject matter experts, and that supports these persons to become
10 educators. The initiative includes:

11 (a) Improvements to existing programs and activities, including
12 the recruiting Washington teachers program, the high school career
13 and technical education course called careers in education, and the
14 alternative route teacher certification programs; and

15 (b) Development and implementation of additional programs and
16 activities, including the coordination of existing resources that
17 attract persons with needed skills and abilities, improving standards
18 of practice, and reviewing barriers to recruitment.

19 **REGIONAL RECRUITERS**

20 NEW SECTION. **Sec. 102.** A new section is added to chapter
21 28A.310 RCW to read as follows:

22 (1) For the purpose of this section, "educator" means a
23 paraeducator, teacher, principal, administrator, superintendent,
24 school counselor, school psychologist, school social worker, school
25 nurse, school physical therapist, school occupational therapist, or
26 school speech-language pathologist or audiologist.

27 (2) An educational service district may employ a person whose
28 duties are to provide to local school districts the following
29 services related to educator recruitment:

30 (a) Serving as a liaison between local school districts and
31 educator preparation programs, between their region and other regions
32 in the state, and between the local school districts and agencies
33 that may be helpful in educator recruitment efforts, including the
34 office of the superintendent of public instruction, the Washington
35 professional educator standards board, the paraeducator board, the
36 student achievement council, the state board for community and
37 technical colleges, the state department of veterans affairs, the

1 state military department, and the workforce training and education
2 coordinating board;

3 (b) Encouraging and supporting local school districts to develop
4 or expand a recruiting Washington teachers program under RCW
5 28A.415.370, a career and technical education careers in education
6 program, or an alternative route teacher certification program under
7 chapter 28A.660 RCW;

8 (c) Providing outreach to community members who may be interested
9 in becoming educators, including high school and college students,
10 subject matter experts, and former military personnel and their
11 spouses;

12 (d) Supporting persons interested in becoming educators by
13 providing resources and assistance with navigating transition points
14 on the path to a career in education; and

15 (e) Providing resources and technical assistance to local school
16 districts on best hiring processes and practices.

17 (3) A person employed to provide the services described in
18 subsection (2) of this section must be reflective of, and have an
19 understanding of, the local community.

20 (4)(a) The professional educator standards board must administer
21 the regional educator recruitment program. In administering the
22 program and providing any associated grants, the office must
23 prioritize grants to educational service districts whose school
24 districts have the least access to alternative route teacher
25 certification programs.

26 (b) Beginning September 1, 2018, the educational service
27 districts in the program must employ a person with the duties and
28 characteristics specified in subsections (2) and (3) of this section.
29 The educational service districts in the program must collaborate
30 with the office of the superintendent of public instruction and the
31 Washington association of educational service districts to prepare
32 the report required in (c) of this subsection.

33 (c) By December 1, 2020, and in compliance with RCW 43.01.036,
34 the office of the superintendent of public instruction, in
35 collaboration with the Washington association of educational service
36 districts, must evaluate the program and submit a report to the
37 appropriate committees of the legislature. At a minimum, the report
38 must: Summarize the activities of the educational service districts
39 in the program with regards to educator recruitment, including the
40 activities described in subsection (2) of this section, in comparison

1 to the educator recruitment activities of the educational service
2 districts not participating in the program; include any outcomes data
3 that is available; and recommend whether the program should be
4 expanded to all educational service districts or discontinued.

5 **STUDENTS**

6 **Sec. 103.** RCW 28A.415.370 and 2007 c 402 s 10 are each amended
7 to read as follows:

8 HIGH SCHOOL STUDENTS—THROUGH THE RECRUITING WASHINGTON TEACHERS
9 PROGRAM. (1)(a) The recruiting Washington teachers program is
10 established to recruit and provide training and support for high
11 school students to enter the teaching profession, especially in
12 teacher shortage areas ~~((and among underrepresented groups and~~
13 ~~multilingual, multicultural students))~~. The program must focus on,
14 but not be limited to, multilingual, multicultural students and
15 students from underrepresented groups. The program shall be
16 administered by the Washington professional educator standards board.

17 (b) As used in this section, "shortage area" has the definition
18 in RCW 28B.102.020.

19 (2) The program shall consist of the following components:

20 (a) Targeted recruitment of diverse high school students~~((τ))~~
21 including, but not limited to, students from underrepresented groups
22 and multilingual, multicultural students in grades nine through
23 twelve, through outreach and communication strategies. The focus of
24 recruitment efforts shall be on encouraging students to consider and
25 explore ~~((becoming future teachers in mathematics, science, bilingual~~
26 ~~education, special education, and English as a second language.~~

27 ~~Program enrollment is not limited to students from underrepresented~~
28 ~~groups or multilingual, multicultural students))~~ careers in
29 education;

30 (b) A high school curriculum that: Provides future teachers with
31 opportunities to observe classroom instruction at all grade levels;
32 includes preteaching internships at all grade levels with a focus on
33 shortage areas; and covers such topics as lesson planning, learning
34 styles, student learning data and information, ~~((the achievement~~
35 ~~gap))~~ academic disparities among student subgroups, cultural
36 competency, college success and workforce skills, and education
37 policy;

1 (c) Academic and community support services (~~for students~~) to
2 help (~~them~~) students overcome possible barriers to becoming future
3 teachers, such as supplemental tutoring; advising on college
4 readiness and college course selection, college applications, and
5 financial aid processes and financial education opportunities; and
6 mentoring. Support services for program participants may continue
7 from high school through the first two years of college; and

8 (d) Future teacher camps held on college campuses where high
9 school students can: Acclimate to the campus, resources, and culture;
10 attend workshops; and interact with college faculty, teacher
11 candidates, and (~~current~~) certificated teachers.

12 (3) As part of its administration of the program, the Washington
13 professional educator standards board shall:

14 (a) Develop the curriculum and program guidelines in consultation
15 with an advisory group of teachers, representatives of teacher
16 preparation programs, teacher candidates, students, and
17 representatives of diverse communities;

18 (b) (~~Subject to funds appropriated for this purpose,~~) Allocate
19 grant funds through a competitive process to partnerships of high
20 schools, teacher preparation programs, and community-based
21 organizations to design and deliver programs that include the
22 components under subsection (2) of this section. The board must
23 prioritize grants to partnerships that also have a running start
24 program under chapter 28A.600 RCW; and

25 (c) Conduct (~~an~~) periodic evaluations of the effectiveness of
26 current strategies and programs for recruiting teachers, especially
27 multilingual, multicultural teachers, in Washington and in other
28 states. The board shall use the findings from the evaluation to
29 revise the recruiting Washington teachers program as necessary and
30 make other recommendations to teacher preparation programs or the
31 legislature.

32 CAREER CHANGERS

33 **Sec. 104.** RCW 28A.660.020 and 2017 c 14 s 1 are each amended to
34 read as follows:

35 SUBJECT MATTER EXPERTS—THROUGH ALTERNATIVE ROUTES. (1)(a) The
36 Washington professional educator standards board shall transition the
37 alternative route partnership grant program from a separate

1 competitive grant program to a preparation program model to be
2 expanded among approved preparation program providers.

3 (b) Alternative routes are partnerships between Washington
4 professional educator standards board-approved preparation programs,
5 Washington school districts, and other partners as appropriate.
6 Program design of alternative route programs shall continue to evolve
7 over time to reflect innovations and improvements in educator
8 preparation.

9 (c) The Washington professional educator standards board must
10 construct rules that address the competitive grant process and
11 program design.

12 (2) As provided in RCW 28A.410.210, it is the duty of the
13 Washington professional educator standards board to establish
14 policies for the approval of nontraditional preparation programs and
15 to provide oversight and accountability related to the quality of
16 these programs. In establishing and amending rules for alternative
17 route programs, the Washington professional educator standards board
18 shall:

19 (a) Uphold criteria for alternative route program design that is
20 innovative and reflects evidence-based practice;

21 (b) Ensure that approved partnerships reflect district engagement
22 in their resident alternative route program as an integral part of
23 their future workforce development, as well as school and student
24 learning improvement strategies;

25 (c) Amend or adopt rules issuing preservice residents
26 certification necessary to serve as substitute teachers in classrooms
27 within the residency school for up to ten days per school year;

28 (d) (~~Continue to~~) Prioritize program designs tailored to the
29 needs of experienced paraeducators and candidates of high academic
30 attainment in, or with occupational industry experience relevant to,
31 the subject area they intend to teach. In doing so the program
32 designs must take into account school district demand for certain
33 teacher credentials;

34 (e) Expand access and opportunity for individuals to become
35 teachers statewide; and

36 (f) Give preference in admissions to applicants for alternative
37 route programs who are eligible veterans or national guard members
38 and who meet the entry requirements for the alternative route
39 program.

1 (3) Beginning December 1, 2017, and by December 1st each (~~odd-~~
2 ~~numbered~~) even-numbered year thereafter, the Washington professional
3 educator standards board shall report to the education committees of
4 the house of representatives and the senate the following outcomes as
5 indicators that alternative route programs are meeting legislative
6 intent through the regulation and oversight of the Washington
7 professional educator standards board. In considering administrative
8 rules for, and reporting outcomes of, alternative route programs, the
9 Washington professional educator standards board shall examine the
10 historical record of the data, reporting on:

11 (a) The number and percentage of alternative route completers
12 hired;

13 (b) The percentage of alternative route completers from
14 underrepresented populations;

15 (c) Three-year and five-year retention rates of alternative route
16 completers;

17 (d) The average hiring dates of alternative route completers; and

18 (e) The percentage of alternative route completers hired in
19 districts where their alternative route program was completed.

20 (4) (~~To the extent funds are appropriated for this purpose,~~)
21 Alternative route programs may apply for program funds to pay
22 stipends to trained mentor teachers of interns during the mentored
23 internship. The per intern amount of mentor stipend provided by state
24 funds shall not exceed five hundred dollars.

25 **Sec. 105.** RCW 28A.660.035 and 2017 c 14 s 2 are each amended to
26 read as follows:

27 COMMUNITY MEMBERS—THROUGH ALTERNATIVE ROUTES. The office of the
28 superintendent of public instruction shall identify school districts
29 that have the most significant achievement gaps among subgroups of
30 students and for large numbers of those students, and districts that
31 should receive priority for assistance in advancing cultural
32 competency skills in their workforce. The Washington professional
33 educator standards board shall provide assistance to the identified
34 school districts to develop partnership (~~grant~~) programs between
35 the districts and teacher preparation programs to provide alternative
36 route programs under RCW 28A.660.020 and to recruit paraeducators and
37 other (~~individuals~~) persons in the local community to become
38 (~~certified~~) certificated as teachers. An alternative route
39 partnership program proposed by an identified school district shall

1 receive priority eligibility for partnership grants under RCW
2 28A.660.020. To the maximum extent possible, the board shall
3 coordinate the recruiting Washington teachers program under RCW
4 28A.415.370 with the alternative route partnership programs under
5 this section.

6 NEW SECTION. **Sec. 106.** MILITARY PERSONNEL AND THEIR SPOUSES—
7 REVIEW BARRIERS TO RECRUITMENT. (1) The Washington professional
8 educator standards board shall convene a work group to examine and
9 make recommendations on recruitment of military personnel and their
10 spouses into educator positions within the school districts. For the
11 purpose of this section, "educator" means a paraeducator, teacher,
12 principal, administrator, superintendent, school counselor, school
13 psychologist, school social worker, school nurse, school physical
14 therapist, school occupational therapist, or school speech-language
15 pathologist or audiologist.

16 (2) The members of the work group must include representatives
17 from the office of the superintendent of public instruction, the
18 state department of veterans affairs, the state military department,
19 educator preparation programs, and state educator associations, and a
20 superintendent from a school district in the vicinity of a military
21 installation.

22 (3) The work group must review the barriers that exist to former
23 military personnel becoming educators in Washington, including
24 obtaining academic credit for prior learning and financial need.

25 (4) Staff support for the work group must be provided by the
26 Washington professional educator standards board.

27 (5) By December 1, 2018, and in compliance with RCW 43.01.036,
28 the work group shall report its findings and recommendations to the
29 appropriate committees of the legislature.

30 (6) This section expires June 30, 2019.

31 NEW SECTION. **Sec. 107.** A new section is added to chapter
32 28A.630 RCW to read as follows:

33 EDUCATIONAL SERVICE DISTRICT ALTERNATIVE ROUTE PILOT PROGRAM.

34 (1)(a) The office of the superintendent of public instruction shall
35 distribute grants to an educational service district that volunteers
36 to pilot an alternative route teacher certification program, under
37 chapter 28A.660 RCW. The purpose of the grant is to provide financial
38 assistance to teacher candidates enrolled in the educational service

1 district's alternative route teacher certification program with the
2 intent to pursue an initial teacher certificate. The office must
3 provide a grant sufficient to provide eight thousand dollars of
4 financial assistance to thirty teacher candidates in the 2018-19
5 school year and to forty teacher candidates in the 2019-20 school
6 year.

7 (b) In piloting the program, the educational service district
8 must:

9 (i) Engage retired or practicing teachers and administrators who
10 are knowledgeable and experienced classroom teachers to inform the
11 development and curriculum of the program;

12 (ii) Provide extended support and mentoring through the first
13 three years of a teacher's career, using the components of the
14 beginning educator support team, under RCW 28A.415.265;

15 (iii) Support school districts to develop school staff and
16 community members to become teachers, so that the district's teachers
17 better reflect the region's demographics, values, and interests; and

18 (iv) Provide opportunities for classified staff to become
19 teachers.

20 (2) By November 1, 2023, the volunteer educational service
21 district must report to the office of the superintendent of public
22 instruction with the outcomes of the pilot and any recommendations
23 for implementing alternative route teacher certification programs in
24 other educational service districts. The report must include the
25 following data: (a) The number of teacher candidates applying for,
26 and completing, the alternative route teacher certification program;
27 (b) the number of completers who become teachers, both in the
28 educational service district and elsewhere in the state; and (c)
29 retention of teachers in the educational service district before and
30 after implementation of the pilot. The data must be disaggregated by
31 race and ethnicity, gender, type of endorsement, and school. The
32 report must also include feedback from school principals and teachers
33 in the local school districts.

34 (3) By December 1, 2023, and in compliance with RCW 43.01.036,
35 the office of the superintendent of public instruction must submit
36 the educational service district's report, required under subsection
37 (2) of this section, to the appropriate committees of the
38 legislature, with recommendations for whether the pilot program
39 should be expanded, modified, or terminated.

40 (4) This section expires July 1, 2024.

1 **PART II**

2 **FINANCIAL INCENTIVES, ASSISTANCE, AND SUPPORTS**

3 NEW SECTION. **Sec. 201.** FINDINGS—INTENT. (1) The legislature
4 finds that financial incentives, assistance, and supports are
5 essential to recruit and retain persons into educator positions
6 within the public common school system. In order to have the most
7 impact, these incentives, assistance, and supports must be related
8 explicitly and directly to the legislature's objectives for
9 recruiting and retaining an educator workforce that will best serve
10 diverse student populations, as well as meet the state's short-term
11 and long-term educator workforce needs.

12 (2) Therefore, the legislature intends to:

13 (a) Promote effective incentives, assistance, and supports;

14 (b) Remove barriers and disincentives; and

15 (c) Enhance and encourage capacity-building for and coordination
16 between educator preparation programs and the public common school
17 system, especially in underserved areas.

18 (3) The legislature further intends to provide conditional
19 scholarships to recruit persons into the profession of education and
20 to assist with keeping them in the profession during the early years
21 of their career. The legislature recognizes that the state need grant
22 does not meet the needs of many qualified students, so these
23 conditional scholarships are intended to be provided in a "last
24 dollar in" model. The legislature also intends for loan repayment
25 programs to help retain certificated educators who are already
26 working in the public common schools.

27 (4) The legislature finds that the location and characteristics
28 of a student teacher's field placement are strong predictors of where
29 the teacher takes his or her first job. Therefore, the legislature
30 intends to encourage the appropriate placement of student teachers,
31 especially in high-need subject and geographic areas. In addition,
32 the legislature intends to continue providing grants for student
33 teachers at Title I public common schools.

34 **FIELD PLACEMENTS**

35 **Sec. 202.** RCW 28B.10.033 and 2016 c 233 s 10 are each amended to
36 read as follows:

1 FIELD PLACEMENT PLANS. (1)(a) By July 1, 2018, each (~~institution~~
2 ~~of higher education with a~~) Washington professional educator
3 standards board-approved teacher preparation program, including an
4 alternative route teacher certification program, must develop a plan
5 describing how the (~~institution of higher education~~) program will
6 partner with school districts in the general geographic region of the
7 (~~school, or where its programs are offered,~~) program regarding
8 field placement of (~~resident~~) student teachers. The plans must be
9 developed in collaboration with school districts desiring to partner
10 with the (~~institutions of higher education~~) programs, and may
11 include use of unexpended federal or state funds to support
12 residencies and mentoring for students who are likely to continue
13 teaching in the district in which they have a supervised (~~student~~
14 ~~teaching residency~~) field placement.

15 (b) The following goals must be considered when developing the
16 plans required under this section:

17 (i) Field placement of student teachers should be targeted to
18 high-need subject areas, including special education and English
19 learner, and high-need geographic areas, including Title I and rural
20 schools; and

21 (ii) Student teacher mentors should be highly effective as
22 evidenced by the mentors having received level 3 or above on both
23 criteria 3 (recognizing individual student learning needs and
24 developing strategies to address those needs) and criteria 6 (using
25 multiple student data elements to modify instruction and improve
26 student learning) on their most recent comprehensive performance
27 evaluation under RCW 28A.405.100. Student teacher mentors should also
28 have received or be concurrently receiving professional development
29 in mentoring skills.

30 (2) The plans required under subsection (1) of this section must
31 be submitted to the professional educator standards board and updated
32 at least biennially.

33 (3) The professional educator standards board shall post the
34 plans and updates required under this section on its web site.

35 (4) By December 1, 2018, and in compliance with RCW 43.01.036,
36 the student achievement council, in cooperation with the professional
37 educator standards board-approved teacher preparation programs, the
38 Washington state school directors' association, and the rural
39 education center at Washington State University, must submit a report
40 to the appropriate committees of the legislature. The report must

1 include policy recommendations to encourage or require the
2 professional educator standards board-approved teacher preparation
3 programs to develop relationships with, and provide supervisory
4 support for field placements of student teachers in, school districts
5 that are not in the general geographic area of an approved teacher
6 preparation program.

7 NEW SECTION. Sec. 203. A new section is added to chapter
8 28A.410 RCW to read as follows:

9 FIELD PLACEMENT PLANS. Each Washington professional educator
10 standards board-approved teacher preparation program, including an
11 alternative route teacher certification program, must develop a plan
12 regarding field placement of student teachers in accordance with RCW
13 28B.10.033.

14 Sec. 204. RCW 28B.76.699 and 2016 c 233 s 17 are each amended to
15 read as follows:

16 GRANTS FOR STUDENT TEACHERS AT TITLE I SCHOOLS. (1) (~~Subject to~~
17 ~~the availability of amounts appropriated for this specific purpose,~~)
18 The office shall administer a student teaching ((residency)) grant
19 program to provide additional funds to ((individuals completing))
20 student ((teaching residencies)) teachers at Title I public common
21 schools in Washington.

22 (2) To qualify for the grant, recipients must be enrolled in a
23 Washington professional educator standards board-approved teacher
24 preparation program, be completing or about to start ((a)) student
25 teaching ((residency)) at a Title I public common school, and
26 demonstrate financial need, as defined by the office and consistent
27 with the income criteria required to receive the state need grant
28 established in chapter 28B.92 RCW or applicable rules.

29 (3)(a) Beginning December 1, 2020, and in compliance with RCW
30 43.01.036, the office must submit a biennial report to the
31 appropriate committees of the legislature. The report must provide
32 the following information:

33 (i) Aggregate data on the number of persons who applied for and
34 received the grants awarded under this section, including teacher
35 preparation program type, student teaching school district, and award
36 amount;

37 (ii) Aggregate data on where grant recipients are teaching two
38 years and five years after obtaining a teacher certificate, and

1 whether grant recipients remain teaching in Title I public common
2 schools; and

3 (iii) Recommendations for modifying the grant program.

4 (b) The education data center must collaborate with the office to
5 provide the data needed for the report required under this section.

6 (4) The office shall establish rules for administering the grants
7 under this section.

8 **BASIC SKILLS AND CONTENT TEST ASSISTANCE**

9 **Sec. 205.** RCW 28A.630.205 and 2016 c 233 s 16 are each amended
10 to read as follows:

11 TEACHER ENDORSEMENT AND CERTIFICATION HELP PROGRAM. (1) (~~Subject~~
12 ~~to the availability of amounts appropriated for this specific~~
13 ~~purpose,~~) The teacher endorsement and certification help (~~(pilot~~
14 ~~project)~~) program, known as the TEACH (~~(pilot)~~) program, is created.

17 NEW SECTION. Sec. 227. EXPAND ENROLLMENTS IN HIGH-NEED SUBJECTS
18 AND LOCATIONS. The legislature recognizes the important role of
19 teacher preparation programs in addressing the shortages in the
20 educator career continuum. Through the omnibus appropriations act,
21 the legislature intends to prioritize the expansion of teacher
22 preparation program enrollments in high-need subjects and high-need
23 locations within the state, taking into consideration the community
24 and technical colleges' capacity to contribute to teacher
25 preparation.

26 **PART III**

27 **RETENTION STRATEGIES**

28 NEW SECTION. Sec. 301. FINDINGS—INTENT. (1) The legislature
29 finds that problems with educator retention within a school or school
30 district are largely reflective of conditions affecting the school
31 and district. The legislature acknowledges that the demands on
32 educators must be balanced with an encouragement of their excitement
33 for the profession. The legislature further finds that professional
34 educators want to improve students' lives through education, and the
35 public school system should empower them to do so. The legislature
36 recognizes that barriers to educator retention must be addressed,

1 such as lack of induction and mentoring for beginning educators,
2 complicated and burdensome certification requirements, and frequent
3 comprehensive performance evaluation requirements for proficient and
4 distinguished educators.

5 (2) The legislature finds that the most successful education
6 systems have robust, well-prepared educators and educator leaders,
7 with ample and relevant mentoring and professional learning
8 opportunities appropriate to their roles and career aspirations.
9 Further, the legislature finds that cultivating a public common
10 school system that focuses on the growth of educator knowledge,
11 skills, and dispositions to help students perform at high levels not
12 only supports better professional practice, but results in greater
13 professional satisfaction for educators.

14 (3) The legislature acknowledges that a substantial step towards
15 reducing the barriers of complicated and burdensome certification
16 requirements was taken in chapter 26, Laws of 2017 by creating a
17 flexible option for renewing teacher and administrator certificates.
18 However, continued legislative review and refinement of the link
19 between certification programs, effective pedagogy, and professional
20 satisfaction is necessary to strengthen educator retention efforts.

21 (4) Further efforts can also focus on the improvement of working
22 conditions within schools and school districts. The legislature
23 intends to expand upon successful educator induction and mentoring
24 programs such as the beginning educator support team program, and to
25 streamline the teacher and principal evaluation program requirements
26 for the highest performing educators.

36 ~~evaluation))~~ performance rating for the focused performance
37 evaluation using the methodology adopted by the superintendent of
38 public instruction for the instructional or leadership framework
39 being used.

1 (iv) A teacher or principal may be transferred from a focused
2 performance evaluation to a comprehensive (~~(summative)~~) performance
3 evaluation at the request of the teacher or principal, or at the
4 direction of the teacher's or principal's evaluator.

5 (v) Due to the importance of instructional leadership and
6 assuring rater agreement among evaluators, particularly those
7 evaluating teacher performance, school districts are encouraged to
8 conduct comprehensive (~~(summative)~~) performance evaluations of
9 principals (~~(performance)~~) on an annual basis.

10 (vi) A classroom teacher or principal may apply the focused
11 performance evaluation professional growth activities toward the
12 professional growth plan for professional certificate renewal as
13 required by the Washington professional educator standards board.

14 (13) Each school district is encouraged to acknowledge and
15 recognize classroom teachers and principals who have attained level 4
16 - distinguished performance ratings.

17 **Sec. 304.** RCW 41.32.068 and 2016 c 233 s 7 are each amended to
18 read as follows:

19 In addition to the postretirement employment options available in
20 RCW 41.32.802 or 41.32.862, (~~(and only until August 1, 2020,)~~) a
21 teacher in plan 2 or plan 3 who has retired under the alternate early
22 retirement provisions of RCW 41.32.765(3)(b) or 41.32.875(3)(b) may
23 be employed with an employer for up to eight hundred sixty-seven
24 hours per calendar year without suspension of his or her benefit,
25 provided that: (1) The retired teacher reenters employment more than
26 one calendar month after his or her accrual date and after June 9,
27 2016; (2) (~~([the retired teacher])~~) the retired teacher is employed
28 exclusively as either a substitute teacher as defined in RCW
29 41.32.010(48)(a) in an instructional capacity, as opposed to other
30 capacities identified in RCW 41.32.010(49); and (3) the employing
31 school district compensates the district's substitute teachers at a
32 rate that is at least eighty-five percent of the full daily amount

35 NEW SECTION. **Sec. 305.** A new section is added to chapter
36 28A.410 RCW to read as follows:

37 REPRIMAND EXPUNGEMENT PROCESS. (1) The professional educator
38 standards board, in consultation with the office of the

1 superintendent of public instruction staff authorized to issue
2 educator reprimands, shall adopt rules that, at a minimum:

3 (a) Establish a process for an educator to apply for review of a
4 reprimand, issued in accordance with RCW 28A.410.090, that occurred
5 no more than five years prior to the application date;

6 (b) Establish a process for review of reprimand expungement
7 applications, including review of educator certification and
8 personnel files, by the authority authorized to grant educator
9 certificates;

10 (c) Define criteria for determining whether a reprimand should be
11 expunged; and

12 (d) Establish a process for expungement of a reprimand from
13 records maintained by the professional educator standards board or
14 the office of the superintendent of public instruction.

15 (2) The authority authorized to grant educator certificates shall
16 use the processes and criteria adopted in accordance with subsection
17 (1) of this section to approve or deny reprimand expungement
18 applications and to expunge educator reprimand records.

19 NEW SECTION. **Sec. 306.** REPRIMAND EXPUNGEMENT REPORT. By
20 December 1, 2020, and in compliance with RCW 43.01.036, the office of
21 the superintendent of public instruction and the professional
22 educator standards board must cooperate to submit a report to the
23 appropriate committees of the legislature that: Summarizes data on
24 the number of reprimand expungement applications reviewed and
25 approved in the prior two years; makes a recommendation on whether
26 the reprimand expungement process under section 305 of this act
27 should be expanded to persons with lapsed certificates; and
28 recommends changes to the statutory requirements of the reprimand
29 expungement process.

30 **PART IV**
31 **STRENGTHENING AND SUPPORTING PROFESSIONAL**
32 **PATHWAYS FOR EDUCATORS—THE COLLABORATIVE**

33 NEW SECTION. **Sec. 401.** FINDINGS—INTENT. (1) The legislature
34 finds that additional evaluation is necessary to establish a
35 comprehensive and coordinated long-term vision that addresses
36 Washington's demands for an excellent, effective educator workforce.
37 The legislature recognizes that such an undertaking requires focused

1 time and resources to develop meaningful policy options to expand the
2 current and future workforce supply.

3 (2) Therefore, the legislature intends to establish a
4 professional educator collaborative, including a variety of
5 stakeholders, to make recommendations on how to improve and
6 strengthen state policies, programs, and pathways that lead to highly
7 effective educators at each level of the public common school system.

8 NEW SECTION. **Sec. 402.** A new section is added to chapter
9 28A.410 RCW to read as follows:

10 THE COLLABORATIVE. (1) For the purpose of this section,
11 "educator" means a paraeducator, teacher, principal, administrator,
12 superintendent, school counselor, school psychologist, school social
13 worker, school nurse, school physical therapist, school occupational
14 therapist, or school speech-language pathologist or audiologist.
15 "Educator" includes persons who hold, or have held, certificates as
16 authorized by rule of the Washington professional educator standards
17 board.

18 (2)(a) The professional educator collaborative is established to
19 make recommendations on how to improve and strengthen state policies,
20 programs, and pathways that lead to highly effective educators at
21 each level of the public school system.

22 (b) The collaborative shall examine issues related to educator
23 recruitment, certification, retention, professional learning and
24 development, leadership, and evaluation for effectiveness. The
25 examination must consider what barriers and deterrents hinder the
26 recruitment and retention of professional educators, including those
27 from underrepresented populations. The collaborative shall also
28 consider what incentives and supports could be provided at each stage
29 of an educator's career to produce a more effective educational
30 system. Specifically, the collaborative must review the following
31 issues:

32 (i) Educator recruitment, including the role of school districts,
33 community and technical colleges, preparation programs, and
34 communities, and the effectiveness of financial incentives and other
35 types of support;

36 (ii) Educator preparation, including traditional and alternative
37 route program design and content, the role of community and technical
38 colleges, field experience duration and quality, financial assistance

1 and incentives, school district and community connections, and
2 academic and social support for students;

3 (iii) Educator certificate types and tiers, including
4 requirements for an initial or first-tier certificate, requirements
5 to advance to the next tier, and requirements that are transferable
6 between certificate types;

7 (iv) Educator certificate renewal requirements, including
8 comparing professional growth plan requirements with the teacher and
9 principal residency certificate renewal requirements established in
10 RCW 28A.410.251;

11 (v) Educator evaluation, including comparison to educator
12 certificate renewal requirements to determine inconsistent or
13 duplicative requirements or efforts, implementation issues and tool
14 refinement, and relationship with educator compensation;

15 (vi) Educator certificate reciprocity;

16 (vii) Professional learning and development opportunities,
17 particularly for mid-career teachers;

18 (viii) Leadership in the education system, including best
19 practices of high quality leaders, training for principals and
20 administrators, and identifying and developing teachers as leaders;
21 and

22 (ix) Systems monitoring, including collection of outcomes data on
23 educator production, employment, and retention, and the value in a
24 cost-benefit analysis of state recruitment and retention activities.

25 (3)(a) The members of the collaborative must include
26 representatives of the following organizations:

27 (i) The two largest caucuses of the senate and the house of
28 representatives, appointed by the president of the senate and the
29 speaker of the house of representatives, respectively;

30 (ii) The Washington professional educator standards board;

31 (iii) The office of the superintendent of public instruction;

32 (iv) Washington professional educator standards board-approved
33 educator preparation programs;

34 (v) The Washington state school directors' association;

35 (vi) The Washington education association;

36 (vii) The Washington association of school administrators;

37 (viii) The association of Washington school principals; and

38 (ix) The association of Washington school counselors.

1 (b) Each organization listed in (a) of this subsection must
2 designate one voting member, except that each legislator is a voting
3 member.

4 (c) The collaborative shall choose its chair or cochairs from
5 among its members.

6 (d) The voting members of the collaborative, where appropriate,
7 may consult with stakeholders, including representatives of other
8 educator associations, or ask stakeholders to establish an advisory
9 committee. Members of such an advisory committee are not entitled to
10 expense reimbursement.

11 (4)(a) Staff support for the collaborative must be provided by
12 the Washington professional educator standards board, and from other
13 state agencies, including the office of the superintendent of public
14 instruction, if requested by the collaborative.

15 (b) The Washington professional educator standards board must
16 convene the initial meeting of the collaborative within sixty days of
17 the effective date of this section.

18 (5) The collaborative must contract with a nonprofit, nonpartisan
19 institute that conducts independent, high quality research to improve
20 education policy and practice and that works with policymakers,
21 researchers, educators, and others to advance evidence-based policies
22 that support equitable learning for each child for the purpose of
23 consultation and guidance on meeting agendas and materials
24 development, meeting facilitation, documenting collaborative
25 discussions and recommendations, locating and summarizing useful
26 policy and research documents, and drafting required reports.

27 (6) Legislative members of the collaborative are reimbursed for
28 travel expenses in accordance with RCW 44.04.120. Nonlegislative
29 members are not entitled to be reimbursed for travel expenses if they
30 are elected officials or are participating on behalf of an employer,
31 governmental entity, or other organization. Any reimbursement for
32 other nonlegislative members is subject to chapter 43.03 RCW.

33 (7)(a) By November 1, 2019, and in compliance with RCW 43.01.036,
34 the collaborative shall submit a preliminary report to the education
35 committees of the legislature that makes recommendations on the
36 educator certificate types, tiers, and renewal issues described in
37 subsection (2) of this section. The report must also describe the
38 activities of the collaborative to date, and include any preliminary
39 recommendations agreed to by the collaborative on other issues
40 described in subsection (2) of this section.

1 (b) By November 1, 2020, and in compliance with RCW 43.01.036,
2 the collaborative shall submit a final report to the education
3 committees of the legislature that describes the activities of the
4 collaborative since the preliminary report and makes recommendations
5 on each issue described in subsection (2) of this section.

6 (8) This section expires August 31, 2021.

7 NEW SECTION. **Sec. 403.** This act is necessary for the immediate
8 preservation of the public peace, health, or safety, or support of
9 the state government and its existing public institutions, and takes
10 effect immediately.
