1 AN ACT Relating to expanding opportunities for students to pursue
2 mental and behavioral health professions; amending RCW 28B.50.271;
3 and reenacting and amending RCW 28B.145.010, 28B.145.030,
4 28B.145.040, and 28B.145.090.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 **Sec. 1.** RCW 28B.50.271 and 2007 c 277 s 101 are each amended to
7 read as follows:

8 (1) The college board shall develop and implement a workforce
9 education program known as the opportunity grant program to provide
10 financial and other assistance for students enrolled at qualified
11 institutions of higher education in opportunity grant-eligible
12 programs of study as described in RCW 28B.50.273. Students enrolled
13 in the opportunity grant program are eligible for:

14 (a) Funding for tuition and mandatory fees at the public
15 community and technical college rate, prorated if the credit load is
16 less than full time, paid directly to the educational institution;
17 and

18 (b) An additional one thousand dollars per academic year for
19 books, tools, and supplies, prorated if the credit load is less than
20 full time.

1 (2) (a) Funding under subsection (1) (a) and (b) of this section is
2 limited to ~~((a maximum))~~:

3 (i) Forty-five credits or the equivalent in ((a)) any
4 opportunity grant-eligible program of study, including required
5 related courses, unless the student is pursuing a certificate or
6 degree under (a) (ii) of this subsection. No student may receive
7 opportunity grant funding for more than forty-five credits or for
8 more than three years from initial receipt of grant funds in one or a
9 combination of programs, unless the student is pursuing a certificate
10 or degree under (a) (ii) of this subsection; or

11 (ii) Ninety credits for students in an opportunity grant-eligible
12 program of study, including required related courses, that result in
13 a certificate or degree required for employment in a behavioral
14 health profession as defined in (b) of this subsection. Extended
15 opportunity grant funding is limited to no more than a total of
16 ninety credits or for more than four years from initial receipt of
17 grant funds.

18 (b) For the purposes of this subsection, "behavioral health
19 profession" means a psychiatrist, psychologist, psychiatric nurse,
20 chemical dependency professional, social worker, or other mental
21 health professionals as defined by the secretary of the department of
22 health.

23 (3) Grants awarded under this section are subject to the
24 availability of amounts appropriated for this specific purpose.

25 **Sec. 2.** RCW 28B.145.010 and 2018 c 254 s 9, 2018 c 209 s 6, and
26 2018 c 114 s 2 are each reenacted and amended to read as follows:

27 The definitions in this section apply throughout this chapter
28 unless the context clearly requires otherwise.

29 (1) "Board" means the opportunity scholarship board.

30 (2) "Council" means the student achievement council.

31 (3) "Eligible advanced degree program" means a health
32 professional degree program beyond the baccalaureate level and
33 includes graduate and professional degree programs.

34 (4) "Eligible county" has the same meaning as "rural county" as
35 defined in RCW 82.14.370 and also includes any county that shares a
36 common border with Canada and has a population of over one hundred
37 twenty-five thousand.

1 (5) "Eligible education programs" means high employer demand
2 (~~and other~~) programs of study as (~~determined~~) identified by the
3 board.

4 (6) "Eligible expenses" means reasonable expenses associated with
5 the costs of acquiring an education such as tuition, books,
6 equipment, fees, room and board, and other expenses as determined by
7 the program administrator in consultation with the council and the
8 state board for community and technical colleges.

9 (7) "Eligible school district" means a school district of the
10 second class as identified in RCW 28A.300.065(2).

11 (8) "Eligible student" means a resident student who received his
12 or her high school diploma or high school equivalency certificate as
13 provided in RCW 28B.50.536 in Washington and who:

14 (a)(i) Has been accepted at a four-year institution of higher
15 education into an eligible education program leading to a
16 baccalaureate degree;

17 (ii) Will attend a two-year institution of higher education and
18 intends to transfer to an eligible education program at a four-year
19 institution of higher education;

20 (iii) Has been accepted at an institution of higher education
21 into a professional-technical degree program in an eligible education
22 program; (~~or~~)

23 (iv) Has been accepted at an institution of higher education into
24 a professional-technical certificate program in an eligible education
25 program; or

26 (v) Has been accepted at an institution of higher education into
27 an eligible advanced degree program and has agreed to the service
28 obligation established by the board;

29 (b) Declares an intention to obtain a professional-technical
30 certificate, professional-technical degree, (~~or~~) baccalaureate
31 degree(~~or~~), or an advanced degree; and

32 (c) Has a family income at or below one hundred twenty-five
33 percent of the state median family income at the time the student
34 applies for an opportunity scholarship.

35 (9) "Gift aid" means financial aid received from the federal Pell
36 grant, the state need grant program in chapter 28B.92 RCW, the
37 college bound scholarship program in chapter 28B.118 RCW, the
38 opportunity grant program in chapter 28B.50 RCW, the opportunity
39 scholarship program in this chapter, or any other state grant,
40 scholarship, or worker retraining program that provides funds for

1 educational purposes with no obligation of repayment. "Gift aid" does
2 not include student loans, work-study programs, the basic food
3 employment and training program administered by the department of
4 social and health services, or other employment assistance programs
5 that provide job readiness opportunities and support beyond the costs
6 of tuition, books, and fees.

7 (10) "High employer demand program of study" has the same meaning
8 as provided in RCW 28B.50.030.

9 (11) "Participant" means an eligible student who has received a
10 scholarship under the opportunity scholarship program.

11 (12) "Professional-technical certificate" means a program as
12 approved by the state board for community and technical colleges
13 under RCW 28B.50.090(7)(c), that is offered by an institution of
14 higher education.

15 (13) "Professional-technical degree" means a program as approved
16 by the state board for community and technical colleges under RCW
17 28B.50.090(7)(c), that is offered by an institution of higher
18 education.

19 (14) "Program administrator" means a private nonprofit
20 corporation registered under Title 24 RCW and qualified as a tax-
21 exempt entity under section 501(c)(3) of the federal internal revenue
22 code.

23 (15) "Resident student" has the same meaning as provided in RCW
24 28B.15.012.

25 (16) "Rural jobs program" means the rural county high employer
26 demand jobs program created in this chapter.

27 (17) "Service obligation" means an obligation by the participant
28 to be employed in a service obligation area in the state for a
29 specific period to be established by the board.

30 (18) "Service obligation area" means a location that meets one of
31 the following conditions:

32 (a) Has been designated by the council as an eligible site under
33 the health professional conditional scholarship program established
34 under chapter 28B.115 RCW;

35 (b) Serves at least forty percent uninsured or medicaid enrolled
36 patients;

37 (c) Is located in a rural county as defined in RCW 82.14.370 and
38 serves a combination of uninsured, medicaid enrolled patients, and
39 medicare enrolled patients, equal to at least forty percent of the
40 practice location's total patients; or

1 (d) Serves a public agency, nonprofit organization, or local
2 health jurisdiction as defined in RCW 43.70.575 by providing public
3 health services necessary to preserve, protect, and promote the
4 health of the state's population, as determined by the board after
5 consultation with the department of health.

6 **Sec. 3.** RCW 28B.145.030 and 2018 c 209 s 8, 2018 c 204 s 2, and
7 2018 c 114 s 4 are each reenacted and amended to read as follows:

8 (1) The program administrator shall provide administrative
9 support to execute the duties and responsibilities provided in this
10 chapter, including but not limited to publicizing the program,
11 selecting participants for the opportunity scholarship award,
12 distributing opportunity scholarship awards, and achieving the
13 maximum possible rate of return on investment of the accounts in
14 subsection (2) of this section, while ensuring transparency in the
15 investment decisions and processes. Duties, exercised jointly with
16 the board, include soliciting funds and setting annual fund-raising
17 goals. The program administrator shall be paid an administrative fee
18 as determined by the board.

19 (2) With respect to the opportunity scholarship program, the
20 program administrator shall:

21 (a) Establish and manage (~~three separate~~) the specified
22 accounts created in (b) of this subsection, into which to receive
23 grants and contributions from private sources as well as state
24 matching funds, and from which to disburse scholarship funds to
25 participants;

26 (b) Solicit and accept grants and contributions from private
27 sources, via direct payment, pledge agreement, or escrow account, of
28 private sources for deposit into any of the (~~three~~) specified
29 accounts created in this subsection (2)(b) upon the direction of the
30 donor and in accordance with this subsection (2)(b):

31 (i) The "scholarship account," whose principal may be invaded,
32 and from which scholarships must be disbursed for baccalaureate
33 programs beginning no later than December 1, 2011, if, by that date,
34 state matching funds in the amount of five million dollars or more
35 have been received. Thereafter, scholarships shall be disbursed on an
36 annual basis beginning no later than May 1, 2012, and every October
37 1st thereafter;

38 (ii) The "student support pathways account," whose principal may
39 be invaded, and from which scholarships may be disbursed for

1 professional-technical certificate or degree programs in the fiscal
2 year following appropriations of state matching funds. Thereafter,
3 scholarships shall be disbursed on an annual basis;

4 (iii) The "advanced degrees pathways account," whose principal
5 may be invaded, and from which scholarships may be disbursed for
6 eligible advanced degree programs in the fiscal year following
7 appropriations of state matching funds. Thereafter, scholarships
8 shall be disbursed on an annual basis;

9 (iv) The "endowment account," from which scholarship moneys may
10 be disbursed for baccalaureate programs from earnings only in years
11 when:

12 (A) The state match has been made into both the scholarship and
13 the endowment account; and

14 (B) The state appropriations for the state need grant under RCW
15 28B.92.010 meet or exceed state appropriations for the state need
16 grant made in the 2011-2013 biennium, adjusted for inflation, and
17 eligibility for state need grant recipients is at least seventy
18 percent of state median family income;

19 (v) An amount equal to at least fifty percent of all grants and
20 contributions must be deposited into the scholarship account until
21 such time as twenty million dollars have been deposited into the
22 scholarship account, after which time the private donors may
23 designate whether their contributions must be deposited to the
24 scholarship account, the student support pathways account, the
25 advanced degrees pathways account, or the endowment account((s)). The
26 board and the program administrator must work to maximize private
27 sector contributions to ((the scholarship account, the student
28 support pathways account, the advanced degrees pathways account, and
29 the endowment account,)) these accounts to maintain a robust
30 scholarship program while simultaneously building the endowment, and
31 to determine the division between the ((scholarship, the student
32 support pathways, the advanced degrees pathways, and the endowment))
33 accounts in the case of undesignated grants and contributions, taking
34 into account the need for a long-term funding mechanism and the
35 short-term needs of families and students in Washington. The first
36 five million dollars in state match, as provided in RCW 28B.145.040,
37 shall be deposited into the scholarship account and thereafter the
38 state match shall be deposited into the ((three)) specified accounts
39 created in this subsection (2)(b) in equal proportion to the private
40 funds deposited in each account, except that no more than one million

1 dollars in state match shall be deposited into the advanced degrees
2 pathways account in a single fiscal biennium; and

3 (vi) Once moneys in the opportunity scholarship match transfer
4 account are subject to an agreement under RCW 28B.145.050(5) and are
5 deposited in the scholarship account, the student support pathways
6 account, the advanced degrees pathways account, or the endowment
7 account under this section, the state acts in a fiduciary rather than
8 ownership capacity with regard to those assets. Assets in the
9 scholarship account, the student support pathways account, the
10 advanced degrees pathways account, and the endowment account are not
11 considered state money, common cash, or revenue to the state;

12 (c) Provide proof of receipt of grants and contributions from
13 private sources to the council, identifying the amounts received by
14 name of private source and date, and whether the amounts received
15 were deposited into the scholarship account, the student support
16 pathways account, the advanced degrees pathways account, or the
17 endowment account((s));

18 (d) In consultation with the council and the state board for
19 community and technical colleges, make an assessment of the
20 reasonable annual eligible expenses associated with eligible
21 education programs and eligible advanced degree programs identified
22 by the board;

23 (e) Determine the dollar difference between tuition fees charged
24 by institutions of higher education in the 2008-09 academic year and
25 the academic year for which an opportunity scholarship is being
26 distributed;

27 (f) Develop and implement an application, selection, and
28 notification process for awarding opportunity scholarships;

29 (g) Determine the annual amount of the opportunity scholarship
30 for each selected participant. The annual amount shall be at least
31 one thousand dollars or the amount determined under (e) of this
32 subsection, but may be increased on an income-based, sliding scale
33 basis up to the amount necessary to cover all reasonable annual
34 eligible expenses as assessed pursuant to (d) of this subsection, or
35 to encourage participation in professional-technical certificate
36 programs, professional-technical degree programs, ((~~or~~))
37 baccalaureate degree programs, or eligible advanced degree programs
38 identified by the board;

39 (h) Distribute scholarship funds to selected participants. Once
40 awarded, and to the extent funds are available for distribution, an

1 opportunity scholarship shall be automatically renewed as long as the
2 participant annually submits documentation of filing both a free
3 application for federal student aid (FAFSA) and for available federal
4 education tax credits including, but not limited to, the American
5 opportunity tax credit, or if ineligible to apply for federal student
6 aid, the participant annually submits documentation of filing a state
7 financial aid application as approved by the office of student
8 financial assistance; and until the participant withdraws from or is
9 no longer attending the program, completes the program, or has taken
10 the credit or clock hour equivalent of one hundred twenty-five
11 percent of the published length of time of the participant's program,
12 whichever occurs first;

13 (i) Notify institutions of scholarship recipients who will attend
14 their institutions and inform them of the terms of the students'
15 eligibility;

16 (j) Establish a required service obligation for participants
17 enrolled in an eligible advanced degree program, and establish a
18 process for verifying a participant's employment in a service
19 obligation area; and

20 (k) Establish a repayment obligation and appeals process for
21 participants who serve less than the required service obligation,
22 unless the program administrator determines the circumstances are
23 beyond the participant's control. If the participant is unable to pay
24 the repayment obligation in full, the participant may enter into
25 payment arrangements with the program administrator. The program
26 administrator is responsible for the collection of repayment
27 obligations on behalf of participants who fail to complete their
28 service obligation.

29 (3) With respect to the opportunity expansion program, the
30 program administrator shall:

31 (a) Assist the board in developing and implementing an
32 application, selection, and notification process for making
33 opportunity expansion awards; and

34 (b) Solicit and accept grants and contributions from private
35 sources for opportunity expansion awards.

36 **Sec. 4.** RCW 28B.145.040 and 2018 c 209 s 9 and 2018 c 114 s 5
37 are each reenacted and amended to read as follows:

38 (1) The opportunity scholarship program is established.

1 (2) The purpose of this scholarship program is to provide
2 scholarships that will help low and middle-income Washington
3 residents earn professional-technical certificates, professional-
4 technical degrees, or baccalaureate degrees in high employer demand
5 and other programs of study and advanced degrees in health
6 professions needed in service obligation areas, and encourage them to
7 remain in the state to work. The program must be designed for
8 students starting professional-technical certificate or degree
9 programs, students starting at two-year institutions of higher
10 education and intending to transfer to four-year institutions of
11 higher education, students starting at four-year institutions of
12 higher education, and students enrolled in an eligible advanced
13 degree program.

14 (3) The opportunity scholarship board shall ~~((determine))~~
15 identify which programs of study ~~((, including but not limited to))~~
16 are high employer demand programs, ~~((are))~~ eligible for purposes of
17 the opportunity scholarship. For eligible advanced degree programs,
18 the board shall limit scholarships to eligible students enrolling in
19 programs that lead to credentials in health professions needed in
20 service obligation areas.

21 (4) The source of funds for the program shall be a combination of
22 private grants and contributions and state matching funds. A state
23 match may be earned under this section for private contributions made
24 on or after June 6, 2011. A state match, up to a maximum of fifty
25 million dollars annually, shall be provided beginning the later of
26 January 1, 2014, or January 1st next following the end of the fiscal
27 year in which collections of state retail sales and use tax, state
28 business and occupation tax, and state public utility tax exceed, by
29 ten percent the amounts collected from these tax resources in the
30 fiscal year that ended June 30, 2008, as determined by the department
31 of revenue.

32 **Sec. 5.** RCW 28B.145.090 and 2018 c 254 s 3, 2018 c 209 s 10, and
33 2018 c 114 s 6 are each reenacted and amended to read as follows:

34 (1) The board may elect to have the state investment board invest
35 the funds in the scholarship account, the student support pathways
36 account, the advanced degrees pathways account, and the endowment
37 account described under RCW 28B.145.030(2)(b). If the board so
38 elects, the state investment board has the full power to invest,
39 reinvest, manage, contract, sell, or exchange investment money in

1 ((~~the three~~)) these accounts. All investment and operating costs
2 associated with the investment of money shall be paid under RCW
3 43.33A.160 and 43.84.160. With the exception of these expenses, the
4 earnings from the investment of the money shall be retained by the
5 accounts.

6 (2) All investments made by the state investment board shall be
7 made with the exercise of that degree of judgment and care under RCW
8 43.33A.140 and the investment policy established by the state
9 investment board.

10 (3) As deemed appropriate by the state investment board, money in
11 the scholarship account, the student support pathways account, the
12 advanced degrees pathways account, and the endowment account may be
13 commingled for investment with other funds subject to investment by
14 the state investment board.

15 (4) Members of the state investment board shall not be considered
16 an insurer of the funds or assets and are not liable for any action
17 or inaction.

18 (5) Members of the state investment board are not liable to the
19 state, to the fund, or to any other person as a result of their
20 activities as members, whether ministerial or discretionary, except
21 for willful dishonesty or intentional violations of law. The state
22 investment board in its discretion may purchase liability insurance
23 for members.

24 (6) The authority to establish all policies relating to the
25 scholarship account, the student support pathways account, the
26 advanced degrees pathways account, and the endowment account, other
27 than the investment policies as provided in subsections (1) through
28 (3) of this section, resides with the board and program administrator
29 acting in accordance with the principles set forth in this chapter.
30 With the exception of expenses of the state investment board in
31 subsection (1) of this section, disbursements from the scholarship
32 account, the student support pathways account, the advanced degrees
33 pathways account, and the endowment account shall be made only on the
34 authorization of the opportunity scholarship board or its designee,
35 and moneys in the accounts may be spent only for the purposes
36 specified in this chapter.

1 (7) The state investment board shall routinely consult and
2 communicate with the board on the investment policy, earnings of the
3 accounts, and related needs of the program.
