State of Washington 67th Legislature 2022 Regular Session

1 AN ACT Relating to extending the time frame for establishing 2 charter schools; amending RCW 28A.710.150; and creating a new 3 section.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

Sec. 1. The legislature finds that the population 5 NEW SECTION. 6 of Washington state has become increasingly diverse over the last 7 several decades. The legislature also finds that as the demographics of state change, historically and currently marginalized 8 our communities still do not have the same opportunities to meet parity 9 10 as their nonmarginalized counterparts across nearly every measure 11 including education, poverty, employment, health, and more. 12 Inequities based on race, ethnicity, gender, and other 13 characteristics continue to be deep, pervasive, and persistent, and 14 they come at a great economic and social cost.

15 The legislature finds that state government must identify and 16 coordinate effective strategies that focus on eliminating systemic 17 barriers for historically and currently marginalized groups and that 18 extending the time frame for the establishment of charter schools is 19 an important step toward promoting opportunities for communities that 20 have not always been well-served by traditional public schools. 1 Sec. 2. RCW 28A.710.150 and 2016 c 241 s 115 are each amended to 2 read as follows:

3 (1) A maximum of forty charter public schools may be established under this chapter ((over the five-year period commencing with April 4 3, 2016)), with the establishment period concluding April 3, 2027. No 5 6 more than eight charter schools may be established in any year during 7 the ((five-year)) establishment period, except that if in any year fewer than eight charter schools are established, additional charter 8 schools, equal in number to the difference between the number 9 established in that year and eight, may be established in subsequent 10 11 years during the ((five-year)) establishment period.

12 (2)(a) To ensure compliance with the limits for establishing new 13 charter schools, certification from the state board of education must 14 be obtained before final authorization of a charter school.

15 (b) Within ten days of taking action to approve or deny an 16 application under RCW 28A.710.140, an authorizer must submit a report 17 of the action to the applicant and the state board of education. The report must include a copy of the authorizer's resolution setting 18 19 forth the action taken, the reasons for the decision, and assurances of compliance with the procedural requirements and application 20 elements under RCW 28A.710.130 and 28A.710.140. The authorizer must 21 22 also indicate whether the charter school is designed to enroll and 23 serve at-risk student populations. The state board of education must establish, for each year in which charter schools may be authorized 24 25 part of the timeline to be established pursuant to RCW as 28A.710.140, the latest annual date by which the authorizer may 26 submit the report. The state board of education must send to each 27 authorizer notice of the date by which a report must be submitted at 28 29 least six months before the date established by the board.

(3) Upon the receipt of notice from an authorizer that a charter 30 31 school has been approved, the state board of education shall certify 32 whether the approval is in compliance with the limits on the maximum number of charters allowed under subsection (1) of this section. If 33 the board receives simultaneous notification of approved charters 34 that exceed the annual allowable limits in subsection (1) of this 35 section, the board must select approved charters for implementation 36 37 through a lottery process, and must assign implementation dates 38 accordingly.

1 (4) The state board of education must notify authorizers when the 2 maximum allowable number of charter schools has been reached.
