## SUBSTITUTE HOUSE BILL 2377

State of Washington 65th Legislature 2018 Regular Session

**By** House Higher Education (originally sponsored by Representatives Hansen, Macri, and Ormsby)

1 AN ACT Relating to eliminating certain postsecondary 2 institutions' eligibility for state financial aid programs; amending 3 RCW 28B.92.030; and adding a new section to chapter 28B.92 RCW.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 Sec. 1. RCW 28B.92.030 and 2013 c 248 s 2 are each amended to 6 read as follows:

7 As used in this chapter:

8

(1) "Council" means the student achievement council.

9 (2) "Disadvantaged student" means a posthigh school student who of adverse cultural, educational, 10 by reason environmental, 11 experiential, familial or other circumstances is unable to qualify 12 for enrollment as a full-time student in an institution of higher 13 education, who would otherwise qualify as a needy student, and who is 14 attending an institution of higher education under an established program designed to qualify the student for enrollment as a full-time 15 16 student.

(3) "Financial aid" means loans and/or grants to needy students
enrolled or accepted for enrollment as a student at institutions of
higher education.

20 (4)(a) "Institution" or "institutions of higher education" means:

1 (((a))) (i) Any public university, college, community college, or 2 technical college operated by the state of Washington or any 3 political subdivision thereof; or

(((<del>b)</del>)) (ii) Except as provided in (b) of this subsection, any 4 other university, college, school, or institute in the state of 5 6 Washington offering instruction beyond the high school level that is a member institution of an accrediting association recognized by rule 7 of the council for the purposes of this section and that agrees to 8 and complies with program rules adopted pursuant to RCW 28B.92.150. 9 10 However, any institution, branch, extension or facility operating within the state of Washington that is affiliated with an institution 11 12 operating in another state must be:

13 (((<del>(i)</del>)) <u>(A)</u> A separately accredited member institution of any 14 such accrediting association;

15 ((((ii))) (B) A branch of a member institution of an accrediting 16 association recognized by rule of the council for purposes of this 17 section, that is eligible for federal student financial aid assistance and has operated as a nonprofit college or university 18 delivering on-site classroom instruction for a minimum of twenty 19 consecutive years within the state of Washington, and has an annual 20 21 enrollment of at least seven hundred full-time equivalent students; 22 or

23 ((((iii))) (C) A nonprofit institution recognized by the state of 24 Washington as provided in RCW 28B.77.240.

25 (b) "Institution" or "institutions of higher education" does not include any university, college, school, or institute owned or 26 operated by a corporation for profit, or any university, college, 27 school, or institute owned, operated, purchased, or acquired by a 28 not-for-profit corporation if the university, college, school, or 29 institute previously operated in the state of Washington under the 30 ownership of a corporation for profit, unless the university, 31 32 college, school, or institute is participating in the state financial aid programs as of the effective date of this section or has been 33 approved to participate in the 2018-19 academic year. 34

35 (5) "Needy student" means a posthigh school student of an 36 institution of higher education who demonstrates to the office the 37 financial inability, either through the student's parents, family 38 and/or personally, to meet the total cost of board, room, books, and 39 tuition and incidental fees for any semester or quarter. "Needy 40 student" also means an opportunity internship graduate as defined by

RCW 28C.18.162 who enrolls in a postsecondary program of study as
 defined in RCW 28C.18.162 within one year of high school graduation.

(6) "Office" means the office of student financial assistance.

4 (7) "Placebound student" means a student who (a) is unable to 5 complete a college program because of family or employment 6 commitments, health concerns, monetary inability, or other similar 7 factors; and (b) may be influenced by the receipt of an enhanced 8 student financial aid award to complete a baccalaureate degree at an 9 eligible institution.

10 <u>NEW SECTION.</u> Sec. 2. A new section is added to chapter 28B.92
11 RCW to read as follows:

(1) Beginning on the effective date of this section, the council may not approve any new applications from any university, college, school, or institute owned or operated by a corporation for profit, or any university, college, school, or institute owned, operated, purchased, or acquired by a not-for-profit corporation if the university, college, school, or institute previously operated in the state of Washington under the ownership of a corporation for profit.

19 (2) A university, college, school, or institute owned or operated 20 by a corporation for profit, or a university, college, school, or institute owned, operated, purchased, or acquired by a not-for-profit 21 corporation that previously operated in the state of Washington under 22 23 the ownership of a corporation for profit, that is participating in 24 the state financial aid programs as of the effective date of this 25 section or has been approved to participate for the 2018-19 academic 26 year may continue to be eligible to participate.
