- 8 (1) Any charter, ordinance, regulation, rule, or resolution 9 enacted by any city, town, county, or port district regulating the 10 minimum hourly wage rate must apply equally to both unionized and 11 nonunionized employers.
- 12 (2) No charter, ordinance, regulation, rule, or resolution 13 enacted by any city, town, county, or port district regulating the 14 minimum hourly wage rate may permit its requirements to be waived, in 15 whole or in part, in collective bargaining.
- (3) Any provision of any charter, ordinance, regulation, rule, or resolution enacted before or after the effective date of this section that conflicts with subsections (1) and (2) of this section shall not be adopted or agreed to and is preempted and unenforceable.
