AN ACT Relating to the treatment of patients with chronic pain; adding a new section to chapter 18.22 RCW; adding a new section to chapter 18.32 RCW; adding a new section to chapter 18.57 RCW; adding a new section to chapter 18.57A RCW; adding a new section to chapter 18.71 RCW; adding a new section to chapter 18.71A RCW; adding a new section to chapter 18.79 RCW; and creating a new section.

## 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

NEW SECTION. Sec. 1. The legislature finds that Washington residents suffering from chronic pain are unable to obtain necessary prescription medications at effective doses to treat their pain because previous opioid-related laws and rules have created a chilling effect among health care practitioners. These health care practitioners are afraid of facing discipline, losing their license to practice, and of possible civil liability if they prescribe high doses of opioids to patients with chronic pain.

Therefore, the legislature intends to end the chilling effect created by these laws to allow patients in Washington with chronic pain to receive prescription medications at levels that effectively treat their pain.
