BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

- 4 **Sec. 1.** RCW 35.21.278 and 2019 c 352 s / are each amended to 5 read as follows:
- 6 (1) Without regard to competitive bidding laws for public works, a county, city, town, school district, metropolitan park district, 7 park and recreation district, port district, or park and recreation 8 service area may contract with a chamber of commerce, a service 9 10 organization, a community, youth, or athletic association, or other 11 similar association located and providing service in the immediate 12 neighborhood, for drawing design plans, making improvements to a park, school playground, public square, public right-of-way, other 13 14 public spaces, or port habitat site, installing equipment, 15 <u>landscaping</u>, or artworks, or providing maintenance services <u>for such</u> 16 a project, or for a facility or facilities as a community or neighborhood project, or <u>for an</u> environmental <u>justice</u> stewardship <u>or</u> 17 18 sustainability project, and may reimburse the contracting association 19 its expense. The contracting association may use volunteers in the 20 project and provide the volunteers with clothing or tools; meals or 21 refreshments; accident/injury insurance coverage; and reimbursement

- 1 of their expenses. The consideration to be received by the public
- 2 entity through the value of the improvements, artworks, <u>landscaping</u>,
- 3 equipment, or maintenance shall have a value at least equal to
- 4 ((three times that of)) the payment to the contracting association.
- 5 All payments made by a public entity under the authority of this
- 6 section for all such contracts in any one year shall not exceed
- 7 twenty-five thousand dollars or two dollars per resident within the
- 8 boundaries of the public entity, whichever is greater.
- 9 (2) A county, city, town, school district, metropolitan park 10 district, park and recreation district, or park and recreation 11 service area may ratify an agreement, which qualifies under 12 subsection (1) of this section and was made before June 9, 1988.
- (3) Without regard to competitive bidding laws for public works, a school district, institution of higher education, or other governmental entity that includes training programs for students may contract with a community service organization, nonprofit organization, or other similar entity, to build tiny houses for low-income housing, if the students participating in the building of the tiny houses are in:
- 20 (a) Training in a community and technical college construction or 21 construction management program;
 - (b) A career and technical education program;

- 24 (d) Training under a construction career exploration program for 25 high school students administered by a nonprofit organization.
