- $((\frac{3}{3}))$ (4) "Bond" means a bond, a note or other evidence of 19 20 indebtedness, including but not limited to a lease-purchase agreement
- 21 or an executory conditional sales contract.

1 (((4))) (5) "Department" means the department of revenue.

- 2 (((+5))) (6) "Fiscal year" means the twelve-month period beginning 3 July 1st and ending the following June 30th.
- 4 (((+6))) (7) "Local government" means any city, town, county, and 5 port district.
- 6 (((7))) <u>(8)</u> "Local property tax allocation revenue" means those 7 tax revenues derived from the receipt of regular property taxes 8 levied on the property tax allocation revenue value and used for 9 local revitalization financing.
 - ((\(\frac{(\(\frac{8}{}\)\)}{\)}) (9) "Local revitalization financing" means the use of revenues from local public sources, dedicated to pay the principal and interest on bonds authorized under RCW 39.104.110 and public improvement costs within the revitalization area on a pay-as-you-go basis, and revenues received from the local option sales and use tax authorized in RCW 82.14.510, dedicated to pay the principal and interest on bonds authorized under RCW 39.104.110.
- $((\frac{(9)}{)})$ (10) "Local sales and use tax increment" means the estimated annual increase in local sales and use taxes as determined by the local government in the calendar years following the approval of the revitalization area by the department from taxable activity within the revitalization area.
- $((\frac{10}{10}))$ (11) "Local sales and use taxes" means local revenues derived from the imposition of sales and use taxes authorized in RCW 82.14.030.
- 25 $((\frac{11}{11}))$ <u>(12)</u> "Ordinance" means any appropriate method of taking legislative action by a local government.
- ((\(\frac{(12)}{12}\))) (13) "Participating local government" means a local government having a revitalization area within its geographic boundaries that has taken action as provided in RCW 39.104.070(1) to allow the use of all or some of its local sales and use tax increment or other revenues from local public sources dedicated for local revitalization financing.
- $((\frac{13}{13}))$ (14) "Participating taxing district" means a taxing district that:
- 35 (a) Has a revitalization area wholly or partially within its 36 geographic boundaries;
- 37 (b) Levies or has levied for it regular property taxes as defined 38 in this section; and
- 39 (c) Has not taken action as provided in RCW 39.104.060(2).

 $((\frac{14}{1}))$ (15) "Property tax allocation revenue base value" means the assessed value of real property located within a revitalization area, less the property tax allocation revenue value.

- (((15))) (16)(a)(i) "Property tax allocation revenue value" means seventy-five percent of any increase in the assessed value of real property in a revitalization area resulting from:
- (A) The placement of new construction, improvements to property, or both, on the assessment roll, where the new construction and improvements are initiated after the revitalization area is approved ((by the department));
- (B) The cost of new housing construction, conversion, and rehabilitation improvements, when the cost is treated as new construction for purposes of chapter 84.55 RCW as provided in RCW 84.14.020, and the new housing construction, conversion, and rehabilitation improvements are initiated after the revitalization area is approved ((by the department));
- (C) The cost of rehabilitation of historic property, when the cost is treated as new construction for purposes of chapter 84.55 RCW as provided in RCW 84.26.070, and the rehabilitation is initiated after the revitalization area is approved ((by the department)).
- (ii) Increases in the assessed value of real property in a revitalization area resulting from (a)(i)(A) through (C) of this subsection are included in the property tax allocation revenue value in the initial year. These same amounts are also included in the property tax allocation revenue value in subsequent years unless the property becomes exempt from property taxation.
- (b) "Property tax allocation revenue value" includes seventy-five percent of any increase in the assessed value of new construction consisting of an entire building in the years following the initial year, unless the building becomes exempt from property taxation.
- (c) Except as provided in (b) of this subsection, "property tax allocation revenue value" does not include any increase in the assessed value of real property after the initial year.
- (d) There is no property tax allocation revenue value if the assessed value of real property in a revitalization area has not increased as a result of any of the reasons specified in (a)(i)(A) through (C) of this subsection.
 - (e) For purposes of this subsection, "initial year" means:

1 (i) For new construction and improvements to property added to 2 the assessment roll, the year during which the new construction and 3 improvements are initially placed on the assessment roll;

- (ii) For the cost of new housing construction, conversion, and rehabilitation improvements, when the cost is treated as new construction for purposes of chapter 84.55 RCW, the year when the cost is treated as new construction for purposes of levying taxes for collection in the following year; and
- 9 (iii) For the cost of rehabilitation of historic property, when 10 the cost is treated as new construction for purposes of chapter 84.55 11 RCW, the year when such cost is treated as new construction for 12 purposes of levying taxes for collection in the following year.

 - (e) Administrative expenses and feasibility studies reasonably necessary and related to these costs, including related costs that may have been incurred before adoption of the ordinance authorizing the public improvements and the use of local revitalization financing to fund the costs of the public improvements.
 - $((\frac{17}{17}))$ (18) "Public improvements" means:
- 32 (a) Infrastructure improvements within the revitalization area 33 that include:
 - (i) Street, road, bridge, and rail construction and maintenance;
 - (ii) Water and sewer system construction and improvements;
- 36 (iii) Sidewalks, streetlights, landscaping, and streetscaping;
- 37 (iv) Parking, terminal, and dock facilities;
 - (v) Park and ride facilities of a transit authority;
- 39 (vi) Park facilities, recreational areas, and environmental 40 remediation;

- 11 (iii) Historic preservation activities authorized under RCW 12 35.21.395.
- $((\frac{18}{19}))$ (19) "Real property" has the same meaning as in RCW 84.04.090 and also includes any privately owned improvements located on publicly owned land that are subject to property taxation.
 - ((\(\frac{(19\)}{19\)})) (20)(a) "Regular property taxes" means regular property taxes as defined in RCW 84.04.140, except: (i) Regular property taxes levied by public utility districts specifically for the purpose of making required payments of principal and interest on general indebtedness; (ii) regular property taxes levied by the state for the support of common schools under RCW 84.52.065; and (iii) regular property taxes authorized by RCW 84.55.050 that are limited to a specific purpose.
 - (b) "Regular property taxes" do not include:
 - (i) Excess property tax levies that are exempt from the aggregate limits for junior and senior taxing districts as provided in RCW 84.52.043; and
 - (ii) Property taxes that are specifically excluded through an interlocal agreement between the sponsoring local government and a participating taxing district as set forth in RCW 39.104.060(3).
 - $((\frac{20}{10}))$ (21)(a) "Revenues from local public sources" means:
- 32 (i) The local sales and use tax amounts received as a result of interlocal agreement, local sales and use tax amounts from sponsoring 33 local governments based on its local sales and use tax increment, and 34 local property tax allocation revenues, which are dedicated by a 35 36 sponsoring local government, participating local governments, and participating taxing districts, for payment of bonds under RCW 37 39.104.110 or public improvement costs within the revitalization area 38 39 on a pay-as-you-go basis; and

- (ii) Any other local revenues, except as provided in (b) of this subsection, including revenues derived from federal and private sources and amounts received by taxing districts as set forth by an interlocal agreement as described in RCW 39.104.060(4), which are dedicated for the payment of bonds under RCW 39.104.110 or public improvement costs within the revitalization area on a pay-as-you-go basis.
- (b) Revenues from local public sources do not include any local funds derived from state grants, state loans, or any other state moneys including any local sales and use taxes credited against the state sales and use taxes imposed under chapter 82.08 or 82.12 RCW.
- $((\frac{21}{1}))$ (22) "Revitalization area" means the geographic area adopted by a sponsoring local government and approved by the $(\frac{department}{department})$ approving agency, from which local sales and use tax increments are estimated and property tax allocation revenues are derived for local revitalization financing.
- $((\frac{(22)}{)})$ (23) "Sponsoring local government" means a city, town, 18 county, or any combination thereof, that adopts a revitalization 19 area.
 - $((\frac{(23)}{(24)}))$ (24) "State contribution" means the lesser of:
 - (a) Five hundred thousand dollars;

- (b) The project award amount approved by the ((department)) approving agency as provided in RCW 39.104.100 or 82.14.505; or
- (c) The total amount of revenues from local public sources dedicated in the preceding calendar year to the payment of principal and interest on bonds issued under RCW 39.104.110 and public improvement costs within the revitalization area on a pay-as-you-go basis. Revenues from local public sources dedicated in the preceding calendar year that are in excess of the project award may be carried forward and used in later years for the purpose of this subsection $((\frac{23}{2}))$ (24)(c).
- (((24))) (25) "State property tax increment" means the estimated amount of annual tax revenues estimated to be received by the state from the imposition of property taxes levied by the state for the support of common schools under RCW 84.52.065 on the property tax allocation revenue value, as determined by the sponsoring local government in an application under RCW 39.104.100 and updated periodically as required in RCW 82.32.765.
- $((\frac{(25)}{)})$ (26) "State sales and use tax increment" means the 40 estimated amount of annual increase in state sales and use taxes to

- be received by the state from taxable activity within the revitalization area in the years following the approval of the revitalization area ((by the department)) as determined by the sponsoring local government in an application under RCW 39.104.100 and updated periodically as required in RCW 82.32.765.
- 6 $((\frac{26}{1}))$ (27) "State sales and use taxes" means state retail sales and use taxes under RCW 82.08.020(1) and 82.12.020 at the rate 7 provided in RCW 82.08.020(1), less the amount of tax distributions 8 from all local retail sales and use taxes, other than the local sales 9 and use taxes authorized by RCW 82.14.510 for the applicable 10 11 revitalization area, imposed on the same taxable events that are 12 credited against the state retail sales and use taxes under RCW 82.08.020(1) and 82.12.020. 13
- $((\frac{27}{1}))$ (28) "Taxing district" means a government entity that levies or has levied for it regular property taxes upon real property located within a proposed or approved revitalization area.

- Sec. 2. RCW 39.104.100 and 2010 c 164 s 6 are each amended to read as follows:
- (1) Prior to applying ((to the department)) to receive a state contribution, a sponsoring local government ((shall)) must adopt a revitalization area within the limitations in RCW 39.104.050 and in accordance with RCW 39.104.040.
 - (2)(a) As a condition to imposing a sales and use tax under RCW 82.14.510, a sponsoring local government must apply ((to the department)) and be approved for a project award amount. - (d) Applications that are not approved for a project award due to lack of available state contribution must be retained on file by the ((department in order of the date of their receipt)) approving agency.

(e)(i) Except as provided in (e)(ii) of this subsection, once total project awards reach the amount of annual state contribution limit, no more applications will be accepted.

- (ii) Any city or county that has been approved for a project award by the department prior to January 1, 2011, and has not imposed a sales and use tax under RCW 82.14.510 by December 31, 2016, must forfeit their project award. However, amounts will not be forfeited if a city or county has sent the department a letter indicating its intent to impose the sales and use tax by July 1, 2022, before July 1, 2016. Amounts forfeited under this section must be made available for new applications under subsection (5) of this section.
- (f) If the annual contribution limit is increased by making additional funds available for applicants ((that apply on a first-come basis)) or if funds become available from project awards forfeited under (e)(ii) of this subsection, applications will be accepted again ((beginning sixty days after the effective date of the increase. However, in the time period before any new applications are accepted, all sponsoring local governments with a complete application already on file with the department must be provided an opportunity to either withdraw their application or update the information in the application. The updated application must be for a project that is substantially the same as the project in the original application. The department must consider these applications, in the order originally submitted, for project awards prior to considering any new applications)) as described in subsection (5) of this section.

- (1) Any city or county that has been approved for a project award under RCW 39.104.100 may impose a sales and use tax under the authority of this section in accordance with the terms of this chapter. Except as provided in this section, the tax is in addition to other taxes authorized by law and must be collected from those persons who are taxable by the state under chapters 82.08 and 82.12 RCW upon the occurrence of any taxable event within the taxing jurisdiction of the city or county.
- (2) The tax authorized under subsection (1) of this section is credited against the state taxes imposed under RCW 82.08.020(1) and 82.12.020 at the rate provided in RCW 82.08.020(1). The department must perform the collection of such taxes on behalf of the city or county at no cost to the city or county. The taxes must be distributed to cities and counties as provided in RCW 82.14.060.

- 23 (a) "Local sales and use taxes" means sales and use taxes imposed 24 by cities, counties, public facilities districts, and other local 25 governments under the authority of this chapter $((\Theta r))$, chapter 67.28 26 RCW, or any other chapter, and that are credited against the state 27 sales and use taxes.
- 28 (b) "State sales and use taxes" means the taxes imposed in RCW 29 82.08.020(1) and 82.12.020.
- 30 **Sec. 5.** RCW 82.32.765 and 2010 c 164 s 10 are each amended to 31 read as follows:
- 32 (1) A sponsoring local government receiving a project award under 33 RCW 39.104.100 must provide a report to the department by March 1st 34 of each year beginning March 1st after the project award has been 35 approved. The report must contain the following information:
- 36 (a) The amounts of local property tax allocation revenues 37 received in the preceding calendar year broken down by sponsoring 38 local government and participating taxing district;

1 (b) The amount of state property tax allocation revenues 2 estimated to have been received by the state in the preceding 3 calendar year;

- (c) The amount of local sales and use tax and other revenue from local public sources dedicated by any participating local government used for the payment of bonds under RCW 39.104.110 and public improvement costs within the revitalization area on a pay-as-you-go basis in the preceding calendar year;
- (d) The amount of local sales and use tax dedicated by the sponsoring local government, as it relates to the sponsoring local government's local sales and use tax increment, used for the payment of bonds under RCW 39.104.110 and public improvement costs within the revitalization area on a pay-as-you-go basis;
- (e) The amounts, other than those listed in (a) through (d) of this subsection, from local public sources, broken down by type or source, used for payment of bonds under RCW 39.104.110 or public improvement costs within the revitalization area on a pay-as-you-go basis in the preceding calendar year;
- (f) The anticipated date when bonds under RCW 39.104.110 are expected to be retired;
 - (g) The names of any businesses locating within the revitalization area as a result of the public improvements undertaken by the sponsoring local government and financed in whole or in part with local revitalization financing;
 - (h) An estimate of the cumulative number of permanent jobs created in the revitalization area as a result of the public improvements undertaken by the sponsoring local government and financed in whole or in part with local revitalization financing;
 - (i) An estimate of the average wages and benefits received by all employees of businesses locating within the revitalization area as a result of the public improvements undertaken by the sponsoring local government and financed in whole or in part with local revitalization financing;
- 34 (j) A list of public improvements financed by bonds issued under 35 RCW 39.104.110 and the date on which the bonds are anticipated to be 36 retired;
- 37 (k) That the sponsoring local government is in compliance with 38 RCW 39.104.030;
- 39 (1) At least once every three years, updated estimates of the 40 amounts of state and local sales and use tax increments estimated to

- 1 have been received since the approval ((by the department)) of the 2 project award under RCW 39.104.100;
- (m) The amount of revenues from local public sources that (i) 3 were expended in prior years for the payment of bonds under RCW 4 39.104.110 and public improvement costs within the revitalization 5 6 area on a pay-as-you-go basis in prior calendar years that were in excess of the project award amount for that year and are carried 7 forward for dedication in future years, (ii) are deemed dedicated to 8 payment of bonds or public improvement costs in the calendar year for 9 which the report is prepared, and (iii) remain available for 10 11 dedication in future years; and
- 12 (n) Any other information required by the department to enable 13 the department to fulfill its duties under this chapter and RCW 14 82.14.510.
- 15 (2) The department must make a report available to the public and 16 the legislature by June 1st of each year. The report must include a 17 summary of the information provided to the department by sponsoring 18 local governments under subsection (1) of this section.
