1 AN ACT Relating to payments in lieu of real property taxes by the
2 department of fish and wildlife; amending RCW 77.12.203; providing an
3 effective date; and declaring an emergency.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 77.12.203 and 2019 c 415 s 983 are each amended to
6 read as follows:

7 (1) (~~Except as provided in subsections (5), (6), and (7) of this~~
8 ~~section and notwithstanding~~) Notwithstanding RCW 84.36.010 or other
9 statutes to the contrary, the (~~director must pay~~) state treasurer,
10 on behalf of the department, must distribute to counties by April
11 30th of each year on game lands, regardless of acreage, in each
12 county, if requested by an election under RCW 77.12.201, an amount in
13 lieu of real property taxes equal to that amount paid on similar
14 parcels of open space land taxable under chapter 84.34 RCW or the
15 greater of seventy cents per acre per year or the amount paid in 1984
16 plus an additional amount for control of noxious weeds equal to that
17 which would be paid if such lands were privately owned. This amount
18 may not be assessed or paid on department buildings, structures,
19 facilities, game farms, fish hatcheries, water access sites,
20 tidelands, or public fishing areas.

1 (2) "Game lands," as used in this section and RCW 77.12.201,
2 means those tracts, regardless of acreage, owned in fee by the
3 department and used for wildlife habitat and public recreational
4 purposes. All lands purchased for wildlife habitat, public access, or
5 recreation purposes with federal funds in the Snake River drainage
6 basin are considered game lands regardless of acreage.

7 (3) This section does not apply to lands transferred after April
8 23, 1990, to the department from other state agencies.

9 (4) The county must distribute the amount received under this
10 section in lieu of real property taxes to all property taxing
11 districts except the state in appropriate tax code areas the same way
12 it would distribute local property taxes from private property. The
13 county must distribute the amount received under this section for
14 weed control to the appropriate weed district.

Note: Governor's explanation of partial veto is as follows:

"I am returning herewith, without my approval as to Section 2, Senate Bill No. 5159 entitled:

"AN ACT Relating to payments in lieu of real property taxes by the department of fish and wildlife."

This bill improves the method the state uses to pay counties for payments in lieu of taxes for lands owned by the Department of Fish and Wildlife. Counties distribute these payments to local taxing districts in the same manner they distribute property taxes supporting things like schools, emergency services, and noxious weed control. Section 2 sets an emergency effective date for the bill of July 1, 2021. The emergency effective date is unnecessary as payments to counties are due in April each year, not in July. The next payment to counties will be made in April 2022 and an emergency effective date is not needed to issue those payments. For this reason, I am vetoing section 2 of SB 5159.

For these reasons I have vetoed Section 2 of Senate Bill No. 5159.

With the exception of Section 2, Senate Bill No. 5159 is approved."
