## SENATE BILL 5252

Passed Legislature - 2017 3rd Special Session

State of Washington 65th Legislature 2017 Regular Session

Read first time 01/18/17. Referred to Committee on Human Services, Mental Health & Housing.

1 AN ACT Relating to measuring the effectiveness of document 2 recording fee surcharge funds that support homeless programs; 3 amending RCW 43.185C.040; and creating a new section.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

The legislature finds that a surcharge on 5 NEW SECTION. Sec. 1. 6 documents recorded for the sale or transfer of real property have 7 generated approximately one hundred forty million dollars for homeless programs in Washington. The legislature further finds that 8 according to a third-party audit of the use of surcharge funds, 9 10 additional performance measures are needed to effectively measure the 11 success of the state's homeless programs. Therefore, the legislature 12 to finds that developing and adopting recommendations improve 13 performance measures contained in the December 5, 2016, report 14 required under RCW 43.185C.240(1)(e) will help ensure accountability 15 and transparency of public funds and their effectiveness in reducing 16 homelessness in Washington.

17 **Sec. 2.** RCW 43.185C.040 and 2015 c 69 s 25 are each amended to 18 read as follows:

(1) Six months after the first Washington homeless census, thedepartment shall, in consultation with the interagency council on

1 homelessness and the affordable housing advisory board, prepare and publish a ten-year homeless housing strategic plan which shall 2 outline statewide goals and performance measures and shall be 3 coordinated with the plan for homeless families with children 4 required under RCW 43.63A.650. To quide local governments in 5 6 preparation of their first local homeless housing plans due December 31, 2005, the department shall issue by October 15, 2005, temporary 7 quidelines consistent with this chapter and including the best 8 available data on each community's homeless population. 9 Local governments' ten-year homeless housing plans not 10 shall be 11 substantially inconsistent with the goals and program recommendations 12 of the temporary guidelines and, when amended after 2005, the state 13 strategic plan.

14 (2) Program outcomes and performance measures and goals shall be 15 created by the department and reflected in the department's homeless 16 housing strategic plan as well as interim goals against which state 17 and local governments' performance may be measured, including:

(a) By the end of year one, completion of the first census asdescribed in RCW 43.185C.030;

(b) By the end of each subsequent year, goals common to all local programs which are measurable and the achievement of which would move that community toward housing its homeless population; and

(c) By July 1, 2015, reduction of the homeless populationstatewide and in each county by fifty percent.

25 (3)(a) The department shall work in consultation with the interagency council on homelessness, the affordable housing advisory 26 board, and the state advisory council on homelessness to develop 27 28 performance measures that address the limitations of the annual point-in-time count on measuring the effectiveness of the document 29 recording fee surcharge funds in supporting homeless programs. The 30 31 department must report its findings and recommendations regarding the new performance measures to the appropriate committees of the 32 33 legislature by December 1, 2017.

34 (b) The department must implement at least three performance 35 metrics, in addition to the point-in-time measurement, that measure 36 the impact of surcharge funding on reducing homelessness by July 1, 37 2018.

38 (c) The joint legislative audit and review committee must review
39 how the surcharge fees are expended to address homelessness,
40 including a review of the related program performance measures and

1 <u>targets. The joint legislative audit and review committee must report</u>
2 <u>its review findings by December 1, 2022, and update the review every</u>
3 five years thereafter.

4 <u>(4)</u> The department shall develop a consistent statewide data 5 gathering instrument to monitor the performance of cities and 6 counties receiving grants in order to determine compliance with the 7 terms and conditions set forth in the grant application or required 8 by the department.

The department shall, in consultation with the interagency 9 council on homelessness and the affordable housing advisory board, 10 11 report biennially to the governor and the appropriate committees of 12 legislature an assessment of the state's performance the in furthering the goals of the state ten-year homeless housing strategic 13 14 plan and the performance of each participating local government in creating and executing a local homeless housing plan which meets the 15 requirements of this chapter. To increase the effectiveness of the 16 17 report, the department must develop a process to ensure consistent presentation, analysis, and explanation in the report, including 18 year-to-year comparisons, highlights of program successes and 19 challenges, and information that supports recommended strategy or 20 operational changes. The annual report may include performance 21 22 measures such as:

(a) The reduction in the number of homeless individuals andfamilies from the initial count of homeless persons;

(b) The reduction in the number of unaccompanied homeless youth.
"Unaccompanied homeless youth" has the same meaning as in RCW 43.330.702;

(c) The number of new units available and affordable for homelessfamilies by housing type;

30 (d) The number of homeless individuals identified who are not 31 offered suitable housing within thirty days of their request or 32 identification as homeless;

33 (e) The number of households at risk of losing housing who 34 maintain it due to a preventive intervention;

35 (f) The transition time from homelessness to permanent housing;

36 (g) The cost per person housed at each level of the housing 37 continuum;

38 (h) The ability to successfully collect data and report 39 performance;

1 (i) The extent of collaboration and coordination among public 2 bodies, as well as community stakeholders, and the level of community 3 support and participation;

(j) The quality and safety of housing provided; and

4

5 (k) The effectiveness of outreach to homeless persons, and their 6 satisfaction with the program.

7 (((4))) (5) Based on the performance of local homeless housing 8 programs in meeting their interim goals, on general population 9 changes and on changes in the homeless population recorded in the 10 annual census, the department may revise the performance measures and 11 goals of the state homeless housing strategic plan, set goals for 12 years following the initial ten-year period, and recommend changes in 13 local governments' plans.
