PART I

ARTICLE 1

GENERAL PROVISIONS

35 <u>NEW SECTION.</u> Sec. 1101. SHORT TITLE. This chapter may be known 36 and cited as the uniform business organizations code—general 37 provisions.

1 NEW SECTION. Sec. 1102. DEFINITIONS. The definitions in this 2 section apply throughout this chapter unless the context clearly requires otherwise or as set forth in section 1401 or 1601 of this 3 4 act. 5 (1) "Annual report" means the report required by section 1212 of 6 this act. 7 (2) "Business corporation" means a domestic business corporation incorporated under or subject to Title 23B RCW or a foreign business 8 9 corporation. (3) "Commercial registered agent" means a person listed under 10 section 1405 of this act. 11 12 (4) "Domestic," with respect to an entity, means governed as to its internal affairs by the law of this state. 13 14 (5) "Electronic transmission" means an electronic communication: (a) Not directly involving the physical transfer of a record in a 15 16 tangible medium; and 17 (b) That may be retained, retrieved, and reviewed by the sender and the recipient thereof, and that may be directly reproduced in a 18 19 tangible medium by such a sender and recipient. (6) "Entity" means: 20 21 (a) A business corporation; 22 (b) A nonprofit corporation; (c) A limited liability partnership; 23 (d) A limited partnership; 24 25 (e) A limited liability company; or 26 (f) A general cooperative association. (7) "Entity filing" means a record delivered to the secretary of 27 state for filing pursuant to this chapter. 28 (8) "Execute," "executes," or "executed" means: 29 (a) Signed with respect to a written record; 30 31 (b) Electronically transmitted along with sufficient information 32 to determine the sender's identity with respect to an electronic 33 transmission; or (c) With respect to a record to be filed with the secretary of 34 state, in compliance with the standards for filing with the office of 35 36 the secretary of state as prescribed by the secretary of state. (9) "Filed record" means a record filed by the secretary of state 37 38 pursuant to this chapter.

1 (10) "Foreign," with respect to an entity, means governed as to its internal affairs by the law of a jurisdiction other than this 2 3 state. (11) "General cooperative association" means a domestic general 4 cooperative association formed under or subject to chapter 23.86 RCW. 5 (12) "Governor" means: 6 7 (a) A director of a business corporation; (b) A director of a nonprofit corporation; 8 (c) A partner of a limited liability partnership; 9 (d) A general partner of a limited partnership; 10 11 (e) A manager of a manager-managed limited liability company; (f) A member of a member-managed limited liability company; 12 (g) A director of a general cooperative association; or 13 14 (h) Any other person under whose authority the powers of an entity are exercised and under whose direction the activities and 15 16 affairs of the entity are managed pursuant to the organic law and 17 organic rules of the entity. (13) "Interest" means: 18 (a) A share in a business corporation; 19 (b) A membership in a nonprofit corporation; 20 21 (c) A share in a nonprofit corporation formed under chapter 24.06 22 RCW; (d) A partnership interest in a limited liability partnership; 23 24 (e) A partnership interest in a limited partnership; 25 (f) A limited liability company interest; or 26 (g) A share or membership in a general cooperative association. (14) "Interest holder" means: 27 (a) A shareholder of a business corporation; 28 29 (b) A member of a nonprofit corporation; (c) A shareholder of a nonprofit corporation formed under chapter 30 31 24.06 RCW; (d) A partner of a limited liability partnership; 32 (e) A general partner of a limited partnership; 33 (f) A limited partner of a limited partnership; 34 (g) A member of a limited liability company; or 35 36 (h) A shareholder or member of a general cooperative association. (15) "Jurisdiction" when used to refer to a political entity, 37 means the United States, a state, a foreign country, or a political 38 subdivision of a foreign country. 39

(16) "Jurisdiction of formation" means the jurisdiction whose law
 includes the organic law of an entity.

3 (17) "Limited liability company" means a domestic limited
4 liability company formed under or subject to chapter 25.15 RCW or a
5 foreign limited liability company.

6 (18) "Limited liability limited partnership" means a domestic 7 limited liability limited partnership formed under or subject to 8 chapter 25.10 RCW or a foreign limited liability limited partnership.

9 (19) "Limited liability partnership" means a domestic limited 10 liability partnership registered under or subject to chapter 25.05 11 RCW or a foreign limited liability partnership.

12 (20) "Limited partnership" means a domestic limited partnership 13 formed under or subject to chapter 25.10 RCW or a foreign limited 14 partnership. "Limited partnership" includes a limited liability 15 limited partnership.

16 (21) "Noncommercial registered agent" means a person that is not 17 a commercial registered agent and is:

(a) An individual or domestic or foreign entity that serves inthis state as the registered agent of an entity;

(b) An individual who holds the office or other position in an entity which is designated as the registered agent pursuant to section 1404(1)(b)(ii) of this act; or

(c) A government, governmental subdivision, agency, or
 instrumentality, or a separate legal entity comprised of two or more
 of these entities, that serves as the registered agent of an entity.

(22) "Nonprofit corporation" means a domestic nonprofit
 corporation incorporated under or subject to chapter 24.03 or 24.06
 RCW or a foreign nonprofit corporation.

(23) "Nonregistered foreign entity" means a foreign entity that
 is not registered to do business in this state pursuant to a
 statement of registration filed by the secretary of state.

32 (24) "Organic law" means the law of an entity's jurisdiction of33 formation governing the internal affairs of the entity.

34 (25) "Organic rules" means the public organic record and private35 organic rules of an entity.

36 (26) "Person" means an individual, business corporation, nonprofit corporation, partnership, limited partnership, 37 limited liability company, general cooperative association, 38 limited 39 cooperative association, unincorporated nonprofit association, 40 statutory trust, business trust, common-law business trust, estate,

1 trust, association, joint venture, public corporation, government or 2 governmental subdivision, agency, or instrumentality, or any other 3 legal or commercial entity.

4 (27) "Principal office" means the principal executive office of 5 an entity, whether or not the office is located in this state.

6 (28) "Private organic rules" means the rules, whether or not in a 7 record, that govern the internal affairs of an entity, are binding on 8 all its interest holders, and are not part of its public organic 9 record, if any. "Private organic rules" includes:

(a) The bylaws of a business corporation and any agreement amongshareholders pursuant to RCW 23B.07.320;

12 (b) The bylaws of a nonprofit corporation;

13 (c) The partnership agreement of a limited liability partnership;

14 (d) The partnership agreement of a limited partnership;

15 (e) The limited liability company agreement; and

16 (f) The bylaws of a general cooperative association.

17 (29) "Proceeding" means civil suit and criminal, administrative,18 and investigatory action.

19 (30) "Property" means all property, whether real, personal, or 20 mixed or tangible or intangible, or any right or interest therein.

(31) "Public organic record" means the record the filing of which by the secretary of state is required to form an entity and any amendment to or restatement of that record. The term includes:

24 (a) The articles of incorporation of a business corporation;

25 (b) The articles of incorporation of a nonprofit corporation;

26 (c) The certificate of limited partnership of a limited 27 partnership;

28 (d) The certificate of formation of a limited liability company;

(e) The articles of incorporation of a general cooperativeassociation; and

31 (f) The document under the laws of another jurisdiction that is 32 equivalent to a document listed in this subsection.

33 (32) "Receipt," as used in this chapter, means actual receipt.34 "Receive" has a corresponding meaning.

35 (33) "Record" means information inscribed on a tangible medium or 36 contained in an electronic transmission.

37 (34) "Registered agent" means an agent of an entity which is 38 authorized to receive service of any process, notice, or demand 39 required or permitted by law to be served on the entity. The term

1 includes a commercial registered agent and a noncommercial registered 2 agent. (35) "Registered foreign entity" means a foreign entity that is 3 registered to do business in this state pursuant to a certificate of 4 registration filed by the secretary of state. 5 б (36) "State" means a state of the United States, the District of 7 Columbia, Puerto Rico, the United States Virgin Islands, or any territory or insular possession subject to the jurisdiction of the 8 9 United States. (37) "Transfer" includes: 10 11 (a) An assignment; 12 (b) A conveyance; (c) A sale; 13 14 (d) A lease; (e) An encumbrance, including a mortgage or security interest; 15 (f) A change of record owner of interest; 16 17 (g) A gift; and (h) A transfer by operation of law. 18 (38) "Type of entity" means a generic form of entity: 19 20 (a) Recognized at common law; or 21 (b) Formed under an organic law, whether or not some entities formed under that law are subject to provisions of that law that 22 create different categories of the form of entity. 23 (39) "Writing" does not include an electronic transmission. 24 25 (40) "Written" means embodied in a tangible medium. 26

26 <u>NEW SECTION.</u> Sec. 1103. DELIVERY OF RECORD. (1) Except as 27 otherwise provided in this chapter, permissible means of delivery of 28 a record include delivery by hand, United States mail, private 29 courier service, and electronic transmission.

30 (2) Records may be delivered to the secretary of state by 31 electronic transmission as authorized by the secretary of state 32 pursuant to section 1104(2) of this act. The secretary of state may 33 deliver a record to an entity by electronic transmission if the 34 entity has designated an address, location, or system to which the 35 record may be electronically transmitted.

36 <u>NEW SECTION.</u> **Sec. 1104.** RULES AND PROCEDURES. (1) The secretary 37 of state has the power reasonably necessary to perform the duties 38 required by this chapter, including adoption, amendment, or repeal of 1 rules under chapter 34.05 RCW for the efficient administration of 2 this chapter.

The secretary of state may adopt rules to facilitate 3 (2) electronic filing. The rules will detail the circumstances under 4 which the electronic filing of documents will be permitted, how the 5 6 documents will be filed, and how the secretary of state will return 7 filed documents. The rules may also impose additional requirements related to implementation of electronic filing processes, including 8 9 but not limited to file formats, signature technologies, delivery, and the types of entities, records, or documents permitted. 10

ARTICLE 2 FILING

13 <u>NEW SECTION.</u> Sec. 1201. ENTITY FILING REQUIREMENTS. (1) To be 14 filed by the secretary of state pursuant to this chapter, an entity 15 filing must be received by the secretary of state, comply with this 16 chapter, and satisfy the following:

17 (a) The entity filing must be required or permitted by Title 23,18 23B, 24, or 25 RCW.

(b) The entity filing must be delivered in written form unless and to the extent the secretary of state permits electronic delivery of entity filings pursuant to section 1104(2) of this act.

(c) The words in the entity filing must be in English, and numbers must be in Arabic or Roman numerals, but the name of the entity need not be in English if written in English letters or Arabic or Roman numerals.

(d) The entity filing must be executed by or on behalf of a person authorized or required under this chapter or the entity's organic law to execute the filing.

(e) The entity filing must state the name and capacity, if any, of each individual who executed it, on behalf of either the individual or the person authorized or required to execute the filing, but need not contain a seal, attestation, acknowledgment, or verification.

34 (2) When an entity filing is delivered to the secretary of state 35 for filing, any fee required under this chapter and any fee, 36 interest, or penalty required to be paid under this chapter or law 37 other than this chapter must be paid in a manner permitted by the 38 secretary of state or by that law.

1 (3) The secretary of state may require that an entity filing 2 delivered in written form be accompanied by an identical or conformed 3 copy.

4 (4) A record filed under this chapter may be executed by an 5 individual acting in a valid representative capacity.

6 <u>NEW SECTION.</u> Sec. 1202. FORMS. (1) The secretary of state may 7 provide forms for entity filings required or permitted to be made by 8 Title 23, 23B, 24, or 25 RCW, but, except as otherwise provided in 9 subsection (2) of this section, their use is not required.

10 (2) The secretary of state may require that a cover sheet for an 11 entity filing and an annual report be on forms prescribed by the 12 secretary of state.

13 <u>NEW SECTION.</u> **Sec. 1203.** EFFECTIVE DATE AND TIME. Except as 14 otherwise provided in this chapter and subject to section 1205(4) of 15 this act, an entity filing is effective:

16 (1) On the date of filing and at the time specified in the entity 17 filing as its effective time;

(2) Unless prohibited by the entity's organic law, at a specified
delayed effective date and time, which may not be more than ninety
days after the date of filing;

(3) If a delayed effective date is specified, but no time isspecified, at 12:01 a.m. on the date specified; or

(4) If subsection (1), (2), or (3) of this section does not apply, on the date and at the time of its filing by the secretary of state as provided in section 1206 of this act.

26 <u>NEW SECTION.</u> Sec. 1204. WITHDRAWAL OF FILED RECORD BEFORE 27 EFFECTIVENESS. (1) Except as otherwise provided in this chapter, a 28 filed record may be withdrawn before it takes effect by delivering to 29 the secretary of state for filing a statement of withdrawal.

30

(2) A statement of withdrawal must:

31 (a) Be executed by an individual acting in a valid representative32 capacity; and

33 (b) Identify the filed record to be withdrawn.

(3) On filing by the secretary of state of a statement of
 withdrawal, the action or transaction evidenced by the original filed
 record shall not take effect.

<u>NEW SECTION.</u> Sec. 1205. CORRECTING FILED RECORD. (1) An entity
 may correct a filed record if:

3 (a) The filed record at the time of filing contained an 4 inaccurate statement;

5 (b) The filed record was defectively executed; or

6 (c) The electronic transmission of the filed record to the 7 secretary of state was defective.

8 (2) To correct a filed record, the entity must deliver to the 9 secretary of state for filing a statement of correction.

10 (3) A statement of correction:

11 (a) May not state a delayed effective date;

12 (b) Must be executed by the individual correcting the filed 13 record;

14 (c) Must identify the filed record to be corrected;

15 (d) Must specify the inaccuracy or defect to be corrected; and

16 (e) Must correct the inaccuracy or defect.

17 (4) A statement of correction is effective as of the effective 18 date of the filed record that it corrects except as to persons 19 relying on the uncorrected filed record and adversely affected by the 20 correction. As to those persons, the statement of correction is 21 effective when filed.

22 <u>NEW SECTION.</u> Sec. 1206. DUTY OF SECRETARY OF STATE TO FILE; 23 REVIEW OF REFUSAL TO FILE. (1) The secretary of state shall file an 24 entity filing that satisfies this chapter. The duty of the secretary 25 of state under this section is ministerial.

(2) The secretary of state shall record an entity filing on the date and at the time of its receipt. After filing an entity filing, the secretary of state shall deliver to the person that submitted the filing a copy of the filed record with an acknowledgment of the date and time of filing.

31 (3) If the secretary of state refuses to file an entity filing, 32 the secretary of state not later than fifteen business days after the 33 filing is received, shall:

34 (a) Return the entity filing or notify the person that submitted35 the filing of the refusal; and

36 (b) Provide a brief explanation in a record of the reason for the 37 refusal.

(4) If the secretary of state refuses to file an entity filing,the person that submitted the entity filing may petition the superior

court to compel its filing. The entity filing and the explanation of
 the secretary of state of the refusal to file must be attached to the
 petition. The court may decide the matter in a summary proceeding.

(5) The filing of or refusal to file an entity filing does not:

5 (a) Affect the validity or invalidity of the entity filing in6 whole or in part;

7 (b) Relate to the correctness or incorrectness of information 8 contained in the entity filing; or

9 (c) Create a presumption that the information contained in the 10 filing is correct or incorrect.

11 <u>NEW SECTION.</u> Sec. 1207. EVIDENTIARY EFFECT OF COPY OF FILED 12 RECORD. A certification from the secretary of state accompanying a 13 copy of a filed record is conclusive evidence that the copy is an 14 accurate representation of the original record on file with the 15 secretary of state.

16 <u>NEW SECTION.</u> Sec. 1208. CERTIFICATE OF EXISTENCE OR 17 REGISTRATION. (1) On request of any person, the secretary of state 18 shall issue a certificate of existence for a domestic entity or a 19 certificate of registration for a registered foreign entity.

20 (2) A certificate under subsection (1) of this section must 21 state:

(a) The domestic entity's name or the registered foreign entity'sname used in this state;

24 (b) In the case of a domestic entity:

25 (i) That its public organic record has been filed and has taken 26 effect;

27 (ii) The date the public organic record became effective;

(iii) The period of the entity's duration if the records of the
secretary of state reflect that the entity's period of duration is
less than perpetual; and

31 (iv) That the records of the secretary of state do not reflect 32 that the entity has been dissolved;

33 (c) In the case of a registered foreign entity, that it is 34 registered to do business in this state;

35 (d) That all fees, interest, and penalties owed to this state by 36 the domestic or foreign entity and collected through the secretary of 37 state have been paid, if:

1 (i) Payment is reflected in the records of the secretary of 2 state; and

(ii) Nonpayment affects the existence or registration of the 3 domestic or foreign entity; 4

(e) That the most recent annual report required by section 1212 5 б of this act has been delivered to the secretary of state for filing;

7 (f) That a proceeding is not pending under section 1603 of this 8 act; and

(g) Other facts reflected in the records of the secretary of 9 state pertaining to the domestic or foreign entity which the person 10 11 requesting the certificate reasonably requests.

(3) Subject to any qualification stated in the certificate, a 12 certificate issued by the secretary of state under subsection (1) of 13 this section may be relied upon as conclusive evidence of the facts 14 stated in the certificate. 15

16 Sec. 1209. EXECUTION OF ENTITY FILING. (1) Any NEW SECTION. person who executes a record the person knows is false in any 17 material respect with the intent the record be an entity filing is 18 guilty of a gross misdemeanor punishable under chapter 9A.20 RCW. 19

20 (2) A person that executes an entity filing as an agent or legal representative thereby affirms as a fact that the person 21 is authorized to execute the entity filing. 22

23 Sec. 1210. EXECUTION AND FILING PURSUANT TO NEW SECTION. 24 JUDICIAL ORDER. (1) If a person required by the entity's organic law to execute a record that is to be an entity filing or to make an 25 entity filing does not do so, any other person that is aggrieved may 26 petition the superior court to order: 27

(a) The person to execute the record; 28

29

(b) The person to make the entity filing; or

(c) The secretary of state to file the entity filing unexecuted. 30

(2) If the petitioner under subsection (1) of this section is not 31 the entity to which the entity filing pertains, the petitioner shall 32 33 make the entity a party to the action.

34 (3) A filed record created under subsection (1)(c) of this section is effective without being executed. 35

36 Sec. 1211. DELIVERY BY SECRETARY OF STATE. Except NEW SECTION. as otherwise provided by section 1411 of this act or by law of this 37

state other than this chapter, the secretary of state may deliver a record to a person by delivering it:

3 (1) In person to the person that submitted it for filing;

4 (2) To the address of the person's registered agent;

5 (3) To the principal office address of the person; or

6 (4) To another address the person provides to the secretary of 7 state for delivery.

8 <u>NEW SECTION.</u> Sec. 1212. (3) Information in an initial or annual report must be current asof the date the report is executed by the entity.

(4) Annual reports must be delivered to the secretary of state on

36 (5) If an initial or annual report does not contain the 37 information required by this section, the secretary of state promptly 38 shall notify the reporting entity in a record and return the report 39 for correction. 1 (6) If an initial or annual report contains the name or address 2 of a registered agent that differs from the information shown in the 3 records of the secretary of state immediately before the annual 4 report becomes effective, the differing information in the initial or 5 annual report is considered a statement of change under section 1407 6 of this act.

7 (7) The secretary of state shall send to each domestic entity and registered foreign entity, not less than thirty or more than ninety 8 days prior to the expiration date of the entity's annual renewal, a 9 notice that the entity's annual report must be filed as required by 10 11 this chapter and that any applicable annual renewal fee must be paid, and stating that if the entity fails to file its annual report or pay 12 the annual renewal fee it will be administratively dissolved. The 13 14 notice may be sent by postal or electronic mail as elected by the entity, addressed to its registered agent within the state, or to an 15 electronic address designated by the entity in a record retained by 16 17 the secretary of state. Failure of the secretary of state to provide any such notice does not relieve a domestic entity or registered 18 foreign entity from its obligations to file the annual report 19 required by this chapter or to pay any applicable annual renewal fee. 20 21 The option to receive the notice provided under this section by electronic mail may be selected only when the secretary of state 22 makes the option available. 23

(5) Service of process, notice, or demand on a registered agent must be in a written record, but service may be made on a commercial registered agent in other forms, and subject to such requirements, as the agent has stated in its listing under section 1405 of this act that it will accept.

17 (6) Service of process, notice, or demand may be made by other 18 means under law other than this chapter.

19 <u>NEW SECTION.</u> Sec. 1412. DUTIES OF REGISTERED AGENT. The only 20 duties under this chapter of a registered agent that has complied 21 with this chapter are:

(1) To forward to the represented entity at the address most recently supplied to the agent by the entity any process, notice, or demand pertaining to the entity which is served on or received by the agent;

(2) To provide the notices required by this chapter to the entityat the address most recently supplied to the agent by the entity;

The address of the agent does not determine 38 venue in an action or a proceeding involving the entity.

ARTICLE 7

MISCELLANEOUS PROVISIONS

37 38 1 <u>NEW SECTION.</u> Sec. 1701. RESERVATION OF POWER TO AMEND OR 2 REPEAL. The legislature has power to amend or repeal all or part of 3 this chapter at any time, and all domestic and foreign entities 4 subject to this chapter are governed by the amendment or repeal.

5 <u>NEW SECTION.</u> Sec. 1702. SUPPLEMENTAL PRINCIPLES OF LAW. Unless 6 displaced by particular provisions of this chapter, the principles of 7 law and equity supplement this chapter.

Sec. 1703. RELATION TO ELECTRONIC SIGNATURES IN 8 NEW SECTION. 9 GLOBAL AND NATIONAL COMMERCE ACT. This chapter modifies, limits, and 10 supersedes the electronic signatures in global and national commerce 11 act, 15 U.S.C. Sec. 7001 et seq., but does not modify, limit, or 12 supersede Sec. 101(c) of that act, 15 U.S.C. Sec. 7001(c), or 13 authorize electronic delivery of any of the notices described in 14 section 103(b) of that act, 15 U.S.C. Sec. 7003(b).

15 <u>NEW SECTION.</u> Sec. 1704. SAVINGS CLAUSE. The repeal of a statute 16 by this act does not affect:

(1) A record <u>required or permitted by this title to be filed in</u> <u>the office of the secretary of state</u> must satisfy the requirements of <u>part I, Article 2 of this act</u>, this section, and ((of)) any other section that adds to or varies from these requirements, to be entitled to filing by the secretary of state.

16 (2) ((The secretary of state may permit records to be filed through electronic transmission. The secretary of state may adopt 17 18 rules varying from these requirements to facilitate electronic filing. These rules shall detail the circumstances under which the 19 electronic filing of records shall be permitted and how such records 20 shall be filed. These rules may also impose additional requirements 21 22 related to implementation of electronic filing processes including 23 but not limited to: File formats; signature technologies; the manner of delivery; and the types of entities or records permitted. 24
