SUBSTITUTE SENATE BILL 5470

State of Washington 68th Legislature 2023 Regular Session

By Senate Health & Long Term Care (originally sponsored by Senators Trudeau, Short, Lovelett, Nguyen, Randall, Saldaña, Shewmake, and C. Wilson)

- AN ACT Relating to creating a new health profession for lactation consultants; amending RCW 18.120.020 and 18.130.040; adding a new chapter to Title 18 RCW; creating a new section; and providing
- 4 effective dates.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- NEW SECTION. Sec. 1. The definitions in this section apply throughout this chapter unless the context clearly requires otherwise.
- 9 (1) "Department" means the department of health.
- 10 (2) "Lactation care and services" means the clinical application 11 of scientific principles and a multidisciplinary body of evidence for 12 evaluation, problem identification, treatment, education, and 13 consultation to provide lactation care and services to childbearing 14 families.
- 15 (3) "Lactation consultant" means a person certified under this 16 chapter to provide lactation care and services.
- 17 (4) "Secretary" means the secretary of health.
- NEW SECTION. Sec. 2. (1) A lactation consultant may voluntarily apply for certification from the department under this section.

- 1 (2) The department shall issue a certification to any applicant 2 who has met the following requirements:
 - (a) (i) Board certification by a secretary-approved national or international certifying organization that, at a minimum, requires the following for board certification:
 - (A) 90 hours of lactation-specific education;
- 7 (B) 24 college-level academic credits in health professional 8 courses; and
 - (C) At least 300 hours of clinical practice; or
- 10 (ii) Equivalent education and experience approved by the 11 secretary. The education, clinical training, and experience of 12 licensed midwives and certified nurse midwives may be considered as 13 credit toward lactation consultant certification;
 - (b) Passage of an examination approved by the secretary;
- (c) Good moral character;

- 16 (d) The physical and mental capability to safely provide 17 lactation care and services;
- 18 (e) Submission of an application on a form provided by the 19 department;
- 20 (f) Payment of a certification fee established by the secretary 21 in rule; and
- 22 (g) Has not engaged in unprofessional conduct as defined in RCW 23 18.130.180.
- 24 (3) The uniform disciplinary act, chapter 18.130 RCW, governs the 25 issuance and denial of certifications and the discipline of certified 26 lactation consultants under this chapter. The secretary is the 27 disciplining authority under this chapter.
- 28 (4) The secretary shall adopt rules specifying the requirements 29 for renewal of a lactation consultant's certification including, but 30 not limited to:
 - (a) Reasonably appropriate evidence of competency, as long as such requirements are uniform as to application, are reasonably related to the measurement of qualification, performance, or competence, and are desirable and necessary for the protection of public health; and
- 36 (b) Continuing education requirements consistent with the 37 requirements of the certifying organization approved under subsection 38 (2)(a)(i) of this section. The rules must allow an applicant to 39 successfully complete a criterion-referenced examination approved by 40 the secretary in lieu of the continuing education requirements.

- 1 (5) The secretary shall maintain a record of all applicants and certifications under this chapter and establish administrative procedures, administrative requirements, and fees for renewal or late renewal as provided in RCW 43.70.250 and 43.70.280.
- 5 (6) All fees collected under this chapter must be credited to the 6 health professions account as required under RCW 43.70.320.
- NEW SECTION. Sec. 3. (1) Nothing in this chapter prohibits a person from practicing as a lactation consultant without obtaining certification under this chapter.
- 10 (2) No person may use the title "state-certified lactation consultant" in connection with the person's name to indicate or imply, directly or indirectly, that the person is a state-certified lactation consultant without being certified in accordance with this chapter as a lactation consultant.
- 15 (3) Nothing in this chapter prohibits an individual who holds a 16 credential issued by this state to engage in the practice of 17 lactation consultation without obtaining a lactation consultant 18 credential if it is within that profession's scope of practice.
- NEW SECTION. Sec. 4. An applicant holding a license in another state may be certified as a lactation consultant in this state without examination if the secretary determines that the other state's licensing standards are substantially equivalent to the standards in this state.
- NEW SECTION. Sec. 5. A lactation consultant certified under this chapter may perform lactation care and services including, but not limited to:
- 27 (1) Lactation assessment through the systemic collection of 28 subjective and objective data;
 - (2) Analysis of data and creation of a plan of care;
- 30 (3) Implementation of a lactation care plan with demonstration 31 and instruction to parents and communication to the primary health 32 care provider;
 - (4) Evaluation of outcomes;

- 34 (5) Provision of lactation education to parents and health care providers;
 - (6) The recommendation and use of assistive devices; and

- 1 (7) Other lactation care and services authorized in rule by the 2 secretary.
- NEW SECTION. Sec. 6. An applicant with military training or experience satisfies the training or experience requirements of this chapter unless the secretary determines the military training or experience is not substantially equivalent to the standards of this state.
- 8 <u>NEW SECTION.</u> **Sec. 7.** The secretary may adopt any rules 9 necessary to implement this chapter.
- **Sec. 8.** RCW 18.120.020 and 2020 c 80 s 22 are each amended to 11 read as follows:
- The definitions in this section apply throughout this chapter unless the context clearly requires otherwise.

- (1) "Applicant group" includes any health professional group or organization, any individual, or any other interested party which proposes that any health professional group not presently regulated be regulated or which proposes to substantially increase the scope of practice of the profession.
 - (2) "Certificate" and "certification" mean a voluntary process by which a statutory regulatory entity grants recognition to an individual who (a) has met certain prerequisite qualifications specified by that regulatory entity, and (b) may assume or use "certified" in the title or designation to perform prescribed health professional tasks.
 - (3) "Grandfather clause" means a provision in a regulatory statute applicable to practitioners actively engaged in the regulated health profession prior to the effective date of the regulatory statute which exempts the practitioners from meeting the prerequisite qualifications set forth in the regulatory statute to perform prescribed occupational tasks.
- 31 (4) "Health professions" means and includes the following health and health-related licensed or regulated professions and occupations: 33 Podiatric medicine and surgery under chapter 18.22 RCW; chiropractic under chapter 18.25 RCW; dental hygiene under chapter 18.29 RCW; dentistry under chapter 18.32 RCW; denturism under chapter 18.30 RCW; dental anesthesia assistants under chapter 18.350 RCW; dispensing opticians under chapter 18.34 RCW; hearing instruments under chapter

(5) "Inspection" means the periodic examination of practitioners by a state agency in order to ascertain whether the practitioners' occupation is being carried out in a fashion consistent with the public health, safety, and welfare.

- (6) "Legislative committees of reference" means the standing legislative committees designated by the respective rules committees of the senate and house of representatives to consider proposed legislation to regulate health professions not previously regulated.
- (7) "License," "licensing," and "licensure" mean permission to engage in a health profession which would otherwise be unlawful in the state in the absence of the permission. A license is granted to

those individuals who meet prerequisite qualifications to perform prescribed health professional tasks and for the use of a particular title.

- (8) "Practitioner" means an individual who (a) has achieved knowledge and skill by practice, and (b) is actively engaged in a specified health profession.
- (9) "Professional license" means an individual, nontransferable authorization to carry on a health activity based on qualifications which include: (a) Graduation from an accredited or approved program, and (b) acceptable performance on a qualifying examination or series of examinations.
- (10) "Public member" means an individual who is not, and never was, a member of the health profession being regulated or the spouse of a member, or an individual who does not have and never has had a material financial interest in either the rendering of the health professional service being regulated or an activity directly related to the profession being regulated.
- (11) "Registration" means the formal notification which, prior to rendering services, a practitioner shall submit to a state agency setting forth the name and address of the practitioner; the location, nature and operation of the health activity to be practiced; and, if required by the regulatory entity, a description of the service to be provided.
- (12) "Regulatory entity" means any board, commission, agency, division, or other unit or subunit of state government which regulates one or more professions, occupations, industries, businesses, or other endeavors in this state.
- (13) "State agency" includes every state office, department, board, commission, regulatory entity, and agency of the state, and, where provided by law, programs and activities involving less than the full responsibility of a state agency.
 - Sec. 9. RCW 18.130.040 and 2022 c 217 s 5 are each amended to read as follows:
- 34 (1) This chapter applies only to the secretary and the boards and 35 commissions having jurisdiction in relation to the professions 36 licensed under the chapters specified in this section. This chapter 37 does not apply to any business or profession not licensed under the 38 chapters specified in this section.

- (iii) The dental quality assurance commission as established in chapter 18.32 RCW governing licenses issued under chapter 18.32 RCW,
- 25 licenses and registrations issued under chapter 18.260 RCW, and
- 26 certifications issued under chapter 18.350 RCW;
- 27 (iv) The board of hearing and speech as established in chapter 28 18.35 RCW;

- (3) In addition to the authority to discipline license holders, 18 the disciplining authority has the authority to grant or deny 19 licenses. The disciplining authority may also grant a license subject 20 21 to conditions.
- 22 (4) All disciplining authorities shall adopt procedures to ensure substantially consistent application of this chapter, the uniform 23 24 disciplinary act, among the disciplining authorities listed in 25 subsection (2) of this section.
- 26 NEW SECTION. Sec. 10. The health care authority shall take any 27 steps which are necessary and proper to ensure that the services of lactation consultants certified by an international governing body 28 who also hold a certification issued by the department of health are 29 30 covered under the state medicaid program by January 1, 2025.
- 31 NEW SECTION. Sec. 11. Sections 1 through 7 of this act 32 constitute a new chapter in Title 18 RCW.
- 33 <u>NEW SECTION.</u> **Sec. 12.** Sections 1 through 7 of this act take 34 effect January 1, 2024.
