- 10 $((\frac{a}{a}))$ (i) Any goods or services that are registered as a 11 trademark under federal law or under chapter 19.77 RCW;
- 12 $((\frac{b}{b}))$ <u>(ii)</u> Any unregistered trademark, trade name, or trade dress; or 13
- 14 $((\frac{c}{c}))$ (iii) Any trade secret, technology, or proprietary information used to manufacture a ((cannabis)) marijuana product or 15 16 used to provide a service related to a marijuana business.
- 17 $((\frac{2}{2}))$ (b) All agreements or contracts entered into by a 18 licensed marijuana business, as authorized under this section, must 19 be disclosed to the state liquor and cannabis board.
- 20 (2) Nothing in RCW 69.50.328 or this chapter prohibits business arrangements through which a marijuana product is offered or sold at 21

- retail by a marijuana retailer under a private label bearing the
 business or trade name of the marijuana retailer, or of an entity
 other than the marijuana producer or processor that produced or
 processed the marijuana product, so long as:

 (a) The marijuana retailer offering or selling the marijuana
 - (a) The marijuana retailer offering or selling the marijuana product does not have an exclusive right to sell the marijuana product; and
