1 AN ACT Relating to marriage licensing and solemnization by county  
2 auditors; and amending RCW 26.04.050, 26.04.070, and 26.04.180.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 26.04.050 and 2019 c 52 s 2 are each amended to read  
5 as follows:

6 The following named officers and persons, active or retired, are  
7 hereby authorized to solemnize marriages, to wit: Justices of the  
8 supreme court, judges of the court of appeals, judges of the superior  
9 courts, supreme court commissioners, court of appeals commissioners,  
10 superior court commissioners, judges and commissioners of courts of  
11 limited jurisdiction as defined in RCW 3.02.010, judges of tribal  
12 courts from a federally recognized tribe, county auditors, and any  
13 regularly licensed or ordained minister or any priest, imam, rabbi,  
14 or similar official of any religious organization. The solemnization  
15 of a marriage by a tribal court judge pursuant to authority under  
16 this section does not create tribal court jurisdiction and does not  
17 affect state court authority as otherwise provided by law to enter a  
18 judgment for purposes of any dissolution, legal separation, or other  
19 proceedings related to the marriage that is binding on the parties  
20 and entitled to full faith and credit.

1       **Sec. 2.** RCW 26.04.070 and 2012 c 3 s 6 are each amended to read  
2 as follows:

3       In the solemnization of marriage no particular form is required,  
4 except that the parties thereto shall assent or declare in the  
5 presence of the minister, priest, imam, rabbi, or similar official of  
6 any religious organization, county auditor, or judicial officer  
7 solemnizing the same, and in the presence of at least two attending  
8 witnesses, that they take each other to be spouses.

9       **Sec. 3.** RCW 26.04.180 and 1985 c 82 s 4 are each amended to read  
10 as follows:

11       The county auditor (~~(may)~~) shall issue the marriage license at  
12 the time of application(~~(, but shall issue such license no later than~~  
13 ~~the third full day following the date of the application)~~). A  
14 marriage license issued pursuant to the provisions of this chapter  
15 (~~(may not be used until three days after the date of application~~  
16 ~~and)~~) shall become void if the marriage is not solemnized within  
17 sixty days of the date of the issuance of the license, and the county  
18 auditor shall notify the applicant in writing of this requirement at  
19 the time of issuance of the license.
