## SENATE BILL 6251

- 1 AN ACT Relating to creating an inactive certification, license, or
- 2 registration status for real estate appraisers; amending RCW
- 3 18.140.160; and adding a new section to chapter 18.140 RCW.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 18.140 RCW 6 to read as follows:
- 7 (1) A holder of a valid certification, license, or registration may 8 place his or her certification, license, or registration on inactive
- 9 status. The holder of an inactive certification, license, or
- 10 registration may not act as a state-certified real estate appraiser,
- 11 state-licensed real estate appraiser, or state-registered appraiser
- 12 trainee in this state without first activating the certification,
- 13 license, or registration. The director shall establish rules governing
- 14 inactive certifications, licenses, or registrations, and their
- 15 maintenance and reactivation.
- 16 (2) The director shall establish an inactive renewal fee. Failure
- 17 to renew an inactive certification, license, or registration results in
- 18 cancellation of the certification, license, or registration.

1 (3) An inactive certification, license, or registration may be 2 placed on an active status upon compliance with the rules established 3 by the director.

- (4) No holder of an inactive certification, license, or registration may maintain his or her certification, license, or registration on inactive status for a period exceeding two years.
- (5) The provisions relating to the denial, suspension, and revocation of active certifications, licenses, and registrations and the discipline of its holder apply to inactive certifications, licenses, and registrations and their holders.
- **Sec. 2.** RCW 18.140.160 and 2007 c 256 s 1 are each amended to read 12 as follows:

In addition to the unprofessional conduct described in RCW 18.235.130, the director may take disciplinary action for the following conduct, acts, or conditions:

- (1) Failing to meet the minimum qualifications for state certification, licensure, or registration established by or pursuant to this chapter;
  - (2) Paying money other than the fees provided for by this chapter to any employee of the director or the commission to procure state certification, licensure, or registration under this chapter;
  - (3) Continuing to act as a state-certified real estate appraiser, state-licensed real estate appraiser, or state-registered appraiser trainee when his or her certificate, license, or registration is on an expired or inactive status;
- (4) Violating any provision of this chapter or any lawful rule made by the director pursuant thereto;
- (5) Issuing an appraisal report on any real property in which the appraiser has an interest unless his or her interest is clearly stated in the appraisal report;
- (6) Being affiliated as an employer, independent contractor, or supervisory appraiser of a state-certified real estate appraiser, state-licensed real estate appraiser, or state-registered appraiser trainee whose certification, license, or registration is currently in a suspended or revoked status;

diligence in performing an appraisal practice under this chapter, including preparing an oral or written report to communicate information concerning an appraisal practice; and
