By Senate Transportation (originally sponsored by Senators King and Hobbs; by request of Department of Transportation)

1 AN ACT Relating to rail fixed guideway public transportation
2 system safety and security oversight, requiring rule making; amending
3 RCW 81.112.180, 35.21.228, 35A.21.300, 36.01.210, 36.57.120,
4 36.57A.170, 81.104.015, and 81.104.115; and declaring an emergency.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 **Sec. 1.** RCW 81.112.180 and 2007 c 422 s 6 are each amended to
7 read as follows:

8 (1) Each regional transit authority that owns or operates a rail
9 fixed guideway public transportation system as defined in RCW
10 81.104.015 shall submit a system safety program plan and a system
11 security and emergency preparedness plan for that guideway to the
12 state department of transportation by September 1, 1999, or at least
13 one hundred eighty calendar days before beginning operations or
14 instituting significant revisions to its plans. These plans must
15 describe the authority's procedures for (a) reporting and
16 investigating (~~reportable accidents, unacceptable hazardous~~
17 ~~conditions, and security breaches~~) any reportable incident,
18 accident, or security breach and identifying and resolving hazards or
19 security vulnerabilities discovered during planning, design,
20 construction, testing, or operations, (b) developing and submitting
21 corrective action plans and annual safety and security audit reports,

1 (c) facilitating on-site safety and security reviews by the state
2 department of transportation and the federal transit administration,
3 and (d) addressing passenger and employee safety and security. The
4 plans must, at a minimum, conform to the standards adopted by the
5 state department of transportation as set forth in the most current
6 version of the Washington state rail safety oversight program
7 standard manual as it exists on the effective date of this section,
8 or such subsequent date as may be provided by the department by rule,
9 consistent with the purposes of this section. If required by the
10 department, the regional transit authority shall revise its plans to
11 incorporate the department's review comments within sixty days after
12 their receipt, and resubmit its revised plans for review.

13 (2) Each regional transit authority shall implement and comply
14 with its system safety program plan and system security and emergency
15 preparedness plan. The regional transit authority shall perform
16 internal safety and security audits to evaluate its compliance with
17 the plans, and submit its audit schedule to the department of
18 transportation (~~no later than December 15th each year~~) pursuant to
19 the requirements in the most current version of the Washington state
20 rail safety oversight program standard manual as it exists on the
21 effective date of this section, or such subsequent date as may be
22 provided by the department by rule, consistent with the purposes of
23 this section. The regional transit authority shall prepare an annual
24 report for its internal safety and security audits undertaken in the
25 prior year and submit it to the department no later than February
26 15th. (~~This~~) The department shall establish the requirements for
27 the annual report. The contents of the annual report must include, at
28 a minimum, the dates the audits were conducted, the scope of the
29 audit activity, the audit findings and recommendations, the status of
30 any corrective actions taken as a result of the audit activity, and
31 the results of each audit in terms of the adequacy and effectiveness
32 of the plans.

8 (1) "High capacity transportation corridor area" means a quasi-
9 municipal corporation and independent taxing authority within the
10 meaning of Article VII, section 1 of the state Constitution, and a
11 taxing district within the meaning of Article VII, section 2 of the
12 state Constitution, created by a transit agency governing body.

13 (2) "High capacity transportation system" means a system of
14 public transportation services within an urbanized region operating
15 principally on exclusive rights-of-way, and the supporting services
16 and facilities necessary to implement such a system, including
17 interim express services and high occupancy vehicle lanes, which
18 taken as a whole, provides a substantially higher level of passenger
