1 WHEREAS, Washington hospitality is the industry that serves. It
2 cares about its people, growing careers, and giving back to local
3 communities; and

4 WHEREAS, Our collective interest in food, beverages, and lodging
5 accommodations are a part of the past, present, and future of our
6 state; and

7 WHEREAS, As an industry filled with opportunity and hope,
8 hospitality is driven by the passion, determination, and spirit of
9 nearly three hundred thousand people in local communities across the
10 state; and

11 WHEREAS, Jobs in hospitality can positively transform lives. From
12 first jobs to second chances at employment and lifelong careers.
13 There is a place for everyone in hospitality; and

14 WHEREAS, A majority of the owners and operators who are attending
15 Hill Climb today began as dishwashers and front desk clerks. Their
16 success is not by chance — they have worked hard to get to where
17 they are today; and

18 WHEREAS, Hospitality businesses give back to their communities by
19 supporting local youth sports teams, reading programs, and teachers,
20 donating to local nonprofits and providing food and beverages for
21 community events; and

1 WHEREAS, These same businesses also give back to the state.
2 In 2017, the hospitality industry generated 1.3 billion dollars
3 in sales tax and Business & Occupation Tax revenue; and

4 WHEREAS, As the hospitality industry makes up 10.1 percent
5 of the total workforce in Washington, hospitality employers are
6 just as passionate about their team members as they are with any
7 other part of their business. Strong and cohesive teams are
8 essential to succeeding in the industry; and

9 WHEREAS, Hospitality is a part of the fabric of America with
10 24.3 percent of the workforce born outside the United States and
11 these employees, like any other, are empowered to rise through
12 the career ladder; and

13 WHEREAS, Diversity and representation within the industry
14 continues to grow. Nearly one-third of lodging establishments
15 and restaurants are owned by women and additionally, nearly
16 thirty percent of hospitality businesses are minority-owned; and

17 WHEREAS, The Washington Hospitality Association is proud to
18 serve more than six thousand five hundred small, medium, and
19 large hospitality members in Washington state; and

20 WHEREAS, January 28, 2019, marks the twenty-second Hill
21 Climb for the organization, the largest grassroots day on the
22 hill for the hospitality industry;

23 NOW, THEREFORE, BE IT RESOLVED, That the Washington State
24 Senate recognize the positive impact of the hospitality industry
25 in communities across Washington as it continues to create jobs
26 and contribute to the strength and economic vitality of our
27 state; and

28 BE IT FURTHER RESOLVED, That copies of this resolution be
29 immediately transmitted by the Secretary of the Senate to the
30 membership of the Washington Hospitality Association, and
31 Washington Hospitality Association president and CEO, Anthony
32 Anton.
