**ASSEMBLY AMENDMENT 1,
TO ASSEMBLY BILL 230**

October 24, 2023 – Offered by Representative KRUG.

AUTHORS SUBJECT TO CHANGE

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 3, line 19: delete lines 19 and 20 and substitute:
- 3 “218.10 (**1n**) “Distributor” means a resident or nonresident who, in whole or
- 4 in part, sells or distributes new recreational vehicles to recreational vehicle dealers
- 5 or who maintains distributor representatives.”.
- 6 **2.** Page 4, line 4: delete “travel trailer” and substitute “recreational vehicle”.
- 7 **3.** Page 5, line 17: delete “45” and substitute “46”.
- 8 **4.** Page 5, line 18: delete “travel trailer” and substitute “recreational vehicle”.
- 9 **5.** Page 5, line 19: delete that line and substitute “vehicle, and travel trailer”.
- 10 **6.** Page 6, line 3: delete lines 3 to 7.
- 11 **7.** Page 6, line 15: after that line insert:
- 12 “**SECTION 18e.** 218.11 (title) of the statutes is amended to read:

1 **218.11** (title) **Recreational vehicle dealers, manufacturers, and**
2 **distributors regulated.**

3 **SECTION 18g.** 218.11 (2) (e) of the statutes is created to read:

4 218.11 (2) (e) A recreational vehicle dealer or an applicant for a recreational
5 vehicle dealer license shall provide and maintain in force a bond or irrevocable letter
6 of credit of not less than \$50,000. The bond or letter of credit shall be executed in the
7 name of the department of transportation for the benefit of any person who sustains
8 a loss because of an act of a recreational vehicle dealer that constitutes grounds for
9 the suspension or revocation of a license under sub. (6).

10 **SECTION 18j.** 218.11 (4) of the statutes is created to read:

11 218.11 (4) (a) No manufacturer or distributor may engage in business as a
12 manufacturer or distributor in this state without a license.

13 (b) No manufacturers' or distributors' recreational vehicles may be sold in this
14 state unless either the manufacturer on direct dealerships of domestic vehicles or the
15 distributor on indirect dealerships of either domestic or foreign vehicles are licensed
16 under par. (a). The obtaining of a license under par. (a) shall conclusively establish
17 that a manufacturer or distributor is doing business in this state and shall subject
18 the licensee to all provisions of the Wisconsin statutes regulating manufacturers and
19 distributors.

20 **SECTION 18m.** 218.11 (6) (o) of the statutes is created to read:

21 218.11 (6) (o) Being a dealer, manufacturer, or distributor that violates any
22 provision of s. 218.161 to 218.167.

23 **SECTION 18w.** 218.15 of the statutes is amended to read:

24 **218.15 Sale or lease of used recreational vehicles.** In the sale or lease of
25 any used recreational vehicle, the sales invoice or lease agreement shall contain the

1 point of manufacture of the used recreational vehicle, and the name of the
2 manufacturer ~~and the name and address of the previous owner.~~”.

3 **8.** Page 21, line 6: delete lines 6 to 14.

4 **9.** Page 22, line 7: delete “45” and substitute “45 46”.

5 **10.** Page 22, line 9: after “(7m),” insert “and”.

6 **11.** Page 22, line 10: delete that line and substitute “(8v)”.

7 **12.** Page 23, line 17: after that line insert:

8 **“SECTION 33. Effective date.**

9 (1) This act takes effect on the first day of the 7th month beginning after
10 publication.”.
