Assumptions Used in Arriving at Fiscal Estimate

This bill requires the Department of Financial Institutions (DFI) to establish and manage a retirement plan marketplace to connect individuals who are residents of this state and employers that have fewer than 100 employees and that employ at least one individual who is a resident of this state with retirement plans offered by private financial services firms.

The bill also requires DFI, in cooperation with the Departments of Revenue and Workforce Development, to develop a marketing program to publicize and promote the retirement plan marketplace.

Fiscal Estimate

This estimate pertains only to the administrative costs that the Department of Revenue may incur in the promotion of the retirement marketplace.

The Department expects administrative costs related to promoting the retirement marketplace to be minimal.
