Referred to Committee on Judiciary.

AUTHORS SUBJECT TO CHANGE

AN ACT *to create* 20.455 (2) (es) and 165.97 of the statutes; **relating to:** grants for pretrial release monitoring and accountability programs and making an appropriation.

Analysis by the Legislative Reference Bureau

Under this bill, the Department of Justice is authorized to provide up to \$10,000,000 in grants to counties for programs that provide pretrial release monitoring and accountability services. Under the bill, the programs must be evidence-based and may include location monitoring, mental health treatment, substance use disorder treatment, and sobriety monitoring.
