2021 ASSEMBLY BILL 1009

February 16, 2022 - Introduced by Representatives DRAKE, GOYKE, VRUWINK, HEBL, ANDRACA, HONG, SHELTON, CONLEY, MILROY, CONSIDINE, STUBBS, SUBECK, VINING, SPREITZER, HESSELBEIN, BILLINGS, SINICKI and CABRERA, cosponsored by Senators ROYS, LARSON, AGARD and JOHNSON. Referred to Committee on Judiciary.

AUTHORS SUBJECT TO CHANGE

1 **AN ACT** *to create* 20.455 (2) (es) and 165.97 of the statutes; **relating to:** grants
2 for pretrial release monitoring and accountability programs and making an
3 appropriation.

Analysis by the Legislative Reference Bureau

Under this bill, the Department of Justice is authorized to provide up to \$10,000,000 in grants to counties for programs that provide pretrial release monitoring and accountability services. Under the bill, the programs must be evidence-based and may include location monitoring, mental health treatment, substance use disorder treatment, and sobriety monitoring.

4 **SECTION 1.** 20.005 (3) (schedule) of the statutes: at the appropriate place, insert

9 **SECTION 3.** 165.97 of the statutes is created to read:

10 **165.97 Pretrial release monitoring and accountability; grant program.**

11 The department of justice shall award grants from the appropriation under s. 20.455
12 (2) (es) to counties for pretrial release monitoring and accountability programs.

13 Programs funded under this section must use evidence-based practices to provide
14 services for individuals released from custody under ch. 969, and may include
15 location monitoring, mental health treatment, substance use disorder treatment,
16 and sobriety monitoring.

17 **SECTION 4. Fiscal changes.**

18 (1) SPECIAL EDUCATION AID. In the schedule under s. 20.005 (3) for the
19 appropriation to the department of public instruction under s. 20.255 (2) (b), the
20 dollar amount is increased by \$3,100,000 for the 2021-22 fiscal year to increase
21 funding for aids for special education under s. 115.88. In the schedule under s. 20.005
22 (3) for the appropriation to the department of public instruction under s. 20.255 (2)

3 (2) UW SYSTEM, GENERAL PROGRAM OPERATIONS. In the schedule under s. 20.005
4 (3) for the appropriation to the Board of Regents of the University of Wisconsin
5 System under s. 20.285 (1) (a), the dollar amount is increased by \$800,000 for the
6 2021-22 fiscal year to increase funding for the purpose for which the appropriation

9 amount is increased by \$800,000 for the 2022-23 fiscal year to increase funding for
