



2021 ASSEMBLY BILL 1081

March 7, 2022 - Introduced by Representatives MAGNAFICI, ROZAR, CABRAL-GUEVARA, KRUG, ARMSTRONG, BROOKS, EDMING, HORLACHER, MOSES and STEFFEN, cosponsored by Senators TESTIN, NASS and FEYEN. Referred to Committee on Colleges and Universities.

AUTHORS SUBJECT TO CHANGE

1 **AN ACT** *to create* 36.11 (59) and 38.12 (15) of the statutes; **relating to:** nursing
2 degree program enrollment at University of Wisconsin System schools and
3 technical colleges.

Analysis by the Legislative Reference Bureau

This bill requires the Board of Regents of the University of Wisconsin System and technical college district boards to collect data identifying, respectively, the number of qualified applicants denied enrollment in a nursing degree program of a UW institution or technical college because of program capacity constraints, and to annually report to the legislature 1) this number, and 2) the admissions criteria used to determine applicants' qualifications. The bill also requires the Board of Regents and technical college district boards to submit to the legislature a plan to increase enrollment capacity in UW System and technical college nursing degree programs in the 10-year period following the plan's submission.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 **SECTION 1.** 36.11 (59) of the statutes is created to read:

1 36.11 **(59)** REPORT ON NURSING PROGRAM CAPACITY AND APPLICANT QUALIFICATIONS.

2 (a) The board shall collect data identifying, for each institution with a nursing
3 degree program, the number of qualified applicants denied enrollment in any
4 nursing degree program of the institution because of program capacity constraints.

5 (b) By July 1 of each year, the board shall submit to the chief clerk of each house
6 of the legislature, for distribution to the legislature under s. 13.172 (2), a report
7 identifying all of the following for the most recent academic year:

8 1. The number of qualified applicants denied enrollment as described in par.

9 (a) at each applicable institution.

10 2. The admissions criteria used by each applicable institution to determine
11 applicants' qualifications for enrollment in the institution's nursing degree
12 programs.

13 **SECTION 2.** 38.12 (15) of the statutes is created to read:

14 38.12 **(15)** REPORT ON NURSING PROGRAM CAPACITY AND APPLICANT QUALIFICATIONS.

15 (a) If the district board offers any nursing degree program, the district board shall
16 collect data identifying the number of qualified applicants denied enrollment in any
17 nursing degree program of a technical college in the district because of program
18 capacity constraints.

19 (b) By July 1 of each year, the district board shall submit to the technical college
20 system board and to the chief clerk of each house of the legislature, for distribution
21 to the legislature under s. 13.172 (2), a report identifying all of the following for the
22 most recent school year:

23 1. The number of qualified applicants denied enrollment as described in par.

1 2. The admissions criteria used by the district board to determine applicants'
2 qualifications for enrollment in the technical college's nursing degree programs.

3 **SECTION 3. Nonstatutory provisions.**

4 (1) PLAN TO INCREASE ENROLLMENT CAPACITY FOR UNIVERSITY OF WISCONSIN
5 SYSTEM NURSING PROGRAMS.

6 (a) In this subsection:

7 1. "Board" means the Board of Regents of the system.

8 2. "System" means the University of Wisconsin System.

9 (b) No later than December 1, 2022, the board shall submit to the legislature
10 in the manner provided in s. 13.172 (2) a plan to increase enrollment capacity in the
11 system's nursing degree programs in the 10-year period following submission of the
12 plan.

13 (2) PLAN TO INCREASE ENROLLMENT CAPACITY FOR TECHNICAL COLLEGE NURSING
14 PROGRAMS.

15 (a) In this subsection:

16 1. "District" has the meaning given in s. 38.01 (5).

17 2. "District board" has the meaning given in s. 38.01 (6).

18 (b) No later than December 1, 2022, each district board offering a nursing
19 degree program shall submit to the technical college system board and to the
20 legislature, in the manner provided in s. 13.172 (2), a plan to increase enrollment
21 capacity in the nursing degree programs of the technical colleges in the district in the
22 10-year period following submission of the plan.

1 (1) NURSING PROGRAM CAPACITY REPORT. The treatment of ss. 36.11 (59) (b) and
2 38.12 (15) (b) first applies to reports required by July 1, 2022.
