



## 2009 ASSEMBLY BILL 125

March 4, 2009 - Introduced by Representatives POPE-ROBERTS, DEXTER, NASS, BERCEAU, BLACK, DANOU, HEBL, HILGENBERG, HRAYCHUCK, PASCH, SINICKI, SMITH, SOLETSKI, TOLES, VRUWINK and WOOD, cosponsored by Senators LEHMAN, TAYLOR, LAZICH, MILLER, RISSER, VINEHOUT and WIRCH. Referred to Committee on Education.

1     **AN ACT** *to repeal* 118.045 and 118.38 (1) (a) 8.; and *to amend* 119.04 (1) of the  
2             statutes; **relating to:** commencement of the school term in public schools.

### *Analysis by the Legislative Reference Bureau*

Current law prohibits a school district from commencing fall classes in any year until September 1.

This bill eliminates this prohibition beginning in the 2011-12 school year.

3             **SECTION 1.** 118.045 of the statutes is repealed.

4             **SECTION 2.** 118.38 (1) (a) 8. of the statutes is repealed.
