## 2017 ASSEMBLY BILL 159

March 20, 2017 – Introduced by Representatives POPE, KOLSTE, MASON, MILROY, ANDERSON, SARGENT, BERCEAU, VRUWINK, CROWLEY, SUBECK, BILLINGS, SPREITZER, SINICKI, CONSIDINE, WACHS and MURSAU, cosponsored by Senators C. LARSON, MILLER, L. TAYLOR and RINGHAND. Referred to Committee on Education.

1 AN ACT *to amend* 119.04 (1); and *to create* 118.073 of the statutes; **relating to:** 2 policies regulating the use of electronic smoking devices on school district 3 property.

#### Analysis by the Legislative Reference Bureau

This bill requires the Department of Public Instruction to develop a model policy regulating the use of electronic smoking devices on school district property (model electronic smoking policy). The bill also requires each school board to adopt an electronic smoking policy, which may be the same as the model electronic smoking policy developed by DPI. Under the bill, an "electronic smoking device" is defined as an electronic device containing or delivering nicotine, or any other substance, that an individual uses to simulate smoking by inhaling vapor or aerosol from the device.

5	(2) By 180 days after the effective date of this subsection [LRB inserts date],
6	the department shall develop a model policy regulating the use of electronic smoking
7	devices on school district property. The department shall post the model policy on
8	its Internet site.
9	(3) By 270 days after the effective date of this subsection [LRB inserts date],
10	each school board shall adopt a policy regulating the use of electronic smoking
11	devices on school district property. A school board may adopt the model policy under
12	sub. (2). The school board shall provide a copy of the policy to any person who
