## 2013 ASSEMBLY BILL 236

June 4, 2013 – Introduced by Representatives SARGENT, GENRICH, BARNES, BERCEAU, BERNARD SCHABER, BILLINGS, CLARK, DANOU, HESSELBEIN, HULSEY, KAHL, KOLSTE, MASON, NASS, OHNSTAD, SHANKLAND, POPE, HINTZ, HEBL, JORGENSEN, KESSLER and WRIGHT, cosponsored by Senators HANSEN, VINEHOUT, CARPENTER, HARRIS, C. LARSON, LEHMAN, MILLER, RISSER, L. TAYLOR, WIRCH and LASSA. Referred to Committee on Jobs, Economy and Mining.

1 AN ACT *to amend* 13.94 (1) (dr) and 13.94 (1s) (c) 5. of the statutes; **relating to:** 2 audits of the Wisconsin Economic Development Corporation by the Legislative 3 Audit Bureau.

#### Analysis by the Legislative Reference Bureau

Under current law, the legislative Audit Bureau (LAB) is required to perform a financial audit of the Wisconsin Economic Development Corporation (WEDC) every two years and a program evaluation audit of WEDC's economic development programs every two years. This bill requires that the financial audit be conducted annually. The bill also creates a new requirement for a performance evaluation audit of WEDC's policies and management practices to be conducted by LAB on an annual basis.
