2021 ASSEMBLY BILL 439

July 12, 2021 - Introduced by Representatives NEYLON, DUCHOW, ANDRACA, CABRAL-GUEVARA, HAYWOOD, J. RODRIGUEZ and SCHRAA, cosponsored by Senators KOOYENGA, BERNIER and ROYS. Referred to Committee on Transportation.

Analysis by the Legislative Reference Bureau

Under current law, a motor vehicle dealer must be licensed by the Department of Transportation. Also under current law, a manufacturer of motor vehicles may not operate or control a motor vehicle dealership. Under this bill, a manufacturer of electric motor vehicles may engage in the business of a motor vehicle dealer with regard to the electric motor vehicles it manufactures.

Also under current law, with several exceptions, a manufacturer, importer, or distributor may not perform warranty service or delivery and preparation work on a motor vehicle that it does not own or authorize or permit a person to perform warranty service or delivery and preparation work on a motor vehicle unless the person is a motor vehicle dealer with whom the manufacturer, importer, or distributor has entered into a franchise agreement for the sale and service of the manufacturer's, importer's, or distributor's motor vehicles. Under the bill, this prohibition does not apply to a manufacturer of electric motor vehicles with regard to the electric motor vehicles it manufactures.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

1	SECTION 1. 218.0101 (9m) of the statutes is created to read:
2	218.0101 (9m) "Electric vehicle" means a motor vehicle that is propelled solely
3	by electric power.
4	SECTION 2. 218.0116 (1) (n) of the statutes is amended to read:
5	218.0116 (1) (n) The selling of new motor vehicles for which the dealer is not
6	franchised <u>or otherwise authorized to sell</u> .
7	SECTION 3. 218.0116 (1) (w) 3. of the statutes is created to read:
8	218.0116 (1) (w) 3. Subdivision 1. does not apply to a manufacturer of electric
9	vehicles with regard to the manufacturer's electric vehicles.
10	SECTION 4. 218.0121 $(3m)$ (e) of the statutes is created to read:
11	218.0121 (3m) (e) The ownership, operation, or control by a manufacturer of
12	electric vehicles of a dealership that deals solely in the manufacturer's electric
13	vehicles.
