AN ACT to create 115.28 (55s), 118.40 (2r) (b) 2. m., 118.40 (2x) (b) 2. m. and 121.02 (1) (L) 9. of the statutes; relating to: requiring voter education instruction in the elementary and high school grades and incorporating voter education instruction into the state model social studies standards.

### Analysis by the Legislative Reference Bureau

This bill requires school boards and operators of independent charter schools to include, as part of the social studies curriculum, at least one hour of voter education instruction in each elementary and high school grade. The bill specifies specific information that must be provided to pupils in the elementary grades, middle school grades, and high school grades. The bill also requires the state superintendent of public instruction to incorporate voter education instruction into the model academic standards for social studies and to develop model curriculum on the same subject.

(1) Independent charter school contracts. The treatment of s. 118.40~(2r)~(b) 2. m. and (2x)~(b) 2. m. first applies to a contract that is entered into, renewed, or modified on the effective date of this subsection.
