***Analysis by the Legislative Reference Bureau***

This bill adopts, with modifications, the most recent versions of the Uniform Limited Partnership Act and Uniform Limited Liability Company Act. The bill also makes changes to the state's partnership law and to the law governing business corporations and nonstock corporations.

**LIMITED PARTNERSHIPS**

***Background***

In 1916, the National Conference of Commissioners on Uniform State Laws, now called the Uniform Law Commission (ULC), promulgated the Uniform Limited Partnership Act. In 1976, the ULC adopted a Revised Uniform Limited Partnership Act and, in 1985, adopted amendments to this act. The revised act was again revised in 2001. In 2013, the ULC amended the Revised Uniform Limited Partnership Act (2001).

This state has, by statute, recognized limited partnerships since the 1850s. This state first adopted the Uniform Limited Partnership Act in 1919. In 1983 Wisconsin Act 173, this state adopted, with modifications, the Revised Uniform Limited Partnership Act (1976). In 1989 Wisconsin Act 232, this state adopted, with modifications, the 1985 amendments to the Revised Uniform Limited Partnership

Act (1976). Current law, therefore, reflects the Revised Uniform Limited Partnership Act (1976), as amended in 1985, subject to various modifications.

This bill repeals and recreates Wisconsin's limited partnership law to adopt the Revised Uniform Limited Partnership Act (2001), as last amended in 2013 (RULPA), subject to certain modifications. Many provisions of RULPA and current law are similar, including the following: A limited partnership is a legal entity separate from its partners, and the filing of a certificate of limited partnership is required to form a limited partnership. A limited partnership is distinguished from a general partnership by the presence of limited partners. A limited partnership must have at least one general partner and at least one limited partner. The limited partnership generally is managed by general partners, and limited partners primarily provide capital for the limited partnership. A partnership agreement usually provides rules of governance for the limited partnership, and, in many instances, statutory provisions are default rules that govern the limited partnership only in the absence of applicable terms in the partnership agreement. However, in some instances, the terms of the partnership agreement may not vary from statutory requirements. Unless stated otherwise in the partnership agreement, a limited partnership interest (a partner's right to receive distributions from the limited partnership) is transferable, but the recipient of the transfer (transferee) generally is entitled to receive only partnership distributions and does not gain the voting and other rights of a partner. Yet there are significant changes to current law made by RULPA, as adopted under this bill, which are discussed below.

***Formation and partnership agreement***

Current law defines "limited partnership" as a partnership formed under applicable state law by two or more persons and having one or more general partners and one or more limited partners. To form a limited partnership, a certificate of limited partnership, containing certain information, must be filed with the Department of Financial Institutions. The limited partnership is formed upon the filing of the certificate of limited partnership or, if a later date is specified in the certificate of limited partnership, on that later date.

Under this bill, a certificate of limited partnership containing specified information must still be filed with DFI to form a limited partnership. However, the limited partnership is not formed until the certificate of limited partnership is filed and becomes effective *and* the limited partnership, which must have at least two partners, has at least one general partner and at least one limited partner. The bill also eliminates as required information in the certificate of limited partnership a statement of duration of the limited partnership (when the limited partnership must dissolve). Instead, the bill specifies that a limited partnership has perpetual duration, although this may be modified by the partnership agreement.

The bill clarifies that a person may be both a general partner and a limited partner and that the rights, powers, duties, and obligations of such a person are determined by the capacity in which the person acts.

The bill includes provisions related to permissible names for a limited partnership. The bill eliminates a provision of current law that, with exceptions, prohibits a limited partner's name from appearing in the limited partnership's name.

The bill also changes the standard for permissible limited partnership names. Under current law, a limited partnership's name may not be the same as or "deceptively similar" to the names of certain other businesses. Under the bill, a limited partnership's name must be "distinguishable" from the names of certain other businesses.

Current law defines "partnership agreement" as any valid agreement of the partners (limited partners and general partners) as to the affairs of a limited partnership and the conduct of its business. Certain provisions of current law relating to rights and duties of and restrictions on a partner in a limited partnership apply only if there is no contrary provision in the partnership agreement.

This bill provides more specific guidance, in comparison with current law, as to when the provisions of a partnership agreement override contrary statutory provisions and when they do not. Under the bill, "partnership agreement" means the agreement, whether oral, implied, written, or recorded in a tangible or electronic medium, of all the general and limited partners of a limited partnership concerning: 1) relations among the partners and between the partners and the limited partnership; 2) the activities and affairs of the limited partnership and the conduct of those activities and affairs; 3) the means and conditions for amending the partnership agreement; and 4) mergers and other reorganizations involving the limited partnership. As to these matters, statutory provisions govern only in the absence of an applicable provision in the partnership agreement. However, the bill also imposes restrictions on the terms of a partnership agreement. Among these restrictions, a partnership agreement may not vary from certain statutory provisions relating to the following: the power of a person to dissociate as a general partner, except with respect to a limited liability limited partnership (LLLP) (discussed further below); the grounds for expulsion of a general partner by judicial order because of certain conduct by the general partner; the causes of dissolution; requirements for winding up the limited partnership's activities and affairs; requirements for DFI filings or for a limited partnership's registered agent; lawsuits by and against partners and the limited partnership; records and information required to be kept by the limited partnership and a partner's right of access to the records and information; a partner's fiduciary and other duties (discussed further below); and the applicable law governing a limited partnership's internal affairs and the liability of its partners. The partnership agreement also governs the obligations of the limited partnership and its partners to a person dissociated as a partner (discussed further below) and to a transferee of a partner's interest, but an amendment to the partnership agreement after a person has dissociated as a partner cannot impose a new obligation on the person.

***Partner liability and limited liability limited partnerships***

Under current law, a general partner of a limited partnership has the same liabilities as a partner in a partnership without limited partners (general partnership). In general, all partners in a general partnership are jointly and severally liable for all debts, obligations, and other liabilities of the general partnership. In contrast, a limited partner is generally not liable for the obligations of the limited partnership. However, there are exceptions if the limited partner is

also a general partner or if the limited partner participates in the control of the business and a person who transacts business with the limited partnership reasonably believes that the limited partner is a general partner.

Under this bill, general partners are, with exceptions, liable jointly and severally for all debts, obligations, and other liabilities of the limited partnership. The bill also eliminates the “control” exception under current law to a limited partner’s exemption from liability. Under the bill, a limited partner is not personally liable for a debt, obligation, or other liability of the limited partnership solely by reason of being or acting as a limited partner, even if the limited partner participates in the management and control of the limited partnership.

Under current law, a general partnership may form as or become a limited liability partnership (LLP), and a partner in an LLP is not personally liable for any debt, obligation, or liability of the LLP, except that under some circumstances the partner may be liable for the partner’s own actions or the actions of a person under the partner’s supervision and control.

This bill allows a limited partnership to form as or become an LLLP by including a statement to this effect in the certificate of limited partnership. If a limited partnership is an LLLP, a general partner is not personally liable for a debt, obligation, or other liability of the LLLP solely by reason of being or acting as a general partner. Instead, a debt, obligation, or other liability incurred by the LLLP is solely that of the LLLP.

***Fiduciary and other duties of partners***

Under current law, except as provided in the partnership agreement, a general partner of a limited partnership generally has the rights and powers, and is subject to the restrictions, of a partner in a general partnership. In general, a partner in a general partnership owes to the partnership and to the other partners duties of loyalty and care and must discharge the partner’s duties and obligations consistently with the contractual obligation of good faith and fair dealing. Except as provided in the partnership agreement, a general partner or limited partner may lend money to and transact other business with the limited partnership.

This bill more directly specifies a general partner’s duties to the limited partnership and to other partners and also specifies the extent to which these statutory duties may be overridden by the partnership agreement. The bill also specifies a limited partner’s duties. Under the bill, unless the duty is permissibly modified in the partnership agreement (as discussed below), a general partner owes to the limited partnership, and to the other general and limited partners, duties of loyalty and care, as described below. A general partner must also discharge its duties and obligations, whether statutory or arising under the partnership agreement, and exercise its rights, consistently with the contractual obligation of good faith and fair dealing. However, a general partner does not violate a duty or obligation solely because the general partner’s conduct furthers the general partner’s own interest.

Under the bill, a general partner owes a fiduciary duty of loyalty that includes the duty 1) to account to the limited partnership and hold as trustee for it any property, profit, or benefit derived by the general partner in the conduct or winding up of the partnership’s activities and affairs, from use of the partnership’s property,

or from the appropriation of a partnership opportunity; 2) to refrain from dealing with the partnership, in the conduct or winding up of the partnership's activities and affairs, adversely or on behalf of a person having an adverse interest; and 3) to refrain from competing with the partnership in the conduct of the partnership's activities and affairs. However, all the general and limited partners, or those disinterested partners with authority to act, may authorize or ratify, after disclosure of all material facts, a specific act or transaction by a general partner that otherwise would violate the duty of loyalty. Also, it is a defense to a claim of dealing adversely with the limited partnership (item 2 above) that the transaction was fair to the limited partnership.

Under the bill, a general partner also owes a duty of care, in the conduct or winding up of the limited partnership's activities and affairs, to refrain from 1) grossly negligent or reckless conduct; 2) willfully failing to deal fairly with the limited partnership or its partners when the partner has a material conflict of interest; 3) violating the criminal law; 4) engaging in a transaction in which the partner derives an improper personal profit; or 5) engaging in willful misconduct.

Under the bill, in contrast to general partners, limited partners have minimal duties to the limited partnership. A limited partner must exercise any rights under the statutes or the partnership agreement and discharge any duties under the partnership agreement consistently with the contractual obligation of good faith and fair dealing. A limited partner does not have any other duty to the limited partnership or to any other partner solely by reason of acting as a limited partner.

Under the bill, the partnership agreement of a limited partnership may not do any of the following: alter or eliminate, or restrict remedies for the breach of, the duty of loyalty or the duty of care owed by a general partner, except as described below; eliminate a general partner's or limited partner's contractual obligation of good faith and fair dealing, but may, if not manifestly unreasonable, prescribe standards by which performance of the obligation is measured or restrict remedies for breach of the obligation; or relieve a partner from liability for conduct that violates the duty of care (described above). However, the partnership agreement may specify the method by which an act or transaction that would otherwise violate the duty of loyalty may be authorized or ratified after the disclosure of all material facts. If not manifestly unreasonable, the partnership agreement may also alter or eliminate, or restrict remedies with respect to, certain aspects of the duty of loyalty; identify specific types or categories of activities that do not violate the duty of loyalty or the contractual obligation of good faith and fair dealing; otherwise alter the duty of care; or alter or eliminate any other fiduciary duty. A court determines, as a matter of law, whether a term of a partnership agreement is manifestly unreasonable.

Under the bill, if a general partner acts in compliance with the general partner's fiduciary and other duties, the limited partnership must reimburse the general partner for any payment made by the general partner in the course of the general partner's activities on behalf of the partnership and must indemnify the general partner with respect to third-party claims. The limited partnership may also advance reasonable litigation expenses to the general partner. A general partner is also entitled to reimbursement from the limited partnership for advances

to the partnership beyond the amount of capital the general partner agreed to contribute, which advances are considered loans.

The bill also allows a limited partnership to file with DFI a statement of partnership authority. This statement may recognize or limit, for purposes of a third party dealing with the limited partnership, the authority of a person to act for or enter into transactions on behalf of the limited partnership. In this statement, the limited partnership may identify the authority, or limitations on the authority, of any person or position (which covers all persons holding that position). The statement of authority is effective for five years from its original date or its most recent amendment or renewal, and the statement affects only the power of a person to bind the limited partnership to persons that are not partners. All persons are deemed to know of a statement of authority recorded with the register of deeds that limits a person's authority to transfer real property on behalf of the limited partnership. The bill also allows any person named in a statement of authority to file with DFI a statement of denial of authority.

***Operating requirements***

Current law requires a limited partnership to maintain in this state a record office where specified limited partnership records are kept. This bill continues to require a limited partnership to maintain specified records and information and requires the limited partnership to maintain a registered office in this state. The bill also retains the current law requirement that the limited partnership maintain a registered agent for service of process in this state.

This bill requires limited partnerships to file with DFI annual reports containing specified information. This requirement also applies to registered foreign limited partnerships, which are limited partnerships governed by the law of another jurisdiction and authorized to do business in this state.

Under current law, a general partner or limited partner has the right to inspect and copy any of the partnership records required to be maintained by the limited partnership and also has certain rights to other information.

As under current law, this bill provides general partners and limited partners with certain rights to inspect and copy records maintained by the limited partnership, although the details of these rights in the bill differ from current law. The bill specifies records and information that the limited partnership must furnish to general partners and limited partners without demand, as well as information that the limited partnership must furnish to partners on demand. The duty to furnish information also applies to each general partner on whom a demand is made, not just to the limited partnership. The bill also specifies the rights to information of a person dissociated as a general partner or limited partner. The bill allows a limited partnership to impose reasonable restrictions and conditions on access to and use of information furnished by the partnership.

***Dissociation of partners***

Current law specifies the circumstances under which a general partner or limited partner may withdraw from a limited partnership. With a narrow exception, a limited partner may withdraw from a limited partnership only at the time or upon the occurrence of an event specified in the partnership agreement. In contrast, a

general partner may withdraw from a limited partnership at any time by giving notice to the other partners, but if the withdrawal violates the partnership agreement, the limited partnership may recover damages from the withdrawing general partner for breaching the partnership agreement. Current law also specifies events that, absent consent of all partners, cause a person to cease to be a general partner of the limited partnership, including that the general partner: 1) is removed as a general partner in accordance with the partnership agreement; 2) assigns all his or her partnership interest to another; 3) files for bankruptcy; or 4) dies or is adjudicated incompetent.

This bill adopts the term “dissociation” in connection with the voluntary or involuntary withdrawal of a general partner or limited partner from a limited partnership and modifies the bases under which a partner’s dissociation from the limited partnership occurs. Among other events causing dissociation, a general partner is dissociated when 1) the partner withdraws from the partnership or is expelled from the partnership; 2) an event occurs that, under the terms of the partnership agreement, results in the partner’s dissociation; 3) the partner becomes a debtor in bankruptcy, dies, has a guardian or conservator appointed, or is adjudged to be incapable of performing his or her duties under the partnership agreement; or 4) the partnership dissolves and completes winding up. A general partner has the power to dissociate from a limited partnership at any time, rightfully or wrongfully, by expressly withdrawing, but the dissociation is wrongful if it breaches the partnership agreement or if it occurs before the winding up of the limited partnership and the general partner withdraws by express will, is expelled by judicial order, files for bankruptcy, or dissolves or terminates. A general partner that wrongfully dissociates is liable to the limited partnership and the other partners for damages caused by the dissociation.

Under this bill, in contrast to a general partner, a limited partner does not have a right to dissociate before the winding up of the limited partnership. The bill specifies that, among the events causing dissociation, a limited partner is dissociated when 1) the partner withdraws from the partnership or is expelled from the partnership; 2) an event occurs that, under the terms of the partnership agreement, results in the partner’s dissociation; 3) the partner dies or, if an entity, its existence terminates; or 4) the partnership dissolves and completes winding up.

The bill provides more specific information, in comparison with current law, about the effects of a general partner’s or limited partner’s dissociation from a limited partnership. Among these effects, a dissociated general partner has no right to participate in the management and conduct of the partnership activities and affairs; a dissociated partner’s interest takes on the status of a transferee’s interest rather than a partner’s interest; and certain obligations terminate as to future events but may continue to apply to past events.

Under current law, a partner that withdraws from a limited partnership is entitled to receive, within a reasonable time after withdrawal, the fair value of the partner’s interest in the limited partnership as of the date of withdrawal, unless the partnership agreement provides otherwise.

Under this bill, unless the partnership agreement provides otherwise, a partner has no right to a distribution before the dissolution and winding up of the limited partnership, and any earlier distribution to a dissociated partner is discretionary with the limited partnership.

***Dissolution and winding up***

This bill modifies some of the grounds under which a limited partnership is dissolved and its activities and affairs must be wound up. Under current law, among the grounds for dissolution, a limited partnership may be voluntarily dissolved on the written consent of all general partners and limited partners.

Under the bill, a limited partnership may be voluntarily dissolved on the consent of all general partners and of limited partners owning a majority of the rights to receive distributions, whether as a general partner, limited partner, or both.

Under current law, if any general partner withdraws or otherwise ceases to be a general partner, the limited partnership is dissolved unless: 1) the partnership agreement allows the limited partnership to continue and there is at least one remaining general partner that continues the partnership's business; or 2) within 90 days, all partners agree to continue the business of the limited partnership and to appoint one or more additional general partners if necessary.

Under this bill, there is no presumptive dissolution of the limited partnership upon dissociation of a general partner. Instead, upon dissociation of a general partner, the limited partnership is dissolved only if: 1) the partnership has at least one remaining general partner and partners owning a majority interest consent, within 90 days, to dissolve the partnership; or 2) the partnership does not have any remaining general partner and 90 days pass without both of the following occurring: a majority (by interest) of limited partners consenting to continue the partnership; and, at least one general partner being admitted.

Under current law, a limited partnership must file a certificate of cancellation upon dissolution or at any other time that there are no limited partners.

The bill provides that a limited partnership is dissolved if: 1) 90 consecutive days pass after the dissociation of the partnership's last limited partner without the partnership admitting at least one limited partner; or 2) 90 consecutive days pass during which the limited partnership has only one partner or does not have both a general partner and a limited partner. The bill, which does not require a certificate of limited partnership to include a statement of duration, also eliminates the automatic dissolution under current law of a limited partnership upon expiration of its stated duration.

Under this bill, a dissolved limited partnership, in winding up its activities and affairs, may amend its certificate of limited partnership to state that the partnership is dissolved and may also file a statement of termination with DFI. With exceptions, a limited partnership that initiates dissolution may also rescind its dissolution and continue carrying on its activities and affairs as if dissolution had never been initiated.

The bill also provides DFI with authority to administratively dissolve a limited partnership. Under the bill, DFI may commence a proceeding to dissolve a limited partnership administratively if the limited partnership does not pay a required fee

or penalty or file an annual report within one year after the fee or penalty or report is due or is without a registered agent or registered office in this state for at least one year. The bill establishes a procedure for these proceedings and allows an administratively dissolved limited partnership to apply to DFI for reinstatement. The bill also provides a process for appeal and court review of DFI's denial of an application for reinstatement.

***Mergers, conversions, and other business combinations***

This bill makes significant changes with respect to mergers, conversions, and other business-combination transactions involving domestic or foreign limited partnerships. Under current law, one or more domestic limited partnerships may merge with or into one or more other domestic or foreign business entities (business corporations, nonprofit or nonstock corporations, limited liability companies, or limited partnerships) if the merger satisfies certain requirements. Current law also allows a domestic limited partnership to convert to another form of domestic or foreign business entity if the conversion satisfies certain requirements.

This bill significantly changes the requirements applicable to a merger or conversion involving a limited partnership and also allows a limited partnership to undertake transactions in the form of an interest exchange or domestication. In an interest exchange, a limited partnership acquires interests of another domestic or foreign business entity, or has its own interests acquired by another domestic or foreign business entity. In a domestication, an entity governed by the law of a foreign country (a non-U.S. entity) may domesticate as a domestic limited partnership under Wisconsin law while continuing to be subject to the foreign country's law and a domestic limited partnership may domesticate as a non-U.S. entity subject to a foreign country's law while continuing to be a domestic limited partnership. The bill allows mergers, conversions, interest exchanges, and domestications to involve a diverse array of business entities, including business corporations, nonprofit or nonstock corporations, limited liability companies, limited partnerships, LLPs, cooperative associations, and unincorporated associations. Certain requirements apply to these business-structure transactions, including approval of a plan of merger, conversion, interest exchange, or domestication and filing with DFI articles of merger, conversion, interest exchange, or domestication, although the terms of the partnership agreement generally govern mergers, conversions, interest exchanges, and domestications. When the merger, conversion, interest exchange, or domestication becomes effective, certain results occur automatically, as a matter of law, with respect to such matters as assets, obligations, continued existence, and organizational documents of the parties involved in the transaction. The bill also eliminates a provision of current law that requires a surviving foreign business entity in a merger to pay dissenting owners of merged domestic business entities for their interests, but creates new dissenter's rights for a partner in a business-structure transaction if the transaction materially increases the partner's obligation or liability or treats the partner's interest different from that of other partners.

Under current law, on application to the circuit court by a creditor that has obtained a judgment against a general partner or limited partner, the court may charge the partnership interest of the partner with payment of the unsatisfied amount of the judgment. To the extent charged, the judgment creditor has only the rights of an assignee of the partnership interest.

This bill expands on provisions of current law under which a creditor of a general partner or limited partner may seek from a court a charging order against the partner's interest in the limited partnership to satisfy the unpaid amount of the creditor's judgment. Under the bill, a charging order is available against the interest of either a partner or a transferee of a partner. A charging order constitutes a lien on the partner's or transferee's interest and requires the limited partnership to pay over to the creditor any distribution that otherwise would be paid to the partner or transferee. Under certain circumstances, the court may foreclose the lien and order the sale of the partner's or transferee's interest in the limited partnership. The purchaser of the interest at the foreclosure sale obtains only the interest and does not thereby become a partner or gain any right to participate in the activities and affairs of the limited partnership.

Under current law, a limited partner may bring an action on behalf of a limited partnership (derivative action) to recover a judgment in its favor if general partners with authority to do so have refused to bring the action or if an effort to cause those general partners to bring the action is not likely to succeed.

This bill continues to allow a limited partner to bring a derivative action and also allows a general partner to bring a derivative action. However, under the bill, the limited partnership may appoint a special litigation committee to investigate the claims in the derivative action and to determine whether pursuing the action is in the best interests of the limited partnership. The special litigation committee must be composed of disinterested and independent individuals, who may be partners. If the limited partnership appoints a special litigation committee, the court must, on motion of the committee, stay discovery for the time reasonably necessary to permit the committee to make its investigation, unless there is good cause shown for the court to deny the stay. After appropriate investigation, the special litigation committee may determine that it is in the best interests of the limited partnership for the proceeding to continue under the control of the plaintiff; for the proceeding to continue under the control of the committee; for the proceeding to be settled on terms approved by the committee; or for the proceeding to be dismissed. After making its determination, the special litigation committee must submit its determination to the court and, if the court determines that certain requirements are satisfied, the court must follow and enforce the committee's recommendation. If the court finds the applicable requirements are not satisfied, the court must dissolve the stay of discovery and allow the plaintiff to continue the action.

The bill provides a procedure and specifies grounds for DFI to terminate authority of a foreign limited partnership to do business in this state.

The bill includes many changes relating to procedures applicable to limited partnerships and foreign limited partnerships, including changes related to

registered agents, service of process, and permissible names. The bill also provides a procedure for DFI to issue a certificate of status for a limited partnership or foreign limited partnership.

This bill includes provisions specifying when a person is considered to have notice or knowledge of a fact. The bill also specifies when a person is considered to have given another person notice of a fact. The bill also allows DFI to provide written notice to a limited partnership or foreign limited partnership solely by e-mail to its registered agent.

The bill includes numerous other substantive and stylistic changes from current law. The bill also includes some modifications from, or additions to, the model language of RULPA. For example, the bill includes provisions relating to DFI fees that are not included in RULPA.

***Phase-in***

The changes in this bill apply to a limited partnership formed on or after January 1, 2023, and apply on January 1, 2023, to a limited partnership formed before that date unless 1) the limited partnership elects to be governed earlier by the new provisions of the bill, or 2) the limited partnership elects to be governed by the existing law applicable before enactment of the bill.

**PARTNERSHIPS**

In enacting 2015 Wisconsin Act 295, this state repealed and recreated Wisconsin's partnership law to adopt, with modifications, the Revised Uniform Partnership Act (RUPA), as last amended in 2013. This state's law was previously based on an earlier version of the Uniform Partnership Act. With a limited exception, a partnership formed on or after January 1, 2018, is subject to the new statutory provisions of RUPA.

This bill makes modifications to the state's partnership law as recreated in Act 295, including changes relating to 1) a partnership's governing law; 2) prohibited provisions in a partnership agreement; 3) DFI's fees for partnership-related filings; 4) consent to partnership action without a meeting of the partners; 5) a partner's duty of care in the conduct or winding up of the partnership business; 6) compensating a dissociated partner; 7) claims against a dissolved limited liability partnership; 8) business-structure transactions involving partnerships, including dissenter's rights for a partner; and 9) the method by which DFI may provide written notice to a partnership.

**LIMITED LIABILITY COMPANIES**

In 1992, the ULC began working on the Uniform Limited Liability Company Act, which was completed in 1994 and approved in 1996. Before the ULC had completed its work, many states had already passed limited liability company (LLC) legislation and the American Bar Association had created a prototype LLC Act. The ULC adopted a Revised Uniform Limited Liability Company Act in 2006, which was amended in 2013.

Wisconsin authorized the creation of LLCs prior to the ULC's first model act, by enacting 1993 Wisconsin Act 112, effective January 1, 1994. Since then, various modifications have been made to this state's LLC law.

This bill repeals and recreates Wisconsin's LLC law to adopt the Revised Uniform Limited Liability Company Act (2006), as last amended in 2013 (RULLCA), subject to certain modifications. Many provisions of RULLCA are similar to current law. Under both current law and RULLCA, an LLC is a distinct legal entity separate from its members and may be organized for any lawful purpose. An LLC may be managed by its members or by managers, and an operating agreement between the members may provide rules of governance for the LLC. In many instances, statutory provisions are merely default rules that govern an LLC only in the absence of applicable terms in an operating agreement, but in some instances the terms of an operating agreement may not vary from statutory requirements. Some of the significant changes to current law made by RULLCA, as adopted under this bill, are discussed below.

***Formation and operating agreement***

Under current law, an organizer files articles of organization with DFI to form an LLC. The articles of organization must contain specified information and may not contain any additional information.

This bill modifies the information required in articles of organization filed with DFI and allows additional information to be included in the articles of organization. The bill also specifies that an LLC has perpetual duration (although the duration may be modified by the operating agreement). The bill allows a person, in addition to various other permissible ways, to become a member of an LLC in any way provided for in the operating agreement. The bill includes various provisions regarding the formation of a one-member LLC (which is also permitted under current law).

Current law defines "operating agreement" to include only a written document and allows for the possibility that an LLC could be formed and operate without an operating agreement. Under current law, "operating agreement" means an agreement in writing, if any, among all of the members as to the conduct of the business of an LLC and its relationships with its members.

Under this bill, the operating agreement may be oral or written, express or implied, and an LLC cannot exist without an operating agreement. Under the bill, "operating agreement" means the agreement, whether or not referred to as an operating agreement and whether oral, implied, written, or recorded in a tangible or electronic medium, or in any combination of these, of all the members of an LLC, including a sole member, concerning 1) relations among the members as members and between the members and the LLC; 2) the rights and duties of managers; 3) the activities and affairs of the LLC and the conduct of those activities and affairs; 4) the means and conditions for amending the operating agreement; and 5) mergers, conversions, and other business combinations.

This bill provides more specific guidance, in comparison with current law, as to when the provisions of an operating agreement override contrary statutory provisions and when they do not. Under the bill, subject to certain exceptions, the operating agreement governs all matters described in items 1) to 5), above, but if the operating agreement does not provide for a matter described in items 1) to 5), above, statutory provisions govern the matter. The operating agreement also governs the

obligations of an LLC and its members to a person dissociated as a member or a person to whom a member's interest (right to receive distributions from the LLC) has been transferred. The bill includes a list of matters for which the operating agreement may not vary from statutory provisions, including matters related to a member's fiduciary and other duties, discussed below.

***Authority of members***

This bill generally eliminates the concept of "apparent authority" in connection with LLCs. Under current law, in a member-managed LLC, each member is an agent of the LLC and, subject to exceptions, the act of a member for apparently carrying on the business of the LLC binds the LLC. This principle does not apply in a manager-managed LLC, where the managers, not the members, are the agents of the LLC for purposes of carrying on its business.

Under this bill, a member is not an agent of an LLC solely by reason of being a member. An LLC may file with DFI a statement of authority identifying the authority of any position with the LLC (which covers all persons holding that position), identifying the authority of any specific person, or identifying limitations on the authority of any position or person. The statement of authority is effective for five years from its original date or its most recent amendment or renewal, and the statement affects only the power of a person to bind the LLC to persons that are not members. The bill allows any person named in a statement of authority to file with DFI a statement of denial of authority.

***Fiduciary and other duties of members and managers***

Under current law, unless otherwise provided in an operating agreement, a member or manager cannot act, or fail to act, in a manner that constitutes willful misconduct; a willful failure to deal fairly with the LLC or its members where the member or manager has a material conflict of interest; or, with exceptions, a violation of criminal law. Unless otherwise provided in an operating agreement, a member or manager cannot derive improper personal profit from a transaction. A member or manager must account to the LLC, and hold as trustee for it, any improper personal profit derived, without the consent of a majority of the disinterested members or managers, from a transaction connected with the LLC or from use by the member or manager of LLC property, including confidential or proprietary information.

Under this bill, unless the duty is permissibly modified in the LLC's operating agreement (as discussed below), a member of a member-managed LLC, or a manager of a manager-managed LLC, owes to the LLC, and to its members, fiduciary duties of loyalty and care, as described below. A member or manager must also discharge its duties and obligations, whether statutory or arising under the operating agreement, and exercise its rights, consistently with the contractual obligation of good faith and fair dealing. However, a member does not violate a duty or obligation solely because the member's conduct furthers the member's own interest.

Under the bill, a member of a member-managed LLC, or a manager of a manager-managed LLC, owes a duty of loyalty that includes the duty 1) to account to the LLC and hold as trustee for it any property, profit, or benefit derived by the member or manager in the conduct or winding up of the LLC's business, from use of the LLC's property, or from the appropriation of an LLC opportunity; 2) to refrain

from dealing with the LLC, in the conduct or winding up of the LLC's business, adversely or on behalf of a person having an adverse interest; and 3) to refrain from competing with the LLC in the conduct of the LLC's business. However, all the members of an LLC may authorize or ratify, after disclosure of all material facts, a specific act or transaction that otherwise would violate the duty of loyalty. Also, it is a defense to a claim of dealing adversely with the LLC (item 2, above) that the transaction was fair to the LLC.

Under the bill, a member of a member-managed LLC, or a manager of a manager-managed LLC, also owes a duty of care, in the conduct or winding up of the LLC's business, to refrain from 1) willfully failing to deal fairly with the LLC or its members when the person has a material conflict of interest; 2) violating the criminal law; 3) engaging in a transaction in which the person derives an improper personal profit; or 4) engaging in willful misconduct.

Under the bill, the operating agreement may not alter or eliminate, or restrict the remedies for breach of, the duty of loyalty or the duty of care, except as described below; eliminate, or restrict remedies for the breach of, the contractual obligation of good faith and fair dealing, but a written operating agreement may prescribe standards, if not manifestly unreasonable, by which performance of the obligation is measured; or relieve a person from liability for conduct that violates the duty of care described in items 1) to 4) in the immediately preceding paragraph. However, the operating agreement may specify the method by which an act or transaction that would otherwise violate the duty of loyalty may be authorized or ratified after the disclosure of all material facts. In a member-managed LLC, a written operating agreement may also eliminate or limit a member's fiduciary duty if it also relieves the member of a responsibility and imposes it on another member. A written operating agreement may also alter or eliminate, or restrict remedies with respect to, certain aspects of the duty of loyalty; identify specific types or categories of activities that do not violate the duty of loyalty or the contractual obligation of good faith and fair dealing; alter the duty of care, if it does not authorize the conduct described in items 1) to 4) in the immediately preceding paragraph; or alter or eliminate any other fiduciary duty.

***Operating requirements***

This bill makes changes to the information that must be contained in an LLC's annual report. Under current law, if a domestic LLC or registered foreign LLC is manager-managed, its annual report must contain the name and business address of each manager. The annual report of a registered foreign LLC must also contain the name and business address of each LLC member. A domestic LLC is one organized under this state's law, and a registered foreign LLC is one organized under the law of another state or jurisdiction and authorized to do business in this state.

Under this bill, the annual report of a domestic LLC or registered foreign LLC must include the name of at least one member if it is member-managed or the name of at least one manager if it is manager-managed.

This bill makes some changes with respect to the records that an LLC must keep at its office. As under current law, the bill provides members with certain rights to, on request, inspect and copy records maintained by the LLC, and requires the

LLC to provide records and information, although the details of these requirements in the bill differ from current law. Under the bill, managers have these rights in a manager-managed LLC. In addition, the bill requires an LLC, without request, to furnish each member in a member-managed LLC, or each manager in a manager-managed LLC, with any information concerning the LLC's activities, affairs, financial condition, and other circumstances that the LLC knows and is material to the proper exercise of the member's or manager's rights and duties, unless the member or manager already knows the information. In a manager-managed LLC, the LLC must, without request, provide members with all known, material information before the member is required to vote on or give or withhold consent to a matter. In addition to the LLC's duty, each member in a member-managed LLC, or each manager in a manager-managed LLC, has a duty to furnish information known by the member or manager. The bill also contains provisions relating to the rights to information after a person dissociates as a member. The bill allows an LLC to impose reasonable restrictions and conditions on access to and use of information furnished by the LLC.

Current law includes provisions relating to when notice to, or knowledge of, a member or manager is imputed to an LLC.

This bill eliminates these provisions and creates new provisions as to when a person is considered to have notice or knowledge of a fact. The bill also specifies when a person is considered to have given another person notice of a fact.

The bill also allows DFI to provide written notice to an LLC solely by e-mail to its registered agent.

***Dissociation of members***

As under current law, this bill specifies circumstances under which a member of an LLC dissociates from the LLC, including voluntary dissociation. Under the bill, a person may dissociate as a member at any time, rightfully or wrongfully, by withdrawing as a member by express will. A person's dissociation as a member is wrongful if, among other things, the dissociation is in violation of a written operating agreement. The bill provides more specific information, in comparison with current law, about the effects of a member's dissociation from an LLC. Among these effects, a person dissociated as a member has no right to participate in the management and conduct of the LLC's business and the person's right to distributions takes on the status of the right of a transferee. Upon dissociation, certain obligations of the person terminate as to future events but continue to apply to past events.

Under current law, if a member withdraws from an LLC and the withdrawal occurs as a result of the member's wrongful conduct, the LLC may recover from the withdrawing member damages as a result of the wrongful conduct.

Under this bill, a member that wrongfully dissociates from an LLC is liable for damages caused by the dissociation and the liability is to both the LLC and to any other member if the other member shows that its injury is not solely the result of injury suffered by the LLC.

Under current law, a member who dissociates from an LLC has a right to a distribution in complete redemption of the fair value of the member's interest at the time of dissociation, unless the operating agreement provides otherwise.

Under this bill, unless the operating agreement provides otherwise, a distribution to a person who dissociates as a member of an LLC is discretionary with the LLC, and the person has no right to a distribution. The bill also specifies that an LLC's obligations to a person dissociated as a member are governed by the operating agreement, but an amendment to the operating agreement after the person has dissociated as a member cannot impose a new obligation on the person.

This bill expands on provisions of current law under which a creditor of an LLC's member may seek from a court a charging order against the member's interest in the LLC to satisfy the unpaid amount of the creditor's judgment. Under the bill, a charging order is available against the interest (right to receive distributions) of either a member or a person to whom the member's interest has been transferred (transferee). A charging order constitutes a lien on the member's or transferee's interest and requires the LLC to pay over to the creditor any distribution that otherwise would be paid to the member or transferee. Under certain circumstances, the court may foreclose the lien and order the sale of the member's or transferee's interest in the LLC. The purchaser of the interest at the foreclosure sale obtains only the interest and does not thereby become a member or gain any right to participate in the business of the LLC. The bill includes specific provisions applicable when a court orders foreclosure of a charging order lien against a single-member LLC.

***Dissolution and winding up***

This bill modifies some of the grounds under which an LLC is dissolved and its activities and affairs must be wound up, and replaces the term "articles of dissolution" in current law with the term "statement of dissolution." As new grounds for dissolution under the bill, dissolution occurs upon the passage of 90 consecutive days during which the LLC has no members. The bill eliminates as a ground for judicial dissolution of an LLC that the LLC is not acting in conformity with its operating agreement. The bill also eliminates a "grandfather" provision relating to dissolution of an LLC organized before October 1, 2002.

Under current law, DFI may administratively dissolve an LLC that does not file its annual report within one year after it is due. Under this bill, DFI may administratively dissolve an LLC if the LLC does not pay any required fee or penalty within one year after it is due; does not file its annual report within one year after it is due; is without a registered agent in this state for at least one year; does not notify DFI within one year of changes to its registered agent or registered office; or commits certain crimes involving human trafficking.

***Mergers, conversions, and other business combinations***

This bill makes significant changes with respect to mergers, conversions, and other business combinations involving domestic or foreign LLCs. Under current law, one or more domestic or foreign LLCs may merge with or into one or more other domestic or foreign business entities (business corporations, nonprofit or nonstock corporations, LLCs, or limited partnerships) if the merger satisfies certain requirements. Current law also allows a domestic LLC to convert to another form of domestic or foreign business entity if the conversion satisfies certain requirements.

This bill significantly changes the requirements applicable to a merger or conversion involving an LLC and also allows an LLC to undertake transactions in the form of an interest exchange or domestication. In an interest exchange, a domestic LLC acquires interests of another domestic or foreign business entity, or has its own interests acquired by another domestic or foreign business entity. In a domestication, an entity governed by the law of a foreign country (a non-U.S. entity) may domesticate as a domestic LLC under Wisconsin law while continuing to be subject to the foreign country's law and a domestic LLC may domesticate as a non-U.S. entity subject to a foreign country's law while continuing to be a domestic LLC. Under the bill, a merger, conversion, interest exchange, or domestication is not limited to transactions involving business entities that are business corporations, nonprofit or nonstock corporations, LLCs, or limited partnerships; the bill allows these transactions to include other entities such as limited liability partnerships, cooperative associations, and unincorporated associations. Certain requirements apply to organizational transactions under the bill, including approval of a plan of merger, conversion, interest exchange, or domestication and filing with DFI articles of merger, conversion, interest exchange, or domestication, although the terms of the operating agreement generally govern mergers, conversions, interest exchanges, and domestications. When the merger, conversion, interest exchange, or domestication becomes effective, certain results occur automatically, as a matter of law, with respect to such matters as assets, obligations, continued existence, and organizational documents of the parties involved in the transaction. With respect to a merger, the bill also eliminates a provision of current law that gives a dissenting member of the LLC who does not vote in favor of the merger the right, upon dissociation from the LLC, to receive fair value for the member's LLC interest, unless the operating agreement provides otherwise.

***Other changes***

Under the bill, a member of an LLC may bring a derivative action against the LLC to enforce a right of the LLC if certain conditions are satisfied. The LLC may appoint a special litigation committee to investigate the claims in the derivative action and to determine whether pursuing the action is in the best interests of the LLC. The special litigation committee must be composed of disinterested and independent individuals, who may be members. If the LLC appoints a special litigation committee, the court must, on motion of the committee, stay discovery for the time reasonably necessary to permit the committee to make its investigation, unless there is good cause shown for the court to deny the stay. After appropriate investigation, the special litigation committee may determine that it is in the best interests of the LLC for the proceeding to continue under the control of the plaintiff; for the proceeding to continue under the control of the committee; for the proceeding to be settled on terms approved by the committee; or for the proceeding to be dismissed. After making its determination, the special litigation committee must submit its determination to the court and, if the court determines that certain requirements are satisfied, the court must follow and enforce the committee's recommendation. If the court finds the applicable requirements are not satisfied, the

court must dissolve the stay of discovery and allow the plaintiff to continue the action.

This bill also changes many terms used under current law in connection with LLCs. For example, in addition to changing “articles of dissolution” to “statement of dissolution,” the bill changes “articles of correction” to “statement of correction” or “statement of change,” depending on the circumstances.

The bill includes numerous other substantive and stylistic changes from current law. The bill also includes some modifications from, or additions to, the model language of RULLCA.

***Phase-in***

The changes in this bill apply to an LLC formed on or after January 1, 2023, and apply, on January 1, 2023, to an LLC formed before that date unless 1) the LLC elects to be governed earlier by the new provisions of the bill, or 2) the LLC elects to be governed by the existing law applicable before enactment of the bill. When the provisions of the bill become applicable to an LLC, provisions of prior law relating to obligations incurred by the LLC prior to the bill’s enactment continue to apply and any provision of an operating agreement that was valid before enactment of the bill remains valid.

**CORPORATIONS**

This bill also makes changes to the law governing business corporations and nonstock corporations that generally correspond to the changes applicable to limited partnerships, LLCs, and partnerships, including changes similar to those described above and related to 1) mergers, conversions, and other business-structure transactions; 2) the process and fees for corporate filings with DFI; 3) procedures and requirements applicable to corporations including those related to registered agents and permissible names; 4) the method by which DFI may provide written notice to a corporation; and 5) consent to corporate action without a meeting.

Because this bill creates a new crime or revises a penalty for an existing crime, the Joint Review Committee on Criminal Penalties may be requested to prepare a report.

11 magnetic, wireless, optical, electromagnetic, or similar capabilities.

12 (4p) "Entity" means a person other than an individual.

13 (4t) "Foreign" means, with respect to an entity, an entity whose governing law  
14 is other than the law of this state.

15 (5) "Foreign limited liability limited partnership" means a foreign limited  
16 partnership whose general partners have limited liability for the debts, obligations,  
17 or other liabilities of the foreign limited partnership under a provision similar to s.

6 combination thereof, of all the partners of a limited partnership concerning the

10 corporation, partnership, limited partnership, limited liability company, general

22 provisions of this chapter, the principles of law and equity supplement this chapter.

23 **179.0114 Permitted names.** (1) The name of a limited partnership may  
24 contain the name of any partner.

13           (c) The words in the record must be in English, and numbers must be in Arabic  
14           or Roman numerals, but the name of an entity need not be in English if written in  
15           English letters or Arabic or Roman numerals.

16           (d) The record must be signed by a person authorized or required under this  
17           chapter to sign the record.

18           (e) The record must state the name and capacity, if any, of each individual who  
19           signed it, either on behalf of the individual or the person authorized or required to  
20           sign the record, but need not contain a seal, attestation, acknowledgment, or  
21           verification.

22           (f) The record must contain the name of the drafter, if required by s. 182.01 (3).

23           **(1m)** The department may waive any of the requirements of sub. (1) (a) to (f)  
24           if it appears from the face of the document that the document's failure to satisfy the  
25           requirement is immaterial.

1           (2) If law other than this chapter prohibits the disclosure by the department  
2 of information contained in a record delivered to the department for filing, the  
3 department shall file the record if the record otherwise complies with this chapter

7           **179.0210 Duty of department to file; review of refusal to file; delivery**

9 department for filing which satisfies this chapter. The duty of the department under  
10 this section is ministerial.

11           **(2)** When the department files a record, the department shall record it as filed

16 may confirm any other information permitted under sub. (3).

17           **179.0212 Annual report for department.** **(1)** A limited partnership or  
18 registered foreign limited partnership shall deliver to the department for filing an  
19 annual report that states all of the following:

20           (a) The name of the partnership or registered foreign partnership.

21           (b) The street address of its registered office in this state and the name and  
22 e-mail address of its registered agent at that office.

24           (d) The name of at least one general partner.

14          **179.0302 No agency power of limited partner as limited partner.** (1)

15 A limited partner is not an agent of a limited partnership solely by reason of being  
16 a limited partner.

17          (2) A person's status as a limited partner does not prevent or restrict law other  
18 than this chapter from imposing liability on a limited partnership because of the  
19 person's conduct.

20          **179.0303 No liability as limited partner for limited partnership**

21 **obligations.** (1) A debt, obligation, or other liability of a limited partnership is not  
22 the debt, obligation, or other liability of a limited partner. A limited partner is not  
23 personally liable, directly or indirectly, by way of contribution or otherwise, for a  
24 debt, obligation, or other liability of the partnership solely by reason of being or  
25 acting as a limited partner, even if the limited partner participates in the

1 management and control of the limited partnership. This subsection applies  
2 regardless of the dissolution of the partnership.

3 (2) The failure of a limited partnership to observe formalities relating to the  
4 exercise of its powers or management of its activities and affairs is not a ground for

6 partnership.

7 **179.0304 Rights to information of limited partner and person**  
8 **dissociated as limited partner.** (1) On 10 days' demand made in a record received  
9 by the limited partnership, a limited partner may inspect and copy required  
10 information during regular business hours in the limited partnership's principal  
11 office. The limited partner need not have any particular purpose for seeking the  
12 information.

13 (2) During regular business hours and at a reasonable location specified by the  
14 limited partnership, a limited partner may inspect and copy information regarding  
15 the activities and affairs, financial condition, and other circumstances of the limited  
16 partnership as is just and reasonable if all of the following apply:

17 (a) The limited partner seeks the information for a purpose reasonably related  
18 to the partner's interest as a limited partner.

19 (b) The limited partner makes a demand in a record received by the limited  
20 partnership, describing with reasonable particularity the information sought and  
21 the purpose for seeking the information.

22 (c) The information sought is directly connected to the limited partner's  
23 purpose.

1           **(3)** Not later than 10 days after receiving a demand pursuant to sub. (2), the  
2 limited partnership shall inform, in a record, the limited partner that made the  
3 demand of all of the following:

6           (b) The partnership's reasons for declining, if the partnership declines to

15 person was entitled while a limited partner if all of the following apply:

16           (a) The information pertains to the period during which the person was a

18           (b) The person seeks the information in good faith.

19           (c) The person satisfies the requirements imposed on a limited partner by sub.  
20 (2).

21           **(6)** A limited partnership shall respond to a demand made pursuant to sub. (5)  
22 in the manner provided in sub. (3).

23           **(7)** A limited partnership may charge a person that makes a demand under this  
24 section reasonable costs of copying, limited to the costs of labor and material.

1           **(8)** A limited partner or person dissociated as a limited partner may exercise  
2 the rights under this section through an agent or, in the case of an individual under  
3 legal disability, a legal representative. Any restriction or condition imposed by the

5 representative and to the limited partner or person dissociated as a limited partner.

14 this subsection, the partnership has the burden of proving reasonableness.

15           **179.0305 Limited duties of limited partners.** **(1)** A limited partner shall  
16 discharge any duties to the partnership and the other partners under the  
17 partnership agreement and exercise any rights under this chapter or the partnership  
18 agreement consistently with the contractual obligation of good faith and fair dealing.

19           **(2)** Except as otherwise provided in sub. (1), a limited partner does not have  
20 any duty to the limited partnership or to any other partner solely by reason of acting  
21 as a limited partner.

22           **(3)** If a limited partner enters into a transaction with the limited partnership,  
23 the limited partner's rights and obligations arising from the transaction are the same  
24 as those of a person that is not a partner.

1           **(4m)** Unless otherwise provided in the partnership agreement, any action that  
2 is to be voted on or consented to by some or all of the limited partners may be taken  
3 without a meeting of the limited partners entitled to vote or consent if all of such

5 consents describing the action, signed by each of such partners, and delivered to the

17 become a limited partner in the enterprise is not liable for the enterprise's obligations  
18 by reason of making the investment, receiving distributions from the enterprise, or  
19 exercising any rights of or appropriate to a limited partner, if, on ascertaining the  
20 mistake, the person does any of the following:

21           (a) Causes an appropriate certificate of limited partnership, amendment, or  
22 statement of correction to be signed and delivered to the department for filing.

23           (b) Withdraws from future participation as an owner in the enterprise by  
24 signing and delivering to the department for filing a statement of negation under this  
25 section.

1           **(2)** A person that makes an investment described in sub. (1) is liable to the same  
2 extent as a general partner to any 3rd party that enters into a transaction with the

5 amendment, or statement of correction to show that the person is not a general  
6 partner.

7           **(3)** If a person makes a diligent effort in good faith to comply with sub. (1) (a)

21           (b) As a result of a transaction effective under subch. XI.

22           (c) With the affirmative vote or consent of all the partners.

23           (d) As provided in s. 179.0801 (1) (c) 2.

24           **(3)** A person may become a general partner without doing any of the following:

25           (a) Acquiring a transferable interest.

1 (b) Making or being obligated to make a contribution to the partnership.

2 **179.0402 General partner agent of limited partnership.** Subject to the  
3 effect of a statement of partnership authority under s. 179.04023, the following rules  
4 apply:

5 (1) Each general partner is an agent of the limited partnership for the purposes  
6 of its activities and affairs. An act of a general partner, including the signing of a  
7 record in the partnership's name, for apparently carrying on in the ordinary course  
8 the partnership's activities and affairs or activities and affairs of the kind carried on  
9 by the partnership binds the partnership, unless the general partner did not have  
10 authority to act for the partnership in the particular matter and the person with  
11 which the general partner was dealing knew or had notice that the general partner  
12 lacked authority.

13 (2) An act of a general partner which is not apparently for carrying on in the  
14 ordinary course the limited partnership's activities and affairs or activities and  
15 affairs of the kind carried on by the partnership binds the partnership only if the act  
16 was actually authorized by all the other partners.

17 **179.04023 Statement of partnership authority. (1) (a)** A limited  
18 partnership may deliver to the department for filing a statement of partnership  
19 authority.

20 (b) The statement of authority must include all of the following:

21 1. The name of the partnership.

22 2. The street address of the partnership's registered office in this state and the  
23 name and e-mail address of its registered agent at that office.

**ASSEMBLY BILL 566****SECTION 143**

1 (c) With respect to any position that exists in or with respect to the partnership,  
2 the statement of authority may state the authority, or limitations on the authority,  
3 of all persons holding the position to do any of the following:

4 1. Sign an instrument transferring real property held in the name of the  
5 partnership.

6 2. Enter into other transactions on behalf of, or otherwise act for or bind, the  
7 partnership.

8 (d) The statement of authority may state the authority, or limitations on the  
9 authority, of a specific person to do any of the following:

10 1. Sign an instrument transferring real property held in the name of the  
11 partnership.

12 2. Enter into other transactions on behalf of, or otherwise act for or bind, the  
13 partnership.

14 **(2)** To amend or cancel a statement of authority filed by the department, a  
15 limited partnership must deliver to the department for filing an amendment or  
16 cancellation stating all of the following:

17 (a) The name of the partnership.

18 (b) The street address of the partnership's registered office in this state and the  
19 name and e-mail address of its registered agent at that office.

20 (c) The date the statement being affected became effective.

21 (d) The contents of the amendment or a declaration that the statement is  
22 canceled.

23 **(2m)** (a) A statement of authority is renewable for successive 5-year periods.  
24 To renew a statement of authority filed by the department, a partnership must

1 deliver to the department for filing, during the 3 months before the cancellation  
2 would occur under sub. (10), a statement of renewal that includes all of the following:

3 1. The name of the partnership.

6 3. The statement of authority being affected.

7 4. A declaration that the statement of authority is being renewed.

8 (b) When filed, a statement of renewal that complies with par. (a) renews the  
9 statement of authority for a 5-year period commencing with the date of filing of the  
10 statement of renewal.

11 (3) A statement of authority affects only the power of a person to bind a  
12 partnership to persons that are not partners.

13 (4) Subject to sub. (3) and s. 179.0103 (4) (cr), and except as otherwise provided  
14 in subs. (6) to (8), a limitation on the authority of a person or a position contained in  
15 an effective statement of authority is not by itself evidence of any person's knowledge  
16 or notice of the limitation.

17 (5) Subject to sub. (3), a grant of authority not pertaining to transfers of real  
18 property and contained in an effective statement of authority is conclusive in favor  
19 of a person that gives value in reliance on the grant, except to the extent that when  
20 the person gives value any of the following applies:

21 (a) The person has knowledge to the contrary.

22 (b) The statement has been canceled or restrictively amended under sub. (2).

23 (c) A limitation on the grant is contained in another statement of authority that  
24 became effective after the statement containing the grant became effective.

**ASSEMBLY BILL 566****SECTION 143**

1           **(6)** Subject to sub. (3), an effective statement of authority that grants authority  
2 to transfer real property held in the name of the partnership, a certified copy of which  
3 statement is recorded in the office of the register of deeds for the county in which the  
4 property is located, is conclusive in favor of a person that gives value in reliance on  
5 the grant without knowledge to the contrary, except to the extent that when the  
6 person gives value any of the following applies:

7           (a) The statement has been canceled or restrictively amended under sub. (2),

18          **(8)** Subject to sub. (9), an effective statement of dissolution is a cancellation of  
19 any filed statement of authority for the purposes of sub. (6) and is a limitation on  
20 authority for purposes of sub. (7).

21          **(9)** After a statement of dissolution becomes effective, a limited partnership  
22 may deliver to the department for filing and, if appropriate, may record a statement  
23 of authority that is designated as a postdissolution statement of authority. The  
24 statement operates as provided in subs. (6) and (7).

1           **(10)** Unless canceled earlier, an effective statement of authority is canceled by  
2 operation of law 5 years after the date on which the statement, or its most recent

17           **179.0403 Limited partnership liable for general partner's actionable**  
18 **conduct.** **(1)** A limited partnership is liable for loss or injury caused to a person,  
19 or for a penalty incurred, as a result of a wrongful act or omission, or other actionable  
20 conduct, of a general partner acting in the ordinary course of partnership activities  
21 and affairs or with the actual or apparent authority of the partnership.

22           **(2)** If, in the course of the limited partnership's activities and affairs or while  
23 acting with actual or apparent authority of the partnership, a general partner  
24 receives or causes the partnership to receive money or property of a person not a

1 partner, and the money or property is misapplied by a general partner, the  
2 partnership is liable for the loss.

3 **179.0404 General partner's liability.** (1) Except as otherwise provided in  
4 subs. (2) and (3), all general partners are liable jointly and severally for all debts,  
5 obligations, and other liabilities of the limited partnership unless otherwise agreed  
6 by the claimant or provided by law.

7 (2) A person that becomes a general partner is not personally liable for a debt,  
8 obligation, or other liability of the limited partnership incurred before the person  
9 became a general partner.

10 (3) (a) A debt, obligation, or other liability of a limited partnership incurred  
11 while the partnership is a limited liability limited partnership is solely the debt,  
12 obligation, or other liability of the limited liability limited partnership. A general  
13 partner is not personally liable, directly or indirectly, by way of contribution or  
14 otherwise, for a debt, obligation, or other liability of the limited liability limited  
15 partnership solely by reason of being or acting as a general partner.

16 (b) This subsection applies despite anything inconsistent in the partnership  
17 agreement that existed immediately before the vote or consent required to become  
18 a limited liability limited partnership under s. 179.0406 (2) (b).

19 (c) This subsection applies regardless of the dissolution of the partnership.

20 (4) The failure of a limited liability limited partnership to observe formalities  
21 relating to the exercise of its powers or management of its activities and affairs is not  
22 a ground for imposing liability on a general partner for a debt, obligation, or other  
23 liability of the partnership.

24 (5) An amendment of a certificate of limited partnership which deletes a  
25 statement that the limited partnership is a limited liability limited partnership does

1 not affect the limitation in this section on the liability of a general partner for a debt,  
2 obligation, or other liability of the limited partnership incurred before the  
3 amendment became effective.

4 **179.0405 Actions against partnership and partners.** (1) To the extent not  
5 inconsistent with s. 179.0404, a general partner may be joined in an action against  
6 the limited partnership or named in a separate action.

7 (2) A judgment against a limited partnership is not by itself a judgment against  
8 a general partner. A judgment against a partnership may not be satisfied from a  
9 general partner's assets unless there is also a judgment against the general partner.

10 (3) A judgment creditor of a general partner may not levy execution against the  
11 assets of the general partner to satisfy a judgment based on a claim against the  
12 limited partnership unless the partner is personally liable for the claim under s.  
13 179.0404 and any of the following is true:

14 (a) A judgment based on the same claim has been obtained against the limited  
15 partnership and a writ of execution on the judgment has been returned unsatisfied  
16 in whole or in part.

17 (b) The partnership is a debtor in bankruptcy.

18 (c) The general partner has agreed that the creditor need not exhaust  
19 partnership assets.

20 (d) A court grants permission to the judgment creditor to levy execution against  
21 the assets of a general partner based on a finding that partnership assets subject to  
22 execution are clearly insufficient to satisfy the judgment, that exhaustion of  
23 partnership assets is excessively burdensome, or that the grant of permission is an  
24 appropriate exercise of the court's equitable powers.

1 (e) Liability is imposed on the general partner by law or contract independent  
2 of the existence of the partnership.

3 **179.0406 Management rights of general partner.** (1) Each general  
4 partner has equal rights in the management and conduct of the limited partnership's  
5 activities and affairs. Except as otherwise provided in this chapter, any matter  
6 relating to the activities and affairs of the partnership is decided exclusively by the  
7 general partner or, if there is more than one general partner, by a majority of the

19 without a meeting of the general partners entitled to vote or consent if all of such  
20 partners consent to the action. The consent shall be evidenced by one or more written  
21 consents describing the action, signed by each of such partners, and delivered to the  
22 partnership for inclusion in the partnership records. Unless otherwise provided in  
23 the partnership agreement, if a person, whether or not then a general partner, so  
24 consenting directs, whether through instruction to an agent or otherwise, that such  
25 consent will be effective at a future time, including a time determined upon the

1 happening of an event, then the person shall be deemed to have consented as a  
2 partner at this future time so long as the person is then a general partner and did

6 the partnership beyond the amount of capital the general partner agreed to  
7 contribute.

8 (4) A payment or advance made by a general partner which gives rise to an  
9 obligation of the limited partnership under sub. (3) or s. 179.0408 (1) constitutes a  
10 loan to the limited partnership which accrues interest from the date of the payment  
11 or advance.

12 (5) Unless authorized by the partnership agreement or otherwise in  
13 accordance with this chapter, a general partner is not entitled to remuneration for  
14 services performed for the partnership.

15 **179.0407 Rights to information of general partner and person**  
16 **dissociated as general partner.** (1) A general partner may inspect and copy  
17 required information during regular business hours in the limited partnership's  
18 principal office, without having any particular purpose for seeking the information.

19 (2) On reasonable notice, a general partner may inspect and copy during  
20 regular business hours, at a reasonable location specified by the limited partnership,  
21 any record maintained by the partnership regarding the partnership's activities,  
22 affairs, financial condition, and other circumstances, to the extent the information  
23 is material to the general partner's rights and duties under the partnership  
24 agreement or this chapter.

22           (b) The person seeks the information or record in good faith.

23           (c) The person satisfies the requirements imposed on a limited partner by s.  
24 179.0304 (2).

1           **(6)** A limited partnership shall respond to a demand made pursuant to sub. (5)

5           **(8)** A general partner or person dissociated as a general partner may exercise

23           **179.0408 Reimbursement; indemnification; advancement; and**  
24 **insurance.** **(1)** A limited partnership shall reimburse a general partner for any  
25 payment made by the general partner in the course of the general partner's activities

1 on behalf of the partnership, if the general partner complied with ss. 179.0406,  
2 179.0409, and 179.0504 in making the payment.

3 (2) A limited partnership shall indemnify and hold harmless a person with

5 liability incurred by the person by reason of the person's former or present capacity  
6 as a general partner, if the claim, demand, debt, obligation, or other liability does not  
7 arise from the person's breach of s. 179.0406, 179.0409, or 179.0504.

8 (3) In the ordinary course of its activities and affairs, a limited partnership may  
9 advance reasonable expenses, including attorney fees and costs, incurred by a person  
10 in connection with a claim or demand against the person by reason of the person's  
11 former or present capacity as a general partner, if the person promises to repay the  
12 partnership if the person ultimately is determined not to be entitled to be  
13 indemnified under sub. (2).

14 (4) A limited partnership may purchase and maintain insurance on behalf of  
15 a general partner against liability asserted against or incurred by the general  
16 partner in that capacity or arising from that status even if, under s. 179.0105 (3) (h),  
17 the partnership agreement could not eliminate or limit the person's liability to the  
18 partnership for the conduct giving rise to the liability.

19 **179.0409 Standards of conduct for general partners.** (1) A general  
20 partner owes to the limited partnership and, subject to s. 179.0901, the other  
21 partners the duties of loyalty and care stated in subs. (2) and (3).

22 (2) The fiduciary duty of loyalty of a general partner includes all of the  
23 following duties:

1           (a) The duty to account to the limited partnership and hold as trustee for it any  
2 property, profit, or benefit derived by the general partner in or from any of the

6           3. The appropriation of a partnership opportunity.

7           (b) The duty to refrain from dealing with the partnership in the conduct or  
8 winding up of the partnership's activities and affairs as or on behalf of a person

10          (c) The duty to refrain from competing with the partnership in the conduct or  
11 winding up of the partnership's activities and affairs.

12          **(3)** The duty of care of a general partner in the conduct or winding up of the  
13 limited partnership's activities and affairs is to refrain from engaging in grossly  
14 negligent or reckless conduct or in conduct for which relief or exoneration from  
15 liability is not permitted under s. 179.0105 (3) (h).

16          **(4)** A general partner shall discharge the duties and obligations under this  
17 chapter or under the partnership agreement and exercise any rights thereunder  
18 consistently with the contractual obligation of good faith and fair dealing.

19          **(5)** A general partner does not violate a duty or obligation under this chapter  
20 or under the partnership agreement solely because the general partner's conduct  
21 furthers the general partner's own interest.

22          **(6)** All the partners of a limited partnership, or one or more disinterested  
23 partners with authority to act in the matter, may authorize or ratify, after full  
24 disclosure of all material facts, a specific act or transaction by a general partner that  
25 otherwise would violate the duty of loyalty.

1 (7) It is a defense to a claim under sub. (2) (b) and any comparable claim in  
2 equity or at common law that the transaction was fair to the limited partnership.

7 SUBCHAPTER V

8 CONTRIBUTIONS AND DISTRIBUTIONS

9 **179.0501 Form of contribution.** A contribution may consist of money or  
10 other property transferred to, services performed for, or another benefit provided to  
11 the limited partnership or an agreement to transfer money or property to, perform  
12 services for, or provide another benefit to the partnership.

13 **179.0502 Liability for contribution.** (1) A person's obligation to make a  
14 contribution to a limited partnership is not excused by the person's death, disability,  
15 termination, or other inability to perform personally.

16 (2) If a person does not fulfill an obligation to make a contribution other than  
17 money, the person is obligated at the option of the limited partnership to contribute  
18 money equal to the value, as stated in the required information, of the part of the  
19 contribution which has not been made.

20 (3) The obligation of a person to make a contribution may be compromised only  
21 by the affirmative vote or consent of all the partners. If a creditor of a limited  
22 partnership extends credit or otherwise acts in reliance on an obligation described  
23 in sub. (1) without knowledge or notice of a compromise under this subsection, the  
24 creditor may enforce the obligation.

**ASSEMBLY BILL 566****SECTION 143****1 179.0503 Sharing of and right to distributions before dissolution. (1)**

2 Any distribution made by a limited partnership before its dissolution and winding  
3 up must be shared among the partners on the basis of the value, as stated in the

13 s. 179.0810 (5), a partnership may distribute an asset in kind only if each part of the  
14 asset is fungible with each other part and each person receives a percentage of the  
15 asset equal in value to the person's share of distributions.

16 (4) If a partner or transferee becomes entitled to receive a distribution, the  
17 partner or transferee has the status of, and is entitled to all remedies available to,  
18 a creditor of the limited partnership with respect to the distribution. However, the  
19 partnership's obligation to make a distribution is subject to offset for any amount  
20 owed to the partnership by the partner or a person dissociated as a partner on whose  
21 account the distribution is made.

22 **179.0504 Limitations on distributions. (1)** A limited partnership may not  
23 make a distribution, including a distribution under s. 179.0810, if after the  
24 distribution any of the following applies:

1 (a) The partnership would not be able to pay its debts as they become due in  
2 the ordinary course of the partnership's activities and affairs.

3 (b) The partnership's total assets would be less than the sum of its total

5 dissolved and wound up at the time of the distribution, to satisfy the preferential  
6 rights upon dissolution and winding up of partners and transferees whose  
7 preferential rights are superior to the rights of persons receiving the distribution.

8 **(2)** A limited partnership may base a determination that a distribution is not  
9 prohibited under sub. (1) on any of the following:

10 (a) Financial statements prepared on the basis of accounting practices and  
11 principles that are reasonable in the circumstances.

12 (b) A fair valuation or other method that is reasonable under the  
13 circumstances.

14 **(3)** Except as otherwise provided in sub. (5), the effect of a distribution under  
15 sub. (1) is measured as follows:

16 (a) In the case of a distribution as described in s. 179.0102 (4) (a) 1. and 2., as  
17 of the earlier of the following:

18 1. The date money or other property is transferred or debt is incurred by the  
19 limited partnership.

20 2. The date the person entitled to the distribution ceases to own the interest  
21 or rights being acquired by the partnership in return for the distribution.

22 (b) In the case of any distribution of indebtedness other than one under par. (a),  
23 as of the date the indebtedness is distributed.

24 (c) In all cases other than those under par. (a) or (b), as of the following:

1           1. The date the distribution is authorized, if the payment occurs not later than  
2           120 days after that date.

3           2. The date the payment is made, if the payment occurs more than 120 days  
4           after the distribution is authorized.

5           **(4)** A limited partnership's indebtedness to a partner or transferee incurred by  
6           reason of a distribution made in accordance with this section is at parity with the  
7           partnership's indebtedness to its general, unsecured creditors, except to the extent  
8           subordinated by agreement.

9           **(5)** A limited partnership's indebtedness, including indebtedness issued as a  
10          distribution, is not a liability for purposes of sub. (1) if the terms of the indebtedness  
11          provide that payment of principal and interest is made only if and to the extent that  
12          a payment of a distribution could then be made under this section. If the  
13          indebtedness is issued as a distribution, each payment of principal or interest is  
14          treated as a distribution, the effect of which is measured on the date the payment is  
15          made.

16          **(6)** In measuring the effect of a distribution under s. 179.0810, the liabilities  
17          of a dissolved limited partnership do not include any claim that has been disposed  
18          of under s. 179.0806, 179.0807, or 179.0808.

19          **179.0505 Liability for improper distributions.** **(1)** If a general partner  
20          consents to a distribution made in violation of s. 179.0504 and in consenting to the  
21          distribution fails to comply with s. 179.0409, the general partner is personally liable  
22          to the limited partnership for the amount of the distribution which exceeds the  
23          amount that could have been distributed without the violation of s. 179.0504.

24          **(2)** A person that receives a distribution knowing that the distribution violated  
25          s. 179.0504 is personally liable to the limited partnership but only to the extent that

1 the distribution received by the person exceeded the amount that could have been  
2 properly paid under s. 179.0504.

3 (3) A general partner against which an action is commenced because the  
4 general partner is liable under sub. (1) with respect to a distribution may do any of

7 distribution and seek to enforce a right of contribution from the person.

8 (b) Implead any person that received the distribution in violation of sub. (2) and

11 (4) An action under this section is barred unless commenced not later than 2  
12 years after the distribution.

14 DISSOCIATION

15 **179.0601 Dissociation as limited partner.** (1) A person does not have a  
16 right to dissociate as a limited partner before the completion of the winding up of the  
17 limited partnership.

18 (2) A person is dissociated as a limited partner when any of the following  
19 applies:

20 (a) The limited partnership knows or has notice of the person's express will to  
21 withdraw as a limited partner, but, if the person has specified a withdrawal date  
22 later than the date the partnership knew or had notice, on that later date.

23 (b) An event stated in the partnership agreement as causing the person's  
24 dissociation as a limited partner occurs.

1 (c) The person is expelled as a limited partner pursuant to the partnership  
2 agreement.

3 (d) The person is expelled as a limited partner by the affirmative vote or consent  
4 of all the other partners if any of the following applies:

5 1. It is unlawful to carry on the limited partnership's activities and affairs with  
6 the person as a limited partner.

7 2. There has been a transfer of all of the person's transferable interest in the  
8 partnership, other than a transfer for security purposes or the entry of a charging  
9 order that is in effect under s. 179.0703 and that has not been foreclosed.

10 3. The person is an entity and all of the following apply:

11 a. The partnership notifies the person that it will be expelled as a limited  
12 partner because the person has filed a statement of dissolution or the equivalent, the  
13 person has been administratively dissolved, the person's charter or the equivalent  
14 has been revoked, or the person's right to conduct activities and affairs has been  
15 suspended by the jurisdiction of the person's governing law.

16 b. The statement of dissolution or the equivalent has not been withdrawn,  
17 rescinded, or revoked, the person has not been reinstated, or the person's charter or  
18 the equivalent or right to conduct activities and affairs has not been reinstated,  
19 within 90 days after the notification under subd. 3. a.

20 4. The person is an unincorporated entity that has been dissolved and whose  
21 activities and affairs are being wound up.

22 (e) On application by the limited partnership or a partner in a direct action  
23 under s. 179.0901, the person is expelled as a limited partner by judicial order  
24 because the person has done any of the following:

1           1. Engaged, or is engaging, in wrongful conduct that has affected adversely and  
2           materially, or will affect adversely and materially, the partnership's activities and  
3           affairs.

4           2. Committed willfully or persistently, or is committing willfully or persistently,  
5           a material breach of the partnership agreement or of the contractual obligation of  
6           good faith and fair dealing under s. 179.0305 (1).

7           3. Engaged, or is engaging, in conduct relating to the partnership's activities  
8           and affairs which makes it not reasonably practicable to carry on the partnership's  
9           activities and affairs with the person as a limited partner.

10          (f) In the case of an individual, the individual dies.

11          (g) In the case of a person that is a testamentary or living trust or is acting as  
12          a limited partner by virtue of being a trustee of such a trust, the trust's entire  
13          transferable interest in the limited partnership is distributed.

14          (h) In the case of a person that is an estate or is acting as a limited partner by  
15          virtue of being a personal representative of an estate, the estate's entire transferable  
16          interest in the limited partnership is distributed.

17          (i) In the case of a person that is not an individual, the existence of the person  
18          terminates.

19          (n) The limited partnership dissolves and completes winding up.

20          **179.0602 Effect of dissociation as limited partner.** (1) If a person is  
21          dissociated as a limited partner, all of the following apply:

22          (a) Subject to s. 179.0704, the person does not have further rights as a limited  
23          partner.

1 (b) The person's contractual obligation of good faith and fair dealing as a limited  
2 partner under s. 179.0305 (1) ends with regard to matters arising and events  
3 occurring after the person's dissociation.

4 (c) Subject to s. 179.0704 and subch. XI, any transferable interest owned by the  
5 person in the person's capacity as a limited partner immediately before dissociation  
6 is owned by the person solely as a transferee.

7 (2) A person's dissociation as a limited partner does not of itself discharge the  
8 person from any debt, obligation, or other liability to the limited partnership or the  
9 other partners which the person incurred while a limited partner.

10 **179.0603 Dissociation as general partner.** A person is dissociated as a  
11 general partner when any of the following applies:

12 (1) The limited partnership knows or has notice of the person's express will to  
13 withdraw as a general partner, but, if the person has specified a withdrawal date  
14 later than the date the partnership knew or had notice, on that later date.

15 (2) An event stated in the partnership agreement as causing the person's  
16 dissociation as a general partner occurs.

17 (3) The person is expelled as a general partner pursuant to the partnership  
18 agreement.

19 (4) The person is expelled as a general partner by the affirmative vote or  
20 consent of all the other partners if any of the following applies:

21 (a) It is unlawful to carry on the limited partnership's activities and affairs with  
22 the person as a general partner.

23 (b) There has been a transfer of all of the person's transferable interest in the  
24 partnership, other than a transfer for security purposes or the entry of a charging  
25 order that is in effect under s. 179.0703 and that has not been foreclosed.

20 persistently, a material breach of the partnership agreement or a duty or obligation  
21 under s. 179.0409.

22 (c) Engaged, or is engaging, in conduct relating to the partnership's activities  
23 and affairs which makes it not reasonably practicable to carry on the activities and  
24 affairs of the limited partnership with the person as a general partner.

25 **(6)** In the case of an individual, any of the following applies:

**ASSEMBLY BILL 566****SECTION 143**

1 (a) The individual dies.

2 (b) A guardian or general conservator for the individual is appointed.

3 (c) A court orders that the individual has otherwise become incapable of  
4 performing the individual's duties as a general partner under this chapter or the  
5 partnership agreement.

6 **(7)** Any of the following applies to the person:

7 (a) The person becomes a debtor in bankruptcy.

8 (b) The person signs an assignment for the benefit of creditors.

9 (c) The person seeks, consents to, or acquiesces in the appointment of a trustee,  
10 receiver, or liquidator of the person or of all or substantially all the person's property.

11 **(8)** In the case of a person that is a testamentary or living trust or is acting as  
12 a general partner by virtue of being a trustee of such a trust, the trust's entire  
13 transferable interest in the limited partnership is distributed.

14 **(9)** In the case of a person that is an estate or is acting as a general partner by  
15 virtue of being a personal representative of an estate, the estate's entire transferable  
16 interest in the limited partnership is distributed.

17 **(10)** In the case of a person that is not an individual, the existence of the person  
18 terminates.

19 **(15)** The limited partnership dissolves and completes winding up.

20 **179.0604 Power to dissociate as general partner; wrongful**  
21 **dissociation.** (1) A person has the power to dissociate as a general partner at any  
22 time, rightfully or wrongfully, by withdrawing as a general partner by express will  
23 under s. 179.0603 (1).

24 **(2)** A person's dissociation as a general partner is wrongful only if any of the  
25 following applies:



**ASSEMBLY BILL 566****SECTION 143**

1 (a) The dissociation is in breach of an express provision of the partnership  
2 agreement.

3 (b) The dissociation occurs before the completion of the winding up of the  
4 limited partnership and any of the following applies:

5 1. The person withdraws as a general partner by express will.

6 2. The person is expelled as a general partner by judicial order under s.  
7 179.0603 (5).

8 3. The person is dissociated as a general partner under s. 179.0603 (7).

9 4. In the case of a person that is not a trust other than a business trust, an  
10 estate, or an individual, the person is expelled or otherwise dissociated as a general  
11 partner because it willfully dissolved or terminated.

12 **(3)** A person that wrongfully dissociates as a general partner is liable to the  
13 limited partnership and, subject to s. 179.0901, to the other partners for damages  
14 caused by the dissociation. The liability is in addition to any debt, obligation, or other  
15 liability of the general partner to the partnership or the other partners.

16 **179.0605 Effect of dissociation as general partner.** (1) If a person is  
17 dissociated as a general partner, all of the following apply:

18 (a) The person's right to participate as a general partner in the management  
19 and conduct of the limited partnership's activities and affairs terminates.

20 (b) The person's duties and obligations as a general partner under s. 179.0409  
21 end with regard to matters arising and events occurring after the person's  
22 dissociation.

23 (c) 1. The person may sign and deliver to the department for filing a statement  
24 of dissociation pertaining to the person and, at the request of the limited partnership,

1 shall sign an amendment to the certificate of limited partnership which states that  
2 the person has dissociated as a general partner.

3 2. The statement of dissociation or amendment under subd. 1. is a limitation  
4 on the authority of a person dissociated as a partner for the purposes of s. 179.04023.

5 (d) Subject to s. 179.0704 and subch. XI, any transferable interest owned by the  
6 person in the person's capacity as a general partner immediately before dissociation  
7 is owned by the person solely as a transferee.

8 **(2)** A person's dissociation as a general partner does not of itself discharge the  
9 person from any debt, obligation, or other liability to the limited partnership or the  
10 other partners which the person incurred while a general partner.

11 **(3m)** Continued use of a limited partnership name, or the name of a person  
12 dissociated as a partner as part of the partnership name, by partners continuing the  
13 partnership's activities and affairs does not of itself make the person dissociated as  
14 a partner liable for an obligation of the partners or the partnership continuing the  
15 partnership's activities and affairs.

16 **179.0606 Power to bind and liability of person dissociated as general**  
17 **partner. (1)** After a person is dissociated as a general partner and before the limited  
18 partnership is merged out of existence or converted under subch. XI, or dissolved, the  
19 partnership is bound by an act of the person with respect to a transaction with  
20 another party only if all of the following apply:

21 (a) The act would have bound the partnership under s. 179.0402 before  
22 dissociation.

23 (b) At the time the other party enters into the transaction, less than 2 years has  
24 passed since the dissociation.

**ASSEMBLY BILL 566****SECTION 143**

1 (c) At the time the other party enters into the transaction, the other party does  
2 not know or have notice of the dissociation and reasonably believes that the person  
3 is a general partner.

4 (2) If a limited partnership is bound under sub. (1), the person dissociated as  
5 a general partner which caused the partnership to be bound is liable to all of the  
6 following:

7 (a) The partnership, for any damage caused to the partnership arising from the  
8 obligation incurred under sub. (1).

9 (b) If a general partner or another person dissociated as a general partner is  
10 liable for the obligation, the general partner or other person, for any damage caused  
11 to the general partner or other person arising from the liability.

12 **179.0607 Liability of person dissociated as general partner to other**  
13 **persons. (1)** A person's dissociation as a general partner does not of itself discharge  
14 the person's liability as a general partner for a debt, obligation, or other liability of  
15 the limited partnership incurred before dissociation. Except as otherwise provided  
16 in subs. (2) and (3), the person is not liable for a partnership obligation incurred after  
17 dissociation.

18 (2) A person whose dissociation as a general partner results in a dissolution  
19 and winding up of the limited partnership's activities and affairs is liable on an  
20 obligation incurred by the partnership under s. 179.0804 to the same extent as a  
21 general partner under s. 179.0404.

22 (3) A person that is dissociated as a general partner without the dissociation  
23 resulting in a dissolution and winding up of the limited partnership's activities and  
24 affairs is liable to a party on a transaction entered into by the partnership after the  
25 dissociation only if all of the following apply:

**ASSEMBLY BILL 566****SECTION 143**

1 (a) A general partner would be liable on the transaction.

2 (b) At the time the other party enters into the transaction, less than 2 years has  
3 passed since the dissociation.

4 (c) At the time the other party enters into the transaction, the other party does  
5 not have knowledge or notice of the dissociation and reasonably believes that the  
6 person is a general partner.

7 (4) By agreement with a creditor of a limited partnership and the partnership,  
8 a person dissociated as a general partner may be released from liability for a debt,  
9 obligation, or other liability of the partnership to the creditor.

10 (5) A person dissociated as a general partner is released from liability for a  
11 debt, obligation, or other liability of the limited partnership if the partnership's  
12 creditor, with knowledge or notice of the person's dissociation as a general partner  
13 but without the person's consent, agrees to a material alteration in the nature or time  
14 of payment of the debt, obligation, or other liability.

15 SUBCHAPTER VII

16 TRANSFERABLE INTERESTS AND

17 RIGHTS OF TRANSFEREES

18 AND CREDITORS

19 **179.0701 Nature of transferable interest.** A transferable interest is  
20 personal property.

21 **179.0702 Transfer of transferable interest.** (1) All of the following apply  
22 to a transfer, in whole or in part, of a transferable interest:

23 (a) It is permissible.

24 (b) It does not by itself cause a partner's dissociation or a dissolution and  
25 winding up of the limited partnership's activities and affairs.

**ASSEMBLY BILL 566****SECTION 143**

1 (c) Subject to s. 179.0704, it does not entitle the transferee to do any of the  
2 following:

3 1. Participate in the management or conduct of the partnership's activities and  
4 affairs.

5 2. Except as otherwise provided in sub. (3), have access to required information,  
6 records, or other information concerning the partnership's activities and affairs.

7 (2) A transferee has the right to receive, in accordance with the transfer,  
8 distributions to which the transferor would otherwise be entitled.

9 (3) In a dissolution and winding up of a limited partnership, a transferee is  
10 entitled to an account of the partnership's transactions only from the date of  
11 dissolution.

12 (4) A transferable interest may be evidenced by a certificate of the interest  
13 issued by a limited partnership in a record, and, subject to this section, the interest  
14 represented by the certificate may be transferred by a transfer of the certificate.

15 (5) A limited partnership need not give effect to a transferee's rights under this  
16 section until the partnership knows or has notice of the transfer.

17 (6) A transfer of a transferable interest in violation of a valid restriction on  
18 transfer contained in the partnership agreement is ineffective if the intended  
19 transferee has knowledge or notice of the restriction at the time of transfer.

20 (7) Except as otherwise provided in ss. 179.0601 (2) (d) 2. and 179.0603 (4) (b),  
21 if a general or limited partner transfers a transferable interest, the transferor  
22 retains the rights of a general or limited partner other than the transferable interest  
23 transferred and retains all the duties and obligations of a general or limited partner.

24 (8) If a general or limited partner transfers a transferable interest to a person  
25 that becomes a general or limited partner with respect to the transferred interest,

1 the transferee is liable for the transferor's obligations under ss. 179.0502 and  
2 179.0505 known to the transferee when the transferee becomes a partner.

3 **179.0703 Charging order.** (1) On application by a judgment creditor of a  
4 partner or transferee, a court may enter a charging order against the transferable  
5 interest of the judgment debtor for the unsatisfied amount of the judgment. A  
6 charging order constitutes a lien on a judgment debtor's transferable interest and  
7 requires the limited partnership to pay over to the person to which the charging order  
8 was issued any distribution that otherwise would be paid to the judgment debtor.

9 (2) To the extent necessary to effectuate the collection of distributions pursuant  
10 to a charging order in effect under sub. (1), the court may do any of the following:

11 (a) Appoint a receiver of the distributions subject to the charging order, with  
12 the power to make all inquiries the judgment debtor might have made.

13 (b) Make all other orders necessary to give effect to the charging order.

14 (3) Upon a showing that distributions under a charging order will not pay the  
15 judgment debt within a reasonable time, the court may foreclose the lien and order  
16 the sale of the transferable interest. The purchaser at the foreclosure sale obtains  
17 only the transferable interest, does not thereby become a partner, and is subject to  
18 s. 179.0702.

19 (4) At any time before foreclosure under sub. (3), the partner or transferee  
20 whose transferable interest is subject to a charging order under sub. (1) may  
21 extinguish the charging order by satisfying the judgment and filing a certified copy  
22 of the satisfaction with the court that issued the charging order.

23 (5) At any time before foreclosure under sub. (3), a limited partnership or one  
24 or more partners whose transferable interests are not subject to the charging order

**ASSEMBLY BILL 566****SECTION 143**

1 may pay to the judgment creditor the full amount due under the judgment and  
2 thereby succeed to the rights of the judgment creditor, including the charging order.

3 (6) This chapter does not deprive any partner or transferee of the benefit of any  
4 exemption law applicable to the transferable interest of the partner or transferee.

5 (7) This section provides the exclusive remedy by which a person seeking, in  
6 the capacity of a judgment creditor, to enforce a judgment against a partner or  
7 transferee may satisfy the judgment from the judgment debtor's transferable  
8 interest.

9 **179.0704 Power of legal representative of deceased partner.** If a partner  
10 dies, the deceased partner's legal representative may exercise any of the following:

11 (1) The rights of a transferee provided in s. 179.0702 (3).

12 (2) For purposes of settling the estate, the rights of a current limited partner  
13 under s. 179.0304.

14 SUBCHAPTER VIII

15 DISSOLUTION AND WINDING UP

16 **179.0801 Events causing dissolution.** (1) A limited partnership is  
17 dissolved, and its activities and affairs must be wound up, upon the occurrence of any  
18 of the following:

19 (a) An event or circumstance that the partnership agreement states causes  
20 dissolution.

21 (b) The affirmative vote or consent to dissolve of all general partners and of  
22 limited partners owning a majority of the rights to receive distributions, whether as  
23 a general partner, a limited partner, or both, at the time the vote or consent is to be  
24 effective.

**ASSEMBLY BILL 566****SECTION 143**

1 (c) After the dissociation of a person as a general partner if any of the following  
2 applies:

3 1. If the partnership has at least one remaining general partner, the  
4 affirmative vote or consent to dissolve the partnership not later than 90 days after  
5 the dissociation by partners owning a majority of the rights to receive distributions,  
6 whether as a general partner, a limited partner, or both, at the time the vote or  
7 consent is to be effective.

8 2. If the partnership does not have a remaining general partner, the passage  
9 of 90 days after the dissociation unless, before the end of the period, all of the  
10 following occur:

11 a. Consent to continue the activities and affairs of the partnership and admit  
12 at least one general partner is given by limited partners owning a majority of the  
13 rights to receive distributions as limited partners at the time the consent is to be  
14 effective.

15 b. At least one person is admitted as a general partner in accordance with the  
16 consent.

17 (d) The passage of 90 consecutive days after the dissociation of the  
18 partnership's last limited partner unless, before the end of the period, the  
19 partnership admits at least one limited partner.

20 (e) The passage of 90 consecutive days during which the partnership has only  
21 one partner unless, before the end of the period, all of the following are satisfied:

22 1. The partnership admits at least one person as a partner.

23 2. If the previously sole remaining partner is only a general partner, the  
24 partnership admits the person as a limited partner.



**ASSEMBLY BILL 566****SECTION 143**

1           3. If the previously sole remaining partner is only a limited partner, the  
2 partnership admits a person as a general partner.

3           (f) On application by a partner, the entry by the circuit court of an order  
4 dissolving the partnership on any of the following grounds:

5           1. That the conduct of all or substantially all the partnership's activities and  
6 affairs is unlawful.

7           2. That it is not reasonably practicable to carry on the partnership's activities  
8 and affairs in conformity with the certificate of limited partnership and partnership  
9 agreement.

10          (g) The signing and filing of a notice of administrative dissolution by the  
11 department under s. 179.0811.

12          **(2)** If an event occurs that imposes a deadline on a limited partnership under  
13 sub. (1) and, before the partnership has met the requirements of the deadline,  
14 another event occurs that imposes a different deadline on the partnership under sub.  
15 (1), all of the following apply:

16          (a) The occurrence of the second event does not affect the deadline caused by  
17 the first event.

18          (b) The partnership's meeting of the requirements of the first deadline does not  
19 extend the second deadline.

20          **179.0802 Winding up. (1)** A dissolved limited partnership shall wind up its  
21 activities and affairs and, except as otherwise provided in s. 179.0803, the  
22 partnership continues after dissolution only for the purpose of winding up.

23          **(2)** (a) In winding up its activities and affairs, a limited partnership shall  
24 discharge the partnership's debts, obligations, and other liabilities, settle and close

**ASSEMBLY BILL 566****SECTION 143**

1 the partnership's activities and affairs, and marshal and distribute the assets of the  
2 partnership.

3 (b) In winding up its activities and affairs, a limited partnership may do any  
4 of the following:

5 1. Amend its certificate of limited partnership to state that the partnership is  
6 dissolved.

7 2. Preserve the partnership's activities and affairs and property as a going  
8 concern for a reasonable time.

9 3. Prosecute and defend actions and proceedings, whether civil, criminal, or  
10 administrative.

11 4. Transfer the partnership's property.

12 5. Settle disputes by mediation or arbitration.

13 6. Deliver to the department for filing a statement of termination stating the  
14 name of the partnership and that the partnership is terminated.

15 7. Perform other acts necessary or appropriate to the winding up.

16 **(3)** If a dissolved limited partnership does not have a general partner, a person  
17 to wind up the dissolved partnership's activities and affairs may be appointed by the  
18 affirmative vote or consent of limited partners owning a majority of the rights to  
19 receive distributions as limited partners at the time the vote or consent is to be  
20 effective. All of the following apply to a person appointed under this subsection:

21 (a) The person has the powers of a general partner under s. 179.0804 but is not  
22 liable for the debts, obligations, and other liabilities of the partnership solely by  
23 reason of having or exercising those powers or otherwise acting to wind up the  
24 dissolved partnership's activities and affairs.

**ASSEMBLY BILL 566****SECTION 143**

1 (b) The person shall deliver promptly to the department for filing an  
2 amendment to the partnership's certificate of limited partnership stating all of the  
3 following:

4 1. That the partnership does not have a general partner.

5 2. The name and street and mailing addresses of the person.

6 3. That the person has been appointed pursuant to this subsection to wind up  
7 the partnership.

8 (4) On the application of a partner, the circuit court may order judicial  
9 supervision of the winding up of a dissolved limited partnership, including the  
10 appointment of a person to wind up the partnership's activities and affairs, if any of  
11 the following applies:

12 (a) The partnership does not have a general partner and within a reasonable  
13 time following the dissolution no person has been appointed pursuant to sub. (3).

14 (b) The applicant establishes other good cause.

15 **179.0803 Rescinding dissolution.** (1) A limited partnership may rescind  
16 its dissolution, unless a statement of termination applicable to the partnership has  
17 become effective, the circuit court has entered an order under s. 179.0801 (1) (f)  
18 dissolving the partnership, or the department has dissolved the partnership under  
19 s. 179.0811.

20 (2) Rescinding dissolution under this section requires all of the following:

21 (a) The affirmative vote or consent of each partner.

22 (b) If the limited partnership has delivered to the department for filing an  
23 amendment to the certificate of limited partnership stating that the partnership is  
24 dissolved, delivery to the department for filing of one of the following:

**ASSEMBLY BILL 566****SECTION 143**

1           1. If the amendment has not become effective, a statement of withdrawal under  
2 s. 179.0208 applicable to the amendment.

3           2. If the amendment has become effective, an amendment to the certificate of  
4 limited partnership stating that dissolution has been rescinded under this section.

5           **(3)** If a limited partnership rescinds its dissolution, all of the following apply:

6           (a) Subject to par. (c), the partnership resumes carrying on its activities and  
7 affairs as if dissolution had never occurred.

8           (b) Subject to par. (c), the rescission relates back to and takes effect as of the  
9 effective date of the dissolution.

10          (c) The rights of a person arising out of an act or omission in reliance on the  
11 dissolution before the person knew or had notice of the rescission are not adversely  
12 affected.

13           **179.0804 Power to bind partnership after dissolution.** (1) A limited  
14 partnership is bound by a general partner's act with respect to a transaction with  
15 another party after dissolution if any of the following applies:

16          (a) The act is appropriate for winding up the partnership's activities and  
17 affairs, unless the partner did not have authority to act for the partnership in the  
18 particular matter and the party with which the partner was dealing knew or had  
19 notice that the partner lacked authority.

20          (b) The act would have bound the partnership under s. 179.0402 before  
21 dissolution if, at the time the other party enters into the transaction, the other party  
22 does not know or have notice of the dissolution.

23           **(2)** A person dissociated as a general partner binds a limited partnership with  
24 respect to a transaction with another party through an act occurring after dissolution  
25 if all of the following apply:

**ASSEMBLY BILL 566****SECTION 143**

1 (a) At the time the other party enters into the transaction, less than 2 years has  
2 passed since the dissociation.

3 (b) At the time the other party enters into the transaction, the other party does  
4 not know or have notice of the dissociation and reasonably believes that the person  
5 is a general partner.

6 (c) The act is appropriate for winding up the partnership's activities and affairs,  
7 or the act would have bound the partnership under s. 179.0402 before dissolution and  
8 at the time the other party enters into the transaction the other party does not know  
9 or have notice of the dissolution.

10 **179.0805 Liability after dissolution of general partner and person**  
11 **dissociated as general partner. (1)** If a general partner having knowledge of the  
12 dissolution causes a limited partnership to incur an obligation under s. 179.0804 (1)  
13 by an act that is not appropriate for winding up the partnership's activities and  
14 affairs, the general partner is liable to all of the following:

15 (a) The partnership, for any damage caused to the partnership arising from the  
16 obligation.

17 (b) If another general partner or person dissociated as a general partner is  
18 liable for the obligation, that other general partner or person, for any damage caused  
19 to that other general partner or person arising from the liability.

20 **(2)** If a person dissociated as a general partner causes a limited partnership  
21 to incur an obligation under s. 179.0804 (2), the person is liable to all of the following:

22 (a) The partnership, for any damage caused to the partnership arising from the  
23 obligation.

**ASSEMBLY BILL 566****SECTION 143**

1 (b) If a general partner or another person dissociated as a general partner is  
2 liable for the obligation, the general partner or other person, for any damage caused  
3 to the general partner or other person arising from the obligation.

4 **179.0806 Known claims against dissolved limited partnership. (1)**

5 Except as otherwise provided in sub. (4), a dissolved limited partnership may give  
6 notice of a known claim under sub. (2), which has the effect provided in sub. (3).

7 (2) A dissolved limited partnership may in a record notify its known claimants  
8 of the dissolution. The notice must do all of the following:

9 (a) Specify the information required to be included in a claim.

10 (b) State that a claim must be in writing and provide a mailing address to which  
11 the claim is to be sent.

12 (c) State the deadline for receipt of a claim, which may not be less than 120 days  
13 after the date the notice is effective under s. 179.0103 (7m).

14 (d) State that the claim will be barred if not received by the deadline.

15 (e) Unless the partnership has been throughout its existence a limited liability  
16 limited partnership, state that the barring of a claim against the partnership will  
17 also bar any corresponding claim against any general partner or person dissociated  
18 as a general partner which is based on s. 179.0404.

19 (3) A claim against a dissolved limited partnership is barred if the claim is a  
20 known claim and the notice requirements of sub. (2) are met with respect to the claim  
21 and any of the following applies:

22 (a) The claim is not received by the specified deadline.

23 (b) If the claim is timely received but rejected by the partnership, all of the  
24 following apply:

**ASSEMBLY BILL 566****SECTION 143**

1           1. The partnership notifies the claimant in a record stating that the claim is  
2 rejected and will be barred unless the claimant commences an action against the  
3 partnership to enforce the claim within 90 days after the notice is effective under s.  
4 179.0103 (7m).

5           2. The claimant does not commence the required action within 90 days after  
6 the notice of rejection is effective under s. 179.0103 (7m).

7           **(4)** This section does not apply to a claim based on an event occurring after the  
8 date of dissolution or a liability that on that date is contingent, or a liability for an  
9 additional assessment under s. 71.74 or for sales and use taxes determined as owing  
10 under s. 77.59.

11           **(4r)** The provisions of s. 179.0103 (7m) shall apply to notices under this section.

12           **179.0807 Claims against dissolved limited partnership generally. (1)**

13 A dissolved limited partnership may publish notice of its dissolution and request  
14 persons having claims, whether known or unknown, against the partnership to  
15 present them in accordance with the notice.

16           **(2)** A notice under sub. (1) must satisfy all of the following:

17           (a) It must be published as a class 1 notice, under ch. 985, in a newspaper of  
18 general circulation in the county in this state in which the dissolved limited  
19 partnership's principal office is located or, if the principal office is not located in this  
20 state, in the county in which the partnership's registered office is or was last located.

21           (b) It must describe the information required to be contained in a claim, state  
22 that the claim must be in writing, and provide a mailing address to which the claim  
23 is to be sent.

**ASSEMBLY BILL 566****SECTION 143**

1 (c) It must state that a claim against the partnership is barred unless an action  
2 to enforce the claim is commenced not later than 2 years after publication of the  
3 notice.

4 (d) Unless the partnership has been throughout its existence a limited liability  
5 limited partnership, it must state that the barring of a claim against the partnership  
6 will also bar any corresponding claim against any general partner or person  
7 dissociated as a general partner which is based on s. 179.0404.

8 **(3)** If a dissolved limited partnership publishes a notice in accordance with sub.  
9 (2), the claim of each of the following claimants is barred unless the claimant  
10 commences an action to enforce the claim against the partnership not later than 2  
11 years after the publication date of the notice:

12 (a) A claimant that did not receive notice in a record under s. 179.0806.

13 (b) A claimant whose claim was timely sent to the partnership but not acted  
14 on.

15 (c) A claimant whose claim is contingent at, or based on an event occurring  
16 after, the date of dissolution.

17 **(4)** A claim not barred under this section or s. 179.0806 may be enforced against  
18 any of the following:

19 (a) A dissolved limited partnership, to the extent of its undistributed assets.

20 (b) Except as otherwise provided in s. 179.0808, if assets of the partnership  
21 have been distributed after dissolution, a partner or transferee to the extent of that  
22 person's proportionate share of the claim or of the partnership's assets distributed  
23 to the partner or transferee after dissolution, whichever is less, but a person's total  
24 liability for all claims under this paragraph may not exceed the total amount of  
25 assets distributed to the person after dissolution.

1 (c) Any person liable on the claim under s. 179.0404 or 179.0607.

2 **179.0808 Court proceedings.** (1) A dissolved limited partnership that has  
3 published a notice under s. 179.0807 may file an application with the circuit court  
4 in the county in this state where the partnership's principal office is located or, if the  
5 principal office is not located in this state, where the partnership's registered office  
6 is or was last located, for a determination of the amount and form of security to be  
7 provided for payment of claims that are contingent or are not known to the  
8 partnership or that are based on an event occurring after the effective date of  
9 dissolution but that, based on the facts known to the partnership, are reasonably  
10 expected to arise after the effective date of dissolution. Provision need not be made  
11 for any claim that is or is reasonably anticipated to be barred under s. 179.0807.

12 (2) Not later than 10 days after the filing of an application under sub. (1), the  
13 dissolved limited partnership shall give notice of the proceeding to each claimant  
14 holding a contingent claim whose contingent claim is known to the partnership.

15 (3) In any proceeding under this section, the court may appoint a guardian ad  
16 litem to represent all claimants whose identities are unknown. The reasonable fees  
17 and expenses of the guardian, including all reasonable expert witness fees, must be  
18 paid by the dissolved limited partnership.

19 (4) A dissolved limited partnership that provides security in the amount and  
20 form ordered by the court under sub. (1) satisfies the partnership's obligations with  
21 respect to claims that are contingent, are not known to the partnership, or are based  
22 on an event occurring after the effective date of dissolution, and such claims may not  
23 be enforced against a partner or transferee on account of assets received in  
24 liquidation.

1           **179.0809 Liability of general partner and person dissociated as**  
2 **general partner when claim against limited partnership barred.** If a claim  
3 against a dissolved limited partnership is barred under s. 179.0806, 179.0807, or  
4 179.0808, any corresponding claim under s. 179.0404 or 179.0607 is also barred.

5           **179.0810 Disposition of assets in winding up; when contributions**  
6 **required. (1)** In winding up its activities and affairs, a limited partnership shall  
7 apply its assets, including the contributions required by this section, to discharge the  
8 partnership's obligations to creditors, including partners that are creditors.

9           **(2)** After a limited partnership complies with sub. (1), any surplus must be  
10 distributed in the following order, subject to any charging order in effect under s.  
11 179.0703:

12           (a) To each person owning a transferable interest that reflects contributions  
13 made and not previously returned, an amount equal to the value of the unreturned  
14 contributions.

15           (b) Among persons owning transferable interests, in proportion to their  
16 respective rights to share in distributions immediately before the dissolution of the  
17 partnership.

18           **(3)** If a limited partnership's assets are insufficient to satisfy all its obligations  
19 under sub. (1), with respect to each unsatisfied obligation incurred when the  
20 partnership was not a limited liability limited partnership, the following rules apply:

21           (a) Each person that was a general partner when the obligation was incurred  
22 and that has not been released from the obligation under s. 179.0607 shall contribute  
23 to the partnership for the purpose of enabling the partnership to satisfy the  
24 obligation. The contribution due from each of those persons is in proportion to the

1 right to receive distributions in the capacity of a general partner in effect for each of  
2 those persons when the obligation was incurred.

3 (b) If a person does not contribute the full amount required under par. (a) with

6 amount necessary to discharge the obligation. The additional contribution due from  
7 each of those other persons is in proportion to the right to receive distributions in the  
8 capacity of a general partner in effect for each of those other persons when the  
9 obligation was incurred.

10 (c) If a person does not make the additional contribution required by par. (b),  
11 further additional contributions are determined and due in the same manner as  
12 provided in that paragraph.

13 (4) A person that makes an additional contribution under sub. (3) (b) or (c) may  
14 recover from any person whose failure to contribute under sub. (3) (a) or (b)  
15 necessitated the additional contribution. A person may not recover under this  
16 subsection more than the amount additionally contributed. A person's liability  
17 under this subsection may not exceed the amount the person failed to contribute.

18 (4r) If a limited partnership does not have sufficient surplus to comply with  
19 sub. (2) (a), any surplus must be distributed among the owners of transferable  
20 interests in proportion to the value of the respective unreturned contributions.

21 (5) All distributions made under sub. (2) must be paid in money.

22 **179.0811 Administrative dissolution.** (1) The department may commence  
23 a proceeding under sub. (2) to dissolve a limited partnership administratively if any  
24 of the following applies:

1 (a) The partnership does not pay, within one year after they are due, any fees  
2 or penalties required to be paid to the department under this chapter.

3 (b) The partnership does not have on file with the department its annual report  
4 within one year after it is due.

5 (c) The partnership is without a registered agent or registered office in this  
6 state for at least one year.

7 (d) The partnership does not notify the department within one year that its  
8 registered agent or registered office has been changed, that its registered agent has  
9 resigned, or that its registered office has been discontinued.

10 (e) The partnership violates s. 940.302 (2) or 948.051 (2).

11 **(2)** If the department determines that one or more grounds exist for  
12 administratively dissolving a limited partnership, the department may give the  
13 partnership notice of the determination. The notice shall be in writing and  
14 addressed to the registered agent of the limited partnership.

15 **(3)** (a) Within 60 days after the notice under sub. (2) takes effect under s.  
16 179.0103 (7m), the limited partnership shall, with respect to each ground for  
17 administrative dissolution, either correct it or demonstrate to the reasonable  
18 satisfaction of the department that it does not exist.

19 (b) If the limited partnership fails to satisfy par. (a), the department may  
20 administratively dissolve the partnership. The department shall enter a notation  
21 in its records to reflect each ground for administrative dissolution and the effective  
22 date of dissolution and shall give the partnership notice of those facts. The notice  
23 shall be in writing and addressed to the registered agent of the partnership.

24 **(3m)** (a) If a notice under sub. (2) or (3) (b) is returned to the department as  
25 undeliverable, the department shall again give notice to the limited partnership.

15 **179.0812 Reinstatement.** (1) A limited partnership that is administratively  
16 dissolved under s. 179.0811 may apply to the department for reinstatement. The  
17 application shall include all of the following:

18 (a) The name of the partnership and the effective date of its administrative  
19 dissolution.

20 (b) A statement that each ground for dissolution either did not exist or has been  
21 cured.

22 (c) A statement that the partnership's name satisfies s. 179.0114.

23 (2) (a) Upon application, the department shall reinstate a limited partnership  
24 if the department determines all of the following:

3           2. That all fees and penalties owed by the partnership to the department under

6 shall enter a notation in its records revising the notation specified in s. 179.0811 (3)  
7 (b) to reflect cancellation of the dissolution and reinstatement of the partnership.  
8 The notation shall state both the department's determination under par. (a) and the  
9 effective date of reinstatement. The department shall provide notice of the  
10 reinstatement to the partnership or its representative.

11           (4) When the reinstatement under this section is effective, all of the following  
12 shall apply:

13           (a) Except as provided in par. (c), the reinstatement relates back to and takes  
14 effect as of the effective date of the administrative dissolution.

15           (b) Except as provided in par. (c), the limited partnership resumes carrying on  
16 its activities and affairs as if the administrative dissolution had never occurred.

17           (c) The rights of a person arising out of an act or omission in reliance on the  
18 dissolution before the person knew or had notice of the reinstatement are unaffected.

19           **179.0813 Appeal from denial of reinstatement.** (1) If the department  
20 denies a limited partnership's application for reinstatement under s. 179.0812, the  
21 department shall serve the partnership with a written notice, addressed to the  
22 registered agent of the partnership, that explains each reason for denial.

23           (2) The limited partnership may appeal the denial of reinstatement to the  
24 circuit court for the county where the partnership's principal office or, if none in this  
25 state, the office of its registered agent is located, within 30 days after service of the

1 notice of denial is effective under s. 179.0103 (7m). To appeal, the partnership shall  
2 petition the court to set aside the administrative dissolution and attach to the  
3 petition copies of the department's notice of administrative dissolution under s.

5 (1), and the department's notice of denial under sub. (1).

6 (3) The court may order the department to reinstate the limited partnership  
7 or may take other action that the court considers appropriate.

8 (4) The court's final decision may be appealed as in other civil proceedings.

9 SUBCHAPTER IX

10 ACTIONS BY PARTNERS

11 **179.0901 Direct action by partner.** (1) Subject to sub. (2), a partner may  
12 maintain a direct action against another partner or the limited partnership, with or  
13 without an accounting as to the partnership's activities and affairs, to enforce the  
14 partner's rights and protect the partner's interests, including rights and interests  
15 under the partnership agreement or this chapter or arising independently of the  
16 partnership relationship.

17 (2) A partner maintaining a direct action under this section must plead and  
18 prove an actual or threatened injury that is not solely the result of an injury suffered  
19 or threatened to be suffered by the limited partnership.

20 (3) A right to an accounting on a dissolution and winding up does not revive  
21 a claim barred by law.

22 **179.0902 Derivative action.** A partner may maintain a derivative action to  
23 enforce a right of a limited partnership if any of the following applies:

1           (1) The partner first makes a demand on the general partners, requesting that  
2 they cause the limited partnership to bring an action to enforce the right, and the  
3 general partners do not bring the action within a reasonable time.

4           (2) A demand under sub. (1) would be futile.

5           **179.0903 Proper plaintiff.** A derivative action to enforce a right of a limited  
6 partnership may be maintained only by a person that is a partner at the time the  
7 action is commenced and to which any of the following applies:

8           (1) The person was a partner when the conduct giving rise to the action  
9 occurred.

10          (2) The person's status as a partner devolved on the person by operation of law  
11 or pursuant to the terms of the partnership agreement from a person that was a  
12 partner at the time of the conduct.

13          **179.0904 Pleading.** In a derivative action under s. 179.0902, the complaint  
14 must state with particularity one of the following:

15          (1) The date and content of plaintiff's demand and the response to the demand  
16 by the general partners.

17          (2) Why demand should be excused as futile.

18          **179.0905 Special litigation committee.** (1) If a limited partnership is  
19 named as or made a party in a derivative proceeding, the partnership may appoint  
20 a special litigation committee to investigate the claims asserted in the proceeding  
21 and determine whether pursuing the action is in the best interests of the  
22 partnership. If the partnership appoints a special litigation committee, on motion  
23 by the committee made in the name of the partnership, except for good cause shown,  
24 the court shall stay discovery for the time reasonably necessary to permit the

1 committee to make its investigation. This subsection does not prevent the court from  
2 doing any of the following:

3 (a) Enforcing a person's right to information under s. 179.0304 or 179.0407.

4 (b) Granting extraordinary relief in the form of a temporary restraining order  
5 or preliminary injunction.

6 **(2)** A special litigation committee must be composed of one or more  
7 disinterested and independent individuals, who may be partners.

8 **(3)** A special litigation committee may be appointed as follows:

9 (a) By a majority of the general partners not named as parties in the  
10 proceeding.

11 (b) If all general partners are named as parties in the proceeding, by a majority  
12 of the general partners named as defendants.

13 **(4)** After appropriate investigation, a special litigation committee may  
14 determine that any of the following is in the best interests of the limited partnership:

15 (a) That the proceeding continue under the control of the plaintiff.

16 (b) That the proceeding continue under the control of the committee.

17 (c) That the proceeding be settled on terms approved by the committee.

18 (d) That the proceeding be dismissed.

19 **(5)** After making a determination under sub. (4), a special litigation committee  
20 shall file with the court a statement of its determination and its report supporting  
21 its determination and shall serve each party with a copy of the determination and  
22 report. The court shall determine whether the members of the committee were  
23 disinterested and independent and whether the committee conducted its  
24 investigation and made its recommendation in good faith, independently, and with  
25 reasonable care, with the committee having the burden of proof. If the court finds

1 that the members of the committee were disinterested and independent and that the  
2 committee acted in good faith, independently, and with reasonable care, the court  
3 shall enforce the determination of the committee. Otherwise, the court shall dissolve

5 the control of the plaintiff.

6 **179.0906 Proceeds and expenses.** (1) (a) Except as otherwise provided in  
7 sub. (2), any proceeds or other benefits of a derivative action, whether by judgment,  
8 compromise, or settlement, belong to the limited partnership and not to the plaintiff.

9 (b) Except as otherwise provided in sub. (2), if the plaintiff receives any  
10 proceeds, the plaintiff shall remit them immediately to the partnership.

11 (2) If a derivative action is successful in whole or in part, the court may award  
12 the plaintiff reasonable expenses, including reasonable attorney fees and costs, from  
13 the recovery of the limited partnership.

14 SUBCHAPTER X

15 FOREIGN LIMITED PARTNERSHIPS

16 **179.1001 Governing law.** (1) The governing law of a foreign limited  
17 partnership governs all of the following:

18 (a) The internal affairs of the partnership.

19 (b) The liability of a partner as partner for a debt, obligation, or other liability  
20 of the foreign partnership.

21 (2) A foreign limited partnership is not precluded from registering to do  
22 business in this state because of any difference between its governing law and the  
23 law of this state.

24 (3) Registration of a foreign limited partnership to do business in this state  
25 does not authorize the foreign partnership to engage in any activities and affairs or

**ASSEMBLY BILL 566****SECTION 143**

1 exercise any power that a limited partnership may not engage in or exercise in this  
2 state.

3 **179.1002 Registration to do business in this state.** (1) A foreign limited  
4 partnership may not do business in this state until it registers with the department  
5 under this chapter.

6 (2) A foreign limited partnership doing business in this state may not maintain  
7 an action or proceeding in this state unless it has registered to do business in this  
8 state.

9 (3) The failure of a foreign limited partnership to register to do business in this  
10 state does not impair the validity of a contract or act of the foreign partnership or its  
11 title to property in this state or preclude it from defending an action or proceeding  
12 in this state.

13 (4) A limitation on the liability of a general partner or limited partner of a  
14 foreign limited partnership is not waived solely because the foreign partnership does  
15 business in this state without registering to do business in this state.

16 (5) Section 179.1001 (1) and (2) applies even if a foreign limited partnership  
17 fails to register under this subchapter.

18 (5m) (a) A foreign limited partnership that does business in this state without  
19 registering to do business in this state is liable to this state, for each year or any part  
20 of a year during which it did business in this state without registration, in an amount  
21 equal to all of the following:

22 1. All fees and other charges that would have been imposed by this chapter on  
23 the foreign limited partnership had it properly filed a foreign registration statement  
24 as required by this section and thereafter filed all reports required by this chapter.

25 2. Fifty percent of the amount owed under subd. 1 or \$5,000, whichever is less.

**ASSEMBLY BILL 566****SECTION 143**

1 (b) The foreign limited partnership shall pay the amount owed under par. (a)  
2 to the department, and the department may not file a foreign registration statement  
3 for the foreign limited partnership until the amount owed is paid. The attorney  
4 general may enforce a foreign limited partnership's obligation to pay to the  
5 department any amount owed under this subsection.

6 **179.1003 Foreign registration statement.** To register to do business in this  
7 state, a foreign limited partnership must deliver a foreign registration statement to  
8 the department for filing. The statement must state all of the following:

9 (1) The name of the partnership and, if the name does not comply with s.  
10 179.0114, a fictitious name adopted pursuant to s. 179.1006 (1).

11 (2) That the partnership is a foreign limited partnership.

12 (3) The jurisdiction of the partnership's governing law.

13 (4) The street and mailing addresses of the partnership's principal office and,  
14 if the partnership's governing law requires the partnership to maintain an office in  
15 the jurisdiction of such governing law, the street and mailing addresses of the  
16 required office.

17 (5) The street address of the partnership's registered office in this state and the  
18 name and e-mail address of its registered agent at that office.

19 **179.1004 Amendment of foreign registration statement.** A registered  
20 foreign limited partnership shall deliver to the department for filing an amendment  
21 to its foreign registration statement if there is a change in any of the following:

22 (1) The name of the partnership and, if the name of the partnership filing an  
23 amendment does not comply with s. 179.0114, a fictitious name adopted pursuant to  
24 s. 179.1006 (1).

25 (1r) The cessation of the partnership's status as a foreign limited partnership.

1           (2) The jurisdiction of the partnership's governing law.

2           (3) An address required by s. 179.1003 (4).

3           (4) The information required by s. 179.1003 (5), unless such information has  
4 previously been changed pursuant to s. 179.0118, 179.0209, or 179.0212.

5           **179.1005 Activities not constituting doing business.** (1) Activities of a  
6 foreign limited partnership which do not constitute doing business in this state  
7 under this subchapter include all of the following:

8           (a) Maintaining, defending, mediating, arbitrating, or settling an action or  
9 proceeding.

10           (b) Carrying on any activity concerning its internal affairs, including holding  
11 meetings of its partners.

12           (c) Maintaining accounts in financial institutions.

13           (d) Maintaining offices or agencies for the transfer, exchange, and registration  
14 of securities of the partnership or maintaining trustees or depositaries with respect  
15 to those securities.

16           (e) Selling through independent contractors.

17           (f) Soliciting or obtaining orders by any means if the orders require acceptance  
18 outside this state before they become contracts.

19           (g) Creating or acquiring indebtedness, mortgages, or security interests in  
20 property.

21           (h) Securing or collecting debts or enforcing mortgages or security interests in  
22 property securing the debts and holding, protecting, or maintaining property.

23           (i) Conducting an isolated transaction that is not in the course of similar  
24 transactions.

25           (j) Owning, without more, property.

**ASSEMBLY BILL 566****SECTION 143**

1 (k) Doing business in interstate commerce.

2 (2) A person does not do business in this state solely by being a partner of a  
3 foreign limited partnership that does business in this state.

4 (3) This section does not apply in determining the contacts or activities that  
5 may subject a foreign limited partnership to service of process, taxation, or  
6 regulation under law of this state other than this chapter.

7 **179.1006 Noncomplying name of foreign limited partnership.** (1) A  
8 foreign limited partnership whose name does not comply with s. 179.0114 may not  
9 register to do business in this state until it adopts, for the purpose of doing business  
10 in this state, a fictitious name that complies with s. 179.0114. After registering to  
11 do business in this state with a fictitious name, the partnership shall only do  
12 business in this state under the fictitious name.

13 (2) If a registered foreign limited partnership changes its name to one that does  
14 not comply with s. 179.0114, it may not do business in this state until it complies with  
15 sub. (1) by amending its registration to adopt a fictitious name that complies with  
16 s. 179.0114.

17 **179.1007 Withdrawal deemed on conversion to or merger into**  
18 **domestic filing entity or domestic limited liability partnership.** A registered  
19 foreign limited partnership that converts to, or merges into, a domestic limited  
20 liability partnership or to or into a domestic entity whose formation requires the  
21 delivery of a record to the department for filing is deemed to have withdrawn its  
22 registration on the effective date of the conversion or merger, unless the registration  
23 is transferred to such partnership pursuant to s. 179.1009.

24 **179.1008 Withdrawal on dissolution or conversion to nonfiling entity**  
25 **other than limited liability partnership.** (1) (a) A registered foreign limited

1 partnership that has dissolved and completed winding up or has converted to, or  
2 merged into, a domestic or foreign entity whose formation does not require the  
3 delivery of a record for filing by the department, other than a limited liability  
4 partnership, shall deliver a statement of withdrawal to the department for filing, as  
5 provided in s. 179.1011.

6 (b) In the case of a merger or conversion, the statement under par. (a) must also  
7 state the name and type of entity to which or into which the partnership has  
8 converted or merged and the jurisdiction of its governing law.

9 (2) After a withdrawal under this section is effective, service of process in any  
10 action or proceeding based on a cause of action arising during the time the foreign  
11 limited partnership was registered to do business in this state may be made  
12 pursuant to s. 179.0121, as provided in s. 179.1011 (2).

13 **179.1009 Transfer of registration.** (1) When a registered foreign limited  
14 partnership has merged into a foreign entity that is not registered to do business in  
15 this state or has converted to a foreign entity required to register with the  
16 department to do business in this state, the foreign entity shall deliver to the  
17 department for filing an application for transfer of registration. The application  
18 must state all of the following:

19 (a) The name of the registered foreign limited partnership before the merger  
20 or conversion.

21 (b) That before the merger or conversion the registration pertained to a foreign  
22 limited partnership.

23 (c) The name of the applicant foreign entity into which the foreign limited  
24 partnership has merged or to which it has been converted and, if the name does not  
25 comply with s. 179.0114, a fictitious name adopted pursuant to s. 179.1006 (1).

1 (d) The type of entity of the applicant foreign entity and the jurisdiction of its  
2 governing law.

3 (e) The street and mailing addresses of the principal office of the applicant  
4 foreign entity and, if the foreign limited partnership's governing law requires the  
5 entity to maintain an office in the jurisdiction of that governing law, the street and  
6 mailing addresses of that office.

7 (f) The street address of the applicant foreign entity's registered office in this  
8 state and the name and e-mail address of its registered agent at that address.

9 **(2)** When an application for transfer of registration takes effect, the  
10 registration of the foreign limited partnership to do business in this state is  
11 transferred without interruption to the foreign entity into which the partnership has  
12 merged or to which it has been converted.

13 **179.10101 Grounds for termination.** (1) The department may terminate  
14 the registration of a registered foreign limited partnership in the manner provided  
15 in s. 179.10102 if any of the following applies:

16 (a) The foreign limited partnership fails to file its annual report with the  
17 department within 4 months after it is due.

18 (b) The foreign limited partnership does not pay, within 4 months after they are  
19 due, any fees or penalties due the department under this chapter.

20 (c) The foreign limited partnership is without a registered agent or registered  
21 office in this state for at least 6 months.

22 (d) The foreign limited partnership does not inform the department under s.  
23 179.0118 or 179.0119 that its registered agent or registered office has changed, that  
24 its registered agent has resigned, or that its registered office has been discontinued,  
25 within 6 months of the change, resignation, or discontinuance.

1 (e) The foreign limited partnership's statement of foreign registration contains  
2 fraudulent or materially false information.

3 (f) The department receives a duly authenticated certificate from the secretary  
4 of state or other official having custody of limited partnership records in the  
5 jurisdiction of the foreign limited partnership's governing law stating that it has  
6 been dissolved or disappeared as the result of a merger or other event.

7 (g) The foreign limited partnership violates s. 940.302 (2) or 948.051 (2).

8 **(2)** If the department receives a certificate under sub. (1) (f) and a statement  
9 by the foreign limited partnership that the certificate is submitted to terminate its  
10 authority to do business in this state, the department shall terminate the foreign  
11 limited partnership's registration under s. 179.10102 (2) (b).

12 **(3)** A court may terminate under s. 946.87 the registration of a foreign limited  
13 partnership authorized to transact business in this state. The court shall notify the  
14 department of the action, and the department shall terminate the foreign limited  
15 partnership's registration under s. 179.10102.

16 **179.10102 Procedure for and effect of termination.** (1) If the department  
17 determines that one or more grounds exist under s. 179.10101 for termination of a  
18 foreign limited partnership's registration, the department may give the foreign  
19 limited partnership notice of the determination. The notice shall be in writing and  
20 addressed to the registered agent of the foreign limited partnership.

21 **(2)** (a) Within 60 days after the notice under sub. (1) takes effect under s.  
22 179.0103 (7m), the foreign limited partnership shall, with respect to each ground for  
23 termination, either correct it or demonstrate to the reasonable satisfaction of the  
24 department that it does not exist.

1 (b) If the foreign limited partnership fails to satisfy par. (a), the department  
2 may terminate the foreign limited partnership's registration by entering a notation  
3 in the department's records to reflect each ground for termination and the effective  
4 date of the termination. The department shall give the foreign limited partnership  
5 notice of each ground for termination and the effective date of the termination. The  
6 notice shall be in writing and addressed to the registered agent of the foreign limited  
7 partnership in this state.

8 (c) 1. The department shall reinstate the registration if the foreign limited  
9 partnership does all of the following within 6 months after the effective date of the  
10 termination:

11 a. Corrects each ground for termination.

12 b. Pays any fees or penalties due the department under this chapter or \$5,000,  
13 whichever is less.

14 2. A reinstatement under this paragraph shall relate back to and take effect  
15 as of the effective date of the termination, and the foreign limited partnership may  
16 resume carrying on its business as if the termination never occurred.

17 **(3)** (a) If a notice under sub. (1) or (2) (b) is returned to the department as  
18 undeliverable, the department shall again give notice to the foreign limited  
19 partnership. Except as provided under par. (b), the notice shall be in writing and  
20 addressed to the principal office of the foreign limited partnership.

21 (b) If the notice under par. (a) is returned to the department as undeliverable  
22 or if the foreign limited partnership's principal office cannot be determined from the  
23 records of the department, the department shall give notice by posting the notice on  
24 the department's Internet site.

1           (4) The authority of a foreign limited partnership to transact business in this  
2 state, other than as provided in s. 179.1005 (1) and (2), ends on the effective date of  
3 the termination of its registration.

4           (5) If the department or a court terminates a foreign limited partnership's  
5 registration, the foreign limited partnership may be served under s. 179.0121(2) or  
6 (3) or the foreign limited partnership's registered agent may be served until the  
7 registered agent's authority is terminated, in any civil, criminal, administrative, or  
8 investigatory proceeding based on a cause of action which arose while the foreign  
9 limited partnership was authorized to do business in this state.

10          (6) Termination of a foreign limited partnership's registration does not  
11 terminate the authority of its registered agent.

12           **179.10103 Appeal from termination.** (1) A foreign limited partnership may  
13 appeal the department's termination of its registration under s. 179.10102 to the  
14 circuit court for the county where the foreign limited partnership's principal office  
15 or, if none in this state, the office of its registered agent is located, within 30 days after  
16 the notice of termination takes effect under s. 179.0103 (7m). The foreign limited  
17 partnership shall appeal by petitioning the court to set aside the termination and  
18 attaching to the petition copies of its registration and the department's notice of  
19 termination.

20          (2) The court may order the department to reinstate the registration or may  
21 take any other action that the court considers appropriate.

22          (3) The court's final decision may be appealed as in other civil proceedings.

23           **179.1011 Withdrawal of registration of registered foreign limited**  
24 **partnership.** (1) A registered foreign limited partnership may withdraw its

1 registration by delivering a statement of withdrawal to the department for filing.

2 The statement of withdrawal must state all of the following:

3 (a) The name of the partnership and the jurisdiction of its governing law.

4 (b) That the partnership is not doing business in this state and that it  
5 withdraws its registration to do business in this state.

6 (c) Whether the partnership revokes the authority of its registered agent to  
7 accept service on its behalf and, in any event, that it also consents to service of process  
8 under sub. (2) in any civil, criminal, administrative, or investigatory proceeding  
9 based on a cause of action arising during the time the partnership was registered to  
10 do business in this state.

11 (d) The mailing address of its principal office or, if it has no principal office, an  
12 address to which service of process may be made under sub. (2), and a commitment  
13 to notify the department in the future of any change in such address.

14 (2) After the withdrawal of the registration of a foreign limited partnership,  
15 service of process in any action or proceeding based on a cause of action arising  
16 during the time the partnership was registered to do business in this state may be  
17 made pursuant to s. 179.0121.

18 **179.1012 Action by attorney general.** The attorney general may maintain  
19 an action to enjoin a foreign limited partnership from doing business in this state in  
20 violation of this subchapter.

21 **SUBCHAPTER XI**

22 **MERGER, INTEREST EXCHANGE,**

23 **CONVERSION, AND DOMESTICATION**

24 **179.1101 Definitions.** In this subchapter:

6 merger.

7           **(3)** “Conversion” means a transaction authorized by ss. 179.1141 to 179.1145.

8           **(4)** “Converted entity” means the converting entity as it continues in existence  
9 after a conversion.

10          **(5)** “Converting entity” means an entity that engages in a conversion.

11          **(8)** “Domesticated entity” means the domesticating entity as it continues in  
12 existence after a domestication.

13          **(9)** “Domesticating entity” means either a non-United States entity or a  
14 Wisconsin limited partnership that engages in a domestication.

15          **(10)** “Domestication” means a transaction authorized by ss. 179.1151 to  
16 179.1155.

17          **(16)** “Interest” means any of the following:

18           (a) A share in a business corporation.

19           (b) A membership in a nonprofit or nonstock corporation.

20           (c) A partnership interest in a general partnership.

21           (d) A partnership interest in a limited partnership.

22           (e) A membership interest in a limited liability company.

23           (f) A membership interest or stock in a general cooperative association.

24           (g) A membership interest in a limited cooperative association.

25           (h) A membership in an unincorporated association.

1 (i) A beneficial interest in a statutory trust, business trust, or common-law  
2 business trust.

3 (j) A comparable interest in any other type of unincorporated entity.

4 **(17)** “Interest exchange” means a transaction authorized by ss. 179.1131 to  
5 179.1135.

6 **(18)** “Interest holder” means any of the following:

7 (a) A shareholder of a business corporation.

8 (b) A member of a nonprofit or nonstock corporation.

9 (c) A general partner of a general partnership.

10 (d) A general partner of a limited partnership.

11 (e) A limited partner of a limited partnership.

12 (f) A member of a limited liability company.

13 (g) A member or stockholder of a general cooperative association.

14 (h) A member of a limited cooperative association.

15 (i) A member of an unincorporated association.

16 (j) A beneficiary or beneficial owner of a statutory trust, business trust, or  
17 common-law business trust.

18 (k) Any other direct holder of an interest.

19 **(19)** “Interest holder liability” means any of the following:

20 (a) Personal liability for a debt, obligation, or other liability of an entity which  
21 is imposed on a person under any of the following circumstances:

22 1. Solely by reason of the status of the person as an interest holder of the entity  
23 under its governing law.

24 2. Under the organizational documents of the entity in accordance with its  
25 governing law which make one or more specified interest holders or categories of

1 interest holders liable in their capacity as interest holders for all or specified  
2 liabilities of the entity.

3 (b) An obligation of an interest holder of an entity under its organizational  
4 documents to contribute to the entity.

5 **(20)** “Merger” means a transaction authorized by ss. 179.1121 to 179.1125.

6 **(21)** “Merging entity” means an entity that is a party to a merger and exists  
7 immediately before the merger becomes effective.

8 **(22m)** “Non-United States entity” means an entity whose governing law is the  
9 law of any jurisdiction other than the United States or any state, but does not include  
10 an entity that has domesticated under the law of any other state.

11 **(23m)** “Organizational documents” means, with respect to an entity, whether  
12 in a record or, to the extent permitted under the entity’s governing law, other than  
13 in a record, the following or its equivalent under the entity’s governing law:

14 (a) For a domestic or foreign corporation, whether or not for profit, its articles  
15 of incorporation and bylaws.

16 (b) For a domestic or foreign partnership, its partnership agreement and, in the  
17 case of a domestic or foreign limited liability partnership, its statement of  
18 qualification as a limited liability partnership or foreign limited liability  
19 partnership.

20 (c) For a domestic or foreign limited partnership, its certificate of limited  
21 partnership and partnership agreement.

22 (d) For a domestic or foreign limited liability company, its certificate or articles  
23 of organization and operating agreement.

24 (e) For a business trust, its agreement of trust and declaration of trust.

1 (f) For any other entity, the basic records, agreements, or other items that  
2 create the entity and control its internal governance and the relations among its  
3 interest holders.

4 (24) "Plan" means a plan of merger under s. 179.1122, a plan of interest  
5 exchange under s. 179.1132, a plan of conversion under s. 179.1142, or a plan of  
6 domestication under s. 179.1152.

7 (37) "Surviving entity" means the entity that continues in existence after or is  
8 created by a merger.

9 (38) "Type of entity" means a generic form of entity that is any of the following:

10 (a) Recognized at common law.

11 (b) Recognized under a governing law.

12 **179.1102 Relationship of subchapter to other laws.** (1) This subchapter  
13 does not authorize an act prohibited by, and does not affect the application or  
14 requirements of, law other than this subchapter.

15 (2) A transaction effected under this subchapter may not create or impair a  
16 right, duty, or obligation of a person under the law of this state, other than this  
17 subchapter, relating to a change in control, takeover, business combination,  
18 control-share acquisition, or similar transaction involving a domestic constituent,  
19 acquired, or converting entity.

20 **179.1103 Existing purpose.** (2) Property held for a charitable purpose under  
21 the law of this state by a domestic or foreign entity immediately before a transaction  
22 under this subchapter becomes effective may not, as a result of the transaction, be  
23 diverted from the objects for which it was donated, granted, devised, or otherwise  
24 transferred. An entity that is or plans to be engaged in a transaction covered by this  
25 subchapter may apply to the circuit court for a determination regarding the

1 transaction's compliance with cy pres or other law dealing with nondiversion of  
2 charitable assets.

3 (3) A bequest, devise, gift, grant, or promise contained in a will or other  
4 instrument of donation, subscription, or conveyance that is made to a merging entity  
5 which is not the surviving entity and that takes effect or remains payable after the  
6 merger inures to the surviving entity.

7 (4) A trust obligation that would govern property if transferred to a  
8 nonsurviving entity applies to property that is transferred to the surviving entity  
9 under this section.

10 **179.1104 Nonexclusivity.** The fact that a transaction under this subchapter  
11 produces a certain result does not preclude the same result from being accomplished  
12 in any other manner permitted by law other than this subchapter.

13 **179.1105 Reference to external facts.** A plan may refer to facts  
14 ascertainable outside the plan if the manner in which the facts will operate upon the  
15 plan is specified in the plan. The facts may include the occurrence of an event or a  
16 determination or action by a person, whether or not the event, determination, or  
17 action is within the control of a party to the transaction.

18 **179.1121 Merger authorized.** (1) One or more domestic limited  
19 partnerships may merge with or into one or more other constituent entities pursuant  
20 to ss. 179.1121 to 179.1125 and a plan of merger if the merger is permitted under the  
21 governing law of each constituent entity and each constituent entity approves the  
22 plan of merger in the manner required by its governing law.

23 (2) One or more other domestic or foreign entities may merge with or into a  
24 domestic limited partnership pursuant to ss. 179.1121 to 179.1125 and a plan of  
25 merger if the merger is permitted under the governing law of each constituent entity

1 and each constituent entity approves the plan of merger in the manner required by  
2 its governing law.

3 **179.1122 Plan of merger.** (1) A plan of merger must be in a record and  
4 contain all of the following:

5 (a) As to each constituent entity, its name, type of entity, and governing law.

6 (b) The terms and conditions of the merger.

7 (c) The manner and basis of converting the interests in each constituent entity  
8 into interests, securities, or obligations of the surviving entity, rights to acquire such  
9 interests or securities, money, other property, or any combination of the foregoing.

10 (d) If the surviving entity preexists the merger, any proposed amendments to  
11 its organizational documents that are to be in a record immediately after the merger  
12 becomes effective.

13 (e) If the surviving entity is to be created in the merger, any of its organizational  
14 documents that are to be in a record immediately after the merger becomes effective.

15 (f) Any other matters required under the governing law of any constituent  
16 entity.

17 (2) In addition to the requirements of sub. (1), a plan of merger may contain  
18 any other provision relating to the merger and not prohibited by law.

19 **179.1123 Approval of merger; amendment; abandonment.** (1) Subject  
20 to s. 179.1161, a plan of merger must be approved by a vote or consent of all of the  
21 following with respect to each domestic limited partnership that is a constituent  
22 entity:

23 (a) All general partners.

24 (b) Partners owning a majority of the rights to receive distributions, whether  
25 as a general partner, a limited partner, or both.

1           (2) Subject to s. 179.1161 and the governing law of each constituent entity, after  
2 a plan of merger is approved, and at any time before a merger becomes effective, the  
3 constituent entities may amend the plan of merger or abandon the merger as

5 with the same vote or consent as was required to approve the plan of merger.

6           (3) If, after articles of merger have been delivered to the department for filing  
7 and before the merger becomes effective, the plan of merger is amended in a manner  
8 that requires an amendment to the articles of merger or if the merger is abandoned,  
9 a statement of amendment or abandonment, signed by a constituent entity, must be  
10 delivered to the department for filing before the merger becomes effective. When the  
11 statement of abandonment becomes effective, the merger is abandoned and does not  
12 become effective. The statement of amendment or abandonment must contain all of  
13 the following:

14           (a) The name of each constituent entity.

15           (b) The amendment to or the abandonment of the articles of merger.

16           (c) A statement that the amendment or abandonment was approved in  
17 accordance with this section.

18           (4) In addition to approval under sub. (1), a plan of merger must be approved  
19 by each constituent entity that is not a domestic limited partnership in accordance  
20 with any requirements of its governing law.

21           **179.1124 Filings required for merger; effective date.** (1) After a merger  
22 has been approved with respect to each constituent entity in accordance with its  
23 governing law, the constituent entities shall deliver, or cause to be delivered, to the  
24 department for filing articles of merger setting forth all of the following:

25           (a) The name, type of entity, and governing law of each constituent entity.

1 (b) The name, type of entity, and governing law of the surviving entity and, if  
2 the surviving entity is created by the merger, a statement to that effect.

3 (c) A statement that the plan of merger has been approved and adopted by each

5 (d) 1. If the surviving entity preexists the merger, any amendments to its  
6 organizational documents under s. 179.1122 (1) (d) that are to be in a public record  
7 under its governing law or, if there are no such amendments, a statement to that  
8 effect.

9 2. If the surviving entity is to be created in the merger, any of its organizational  
10 documents that are to be in a public record under its governing law.

11 (e) A statement that the plan of merger is on file at the principal office of the  
12 surviving entity.

13 (f) A statement that upon request the surviving entity will provide a copy of the  
14 plan of merger to any interest holder of a constituent entity.

15 (g) A statement whether s. 179.1161 applies to the merger.

16 (2) In addition to the requirements of sub. (1), the articles of merger may  
17 contain any other provisions relating to the merger, as determined by the constituent  
18 entities in accordance with the plan of merger.

19 (3) If the surviving entity is a foreign entity that will be required to register to  
20 do business in this state immediately after the merger and it has not previously  
21 registered to do so or been assigned a registration to do so under s. 179.1009, it shall  
22 so register.

23 (4) A merger takes effect at the effective date and time of the articles of merger.

24 **179.1125 Effect of merger.** (1) When a merger becomes effective, all of the  
25 following apply:

1           (a) Each merging entity merges into the surviving entity, and the separate  
2 existence of every constituent entity that is a party to the merger, except the  
3 surviving entity, ceases.

4           (am) 1. Except as provided in this paragraph, no interest holder shall have  
5 interest holder liability with respect to any of the constituent entities.

6           2. If, under the governing law of a constituent entity, one or more of the interest  
7 holders thereof had interest holder liability prior to the merger with respect to the  
8 entity, such interest holder or holders shall continue to have such liability and any  
9 associated contribution or other rights to the extent provided in such governing law  
10 with respect to debts, obligations, and other liabilities of the entity that accrued  
11 during the period or periods in which such interest holder or holders had such  
12 interest holder liability.

13           3. If, under the governing law of the surviving entity, one or more of the interest  
14 holders thereof will have interest holder liability after the merger with respect to the  
15 surviving entity, such interest holder or holders will have such liability and any  
16 associated contribution and other rights to the extent provided in such governing law  
17 with respect to the debts, obligations, and other liabilities of the surviving entity that  
18 accrue on or after the merger.

19           4. This paragraph does not affect liability under any taxation laws.

20           (b) The title to all property owned by each constituent entity is vested in the  
21 surviving entity without transfer, reversion, or impairment.

22           (c) The surviving entity has all debts, obligations, and other liabilities of each  
23 constituent entity.

24           (d) A civil, criminal, or administrative proceeding pending by or against any  
25 constituent entity may be continued as if the merger did not occur, or the surviving

1 entity may be substituted in the proceeding for a constituent entity whose existence  
2 ceased.

3 (e) 1. If the surviving entity preexists the merger, its organizational documents  
4 are amended to the extent, if any, provided in the plan of merger and, to the extent  
5 such amendments are to be reflected in a public record, as provided in the articles  
6 of merger.

7 2. If the surviving entity is created in the merger, its organizational documents  
8 are as provided in the plan of merger and, to the extent such organizational  
9 documents are to be reflected in a public record, as provided in the articles of merger.

10 (f) The interests of each constituent entity that are to be converted into  
11 interests, securities, or obligations of the surviving entity, or rights to acquire such  
12 interests or securities, money, other property, or any combination of the foregoing,  
13 are converted as provided in the plan of merger, and the former interest holders of  
14 the interests are entitled only to the rights provided to them in the plan of merger  
15 or to their rights, if any, under ss. 178.1161, 179.1161, 180.1301 to 180.1331,  
16 181.1180, or otherwise under the governing law of the constituent entity. All other  
17 terms and conditions of the merger also take effect.

18 (g) Except as prohibited by other law or as otherwise provided in the articles  
19 and plan of merger, all of the rights, privileges, immunities, powers, and purposes  
20 of each constituent entity vest in the surviving entity.

21 (h) Except as otherwise provided in the articles and plan of merger, if a merging  
22 entity is a partnership, limited liability company, or other entity subject to  
23 dissolution under its governing law, the merger does not dissolve the merging entity  
24 for the purposes of its governing law.

1           **(2)** (a) When a merger takes effect, the department is an agent of any foreign  
2 surviving entity for service of process in a proceeding to enforce any obligation or the  
3 rights of interest holders, in their capacity as such, of each domestic limited  
4 partnership constituent entity.

5           (b) When a merger takes effect, any foreign surviving entity shall timely honor  
6 the rights and obligations of interest holders under this chapter with respect to each  
7 domestic limited partnership constituent entity.

8           **(3)** When a merger takes effect, any foreign surviving entity may be served with  
9 process in this state for the collection and enforcement of any debts, obligations, or  
10 other liabilities of a domestic merging entity in the manner provided in s. 179.0121,  
11 except that references to the department in that section shall be treated as references  
12 to the appropriate authority under the foreign surviving entity's governing law for  
13 purposes of applying this subsection.

14           **179.1131 Interest exchange authorized.** (1) A domestic limited  
15 partnership may acquire all of one or more classes or series of interests of another  
16 domestic or foreign entity pursuant to ss. 179.1131 to 179.1135 and a plan of interest  
17 exchange if the interest exchange is permitted under the governing law applicable  
18 to the partnership and the acquired entity.

19           **(2)** All of one or more classes or series of interests of a domestic limited  
20 partnership may be acquired by another domestic or foreign entity pursuant to ss.  
21 179.1131 to 179.1135 and a plan of interest exchange if the interest exchange is  
22 permitted under the governing law applicable to the acquiring entity and the  
23 partnership.

24           **179.1132 Plan of interest exchange.** (1) A plan of interest exchange must  
25 be in a record and contain all of the following:

3 (b) The terms and conditions of the interest exchange.

6 interests or securities, money, other property, or any combination of the foregoing.

7 (d) Any proposed amendments to the organizational documents of the  
8 acquiring or acquired entity that will take effect when the interest exchange becomes  
9 effective.

10 (e) Any other matters required under the governing law of the acquired or  
11 acquiring entity.

12 (f) A statement whether s. 179.1161 applies to the interest exchange.

13 **(2)** In addition to the requirements of sub. (1), a plan of interest exchange may  
14 contain any other provision relating to the interest exchange and not prohibited by  
15 law.

16 **179.1133 Approval of interest exchange; amendment; abandonment.**

17 **(1)** Subject to s. 179.1161, a plan of interest exchange must be approved by a vote  
18 or consent of all of the following with respect to each domestic limited partnership  
19 acquired entity:

20 (a) All general partners.

21 (b) Partners owning a majority of the rights to receive distributions, whether  
22 as a general partner, limited partner, or both.

23 **(2)** Subject to s. 179.1161 and the governing law of each of the acquiring entity  
24 and acquired entity, after a plan of interest exchange is approved, and at any time  
25 before an interest exchange becomes effective, except as otherwise provided in the

1 plan of interest exchange, the acquiring and acquired entities may amend the plan  
2 of interest exchange or abandon the interest exchange as provided in the plan of  
3 interest exchange with the same vote or consent as was required to approve the plan  
4 of interest exchange.

5 (3) If, after articles of interest exchange have been delivered to the department  
6 for filing and before the interest exchange becomes effective, the plan of interest  
7 exchange is amended in a manner that requires an amendment to the articles of  
8 interest exchange or if the interest exchange is abandoned, a statement of  
9 amendment or abandonment, signed by either the acquiring entity or the acquired  
10 entity, must be delivered to the department for filing before the interest exchange  
11 becomes effective. When a statement of abandonment becomes effective, the interest  
12 exchange is abandoned and does not become effective. The statement of amendment  
13 or abandonment must contain all of the following:

- 14 (a) The name of the acquiring and acquired entities.  
15 (b) The amendment to or abandonment of the articles of interest exchange.  
16 (c) A statement that the amendment or abandonment was approved in  
17 accordance with this section.

18 (4) In addition to approval under sub. (1), a plan of interest exchange must be  
19 approved by any acquiring or acquired entity that is not a domestic limited  
20 partnership in accordance with any requirements of its governing law.

21 **179.1134 Filings required for interest exchange; effective date. (1)**  
22 After an interest exchange has been approved with respect to the acquiring and  
23 acquired entity in accordance with their governing laws, the acquiring entity shall  
24 deliver, or cause to be delivered, to the department for filing articles of interest  
25 exchange setting forth all of the following:

2 (b) The name, type of entity, and governing law of the acquiring entity.

3 (c) A statement that the plan of interest exchange has been approved by the

5 (d) Any amendments to the organizational documents of the acquired or  
6 acquiring entity that are to be in a public record under their respective governing  
7 laws or, if there are no such amendments, a statement to that effect.

8 (e) A statement that the plan of interest exchange is on file at the principal  
9 office of the acquiring entity.

10 (f) A statement that upon request the acquiring entity will provide a copy of the  
11 plan of interest exchange to any interest holder of the acquired entity.

16           **(3)** A limited liability company has perpetual duration.

19           **183.0109 Powers.** A limited liability company has the capacity to sue and be  
20 sued in its own name and the power to do all things necessary or convenient to carry  
21 on its activities and affairs.

22           **183.0110 Applicability. (1)** This chapter applies to a limited liability  
23 company formed on or after January 1, 2023.

24           **(2)** On January 1, 2023, this chapter applies to a limited liability company

20 (b) The date shown on the return receipt, if signed on behalf of the company or  
21 foreign company.

22 (c) Five days after it is deposited in the U.S. mail, or with the commercial  
23 delivery service, if correctly addressed and with sufficient postage or payment.

24 (3) If process, notice, or demand in an action cannot be served on a limited  
25 liability company or registered foreign limited liability company pursuant to sub. (1)

1 or (2), service may be made by handing a copy to the individual in charge of any  
2 regular place of business or activity of the company or foreign company if the  
3 individual served is not a plaintiff in the action. If the address of the company's or

6 3 notice, under ch. 985, in the community where the company's or foreign company's

13 **183.0120 Delivery of record.** (1) Except as otherwise provided in this  
14 chapter, permissible means of delivery of a record include delivery by hand, mail,

16 (2) Delivery to the department is effective only when a record is received by the

18 **183.0122 Filing fees; certified copies.** (1) Subject to sub. (2) (a), the  
19 department may collect a fee for filing, or providing a certified copy of, a record under  
20 this chapter. The department may charge a fee for providing a certified copy of any

## FORMATION; ARTICLES OF

## ORGANIZATION AND OTHER FILINGS

**183.0201 Formation of limited liability company; articles of organization.** (1) One or more persons may act as organizers to form a limited liability company by signing and delivering to the department for filing articles of organization.

(2) The articles of organization shall contain all of the following information:

(a) A statement that the limited liability company is organized under this chapter.

(b) The name of the limited liability company, which must comply with s. 183.0112.

(c) The street and mailing addresses of the company's principal office.

(d) The name and street and mailing and e-mail addresses of the initial registered agent of the limited liability company.

(e) The name and address of each organizer.

(f) If applicable, the delayed effective date and time of the articles of organization permitted under s. 183.0207.

(3) The articles of organization may set forth other information, including any of the following:

(a) If management of the limited liability company is vested in one or more managers, a statement to that effect.

(b) Provisions not inconsistent with law regarding any of the following:

1. The purpose or purposes for which the limited liability company is organized.

2. Managing the business and regulating the affairs of the limited liability company.

1           3. Defining, limiting, and regulating the powers of the limited liability  
2 company, its managers, and its members.

3           4. A par value for transferable interests or classes or series of transferable  
4 interests.

5           (c) Any provision that, under this chapter, is required or permitted to be set  
6 forth in a written operating agreement.

7           **(4)** All of the following rules apply:

8           (a) A limited liability company is formed when the articles of organization  
9 become effective under s. 183.0207.

10          (b) The department's filing of the articles of organization is conclusive proof  
11 that the limited liability company is organized and formed under this chapter.

12          (c) The status of a limited liability company as a limited liability company or  
13 as a foreign limited liability company registered to transact business in this state and  
14 the liability of any member of any such limited liability company is not adversely  
15 affected by errors or subsequent changes in any information stated in any filing  
16 made under this chapter.

17          (d) If a limited liability company or a foreign limited liability company that is  
18 registered to transact business in this state dissolves, but its business continues  
19 without winding up and without liquidating the company, the status of the limited  
20 liability company or foreign limited liability company before dissolution shall  
21 continue to be applicable to the company as it continues its business, and the  
22 company shall not be required to make any new filings under this chapter. Any  
23 filings made by such a limited liability company or foreign limited liability company  
24 before dissolution shall be considered to have been filed by the company while it  
25 continues its business.

1 (e) If a limited liability company or a foreign limited liability company that is  
2 registered to transact business in this state dissolves, any filings made by the  
3 company before dissolution remain in effect as to the company and its members

6 **183.0202 Amendment or restatement of articles of organization. (1)**

7 Articles of organization may be amended or restated at any time.

8 (2) To amend its articles of organization, a limited liability company must  
9 deliver to the department for filing an amendment stating all of the following:

10 (a) The name of the company.

11 (b) The date of filing of its initial articles of organization.

12 (c) The text of the amendment.

13 (3) To restate its articles of organization, a limited liability company must  
14 deliver to the department for filing a restatement, designated as such in its heading.

15 (4) If a member of a member-managed limited liability company, or a manager  
16 of a manager-managed limited liability company, knows or has notice that any  
17 information in the filed articles of organization was inaccurate when the articles  
18 were filed or has become inaccurate due to changed circumstances, the member or  
19 manager shall promptly do one of the following to correct the inaccuracy:

20 (a) Cause the articles to be amended.

21 (b) If appropriate, deliver to the department for filing a statement of change  
22 under s. 183.0116 or a statement of correction under s. 183.0209.

23 **183.0203 Signing of records to be delivered for filing to the**

24 **department. (1)** A record delivered to the department for filing pursuant to this  
25 chapter must be signed as follows:

15 record and the individual is deceased or incompetent, the record may be signed by  
16 a legal representative of the individual.

17 **(3)** A person that signs a record as an attorney-in-fact or legal representative  
18 affirms as a fact that the person is authorized to sign the record.

19 **183.0204 Signing and filing pursuant to judicial order.** (1) If a person  
20 required by this chapter to sign a record or deliver a record to the department for  
21 filing under this chapter does not do so, any other person that is aggrieved may  
22 petition the circuit court to order any of the following:

23 (a) The person to sign the record.

24 (b) The person to deliver the record to the department for filing.

25 (c) The department to file the record unsigned.

1           (2) If a petitioner under sub. (1) is not the limited liability company or foreign  
2 limited liability company to which the record pertains, the petitioner shall make the  
3 company or foreign company a party to the action.

5           **183.0205 Liability for inaccurate information in filed record.** (1) If a  
6 record delivered to the department for filing under this chapter and filed by the  
7 department contains inaccurate information, a person that suffers loss by reliance  
8 on the information may recover damages for the loss from any of the following:

9           (a) A person that signed the record, or caused another to sign it on the person's  
10 behalf, and knew the information to be inaccurate at the time the record was signed.

11           (b) Subject to sub. (2), a member of a member-managed limited liability  
12 company or a manager of a manager-managed limited liability company if all of the  
13 following apply:

14           1. The record was delivered for filing on behalf of the company.

15           2. The member or manager knew or had notice of the inaccuracy for a  
16 reasonably sufficient time before the information was relied upon so that, before the  
17 reliance, the member or manager reasonably could have done any of the following:

18           a. Effected an amendment under s. 183.0202.

19           b. Filed a petition under s. 183.0204.

20           c. Delivered to the department for filing a statement of change under s.  
21 183.0116 or a statement of correction under s. 183.0209.

22           (2) To the extent the operating agreement of a member-managed limited  
23 liability company expressly relieves a member of responsibility for maintaining the  
24 accuracy of information contained in records delivered on behalf of the company to  
25 the department for filing under this chapter and imposes that responsibility on one

2 members and not to the member that the operating agreement relieves of the

7 **183.0206 Filing requirements.** (1) Subject to sub. (1m), to be filed by the  
8 department pursuant to this chapter, a record must be received by the department,

19           (c) The electronic transmission of the record to the department was defective.

20           (2) To correct a filed record, a person on whose behalf the record was delivered  
21 to the department must deliver to the department for filing a statement of correction.

22           (3) (a) A statement of correction may not state a delayed effective date.

23           (b) A statement of correction must satisfy all of the following:

24           1. It must be signed by the person correcting the filed record.

25           2. It must identify the filed record to be corrected.

1           3. It must specify the inaccuracy or defect to be corrected.

2           4. It must correct the inaccuracy or defect.

3           **(4)** A statement of correction is effective as of the effective date of the filed  
4 record that it corrects except for purposes of s. 183.0103 (4) and as to persons relying  
5 on the uncorrected filed record and adversely affected by the correction. For those  
6 purposes and as to those persons, the statement of correction is effective when filed.

7           **183.0210 Duty of department to file; review of refusal to file; delivery**  
8 **of record by department.** **(1)** The department shall file a record delivered to the  
9 department for filing which satisfies this chapter. The duty of the department under  
10 this section is ministerial.

11           **(2)** When the department files a record, the department shall record it as filed  
12 on the date of its delivery. After filing a record, the department shall deliver to the  
13 person that submitted the record a copy of the record with an acknowledgment of the  
14 date of filing and, in the case of a statement of denial, also to the limited liability  
15 company to which the statement pertains.

16           **(3)** If the department refuses to file a record, the department shall, not later  
17 than 5 business days after the record is delivered, do all of the following:

18           (a) Return the record or notify the person that submitted the record of the  
19 refusal.

20           (b) Provide a brief explanation in a record of the reason for the refusal.

21           **(4)** If the department refuses to file a record, the person that submitted the  
22 record may petition the circuit court to compel filing of the record. The record and  
23 the explanation of the department of the refusal to file must be attached to the  
24 petition. The court may decide the matter in a summary proceeding.

12 or the foreign limited liability company is in existence or is authorized to transact  
13 business in this state.

14          **(5)** Upon request, by telephone or otherwise, the department shall confirm by  
15 telephone any of the information required in a certificate of status under sub. (2) and  
16 may confirm any other information permitted under sub. (3).

17          **183.0212 Annual report for department. (1)** A limited liability company  
18 or registered foreign limited liability company shall deliver to the department for  
19 filing an annual report that states all of the following:

20           (a) The name of the company or foreign company.

21           (b) The street address of its registered agent in this state and the name and  
22 e-mail address of its registered agent at that office.

23           (c) The street address of its principal office.

24           (d) If the company is member managed, the name of at least one member.

22 2. The authority, or limitations on the authority, of a specific person to do any  
23 of the following:

24 a. Sign an instrument transferring real property held in the name of the

1           b. Enter into other transactions on behalf of, or otherwise act for or bind, the  
2 company.

3           **(2)** To amend or cancel a statement of authority filed by the department, a  
4 limited liability company must deliver to the department for filing an amendment

6           (a) The name of the company.

7           (b) The street address of the company's registered office in this state and the  
8 name and e-mail address of its registered agent at that office.

9           (c) The date the statement being affected became effective.

10          (d) The contents of the amendment or a declaration that the statement is  
11 canceled.

12          **(2m)** (a) A statement of authority is renewable for successive 5-year periods.  
13 To renew a statement of authority filed by the department, a limited liability  
14 company must deliver to the department for filing, during the 3 months before the  
15 cancellation would occur under sub. (10), a statement of renewal that includes all of  
16 the following:

17           1. The name of the company.

18           2. The street address of the company's registered office in this state and the  
19 name and e-mail address of its registered agent at that office.

20           3. The statement of authority being affected.

21           4. A declaration that the statement of authority is being renewed.

22          (b) When filed, a statement of renewal that complies with par. (a) renews the  
23 statement of authority for a 5-year period commencing with the date of filing of the  
24 statement of renewal.

1           **(3)** A statement of authority affects only the power of a person to bind a limited  
2 liability company to persons that are not members.

3           **(4)** Subject to sub. (3) and s. 183.0103 (4), and except as otherwise provided in  
4 subs. (6) to (8), a limitation on the authority of a person or a position contained in an  
5 effective statement of authority is not by itself evidence of any person's knowledge  
6 or notice of the limitation.

7           **(5)** Subject to sub. (3), a grant of authority not pertaining to transfers of real  
8 property and contained in an effective statement of authority is conclusive in favor  
9 of a person that gives value in reliance on the grant, except to the extent that when  
10 the person gives value any of the following applies:

11           (a) The person has knowledge to the contrary.

12           (b) The statement has been canceled or restrictively amended under sub. (2).

13           (c) A limitation on the grant is contained in another statement of authority that  
14 became effective after the statement containing the grant became effective.

15           **(6)** Subject to sub. (3), an effective statement of authority that grants authority  
16 to transfer real property held in the name of the limited liability company, a certified  
17 copy of which statement is recorded in the office of the register of deeds for the county  
18 in which the property is located, is conclusive in favor of a person that gives value  
19 in reliance on the grant without knowledge to the contrary, except to the extent that  
20 when the person gives value any of the following applies:

21           (a) The statement has been canceled or restrictively amended under sub. (2)  
22 and a certified copy of the cancellation or restrictive amendment has been recorded  
23 in the office of the register of deeds for the county in which the property is located.

24           (b) A limitation on the grant is contained in another statement of authority that  
25 became effective after the statement containing the grant became effective, and a

1 certified copy of the later-effective statement is recorded in the office of the register  
2 of deeds for the county in which the property is located.

3 (7) Subject to sub. (3), if a certified copy of an effective statement containing  
4 a limitation on the authority to transfer real property held in the name of a limited  
5 liability company is recorded in the office of the register of deeds for the county in  
6 which the property is located, all persons are deemed to know of the limitation.

7 (8) Subject to sub. (9), an effective statement of dissolution or termination is  
8 a cancellation of any filed statement of authority for the purposes of sub. (6) and is  
9 a limitation on authority for the purposes of sub. (7).

10 (9) After a statement of dissolution becomes effective, a limited liability  
11 company may deliver to the department for filing and, if appropriate, may record a  
12 statement of authority that is designated as a post-dissolution statement of  
13 authority. The statement operates as provided in subs. (6) and (7).

14 (10) Unless earlier canceled, an effective statement of authority is canceled by  
15 operation of law 5 years after the date on which the statement, or its most recent  
16 amendment or renewal, becomes effective. This cancellation operates without need  
17 for any recording under sub. (6) or (7).

18 (11) An effective statement of denial operates as a restrictive amendment  
19 under this section and may be recorded by certified copy for purposes of sub. (6) (a).

20 **183.0303 Statement of denial.** A person named in a filed statement of  
21 authority granting that person authority may deliver to the department for filing a  
22 statement of denial that does all of the following:

23 (1) Provides the name of the limited liability company and the caption of the  
24 statement of authority to which the statement of denial pertains.

25 (2) Denies the grant of authority.

1           **183.0304 Liability of members and managers.** (1) A debt, obligation, or  
2 other liability of a limited liability company is solely the debt, obligation, or other  
3 liability of the company. Except as provided in ss. 73.0306, 183.0403, and 183.0406,  
4 a member or manager is not personally liable, directly or indirectly, by way of  
5 contribution or otherwise, for a debt, obligation, or other liability of the company  
6 solely by reason of being or acting as a member or manager. This subsection applies

16           **183.0401 Becoming member.** (1) If a limited liability company is to have  
17 only one member upon formation, the person becomes a member as agreed by that  
18 person and the organizer of the company. That person and the organizer may be, but  
19 need not be, different persons. If different, the organizer acts on behalf of the initial  
20 member.

21           (2) If a limited liability company is to have more than one member upon  
22 formation, those persons become members as agreed by the persons before the  
23 formation of the company. The organizer acts on behalf of the persons in forming the  
24 company and may be, but need not be, one of the persons.

**ASSEMBLY BILL 566****SECTION 616**

1           **(3)** A person becomes an initial member of a limited liability company with the  
2 consent of a majority of the organizers. The organizers may consent to more than one  
3 person simultaneously becoming the company's initial members.

4           **(4)** After formation of a limited liability company, a person becomes a member  
5 in any of the following ways:

6           (a) As provided in the operating agreement.

7           (b) As the result of a transaction effective under subch. X.

8           (c) With the affirmative vote or consent of all the members.

9           (d) As provided in s. 183.0701 (1) (c).

10          (e) As provided in s. 183.0503 (6) (c).

11          **(5)** A person may become a member without doing any of the following:

12          (a) Acquiring a transferable interest.

13          (b) Making or being obligated to make a contribution to the limited liability  
14 company.

15          **183.0402 Form of contribution.** **(1)** A contribution may consist of money  
16 or property transferred to, services performed for, or another benefit provided to the  
17 limited liability company or an agreement to transfer money or property to, perform  
18 services for, or provide another benefit to the company.

19          **(2)** The value of a member's contribution shall be determined in the manner  
20 provided in an operating agreement. If the operating agreement does not so provide,  
21 the value of a contribution shall be approved by the members under s. 183.0407 (2)  
22 (d). This value shall be properly reflected in the records and information kept by the  
23 limited liability company at its principal place of business or activity, and this value  
24 shall be binding and conclusive on the limited liability company and its members.

**ASSEMBLY BILL 566****SECTION 616**

1           **183.0403 Liability for contributions.** (1) A person's obligation to make a  
2 contribution to a limited liability company is not excused by the person's death,  
3 disability, termination, or other inability to perform personally.

4           (2) If a person does not fulfill an obligation to make a contribution other than  
5 money, the person is obligated at the option of the limited liability company to  
6 contribute money equal to the value of the part of the contribution which has not been  
7 made.

8           (3) Unless otherwise provided in a written operating agreement, a member's  
9 obligation to provide tangible or intangible property or other benefit to a limited  
10 liability company, including money, services performed, promissory notes, other  
11 agreements to contribute money or property, and contracts for services to be  
12 performed, as a contribution to the limited liability company may be compromised  
13 only by the written consent of all the members. If a creditor of a limited liability  
14 company extends credit or otherwise acts in reliance on an obligation described in  
15 sub. (1) without knowledge or notice of a compromise under this subsection, the  
16 creditor may enforce the obligation.

17           **183.0404 Sharing of and right to distributions before dissolution.** (1)  
18 Except to the extent necessary to comply with any transfer effective under s.  
19 183.0502 or charging order in effect under s. 183.0503, any distributions made by a  
20 limited liability company before its dissolution and winding up must be made  
21 proportionally among members and dissociated members on the basis of the value  
22 of the contributions made by each such member, as stated in the records required to  
23 be kept under s. 183.0402 (2), or, in the case of a company treated as a partnership  
24 for tax purposes, the partnership capital account of each such member as computed  
25 for tax reporting purposes.

**ASSEMBLY BILL 566****SECTION 616**

1           (2) A person has a right to a distribution before the dissolution and winding  
2 up of a limited liability company only if the company decides to make an interim  
3 distribution. A person's dissociation does not entitle the person to a distribution.

4           (3) A person does not have a right to demand or receive a distribution from a  
5 limited liability company in any form other than money. Except as otherwise  
6 provided in s. 183.0707 (4), a limited liability company may distribute an asset in  
7 kind if each part of the asset is fungible with each other part and each person receives  
8 a percentage of the asset equal in value to the person's share of distributions.

9           (4) If a member or transferee becomes entitled to receive a distribution, the  
10 member or transferee has the status of, and is entitled to all remedies available to,  
11 a creditor of the limited liability company with respect to the distribution. However,  
12 the company's obligation to make a distribution is subject to offset for any amount  
13 owed to the company by the member or a person dissociated as a member on whose  
14 account the distribution is made.

15           **183.0405 Limitations on distributions.** (1) A limited liability company  
16 may not make a distribution, including a distribution under s. 183.0707, if after the  
17 distribution any of the following applies:

18           (a) The company would not be able to pay its debts as they become due in the  
19 ordinary course of the company's activities and affairs.

20           (b) The company's total assets would be less than or equal to the sum of its total  
21 liabilities plus the amount that would be needed, if the company were to be dissolved  
22 and wound up at the time of the distribution, to satisfy the preferential rights upon  
23 dissolution and winding up of members and transferees whose preferential rights  
24 are superior to the rights of persons receiving the distribution.

**ASSEMBLY BILL 566****SECTION 616**

1           **(2)** A limited liability company may base a determination that a distribution  
2 is not prohibited under sub. (1) on any of the following:

3           (a) Financial statements prepared on the basis of accounting practices and  
4 principles that are reasonable in the circumstances.

5           (b) A fair valuation or other method that is reasonable under the  
6 circumstances.

7           **(3)** Except as otherwise provided in sub. (5), the effect of a distribution under  
8 sub. (1) is measured as follows:

9           (a) In the case of a distribution as described in s. 183.0102 (4) (a) 1. and 2., as  
10 of the earlier of the following:

11           1. The date money or other property is transferred or debt is incurred by the  
12 limited liability company.

13           2. The date the person entitled to the distribution ceases to own the interest  
14 or right being acquired by the company in return for the distribution.

15           (b) In the case of any distribution of indebtedness other than one under par. (a),  
16 as of the date the indebtedness is distributed.

17           (c) In all cases other than those under par. (a) or (b), as of the following:

18           1. The date the distribution is authorized, if the payment occurs not later than  
19 120 days after that date.

20           2. The date the payment is made, if the payment occurs more than 120 days  
21 after the distribution is authorized.

22           **(4)** A limited liability company's indebtedness to a member or transferee  
23 incurred by reason of a distribution made in accordance with this section is at parity  
24 with the company's indebtedness to its general, unsecured creditors, except to the  
25 extent subordinated by agreement.

**ASSEMBLY BILL 566****SECTION 616**

1           **(5)** A limited liability company's indebtedness, including indebtedness issued  
2 as a distribution, is not a liability for purposes of sub. (1) if the terms of the  
3 indebtedness provide that payment of principal and interest is made only if and to  
4 the extent that payment of a distribution could then be made under this section. If  
5 the indebtedness is issued as a distribution, each payment of principal or interest is  
6 treated as a distribution, the effect of which is measured on the date the payment is  
7 made.

8           **(6)** In measuring the effect of a distribution under s. 183.0707, the liabilities  
9 of a dissolved limited liability company do not include any claim that has been  
10 disposed of under s. 183.0704, 183.0705, or 183.0706.

11           **183.0406 Liability for improper distributions.** **(1)** Except as otherwise  
12 provided in sub. (2), if a member of a member-managed limited liability company or  
13 manager of a manager-managed limited liability company consents to a distribution  
14 made in violation of s. 183.0405 and in consenting to the distribution fails to comply  
15 with s. 183.0409, the member or manager is personally liable to the company for the  
16 amount of the distribution which exceeds the amount that could have been  
17 distributed without the violation of s. 183.0405.

18           **(2)** To the extent a written operating agreement of a member-managed limited  
19 liability company relieves a member of the authority and responsibility to consent  
20 to distributions and imposes that authority and responsibility on one or more other  
21 members, the liability stated in sub. (1) applies to the other members and not the  
22 member that the written operating agreement relieves of the authority and  
23 responsibility.

24           **(3)** A person that receives a distribution knowing that the distribution violated  
25 s. 183.0405 is personally liable to the limited liability company but only to the extent

1 that the distribution received by the person exceeded the amount that could have  
2 been properly paid under s. 183.0405.

3 (4) A person against which an action is commenced because the person is liable  
4 under sub. (1) may do any of the following:

5 (a) Implead any other person that is subject to liability under sub. (1) and seek  
6 to enforce a right of contribution from the person.

7 (b) Implead any person that is subject to liability under sub. (3) and seek to  
8 enforce a right of contribution from the person in the amount of the liability under  
9 sub. (3).

10 (5) An action under this section is barred unless commenced not later than 2  
11 years after the distribution.

12 **183.0407 Management of limited liability company.** (1) A limited liability  
13 company is a member-managed limited liability company unless a written operating  
14 agreement provides any of the following or includes words of similar import:

15 (a) That the company is or will be “manager-managed.”

16 (b) That the company is or will be “managed by managers.”

17 (c) That management of the company is or will be “vested in managers.”

18 (2) In a member-managed limited liability company, all of the following rules  
19 apply:

20 (a) Except as expressly provided in this chapter, the management and conduct  
21 of the company are vested in the members.

22 (b) Each member has rights in the management and conduct of the company’s  
23 activities and affairs proportional to the value of the contributions made by each such  
24 member, as stated in the records required to be kept under s. 183.0402 (2), or, in the

1 case of a company treated as a partnership for tax purposes, the partnership capital  
2 account of each such member.

3 (c) A difference arising among members as to a matter not described in par. (d)  
4 may be decided by a majority of the members' transferable interests.

5 (d) Except as otherwise provided in this chapter, the affirmative vote or consent  
6 of all members is required to do any of the following:

7 1. Amend the articles of organization.

8 2. Issue a transferable interest in the limited liability company to any person.

9 3. Allow the limited liability company to accept any additional contribution  
10 from a member.

11 4. Allow a partial redemption of a transferable interest in the limited liability  
12 company.

13 5. Value the contributions of members under s. 183.0402 (2).

14 6. Approve a merger, interest exchange, conversion, or domestication under  
15 subch. X.

16 7. Authorize a manager, member, or other person to do any act on behalf of the  
17 limited liability company that contravenes an operating agreement, including any  
18 provision of the operating agreement that expressly limits the purpose or business  
19 of the limited liability company or the conduct of the business of the limited liability  
20 company.

21 (e) The operating agreement may be amended only with the consent of all  
22 members.

23 **(3)** In a manager-managed limited liability company, all of the following rules  
24 apply:

1           (a) Except as expressly provided in this chapter, any matter relating to the  
2 activities and affairs of the company is decided exclusively by the manager, or, if  
3 there is more than one manager, by a majority of the managers.

4           (b) Each manager has equal rights in the management and conduct of the  
5 company's activities and affairs.

6           (c) The affirmative vote or consent of all members is required to do any of the  
7 following:

8           1. Sell, lease, exchange, or otherwise dispose of all or substantially all of the  
9 company's property, with or without the goodwill, outside the ordinary course of the  
10 company's activities.

11           2. Approve a merger, interest exchange, conversion, or domestication under  
12 subch. X.

13           3. Undertake any activity described in sub. (2) (d).

14           4. Amend the operating agreement.

15           (d) A manager may be chosen at any time by the affirmative vote or consent of  
16 a majority of the members' transferable interests and remains a manager until a  
17 successor has been chosen, unless the manager at an earlier time resigns, is removed,  
18 or dies, or, in the case of a manager that is not an individual, terminates. A manager  
19 may be removed at any time by the consent of a majority of the members' transferable  
20 interests without notice or cause.

21           (e) A person need not be a member to be a manager, but the dissociation of a  
22 member that is also a manager removes the person as a manager. If a person that  
23 is both a manager and a member ceases to be a manager, that cessation does not by  
24 itself dissociate the person as a member.

**ASSEMBLY BILL 566****SECTION 616**

1 (f) A person's ceasing to be a manager does not discharge any debt, obligation,  
2 or other liability to the limited liability company or members which the person  
3 incurred while a manager.

4 (4) Unless otherwise provided in a written operating agreement, an action  
5 requiring the vote or consent of members under this chapter may be taken without  
6 a meeting if all of such members consent to the action, and a member may appoint  
7 a proxy or other agent to consent or otherwise act for the member by signing an  
8 appointing record, personally or by the member's agent. The consent shall be  
9 evidenced by one or more written consents describing the action, signed by each of  
10 such members, and delivered to the limited liability company for inclusion in the  
11 limited liability company records. Unless otherwise provided in a written operating  
12 agreement, if a person, whether or not then a member, so consenting directs, whether  
13 through instruction to a proxy or other agent, that such consent will be effective at  
14 a future time, including a time determined upon the happening of an event, then the  
15 person shall be deemed to have consented as a member at this future time so long  
16 as the person is then a member and did not revoke the consent prior to that time. Any  
17 such consent shall be revocable prior to its becoming effective, unless the written  
18 consent provides otherwise.

19 (5) The dissolution of a limited liability company does not affect the  
20 applicability of this section. However, a person that wrongfully causes dissolution  
21 of the company loses the right to participate in management as a member and a  
22 manager.

23 (8) This chapter does not entitle a member to remuneration for services  
24 performed for a member-managed limited liability company.

1           **183.0408 Reimbursement; indemnification; advancement; and**  
2           **insurance.** (1) A limited liability company shall reimburse a member of a  
3           member-managed company or the manager of a manager-managed company for

5           manager's activities on behalf of the company, if the member or manager complied  
6           with ss. 183.0405, 183.0407, and 183.0409 in making the payment.

7           (2) A limited liability company shall indemnify and hold harmless a person  
8           with respect to any claim or demand against the person and any debt, obligation, or  
9           other liability incurred by the person by reason of the person's former or present  
10          capacity as a member or manager, if the claim, demand, debt, obligation, or other  
11          liability does not arise from the person's breach of s. 183.0405, 183.0407, or 183.0409.

12          (3) In the ordinary course of its activities and affairs, a limited liability  
13          company may advance reasonable expenses, including attorney fees and costs,  
14          incurred by a person in connection with a claim or demand against the person by  
15          reason of the person's former or present capacity as a member or manager, if the  
16          person promises to repay the company if the person ultimately is determined not to  
17          be entitled to be indemnified under sub. (2).

18          (4) A limited liability company may purchase and maintain insurance on  
19          behalf of a member or manager against liability asserted against or incurred by the  
20          member or manager in that capacity or arising from that status even if, under s.  
21          183.0105 (3) (g), the operating agreement could not eliminate or limit the person's  
22          liability to the company for the conduct giving rise to the liability.

23          **183.0409 Standards of conduct for members and managers.** (1) A  
24          member of a member-managed limited liability company owes to the company and,

1 subject to s. 183.0801, the other members the fiduciary duties of loyalty and care  
2 stated in subs. (2) and (3).

3 (2) The duty of loyalty of a member in a member-managed limited liability  
4 company includes all of the following duties:

5 (a) The duty to account to the company and hold as trustee for it any property,  
6 profit, or benefit derived by the member in or from any of the following:

7 1. The conduct or winding up of the company's activities and affairs.

8 2. A use by the member of the company's property.

9 3. The appropriation of a limited liability company opportunity.

10 (b) The duty to refrain from dealing with the company in the conduct or winding  
11 up of the company's activities and affairs as or on behalf of a person having an  
12 interest adverse to the company.

13 (c) The duty to refrain from competing with the company in the conduct of the  
14 company's activities and affairs before the dissolution of the company.

15 (3) The duty of care of a member of a member-managed limited liability  
16 company in the conduct or winding up of the company's activities and affairs is to  
17 refrain from engaging in conduct for which relief or exoneration from liability is not  
18 permitted under s. 183.0105 (3) (g).

19 (4) A member shall discharge the duties and obligations under this chapter and  
20 under the operating agreement and exercise any rights consistently with the  
21 contractual obligation of good faith and fair dealing.

22 (5) A member does not violate a duty or obligation under this chapter or under  
23 the operating agreement solely because the member's conduct furthers the member's  
24 own interest.

1           **(6)** All the members of a member-managed limited liability company or a  
2 manager-managed limited liability company may authorize or ratify, after full  
3 disclosure of all material facts, a specific act or transaction that otherwise would

5 breach of the duty of loyalty for the act or transaction by such members.

6           **(7)** It is a defense to a claim under sub. (2) (b) and any comparable claim in  
7 equity or at common law that the transaction was fair to the limited liability

9           **(8)** If, as permitted by sub. (6) or (9) (e) or the operating agreement, a member  
10 enters into a transaction with the limited liability company which otherwise would  
11 be prohibited by sub. (2) (b), the member's rights and obligations arising from the  
12 transaction are the same as those of a person that is not a member.

13           **(9)** In a manager-managed limited liability company, the following rules apply:

14           (a) Subsections (1), (2), (3), and (7) apply to the manager or managers and not  
15 the members.

16           (b) The duty stated under sub. (2) (c) continues until winding up is completed.

17           (c) Subsection (4) applies to managers and members.

18           (d) Subsection (5) applies only to members.

19           (e) The power to ratify under sub. (6) applies only to the members.

20           (f) Subject to sub. (4), a member does not have any duty to the company or to  
21 any other member solely by reason of being a member.

22           **183.0410 Rights to information of member, manager, and person**  
23 **dissociated as member. (1)** In a member-managed limited liability company, the  
24 following rules apply:

1 (a) On reasonable notice, a member may inspect and copy during regular  
2 business hours, at a reasonable location specified by the company, any record  
3 maintained by the company regarding the company's activities, affairs, financial

5 member's rights and duties under the operating agreement or this chapter.

6 (b) The company shall furnish to each member all of the following:

7 1. Without demand, any information concerning the company's activities,  
8 affairs, financial condition, and other circumstances which the company knows and  
9 is material to the proper exercise of the member's rights and duties under the  
10 operating agreement or this chapter, except to the extent the company can establish  
11 that it reasonably believes the member already knows or has notice of the  
12 information.

13 2. On demand, any other information concerning the company's activities,  
14 affairs, financial condition, and other circumstances, except to the extent the  
15 demand or the information demanded is unreasonable or otherwise improper under  
16 the circumstances.

17 (c) The duty to furnish information under par. (b) also applies to each member  
18 to the extent the member knows any of the information described in par. (b).

19 **(2)** In a manager-managed limited liability company, the following rules apply:

20 (a) The informational rights stated in sub. (1) and the duty stated in sub. (1)  
21 (c) apply to the managers and not the members.

22 (b) During regular business hours and at a reasonable location specified by the  
23 company, a member may obtain from the company and inspect and copy information  
24 regarding the company's activities, affairs, financial condition, and other  
25 circumstances of the company as is reasonable if all of the following apply:

1           1. The member seeks the information for a purpose material to the member's  
2 interest as a member.

3           2. The member makes a demand in a record received by the company,  
4 describing with reasonable particularity the information sought and the purpose for  
5 seeking the information.

6           3. The information sought is directly connected to the member's purpose.

7           (c) Not later than 10 days after receiving a demand pursuant to par. (b) 2., the  
8 company shall inform, in a record, the member that made the demand of all of the  
9 following:

10           1. What information the company will provide in response to the demand and  
11 when and where the company will provide the information.

12           2. The company's reasons for declining, if the company declines to provide any  
13 demanded information.

14           (d) Whenever this chapter or an operating agreement provides for a member  
15 to vote on or give or withhold consent to a matter, before the vote is cast or consent  
16 is given or withheld, the company shall, without demand, provide the member with  
17 all information that is known to the company and that is material to the member's  
18 decision.

19           **(3)** Subject to sub. (8), on 10 days' demand made in a record received by a  
20 limited liability company, a person dissociated as a member may have access to the  
21 information to which the person was entitled while a member if all of the following  
22 apply:

23           (a) The information pertains to the period during which the person was a  
24 member.

25           (b) The person seeks the information in good faith.

**ASSEMBLY BILL 566****SECTION 616**

1 (c) The person satisfies the requirements imposed on a member by sub. (2) (b).

2 (4) A limited liability company shall respond to a demand made pursuant to  
3 sub. (3) in the manner provided in sub. (2) (c).

4 (5) A limited liability company may charge a person that makes a demand  
5 under this section the reasonable costs of copying, limited to the costs of labor and  
6 material.

7 (6) A member or person dissociated as a member may exercise the rights under  
8 this section through an agent or, in the case of an individual under legal disability,  
9 a legal representative. Any restriction or condition imposed by the operating  
10 agreement or under sub. (8) applies both to the agent or legal representative and to  
11 the member or person dissociated as a member.

12 (7) Subject to s. 183.0504, the rights under this section do not extend to a person  
13 as transferee.

14 (8) In addition to any restriction or condition stated in its operating agreement,  
15 a limited liability company, as a matter within the ordinary course of its activities  
16 and affairs, may impose reasonable restrictions and conditions on access to and use  
17 of information to be furnished under this section, including designating information  
18 confidential and imposing nondisclosure and safeguarding obligations on the  
19 recipient. In a dispute concerning the reasonableness of a restriction under this  
20 subsection, the company has the burden of proving reasonableness.

21 SUBCHAPTER V

22 TRANSFERABLE INTERESTS AND

23 RIGHTS OF TRANSFEREES

24 AND CREDITORS

1           **183.0501 Nature of transferable interest.** A transferable interest is  
2 personal property.

3           **183.0502 Transfer of transferable interest. (1)** Subject to s. 183.0503 (6),  
4 all of the following apply to a transfer, in whole or in part, of a transferable interest:

6           (b) It does not by itself cause a member's dissociation or a dissolution and  
7 winding up of the limited liability company's activities and affairs.

10           1. Participate in the management or conduct of the company's activities and  
11 affairs.

12           2. Except as otherwise provided in sub. (3) and s. 183.0410 (3), have access to  
13 records or other information concerning the company's activities and affairs.

14           **(2)** A transferee has the right to receive, in accordance with the transfer,  
15 distributions to which the transferor would otherwise be entitled.

16           **(3)** In a dissolution and winding up of a limited liability company, a transferee  
17 is entitled to an account of the company's transactions only from the date of  
18 dissolution.

19           **(4)** A transferable interest may be evidenced by a certificate of the interest  
20 issued by a limited liability company in a record, and, subject to this section, the  
21 interest represented by the certificate may be transferred by a transfer of the  
22 certificate.

23           **(5)** A limited liability company need not give effect to a transferee's rights  
24 under this section until the company knows or has notice of the transfer.

**ASSEMBLY BILL 566****SECTION 616**

1           **(6)** A transfer of a transferable interest in violation of a restriction on transfer  
2 contained in the operating agreement is ineffective if the intended transferee knows  
3 or has notice of the restriction at the time of the intended transfer.

4           **(7)** Except as otherwise provided in s. 183.0602 (5) (b), if a member transfers  
5 a transferable interest and the transferee does not become a member with respect  
6 to the transferred interest, the transferor retains the rights of a member other than  
7 the interest in distributions transferred and retains all the duties and obligations of  
8 a member.

9           **(8)** If a member transfers a transferable interest to a person that becomes a  
10 member with respect to the transferred interest, the transferee is liable for the  
11 member's obligations under ss. 183.0403 and 183.0406 known to the transferee when  
12 the transferee becomes a member.

13           **183.0503 Charging order.** **(1)** On application by a judgment creditor of a  
14 member or transferee, a court may enter a charging order against the transferable  
15 interest of the judgment debtor for the unsatisfied amount of the judgment. Except  
16 as otherwise provided in sub. (6), a charging order constitutes a lien on a judgment  
17 debtor's transferable interest and requires the limited liability company to pay over  
18 to the person to which the charging order was issued any distribution that otherwise  
19 would be paid to the judgment debtor.

20           **(2)** To the extent necessary to effectuate the collection of distributions pursuant  
21 to a charging order in effect under sub. (1), the court may do any of the following:

22           (a) Appoint a receiver of the distributions subject to the charging order, with  
23 the power to make all inquiries the judgment debtor might have made.

24           (b) Make all other orders necessary to give effect to the charging order.

1           **(3)** Upon a showing that distributions under a charging order will not pay the  
2 judgment debt within a reasonable time, the court may foreclose the lien and order

5 thereby become a member, and is subject to s. 183.0502.

6           **(4)** At any time before foreclosure under sub. (3), the member or transferee

8 extinguish the charging order by satisfying the judgment and filing a certified copy  
9 of the satisfaction with the court that issued the charging order.

10           **(5)** At any time before foreclosure under sub. (3), a limited liability company  
11 or one or more members whose transferable interests are not subject to the charging  
12 order may pay to the judgment creditor the full amount due under the judgment and  
13 thereby succeed to the rights of the judgment creditor, including the charging order.

14           **(6)** If a court orders foreclosure of a charging order lien against the sole member  
15 of a limited liability company, all of the following apply:

16           (a) The court shall confirm the sale.

17           (b) The purchaser at the sale obtains the member's entire interest, not only the  
18 member's transferable interest.

19           (c) The purchaser thereby becomes a member.

20           (d) The person whose interest was subject to the foreclosed charging order is  
21 dissociated as a member.

22           **(7)** This chapter does not deprive any member or transferee of the benefit of any  
23 exemption law applicable to the transferable interest of the member or transferee.

21 1. The company notifies the person that it will be expelled as a member because

24 or the person's right to conduct business has been suspended by the jurisdiction of

18           (b) In a member-managed limited liability company, any of the following

20           1. A guardian or general conservator for the individual is appointed.

21           2. A court orders that the individual has otherwise become incapable of  
22 performing the individual's duties as a member under this chapter or the operating  
23 agreement.

24           **(8)** In a member-managed limited liability company, any of the following

9 of being a personal representative of an estate, the estate's entire transferable

14 **183.0603 Effect of dissociation.** (1) If a person is dissociated as a member,  
15 all of the following apply:

16 (a) The person's right to participate as a member in the management and  
17 conduct of the limited liability company's activities and affairs terminates.

18 (b) The person's duties and obligations under s. 183.0409 as a member end with  
19 regard to matters arising and events occurring after the person's dissociation.

20 (c) Subject to s. 183.0504 and subch. X, any transferable interest owned by the

**SUBCHAPTER VII****DISSOLUTION AND WINDING UP**

5 **183.0701 Events causing dissolution.** (1) A limited liability company is  
6 dissolved, and its activities and affairs must be wound up, upon the occurrence of any  
7 of the following:

8 (a) An event or circumstance that the operating agreement states causes  
9 dissolution.

10 (b) The affirmative vote or consent of all the members.

11 (c) The passage of 90 consecutive days during which the company has no  
12 members unless, before the end of the period, all of the following occur:

14 transferees owning the rights to receive a majority of distributions as transferees at  
15 the time the consent is to be effective.

16 2. At least one person becomes a member in accordance with the consent.

17 (d) On application by a member, the entry by a court of competent jurisdiction  
18 of an order dissolving the company on any of the following grounds:

19 1. That the conduct of all or substantially all the company's activities and  
20 affairs is unlawful.

21 2. That it is not reasonably practicable to carry on the company's activities and  
22 affairs in conformity with the articles of organization and the operating agreement.

23 3. That the managers or those members in control of the company have done  
24 any of the following:

25 a. Acted, or are acting or will act, in a manner that is illegal or fraudulent.

1           b. Acted, or are acting, in a manner that is oppressive and was, is, or will be

3           (e) The department has given notice of administrative dissolution under s.

5 under s. 183.0709 or pursuant to judicial review under ss. 227.52 to 227.58.

6           **(2)** In a proceeding brought under sub. (1) (d) 3., the court may order a remedy  
7 other than dissolution.

8           **183.0702 Winding up.** (1) A dissolved limited liability company shall wind  
9 up its activities and affairs and, except as otherwise provided in s. 183.0703, the  
10 limited liability company continues after dissolution only for the purpose of winding  
11 up.

12           **(2)** (a) In winding up its activities and affairs, a limited liability company shall  
13 discharge the company's debts, obligations, and other liabilities, settle and close the  
14 company's activities and affairs, and marshal and distribute the assets of the  
15 company.

16           (b) In winding up its activities and affairs, a limited liability company may do  
17 any of the following:

18           1. Deliver to the department for filing a statement of dissolution stating the  
19 name of the company and that the company is dissolved.

20           2. Preserve the company activities, affairs, and property as a going concern for  
21 a reasonable time.

22           3. Prosecute and defend actions and proceedings, whether civil, criminal, or  
23 administrative.

24           4. Transfer the company's property.

25           5. Settle disputes by mediation or arbitration.

1           6. Deliver to the department for filing a statement of termination stating the  
2 name of the company and that the company is terminated.

3           7. Perform other acts necessary or appropriate to the winding up.

4           **(3)** If a dissolved limited liability company has no members, the legal  
5 representative of the last person to have been a member may wind up the activities  
6 and affairs of the company. If the person does so, the person has the powers of a sole  
7 manager under s. 183.0407 (3) and is deemed to be a manager for the purposes of s.  
8 183.0304 (1).

9           **(4)** If the legal representative under sub. (3) declines or fails to wind up the  
10 limited liability company's activities and affairs, a person may be appointed to do so  
11 by the consent of transferees owning a majority of the rights to receive distributions  
12 as transferees at the time the consent is to be effective. All of the following apply to  
13 a person appointed under this subsection:

14           (a) The person has the powers of a sole manager under s. 183.0407 (3) and is  
15 deemed to be a manager for the purposes of s. 183.0304 (1).

16           (b) The person shall deliver promptly to the department for filing an

22           **(5)** The circuit court may order judicial supervision of the winding up of a

24 up the company's activities and affairs, as follows:

25           (a) On the application of a member, if the applicant establishes good cause.

8 **183.0703 Rescinding dissolution. (1)** A limited liability company may

10 is effective, the circuit court has entered an order under s. 183.0701 (1) (d) dissolving  
11 the company, or the department has dissolved the company under s. 183.0708.

12 **(2)** Rescinding dissolution under this section requires all of the following:

13 (a) The affirmative vote or consent of each member.

14 (b) If the limited liability company has delivered to the department for filing  
15 a statement of dissolution, delivery for filing of one of the following additional  
16 statements:

17 1. If the statement of dissolution has not become effective, delivery to the  
18 department for filing of a statement of withdrawal under s. 183.0208 applicable to  
19 the statement of dissolution.

20 2. If the statement of dissolution has become effective, delivery to the  
21 department for filing of a statement of rescission stating the name of the company  
22 and that dissolution has been rescinded under this section.

23 **(3)** If a limited liability company rescinds its dissolution, all of the following

15           **(2)** A notice under sub. (1) must satisfy all of the following:

16           (a) It must be published as a class 1 notice, under ch. 985, in a newspaper of  
17 general circulation in the county in this state in which the dissolved limited liability  
18 company's principal office is located or, if it has none located in this state, in the  
19 county in which the office of the company's registered agent is or was last located.

20           (b) It must describe the information required to be contained in a claim, state  
21 that the claim must be in writing, and provide a mailing address to which the claim  
22 is to be sent.

23           (c) It must state that a claim against the company is barred unless an action  
24 to enforce the claim is commenced not later than 2 years after publication of the  
25 notice.

18 may not exceed the total amount of assets distributed to the person after dissolution.

19           **183.0706 Court proceedings.** **(1)** A dissolved limited liability company that  
20 has published a notice under s. 183.0705 may file an application with the circuit  
21 court in the county where the company's principal office is located or, if the principal  
22 office is not located in this state, where the office of its registered agent is or was last  
23 located, for a determination of the amount and form of security to be provided for  
24 payment of claims that are reasonably expected to arise after the date of dissolution  
25 based on facts known to the company which, at the time of application, are contingent

1 or have not been made known to the company or which are based on an event  
2 occurring after the date of dissolution.

3 (2) Security is not required for any claim that is or is reasonably anticipated  
4 to be barred under s. 183.0705.

6 dissolved limited liability company shall give notice of the proceeding to each  
7 claimant holding a contingent claim known to the company.

8 (4) In a proceeding under this section, the court may appoint a guardian ad  
9 litem to represent all claimants whose identities are unknown. The reasonable fees  
10 and expenses of the guardian, including all reasonable expert witness fees, must be  
11 paid by the dissolved limited liability company.

12 (5) A dissolved limited liability company that provides security in the amount  
13 and form ordered by the court under sub. (1) satisfies the company's obligations with  
14 respect to claims that are contingent, have not been made known to the company, or  
15 are based on an event occurring after the date of dissolution, and such claims may  
16 not be enforced against a member or transferee on account of assets received in  
17 liquidation.

18 **183.0707 Disposition of assets in winding up.** (1) In winding up its  
19 activities and affairs, a limited liability company shall apply its assets to discharge  
20 its obligations to creditors, including members that are creditors.

21 (2) After a limited liability company complies with sub. (1), any surplus must  
22 be distributed in the following order, subject to any charging order in effect under s.  
23 183.0503:

24 (a) To members and dissociated members in satisfaction of liabilities for  
25 distributions previously approved under s. 183.0404.

1 (b) To members and dissociated members first for the return of their  
2 contributions in proportion to their respective values as specified in the records

10 with sub. (2) (a), any surplus must be distributed among the owners of transferable  
11 interests in proportion to the value of the respective unreturned contributions.

12 (4) All distributions made under subs. (2) and (3) must be paid in money.

13 **183.0708 Administrative dissolution.** (1) The department may commence  
14 a proceeding under sub. (2) to dissolve a limited liability company administratively  
15 if any of the following applies:

16 (a) The company does not pay, within one year after they are due, any fees or  
17 penalties required to be paid to the department under this chapter.

18 (b) The company does not have on file with the department its annual report  
19 within one year after it is due.

20 (c) The company is without a registered agent in this state for at least one year.

21 (d) The company does not notify the department within one year that its  
22 registered agent or registered office has been changed, that its registered agent has  
23 resigned, or that its registered office has been discontinued.

24 (e) The company violates s. 940.302 (2) or 948.051 (2).

15           (2) The company may appeal the denial of reinstatement to the circuit court  
16 for the county where the company's principal office or, if none in this state, the office  
17 of its registered agent is located, within 30 days after service of the notice of denial

## SUBCHAPTER VIII

## ACTIONS BY MEMBERS

3       **183.0801 Direct action by member.** (1) Subject to sub. (2), a member may  
4 maintain a direct action against another member, a manager, or the limited liability  
5 company to enforce the member's rights and protect the member's interests,

16 liability company to bring an action to enforce the right, and the managers or other  
17 members do not bring the action within a reasonable time.

18       (2) A demand under sub. (1) would be futile.

19       **183.0803 Proper plaintiff.** A derivative action to enforce a right of a limited  
20 liability company may be maintained only by a person that is a member at the time  
21 the action is commenced and to which any of the following applies:

22       (1) The person was a member when the conduct giving rise to the action  
23 occurred.

1           **(2)** The person's status as a member devolved on the person by operation of law  
2 or pursuant to the terms of the operating agreement from a person that was a

6           **(1)** The date and content of plaintiff's demand and the response to the demand  
7 by the managers or other members.

8           **(2)** Why demand should be excused as futile.

9           **183.0805 Special litigation committee.** **(1)** If a limited liability company  
10 is named as or made a party in a derivative proceeding, the company may appoint  
11 a special litigation committee to investigate the claims asserted in the proceeding  
12 and determine whether pursuing the action is in the best interests of the company.  
13 If the company appoints a special litigation committee, on motion by the committee  
14 made in the name of the company, except for good cause shown, the court shall stay  
15 discovery for the time reasonably necessary to permit the committee to make its  
16 investigation. This subsection does not prevent the court from doing any of the  
17 following:

18           **(a)** Enforcing a person's right to information under s. 183.0410.

19           **(b)** Granting extraordinary relief in the form of a temporary restraining order  
20 or preliminary injunction.

21           **(2)** A special litigation committee must be composed of one or more  
22 disinterested and independent individuals, who may be members.

23           **(3)** **(a)** In a member-managed limited liability company, a special litigation  
24 committee may be appointed as follows:

16          (d) That the proceeding be dismissed.

17          (5) After making a determination under sub. (4), a special litigation committee  
18 shall file with the court a statement of its determination and its report supporting  
19 its determination and shall serve each party with a copy of the determination and  
20 report. The court shall determine whether the members of the committee were  
21 disinterested and independent and whether the committee conducted its  
22 investigation and made its recommendation in good faith, independently, and with  
23 reasonable care, with the committee having the burden of proof. If the court finds  
24 that the members of the committee were disinterested and independent and that the  
25 committee acted in good faith, independently, and with reasonable care, the court

1 shall enforce the determination of the committee. Otherwise, the court shall dissolve  
2 the stay of discovery entered under sub. (1) and allow the action to continue under

5 sub. (2), any proceeds or other benefits of a derivative action, whether by judgment,  
6 compromise, or settlement, belong to the limited liability company and not to the

10 (2) If a derivative action is successful in whole or in part, the court may award

14 FOREIGN LIMITED

15 LIABILITY COMPANIES

16 **183.0901 Governing law.** (1) The governing law of a foreign limited liability  
17 company governs all of the following:

18 (a) The internal affairs of the company.

19 (b) The liability of a member as member and a manager as manager for a debt,  
20 obligation, or other liability of the company.

21 (2) A foreign limited liability company is not precluded from registering to do  
22 business in this state because of any difference between its governing law and the  
23 law of this state.

24 (3) Registration of a foreign limited liability company to do business in this  
25 state does not authorize the foreign company to engage in any activities and affairs

1 or exercise any power that a limited liability company may not engage in or exercise  
2 in this state.

3 **183.0902 Registration to do business in this state.** (1) A foreign limited  
4 liability company may not do business in this state until it registers with the  
5 department under this subchapter.

6 (2) A foreign limited liability company doing business in this state may not  
7 maintain an action or proceeding in this state unless it has registered to do business  
8 in this state.

9 (3) The failure of a foreign limited liability company to register to do business  
10 in this state does not impair the validity of a contract or act of the foreign limited  
11 liability company or its title to property in this state or preclude it from defending  
12 an action or proceeding in this state.

13 (4) A limitation on the liability of a member or manager of a foreign limited  
14 liability company is not waived solely because the company does business in this  
15 state without registering to do business in this state.

16 (5) Section 183.0901 (1) and (2) applies even if a foreign limited liability  
17 company fails to register under this subchapter.

18 (6) (a) A foreign limited liability company that does business in this state  
19 without registering to do business in this state is liable to this state, for each year  
20 or any part of a year during which it did business in this state without registration,  
21 in an amount equal to all of the following:

22 1. All fees and other charges that would have been imposed by this chapter on  
23 the foreign limited liability company had it properly filed a foreign registration  
24 statement as required by this section and thereafter filed all reports required by this  
25 chapter.

2           (b) The foreign limited liability company shall pay the amount owed under par.

24           (1) The name of the company and, if the name does not comply with s. 183.0112,  
25           a fictitious name adopted pursuant to s. 183.0906 (1).

6           **183.0905 Activities not constituting doing business.** **(1)** Activities of a

10 proceeding.

11           (b) Carrying on any activity concerning its internal affairs, including holding

15 of securities of the company or maintaining trustees or depositaries with respect to  
16 those securities.

17           (e) Selling through independent contractors.

18           (f) Soliciting or obtaining orders by any means if the orders require acceptance  
19 outside this state before they become contracts.

20           (g) Creating or acquiring indebtedness, mortgages, or security interests in  
21 property.

22           (h) Securing or collecting debts or enforcing mortgages or security interests in  
23 property securing the debts and holding, protecting, or maintaining property.

24           (i) Conducting an isolated transaction that is not in the course of similar  
25 transactions.

1 (j) Owning, without more, property.

2 (k) Doing business in interstate commerce.

3 **(2)** A person does not do business in this state solely by being a member or  
4 manager of a foreign limited liability company that does business in this state.

6 may subject a foreign limited liability company to service of process, taxation, or  
7 regulation under law of this state other than this chapter.

8 **183.0906 Noncomplying name of foreign limited liability company. (1)**

11 business in this state, a fictitious name that complies with s. 183.0112. After

20 foreign limited liability company that converts to, or merges into, a domestic limited

22 delivery of a record to the department for filing is deemed to have withdrawn its  
23 registration on the effective date of the conversion or merger, unless the registration  
24 is transferred to such company pursuant to s. 183.0909.

17          business in this state or has converted to a foreign entity required to register with  
18          the department to do business in this state, the foreign entity shall deliver to the  
19          department for filing an application for transfer of registration. The application  
20          must state all of the following:

21          (a) The name of the registered foreign limited liability company before the  
22          merger or conversion.

23          (b) That before the merger or conversion the registration pertained to a foreign  
24          limited liability company.

19 (a) The foreign limited liability company fails to file its annual report with the  
20 department within 4 months after it is due.

14 its authority to do business in this state, the department shall terminate the foreign  
15 limited liability company's registration under s. 183.09102 (2) (b).

16 **(3)** A court may terminate under s. 946.87 the registration of a foreign limited  
17 liability company authorized to transact business in this state. The court shall notify  
18 the department of the action, and the department shall terminate the foreign limited  
19 liability company's registration under s. 183.09102.

20 **183.09102 Procedure for and effect of termination.** (1) If the department  
21 determines that one or more grounds exist under s. 183.09101 for termination of a  
22 foreign limited liability company's registration, the department may give the foreign  
23 limited liability company notice of the determination. The notice shall be in writing  
24 and addressed to the registered agent of the foreign limited liability company.

(4) “Converted entity” means the converting entity as it continues in existence after a conversion.

(5) “Converting entity” means an entity that engages in a conversion.

(8) “Domesticated entity” means the domesticating entity as it continues in existence after a domestication.

(9) “Domesticating entity” means either a non-United States entity or a Wisconsin limited liability company that engages in a domestication.

(10) “Domestication” means a transaction authorized by ss. 183.1051 to 183.1055.

(16) “Interest” means any of the following:

(a) A share in a business corporation.

(b) A membership in a nonprofit or nonstock corporation.

(c) A partnership interest in a general partnership.

(d) A partnership interest in a limited partnership.

- 16 (f) A member of a limited liability company.

- 20 (j) A beneficiary or beneficial owner of a statutory trust, business trust, or  
21 common-law business trust.
- 22 (k) Any other direct holder of an interest.
- 23 **(19)** “Interest holder liability” means any of the following:
- 24 (a) Personal liability for a debt, obligation, or other liability of an entity which  
25 is imposed on a person under any of the following circumstances:

19 of incorporation and bylaws.

20           (b) For a domestic or foreign partnership, its partnership agreement and, in the  
21 case of a domestic or foreign limited liability partnership, its statement of  
22 qualification as a limited liability partnership or foreign limited liability  
23 partnership.

24           (c) For a domestic or foreign limited partnership, its certificate of limited  
25 partnership and partnership agreement.

6 interest holders.

7 **(24)** “Plan” means a plan of merger under s. 183.1022, a plan of interest  
8 exchange under s. 183.1032, a plan of conversion under s. 183.1042, or a plan of

10 **(37)** “Surviving entity” means the entity that continues in existence after or is  
11 created by a merger.

12 **(38)** “Type of entity” means a generic form of entity that is any of the following:

13 (a) Recognized at common law.

14 (b) Recognized under a governing law.

15 **183.1002 Relationship of this subchapter to other laws.** (1) This  
16 subchapter does not authorize an act prohibited by, and does not affect the  
17 application or requirements of, law other than this subchapter.

18 **(2)** A transaction effected under this chapter may not create or impair a right,  
19 duty, or obligation of a person under the law of this state, other than this subchapter,  
20 relating to a change in control, takeover, business combination, control-share  
21 acquisition, or similar transaction involving a domestic constituent, acquired, or  
22 converting entity.

23 **183.1003 Existing purpose.** (2) Property held for a charitable purpose under
