2013 ASSEMBLY BILL 573

December 18, 2013 – Introduced by Representatives POPE, HULSEY, HEBL, ZAMARRIPA, OHNSTAD, KESSLER and DANOU, cosponsored by Senators HARRIS, MILLER and LASSA. Referred to Committee on Education.

AUTHORS SUBJECT TO CHANGE

1 AN ACT to renumber and amend 17.03 (4m); to amend 119.04 (1); and to 2 create 17.03 (4m) (b) and 120.06 (16) of the statutes; relating to: requiring 3 school board members to complete an orientation and training program.

Analysis by the Legislative Reference Bureau

This bill requires a school board member to complete a 16-hour orientation and training program within one year of initially taking office. The program must be offered by a statewide association organized for the benefit of school board members or be approved by the Department of Public Instruction. The school board must pay the cost of the program for its members.

The requirement first applies to school board members who take office in 2015. If a school board member fails to complete the requirement within one year, his or her seat on the school board is vacant.
