## 2017 ASSEMBLY BILL 612

November 6, 2017 – Introduced by Representatives SPREITZER, KOLSTE, ANDERSON, BARCA, BERCEAU, BROSTOFF, CROWLEY, FIELDS, JACQUE, KITCHENS, NOVAK, OHNSTAD, POPE, SARGENT, SINICKI, SUBECK, C. 1 AN ACT to amend 46.535 of the statutes; relating to: crisis intervention team

grants and making an appropriation.

#### Analysis by the Legislative Reference Bureau

This bill increases the amount of moneys that the Department of Health Services is required to award in grants for mental health crisis intervention team training for law enforcement agencies and correctional officers from \$250,000 per fiscal biennium to \$1,000,000 per fiscal biennium. The bill also allows grant moneys to be used for overtime costs.

# The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- 3 **SECTION 1.** 46.535 of the statutes is amended to read:
- 4 **46.535 Crisis intervention training grants.** From the appropriation under
- 5 s. 20.435 (5) (cd), the department shall award grants in the total amount of \$250,000
- 6 <u>\$1,000,000</u> in each fiscal biennium for mental health crisis intervention team
- 7 training for law enforcement agencies, as described in s. 165.77 (1) (c), and

correctional officers, as defined in s. 102.475 (8) (a). <u>Grant moneys awarded under</u>
this section may be used for overtime costs.

### SECTION 2. Fiscal changes.

(1) CRISIS INTERVENTION TEAM GRANTS. In the schedule under section 20.005 (3) 4  $\mathbf{5}$ of the statutes for the appropriation to the department of health services under 6 section 20.435 (5) (cd) of the statutes, the dollar amount for fiscal year 2017-18 is 7 increased by \$375,000 for the purposes for which the appropriation is made. In the 8 schedule under section 20.005 (3) of the statutes for the appropriation to the 9 department of health services under section 20.435 (5) (cd) of the statutes, the dollar 10 amount for fiscal year 2018–19 is increased by \$375,000 for the purposes for which 11 the appropriation is made.
