AUTHORS SUBJECT TO CHANGE

AN ACT to amend 36.11 (3) (d) (intro.), 36.11 (47m) (title) and 38.12 (12) (title); and to create 36.11 (47m) (c) and 38.12 (12) (c) of the statutes; relating to: exempting veterans and members of the armed forces from admissions application fees at University of Wisconsin System schools and technical colleges.

Analysis by the Legislative Reference Bureau

This bill creates an application fee exemption for veterans and members of the U.S. armed forces applying for admission to University of Wisconsin System schools or technical colleges.

Under current law, a student who is a service member must be given priority in registering for courses at UW System schools and technical colleges. A "service member" is defined as a person who has served or is serving on active duty under honorable conditions in the U.S. armed forces, in forces incorporated as part of the U.S. armed forces, in the national guard, or in a reserve component of the U.S. armed forces.

Under this bill, a UW System school or technical college may not charge an application fee to a service member applying for admission to the UW System school or technical college or to any program offered at the school or technical college.
