## 2021 ASSEMBLY BILL 684

November 12, 2021 – Introduced by Representatives DITTRICH, SKOWRONSKI, EDMING, THIESFELDT and KNODL, cosponsored by Senators NASS and STROEBEL. Referred to Committee on State Affairs.

1 AN ACT to amend 227.10 (2m) and 227.11 (2) (c); and to create 227.51 (4) of the

statutes; **relating to:** requiring rules for imposing conditions on a license and

rule-making guidelines prescribed by executive order.

## Analysis by the Legislative Reference Bureau

This bill does all of the following:

1. Current law provides that an agency that is authorized to exercise discretion in deciding individual cases may formalize the general policies evolving from its decisions by promulgating those policies as rules. The bill requires an agency to promulgate rules describing how and when the agency will impose conditions on a license, permit, certificate, or other such approval that is granted by the agency. The agency must, under the bill, impose conditions on licenses in accordance with those rules.

2. Current law allows the governor, by executive order, to prescribe guidelines to ensure that rules are promulgated in accordance with the statutory rule-making process. The bill repeals this provision that allows the governor to prescribe such guidelines.

2	227.10 (2m) No agency may implement or enforce any standard, requirement,
3	or threshold, including as a term or condition of any license issued by the agency,
4	unless that standard, requirement, or threshold is explicitly required or explicitly
5	permitted by statute or by a rule that has been promulgated in accordance with this
6	subchapter, $\underline{including \ s. \ 227.51 \ (4)}$ , except as provided in s. 186.118 (2) (c) and (3) (b)
7	3. The governor, by executive order, may prescribe guidelines to ensure that rules
8	are promulgated in compliance with this subchapter.
9	<b>SECTION 2.</b> 227.11 (2) (c) of the statutes is amended to read:
10	227.11 (2) (c) Each Subject to s. 227.51 (4), each agency that is authorized to
11	exercise discretion in deciding individual cases may formalize the general policies
12	evolving from its decisions by promulgating the policies as rules which the agency
13	shall follow until they are amended or repealed. A rule promulgated in accordance
14	with this paragraph is valid only to the extent that the agency has discretion to base
15	an individual decision on the policy expressed in the rule.
16	<b>SECTION 3.</b> 227.51 (4) of the statutes is created to read:
17	227.51 (4) An agency shall promulgate rules describing how and when the
18	agency will impose conditions on a license granted by the agency. The agency shall
19	impose conditions on licenses in accordance with those rules.
