2015 ASSEMBLY BILL 718

January 15, 2016 - Introduced by Representatives Kuglitsch, Schraa, Kahl, R. Brooks, Petryk, Czaja, Rohrkaste, Sanfelippo, Quinn, Edming and E. Brooks. Referred to Committee on Jobs and the Economy.

AUTHORS SUBJECT TO CHANGE

- 1 AN ACT to amend 238.15 (1) (L); and to create 238.15 (1) (Lg) of the statutes;
- 2 **relating to:** qualified new business venture eligibility.

Analysis by the Legislative Reference Bureau

This bill expands eligibility for certain businesses receiving investments that qualify the investors for tax credits under the angel and early stage seed investment tax credit programs administered by the Wisconsin Economic Development Corporation (WEDC). Under current law, certain investors may receive tax credits under those programs for investments in businesses certified by WEDC as "qualified new business ventures." WEDC may certify a business as a qualified new business venture if, among other requirements, for taxable years beginning after December 31, 2010, the business has not received more than \$8,000,000 in investments that qualified for tax credits under the programs. The bill raises that threshold to \$12,000,000 for taxable years beginning after December 31, 2015.
