## 2015 ASSEMBLY BILL 986

March 10, 2016 – Introduced by Representatives GOYKE, BARNES, BOWEN, BROSTOFF, KESSLER, BERCEAU, JOHNSON, SPREITZER and ZAMARRIPA, cosponsored by Senator L. TAYLOR. Referred to Committee on Judiciary.

1     **AN ACT to amend** 938.183 (1) (intro.), 948.60 (2) (d) and 948.61 (4); and **to create**  
2             938.183 (1d), 970.032 (3) and 971.31 (13) (c) of the statutes; **relating to:**  
3             elimination of the original jurisdiction of a court of criminal jurisdiction over  
4             a juvenile.

---

***Analysis by the Legislative Reference Bureau***

This bill eliminates the original jurisdiction of a court of criminal jurisdiction over a juvenile who is alleged to have 1) committed assault or battery while placed in a juvenile correctional facility; 2) committed first-degree or second-degree intentional homicide or first-degree reckless homicide on or after the juvenile's tenth birthday; 3) violated any state criminal law, if the juvenile has previously been convicted of a crime either under the original jurisdiction of a court of criminal jurisdiction or following a waiver of jurisdiction by a court assigned to exercise jurisdiction under the Juvenile Justice Code (juvenile court). Under the bill, a juvenile who is alleged to have committed any of those violations on or after the effective date of the bill is subject to the jurisdiction of the juvenile court.

1           **SECTION 1.** 938.183 (1) (intro.) of the statutes is amended to read:

2           938.183 (1) JUVENILES UNDER ADULT COURT JURISDICTION. (intro.)

3           Notwithstanding ss. 938.12 (1) and 938.18, but subject to sub. (1d), courts of criminal  
4           jurisdiction have exclusive original jurisdiction over all of the following:

5           **SECTION 2.** 938.183 (1d) of the statutes is created to read:

6           938.183 (1d) NONAPPLICABILITY. A court of criminal jurisdiction does not have  
7           exclusive original jurisdiction over a juvenile as provided in sub. (1) with respect to  
8           any violation committed on or after the effective date of this subsection .... [LRB  
9           inserts date]. A juvenile who is alleged to have committed a violation described in  
10          sub. (1) on or after the effective date of this subsection .... [LRB inserts date], is  
11          subject to the jurisdiction of the court assigned to exercise jurisdiction under this  
12          chapter as provided in s. 938.12.

13          **SECTION 3.** 948.60 (2) (d) of the statutes is amended to read:

14          948.60 (2) (d) A person under 17 years of age who has violated this subsection  
15          is subject to the provisions of ch. 938 unless jurisdiction is waived under s. 938.18 ~~or~~  
16          ~~the person is subject to the jurisdiction of a court of criminal jurisdiction under s.~~  
17          ~~938.183.~~

18          **SECTION 4.** 948.61 (4) of the statutes is amended to read:

19          948.61 (4) A person under 17 years of age who has violated this section is  
20          subject to the provisions of ch. 938, unless jurisdiction is waived under s. 938.18 ~~or~~  
21          ~~the person is subject to the jurisdiction of a court of criminal jurisdiction under s.~~  
22          ~~938.183.~~

23          **SECTION 5.** 970.032 (3) of the statutes is created to read:

24          970.032 (3) This section does not apply to a violation committed on or after the
