



2023 ASSEMBLY JOINT RESOLUTION 140

March 6, 2024 - Introduced by Representatives PALMERI, SUBECK, SNODGRASS, MCGUIRE, J. ANDERSON, ANDRACA, BALDEH, BARE, CONLEY, CONSIDINE, EMERSON, HONG, JACOBSON, JOERS, MADISON, MOORE OMOKUNDE, NEUBAUER, OHNSTAD, RATCLIFF, SHANKLAND, SHELTON, SINICKI, STUBBS and VINING, cosponsored by Senators L. AUTHORS SUBJECT TO CHANGE

1 **To create** section 27 of article I of the constitution; **relating to:** equality of rights
2 on the basis of sex, gender identity, race, color, sexual orientation, disability,
3 religion, national origin, marital status, family status, age, ancestry, or any
4 other immutable characteristic and creating a private cause of action for
5 violations of those rights by state actors (first consideration).

Analysis by the Legislative Reference Bureau

This constitutional amendment, proposed to the 2023 legislature on first consideration, provides that equality of rights under the law shall not be denied or abridged by the state or by any political subdivision of the state on account of sex, gender identity, race, color, sexual orientation, disability, religion, national origin, marital status, family status, age, ancestry, or any other immutable characteristic. The constitutional amendment requires the state and each political subdivision to protect and secure the equality of these rights and creates a private cause of action against the state or the appropriate political subdivision of the state for violations of the rights guaranteed under the amendment.

A constitutional amendment requires adoption by two successive legislatures, and ratification by the people, before it can become effective.

6 ***Resolved by the assembly, the senate concurring, That:***

7 **SECTION 1.** Section 27 of article I of the constitution is created to read:

1 [Article I] Section 27 (1) Equality of rights under the law shall not be denied
2 or abridged by this state or by any political subdivision of the state on account of sex,
3 gender identity, race, color, sexual orientation, disability, religion, national origin,
4 marital status, family status, age, ancestry, or any other immutable characteristic.

5 (2) Any person aggrieved by a violation of sub. (1) shall have a private cause
6 of action in any court of competent jurisdiction against the state or the appropriate
7 political subdivision of the state.

8 (3) The state and each political subdivision of this state shall protect and secure
9 the equality of rights guaranteed by this section.

10 **SECTION 2. Numbering of new provisions.** If another constitutional
11 amendment ratified by the people creates the number of any provision created in this
12 joint resolution, the chief of the legislative reference bureau shall determine the
13 sequencing and the numbering of the provisions whose numbers conflict.

14 ***Be it further resolved, That*** this proposed amendment be referred to the
15 legislature to be chosen at the next general election and that it be published for three
16 months previous to the time of holding such election.
