AUTHORS SUBJECT TO CHANGE

Relating to: requesting the federal government to revise its guidance on 1 2 employment services for individuals with developmental disabilities. 3 Whereas, facility-based programs, such as day programs, training centers, and 4 sheltered workshops, give Wisconsin residents with developmental disabilities the 5 opportunity to gain new skills, meet new people, and make meaningful contributions to society; and 6 Whereas, many Wisconsin residents with developmental disabilities choose to 7 8 participate in programs offered by facility-based day programs, training centers, 9 and sheltered workshops and receive great personal and social benefit from doing so; 10 and Whereas, the parents, guardians, and caregivers of many Wisconsin residents 11

whereas, the parents, guardians, and caregivers of many wisconsin residents with developmental disabilities are very supportive of facility-based day programs, training centers, and sheltered workshops and can attest to the benefits their programs provide; and

Whereas, often, funding for services provided by facility-based day programs, training centers, and sheltered workshops is obtained through home and community-based services Medicaid waivers granted under section 1915 (c) of the federal Social Security Act; and

Whereas, Medicaid waiver programs, including home and community-based services waiver programs, have been used in Wisconsin for many years to provide services for individuals with developmental disabilities and allow states to provide a range of services to Medicaid-eligible individuals who would otherwise require institutional care; and

Whereas, according to information from the Department of Health Services, on September 1, 2016, there were 19,114 individuals with developmental disabilities receiving services through the Family Care and Family Care Partnership programs, which are Medicaid waiver programs; and

Whereas, there is growing concern that regulations adopted by the Centers for Medicare and Medicaid Services of the United States Department of Health and Human Services and contained in 42 CFR 441.301 significantly change the home and community-based services Medicaid waiver program and will reduce opportunities for individuals with developmental disabilities to participate in programs offered by facility-based day programs, training centers, and sheltered workshops; and

Whereas, individuals with developmental disabilities should be free to choose the settings in which they receive services, including facility-based day programs, training centers, and sheltered workshops; now, therefore, be it

Resolved by the assembly, the senate concurring, That the members of the Wisconsin legislature strongly urge the Centers for Medicare and Medicaid Services to reconsider its changes concerning participation in programs offered by
