1 **Relating to:** National Adoption Month.

2 Whereas, National Adoption Month is one month of the year designated to
3 recognize families who adopt and to raise awareness about adoption of children and
4 youth from foster care; and

5 Whereas, on any given day, there are approximately 8,000 children in
6 Wisconsin living with foster families, many of whom await placement with a loving,
7 adoptive family to protect and care for them; and

8 Whereas, the number of youth in the foster care system who reach adulthood
9 without being placed in a permanent home has increased by more than 60 percent
10 since 1998; and

11 Whereas, November has been designated as National Adoption Month and is
12 declared so by presidential proclamation each year; and

13 Whereas, Wisconsin has recognized that post-adoption services are critical to
14 helping family stability and has utilized Adoption Resources of Wisconsin, Catholic

1 Charities–Madison, Catholic Charities–La Crosse, and Family Services of Eastern
2 Wisconsin to serve as post–adoption resource centers for our state; and

3 Whereas, the Jockey Corporation has recognized and focused on supporting
4 post–adoption services with its Jockey Being Family program and corporate
5 initiative to create over 2,000 backpacks that have been distributed through the
6 Home to Stay project, created by Adoption Resources of Wisconsin; and

7 Whereas, post–adoption resource centers throughout the state have
8 distributed the backpacks and visited families adopting children from foster care to
9 assist in providing information and services; and

10 Whereas, November 19, 2011, has been designated as National Adoption Day
11 as part of National Adoption Month, a day on which many adoptions in this state and
12 country will be legally finalized; and

13 Whereas, adoption is invaluable to strengthening families in our state and
14 communities, providing waiting children with a permanent, safe, and loving place
15 to call home; now, therefore, be it

16 ***Resolved by the assembly, the senate concurring, That*** the members of the
17 Wisconsin legislature recognize November 2011 as National Adoption Month, honor
18 those Wisconsin families who make a meaningful difference in the life of a child by
19 choosing to adopt, and urge all residents to join in the effort to raise awareness about
20 the importance of adoption.
