- 3 Resolved by the assembly, That:
 - **SECTION 1. Special order scheduled.** The following proposals shall be special orders of business on Thursday, November 14, 2013, at the times shown:
 - (1) At 1:01 p.m., 2013 Assembly Joint Resolution 25, relating to: recall of elective officers and a code of ethics for government officials (first consideration).
 - (2) At 1:02 p.m., 2013 Assembly Joint Resolution 67, or 2013 Senate Joint Resolution 57, if it is in the Assembly, relating to: election of chief justice (first consideration).
 - (3) At 1:03 p.m., 2013 Assembly Bill 54, relating to: limiting the times for voting by absentee ballots in person.
 - (4) At 1:04 p.m., 2013 Assembly Bill 75, or 2013 Senate Bill 183, if it is in the Assembly, relating to: the applicability of a county shoreland zoning ordinance in a shoreland area annexed by, or incorporated as, a city or village.
 - (5) At 1:05 p.m., 2013 Assembly Bill 128, relating to: recall petition requirements.

- (6) At 1:06 p.m., 2013 Assembly Bill 202, relating to: certification of election observers.

- (10) At 1:10 p.m., 2013 Assembly Bill 489, or 2013 Senate Bill 51, if it is in the Assembly, relating to: the number of mathematics and science credits required for a high school diploma.
- (11) At 1:11 p.m., 2013 Assembly Bill 490, or 2013 Senate Bill 384, if it is in the Assembly, relating to: the laws of trusts, the Uniform Trust Code, the Uniform Principal and Income Act, powers of appointment, and changes to estate recovery and divestment provisions relating to public assistance programs.
- (12) At 1:12 p.m., 2013 Assembly Bill 493, relating to: exemption of certain electors from the requirement to present proof of identification when voting in an election and use of veterans identification cards as proof of identification.
- (13) At 1:13 p.m., 2013 Senate Bill 278, relating to: public access to managed forest land that is located in a proposed mining site.
