1 **AN ACT** *to amend* 119.04 (1); and *to create* 120.12 (29) of the statutes; **relating**
2 **to:** paid preparation time for teachers.

Analysis by the Legislative Reference Bureau

This bill requires each school board to ensure that a teacher's daily schedule includes self-directed preparation time of at least 45 minutes or the equivalent of one class period, whichever is greater.

9 **SECTION 2.** 120.12 (29) of the statutes is created to read:

10 120.12 **(29)** TEACHER PREPARATION TIME. Ensure that each teacher's daily
11 schedule includes self-directed preparation time of at least 45 minutes or the
12 equivalent of one class period, whichever is greater.

13 **SECTION 3. Initial applicability.**

14 (1) This act first applies to a teacher who is affected by a collective bargaining
15 agreement or other contract that contains provisions inconsistent with this act on the
16 day on which the collective bargaining agreement or contract expires or is extended,
17 modified, or renewed, whichever occurs first.
