1 **AN ACT to create** 36.11 (44) and 38.04 (33) of the statutes; **relating to:**
2 satisfaction of University of Wisconsin and technical college course
3 requirements through COVID-related activities.

Analysis by the Legislative Reference Bureau

This bill requires University of Wisconsin institutions and technical colleges to offer students an opportunity to use hours engaged in an eligible activity to satisfy related course requirements to the extent appropriate. An “eligible activity” means volunteering or working, for at least one semester, to assist Wisconsin in responding to the COVID-19 pandemic.

13 requirements to the extent appropriate, as determined by the district board.

14 **SECTION 3. Initial applicability.**

15 (1) This act first applies to the first semester beginning after the effective date
16 of this subsection.
