2019 SENATE BILL 459

September 27, 2019 - Introduced by Senators Schachtner, Olsen, Bewley, Carpenter, Johnson, Miller and L. Taylor, cosponsored by Representatives Stubbs, Kitchens, Anderson, Bowen, Mursau, Neylon, Ohnstad, Pope, Sinicki, Spreitzer, Subeck, Tusler and Zamarripa. Referred to Committee on Government Operations, Technology and Consumer Protection.

AN ACT *to create* 20.255 (2) (dq) and 115.453 of the statutes; **relating to:** a science competition participation grant pilot program and making an appropriation.

Analysis by the Legislative Reference Bureau

This bill requires the Department of Public Instruction to award grants to teams of pupils in the 6th through 12th grades for the purpose of participating in science competitions. As a condition of receiving a grant, a team of pupils must demonstrate that it will provide funds to match the grant amount. DPI may not award a grant for this purpose in amount that exceeds \$5,000. Under the bill, these grants are available until June 30, 2021.

and minority interest in science, creating a technologically-literate workforce, and providing recognition for outstanding achievement by both pupils and teachers.

- (2) (a) By no later than April 1, 2020, the department shall notify school boards, operators of charter schools under s. 118.40 (2r) and (2x), governing bodies of private schools, and administrators of home-based private educational programs that applications for grants under this section will be accepted from eligible teams through a date set forth in the notice. As a condition of receiving a grant under this section, an eligible team shall demonstrate to the satisfaction of the department that the eligible team will provide matching funds in an amount equal to the amount awarded under this section.
- (b) From the appropriation under s. 20.255 (2) (dq), the department shall award a grant of up to \$5,000 to each eligible team selected from the applicants under par.(a). Grant funds awarded under this section may be applied only towards allowable expenses.
- (3) The department shall publish on its Internet site a list of grant recipients and submit to the appropriate standing committees of the legislature under s. 13.172(3) a report on the program under this section.

SECTION 4. Effective date.

(1) This act takes effect on the day after publication, or on the 2nd day after publication of the 2019 biennial budget act, whichever is later.
